CONTINUED CONSIDERATION OF MOTION (PARK - HUTT) relative to issues related to the response and recovery for the local fire emergency, including but not limited to a temporary waiver of grant-specific requirements within the Los Angeles Administrative Code (LAAC), and prohibition of all leaf blowers in burn areas.

Recommendations for Council action:

1. REQUEST the City Attorney to prepare and present an ordinance in 30 days that amends LAAC Section 14.6(a) to authorize departments to apply for and accept grants related to a Federal and State declarations of emergency that aid in response and recovery.
2. REQUEST the City Attorney to prepare and present an ordinance in 30 days that amends LAAC Section 14.6(b), allowing departments to apply for and receive grants related to the Palisades, Sunset, Hurst and Kenneth wildfire emergency response and recovery. prevent the spread of toxins and other environmental hazards.

INSTRUCT that the Chief Legislative Analyst, in coordination with the City Attorney and the Emergency Management Department, to report in 30 days on other changes to the LAAC and LAAC that may be required to expedite the response and recovery process, in addition to protecting health and safety.

Since the posting of the January 24, 2025 Council meeting agenda on Friday, January 17, 2025, a need for immediate action has arisen to facilitate the City's ongoing response to the 2025 wildfires, including California lawmakers' approval of \$2.5 billion in wildfire aid on Thursday, January 23, 2025 and a new Mayoral executive order announcing business tax relief on Friday, January 24, 2025.

On January 23, 2025, California lawmakers approved \$2.5 billion in wildfire aid to help Los Angeles City and County as well as schools in their response and recovery from the wildfires that have devastated our region. The aid package includes funding for a number of critical tasks like debris removal, post fire hazards, air quality monitoring and the rebuilding of public facilities. The funding also sets aside \$4 million for the Department of Housing and Community Development to help expedite permitting and rebuilding in burn areas.

In a recent report, the City Administrative Officer estimated that the Palisades Fire and other fires in the City of Los Angeles have resulted in more than \$350 million in costs associated with emergency response and damage to the City's physical infrastructure. Given the City's fiscal challenges, it must understand immediately how the state's wildfire aid can frontfund these initial recovery costs before reimbursement from the Federal Emergency Management Agency takes place.

I THEREFORE MOVE that the City Council determine, as provided in section 54954.2(b)(2) of the Government Code, and pursuant to Rule 23 of the Rules of the City Council, that there is a need to take immediate action on this matter AND that the need for immediate action came to the attention of the City subsequent to the posting of the agenda on Friday, January 17, 2025 for today's Council meeting.

I FURTHER MOVE that Council instruct the City Administrative Officer and Chief Legislative Analyst, in coordination with the Department of Building and Safety, Department of Public Works, Fire Department, Police Department, and other departments as needed, to report in 15 days on the amount of wildfire aid that will be available to the City of Los Angeles and how these funds will be utilized to front fund its emergency response and recovery costs.

Since the posting of the January 24, 2025 Council meeting agenda on Friday, January 17, 2025, a need for immediate action has arisen to facilitate the City's ongoing response to the 2025 wildfires, including California lawmakers' approval of \$2.5 billion in wildfire aid on Thursday, January 23, 2025 and a new Mayoral executive order announcing business tax relief on Friday, January 24, 2025.

In addition to destroying thousands of homes, the Palisades fire has destroyed or significantly interrupted many businesses in the Pacific Palisades - restaurants, cafes, home businesses, gardeners, housekeepers and more. Having lost nearly everything, along with important records, equipment and accounts, these businesses will likely face difficulty or be unable to pay their business taxes in 2025. To alleviate this profound economic hardship, the City should take immediate action to relieve impacted businesses of this responsibility, similar to Council's adoption of Ordinance 169977 following the Northridge Earthquake in 1994.

In the midst of the ongoing wildfires and windstorms, Los Angeles has lived with smoke, ash and soot for consecutive days now. Experts regularly report that even if there is no physical fire damage, the poor air quality impacts all of us - indoor and out. Fumes, ash and particles are still being produced by the yet to be extinguished Palisades and Eaton fires, as well as, the latest Hughes Fire.

As our brave firefighters continue to battle the multiple blazes, multijurisdictional coordination is taking place to begin the clean up and recovery. Agencies at all levels must be mindful to reduce the exposure to the harmful substances that have been spewed into the air and are partially settling across the region. The Los Angeles County Department of Public Health (Public Health) has already declared a local health emergency for the entire county and the South Coast Air Quality Management District (SCAQMD) is monitoring the current fires and their impacts on air quality, in addition to issuing air quality warning advisories for the most impacted areas.


The City of Los Angeles should help disseminate the most recent guidance and advice from air quality experts to ensure we are protecting our residents from the poor air quality. We should get ahead of this bad situation with information for how people can protect themselves and loved ones. This is especially important as people are racing to begin the clean up of their properties, and they need to be aware of the condition of the debris and not disturb it to the point of exposing themselves and others to harmful particulates.

The City Council should extend an invitation to experts on air quality at Public Health and the SCAQMD to present the latest information on the quality of the air during the fires and in the near future, as well as the most recent guidance on how individuals should protect themselves and their families during the clean up process.

I THEREFORE MOVE that the Los Angeles City Council request the leadership of the Los Angeles County Department of Public Health and the South Coast Air Quality Management District to present before council the recent and most relevant data on air quality conditions and guidance for the public to protect itself from the harmful particulate matter that has been released into the environment from these destructive fires.

On January 7, 2025, the Mayor declared a state of local emergency in wake of the windstorm and wildfire events that impacted the Los Angeles metropolitan area, particularly the Pacific Palisades neighborhood. These wildfires are the most serious natural disaster to impact the City since the 1994 Northridge Earthquake. This event has destroyed numerous homes, businesses and critical infrastructure, and resulted in a number of deaths. These unprecedented fires are still ongoing — as is the City's emergency response.

While the City continues to provide robust and timely emergency response, it has also begun preparations for critical long-term recovery efforts. The scale of the disaster, however, will result in extraordinary costs. Given the national significance of these wildfires, the Federal Emergency Management Agency (FEMA) announced that it will reimburse the City for "100 percent of the cost of debris removal and lifesaving and life sustaining activities — including fire suppression efforts — for 180 days."

The federal and State aid, however, requires front-funding by the City. The City Administrative Officer (CAO) has identified the available balance in the Building and Safety Building Permit Enterprise Fund as a potential source to provide a \$50 million loan for the City's emergency response. It is anticipated the loan will be repaid as soon as State and federal reimbursements are received or by the General Fund whenever fiscally feasible.

I THEREFORE MOVE that the Council AUTHORIZE the Controller to transfer a \$50 million appropriation from Fund 48R, Building and Safety Permit Enterprise Fund, Department 08, Account 08S204, Reserve for Future Cost, to a new line item, Fund 100, Department 56, Account TBD, 2025 Wildfire Emergency Response and Recovery, with the understanding that these funds are a temporary loan to be repaid from future State and federal reimbursements, for the 2025 wildfire emergency response and recovery.


I FURTHER MOVE that the Council INSTRUCT the City Administrative Officer to authorize expenditures from the 2025 Wildfire Emergency Response and Recovery Account for FEMA-reimbursable response and recovery activities, with reports to the Mayor, Council President, Chair of the Budget and Finance Committee and Chair of the Ad Hoc Committee for L.A. Recovery, for the duration of the declared local emergency.



As the emergency response to the Palisades Fire winds down, the City is shifting its focus to recovery and reconstruction, and promising a robust, expedited process that must be delivered upon for those who have lost their homes.

The scope of our short-term recovery and long-term reconstruction efforts will be a substantial undertaking, likely surpassing the City's current staffing levels and available resources. Several motions have been introduced over the past week, including CF 25-0006-S6, which instructs City departments to report on their staffing needs to support recovery efforts. Additionally, the motion instructs the City Administrative Officer to sunset the Prioritized Critical Hiring Process for positions essential to the wildfire recovery and rebuilding initiatives.

In addition to reviewing position vacancies and assessing the need for possible new positions, the City should look to creative approaches, such as rehiring retired employees. This strategy was successfully implemented in 1994 following the Northridge Earthquake when the City employed retired employees for 90 days to help the recovery efforts. City employees possess valuable institutional knowledge and experience from past disasters, representing the best of public service. Given the challenges ahead, the City should explore all available options to accelerate recovery and reconstruction efforts.

By including these practices, the City could create a more adaptable, nimble, and diverse workforce for the recovery and reconstruction phases, leveraging both local and external resources to address the scale of this disaster. This would not only expedite recovery efforts but also build resilience for future challenges.

I THEREFORE MOVE that City Council instruct the City Administrative Officer to report in 15 days on the feasibility and steps necessary to authorize the temporary reemployment of retired employees to aid in the City's wildfire recovery and rebuilding efforts, using lessons learned from the Northridge Earthquake.

I FURTHER MOVE that City Council instruct the City Administrative Officer to report in 15 days on possible funding sources for these positions, including, but not limited to, the use of Salaries As-Needed accounts.

I FURTHER MOVE that City Council instruct the City Administrative Officer and the Personnel Department to report in 15 days on the use of Targeted Local Hire and Bridge to Jobs hiring programs as a source of streamlining hiring for these positions.

In advance and in response to the devastating January 2025 windstorm and wildfires, multiple City agencies took action to mitigate potential impacts of the disasters and respond to the crises that struck the City. The Department of Recreation and Parks closed parks in Fire Hazard Severity Zones. The Department of Transportation and Bureau of Street Services worked to prepare streets and traffic management in the event of further evacuations. The Police Department also deployed additional resources as reports of looting in areas impacted by the fires occurred.


While much of the City's response to the wildfires and windstorm will be eligible for reimbursement from the federal and State governments, not all services may be. City agencies that sprang into action to protect the City from further devastation provided emergency services that were not included in their departmental budgets. Without potential reimbursement, these departments and bureaus may be required to absorb the costs of these actions.

The City should assess what unbudgeted services were provided in response to the wildfires and windstorm that may be ineligible for reimbursement and identify potential funding sources to cover any costs that were incurred.

I THEREFORE MOVE that Police Department, Department of Transportation, Department of Recreation and Parks, Department of Public Works Bureaus, and any other necessary departments be instructed and the Department of Water and Power be requested, with the assistance of the City Administrative Officer, to report on any unbudgeted City services provided or expenditures incurred in response to the January 2025 windstorm and wildfires that may not be reimbursable by the federal or State governments.

I FURTHER MOVE that the City Administrative Officer, with the assistance of any necessary City Departments, be instructed to report on potential funding sources for any unbudgeted City services provided or expenditures incurred in response to the January 2025 windstorm and wildfires that may not be reimbursable by the federal or State governments.

Following the devastation and loss of the Palisades Fire, many longtime residents, including the elderly and those of limited resources, are faced with the daunting task and uncertainty of rebuilding their homes. The City should do everything within its power to alleviate the financial burden for these residents in order to facilitate their return and stabilize the Pacific Palisades community.

In a report dated April 4, 2018 relative to the expediting of building permits and granting of fee waivers associated with the reconstruction of homes and other buildings damaged in the La Tuna Canyon and Creek Wildfires in 2017, the City Administrative Officer (CAO) reported (Council File No. 18-0036) that the City Attorney advised that certain fees collected by the Department of Building and Safety should not be waived in order to minimize legal risks to the City and prevent other users from subsidizing these waived fees. Fee waivers, however, following *federally declared natural disasters*, are not unprecedented.

Following the Northridge Earthquake in 1994, the City Council adopted Ordinance No. 169813, which waived all plan check and permit fees for property owners who wished to repair earthquake damage or to demolish and/or rebuild a destroyed structure. In addition, Art Fees Fees were also waived with Council's adoption of Ordinance No. 169350 on February 8, 1994, for repairs and new construction that was substantially similar to the destroyed building. According to the City's report produced in the aftermath of the earthquake: *In the Wake of the Quake: A Prepared City Responds* (1995), - many of these fee waivers were reimbursed by the Federal Emergency Management Agency (FEMA) and the California Governor's Office of Emergency Services (Cal OES).

While California voters' approval of Proposition 218 (*Right to Vote on Taxes Act*) in 1996 may have impacted this framework, the City should leave no stone unturned in its efforts to assist its residents who may be underinsured or lack the resources to finance a rebuild. To stabilize the Pacific Palisades community, the City should further explore the waiver of building fees for reimbursement by FEMA and Cal OES, as was negotiated by the City following the Northridge Earthquake.

I THEREFORE MOVE that the Council instruct the City Administrative Officer, with the assistance of the Department of Building and Safety, the Planning Department, the Federal Emergency Management Agency, Department of Cultural Affairs, and in consultation with the City Attorney, and other departments as needed, to assess the feasibility of waiving plancheck, permit fees and arts fees for repairs and rebuilds of structures that were destroyed in the Palisades Fire, as occurred in 1994 after the Northridge Earthquake. If infeasible, the report should explore alternative solutions, including payment deferrals.

The recent Palisades and Eaton fires have destroyed thousands of structures and displaced thousands more residents who are seeking shelter across Los Angeles. Many of these people are staying with friends and family in neighborhoods with preferential parking districts (PPDs).

Section 80.58(k) of the Los Angeles Municipal Code authorizes the Department of Transportation to administer, implement, and enforce the PPD permit program. The current program restrictions should be modified to accommodate individuals who have been displaced by the Palisades and Eaton fires and who are residing in households that are located in areas with preferential parking districts.

I THEREFORE MOVE that the City Council instruct the Department of Transportation (LADOT) to take the necessary steps to issue up to two additional annual and up to two additional visitor parking permits (for a maximum total of four additional permits), to residents in preferential parking districts who are currently sheltering people displaced by the Palisades or Eaton fires; residents must provide proof of residency in an area that was subject to a mandatory evacuation order that began January 7, 2025 or thereafter; and the permits will be effective until January 7, 2026.

AD HOC LA Recovery

MOTION

In the wake of the January 2025 windstorms, the Palisades and Eaton Fires, and other emerging fire emergencies, the Los Angeles region finds itself reeling from the constant threat and remnants of disaster. Too many Angelenos have seen homes destroyed, trees and vegetation scorched, storm drains filled to their brim, and existing infrastructure decimated. Our City must act swiftly in an extensive debris removal process that allows families and businesses to safely return and anticipates future rain and other hazards. Failing to clear the rubble could lead to further issues such as mudslides and water contamination. Through Emergency Executive Order 1, and subsequent legislation passed by this Council, the City of Los Angeles is stepping up through determined efforts to return and rebuild.

Given the scope of the disastrous fires, the federal government announced that it would reimburse the City for all eligible costs under the Federal Emergency Management Agency Public Assistance Program, including 100 percent reimbursement for debris removal in the public right of way within the first 180 days. At the State level, Governor Newsom has signed a \$2.5 billion bipartisan relief package to expedite Los Angeles' recovery and rebuilding, prioritizing fire-affected communities, debris removal, and investing in mitigation measures to prevent future disasters. The LA County Board of Supervisors has established a comprehensive recovery framework to coordinate local efforts, address community needs, and ensure transparency in the recovery process. These coordinated actions reiterate the critical importance of multijurisdictional coordination to address this crisis and ensure an equitable recovery for all impacted communities.

The devastating impact of recent fires has underscored the critical need for equitable recovery efforts that safeguard public health and prioritize environmental justice. While the ongoing cleanup is essential for fire-ravaged communities to recover and heal, much of the fire debris contains hazardous materials, such as lead, asbestos, mercury, and other toxins, posing significant risks to both health and the environment. It is imperative that debris removal processes not only advance recovery but also protect the health and safety of all Angelenos, particularly those in communities with deep legacies of environmental injustice.

The East San Fernando Valley, long home to numerous landfills and waste facilities, has historically borne the brunt of environmental challenges, including odor, noise, and harmful emissions from disposal operations and the frequent movement of garbage trucks. These cumulative impacts disproportionately harm vulnerable communities and highlight the importance of ensuring that debris hauling and disposal efforts do not exacerbate existing inequities.

As we work together to recover from these fires, the City must reaffirm its commitment to equity by ensuring that no single area, especially historically overburdened areas like the East San Fernando Valley, bears a disproportionate burden of debris removal and storage operations. At the same time, the City must collaborate as one with our Federal, State, and County partners to ensure that recovery efforts move with urgency and reflect our shared values of fairness, health, and environmental stewardship.

I THEREFORE MOVE that the Council instruct the Los Angeles Department of Sanitation and Environment (LASAN), with the assistance of the Local Enforcement Agency (LEA) of the Los Angeles Department of Building and Safety (LADBS), to report back within 15 days on the following:

- **Debris Transport and Destinations**
 - Identify all landfills and trash facilities where fire-related debris is being transported in the City;
 - Provide detailed maps of these facilities and their proximity to vulnerable communities, particularly in the East San Fernando Valley.
- **Distribution Methodology**
 - Describe the methodology being used to determine how debris is dispersed among landfills and facilities to ensure equitable distribution across the region.
- **Contractor Oversight**
 - List the vendors and contractors being considered for debris hauling and storage that are based in the city, use existing public or private facilities in the City, or operate haul routes in the City
 - Evaluate the geographic locations of these vendors to ensure no over-concentration of operations in the East Valley or other historically burdened areas.
- **Haul Routes**
 - Provide a detailed analysis of the haul routes being used to transport debris out of fire-affected areas.
 - Include measures to mitigate noise, air pollution, and safety risks in communities along these routes.
- **Hazardous Waste Management**
 - Outline how hazardous waste is being identified, packaged, transported, and disposed of safely, ensuring compliance with state and federal regulations.
 - Note which permits and other regulations will be removed or expedited as part of the recovery.
 - Specify what safeguards are in place to protect communities from potential exposure to hazardous materials.
- **Debris Composition and Management**
 - Provide a breakdown of the types of debris being removed, including hazardous waste, non-hazardous waste, green waste, and recyclable materials.
 - Clarify whether any categories of debris are being managed or transported by entities outside of the City and under what conditions.
- **City-Owned Facilities in Fire Recovery**
 - Identify any City-owned facilities that are being used as part of fire recovery efforts, including for debris processing, storage, or any other recovery-related operations.
 - Provide a status update on the capacity, operations, and environmental monitoring at these facilities to ensure compliance with local, state, and federal standards.
- **Intergovernmental Collaboration**
 - Detail LASAN and LADBS LEA efforts to coordinate with County, State, and Federal officials in the region's fire recovery efforts, including any collaborative agreements or partnerships.
 - Include information on any funding or resources being secured through these partnerships to aid in debris management and environmental restoration.
- **Timeline for Debris Removal**

- Offer a clear timeline for the anticipated completion of debris removal efforts, specifying benchmarks for various phases of the process.

I FURTHER MOVE that LASAN and LADBS LEA advocate for an equitable distribution of debris management impacts in their coordination with our multijurisdictional partners working on the fire recovery, ensuring that historically overburdened areas like those in the East Valley, do not disproportionately shoulder the burden of debris hauling, storage, or processing. This includes identifying additional processing sites in less impacted areas, and strategies that balance our urgent work to recover and rebuild with our ongoing commitment to equity and environmental justice.

Since the posting of the January 24, 2025 Council meeting agenda on Friday, January 17, 2025, a need for immediate action has arisen to facilitate the City's ongoing response to the 2025 wildfires, including California lawmakers' approval of \$2.5 billion in wildfire aid on Thursday, January 23, 2025 and a new Mayoral executive order announcing business tax relief on Friday, January 24, 2025.

On January 23, 2025, California lawmakers approved \$2.5 billion in wildfire aid to help Los Angeles City and County as well as schools in their response and recovery from the wildfires that have devastated our region. The aid package includes funding for a number of critical tasks like debris removal, post fire hazards, air quality monitoring and the rebuilding of public facilities. The funding also sets aside \$4 million for the Department of Housing and Community Development to help expedite permitting and rebuilding in burn areas.

In a recent report, the City Administrative Officer estimated that the Palisades Fire and other fires in the City of Los Angeles have resulted in more than \$350 million in costs associated with emergency response and damage to the City's physical infrastructure. Given the City's fiscal challenges, it must understand immediately how the state's wildfire aid can frontfund these initial recovery costs before reimbursement from the Federal Emergency Management Agency takes place.

Since the posting of the January 24, 2025 Council meeting agenda on Friday, January 17, 2025, a need for immediate action has arisen to facilitate the City's ongoing response to the 2025 wildfires, including California lawmakers' approval of \$2.5 billion in wildfire aid on Thursday, January 23, 2025 and a new Mayoral executive order announcing business tax relief on Friday, January 24, 2025.

In addition to destroying thousands of homes, the Palisades fire has destroyed or significantly interrupted many businesses in the Pacific Palisades - restaurants, cafes, home businesses, gardeners, housekeepers and more. Having lost nearly everything, along with important records, equipment and accounts, these businesses will likely face difficulty or be unable to pay their business taxes in 2025. To alleviate this profound economic hardship, the City should take immediate action to relieve impacted businesses of this responsibility, similar to Council's adoption of Ordinance 169977 following the Northridge Earthquake in 1994.

I THEREFORE MOVE that the City Council determine, as provided in section 54954.2(b)(2) of the Government Code, and pursuant to Rule 23 of the Rules of the City Council, that there is a need to take immediate action on this matter AND that the need for immediate action came to the attention of the City subsequent to the posting of the agenda on Friday, January 17, 2025 for today's Council meeting by the City Council.

I FURTHER MOVE that the City Council request the City Attorney, with the assistance of the Office of Finance, to prepare and present an urgency ordinance to provide relief from the payment of the gross receipts tax for the 2025 tax year for businesses within the city of Los Angeles that have been destroyed by the wildfires, or that have been impacted for 60 or more consecutive days as a result of the fires, with eligibility to be determined by the Office of Finance on a case-by-case basis.
