In 2019, Council District 15, in collaboration with the California Department of Transportation (CalTrans) and the Port of Los Angeles (POLA), commissioned a Freight Mitigation Study by the Southern California Association of Governments (SCAG) to evaluate the impacts of commercial truck traffic on the quality of life for residents in the East Wilmington area, near Watson Junction. The study focused on the residential community bounded by Sandison Street to the north, Pacific Coast Highway to the south, Drumm Avenue to the east, and Sanford Street to the west.

The study identified several mitigation measures to reduce the interaction between commercial truck traffic and residents. Key recommendations included, but were not limited to, permanently closing Blinn Avenue between Lomita Boulevard and Sandison Street to all vehicular traffic and restricting access to Drumm Avenue by creating cul-de-sacs at the intersections of Drumm and Cruces Street, as well as at 0 Street and Colon Street.

In March 2022, City Council motions (CF 22-0344 and CF 22-0341) were introduced, requesting reports from the Department of Transportation, Bureau of Engineering, and City Administrative Officer on project scoping and budgeting for consideration of funding. However, these motions have not been acted upon, and the ongoing intrusion of commercial traffic into the East Wilmington community continues to negatively affect residents' quality of life. Given the increased risk with the upcoming closure of the Vincent Thomas Bridge due to repairs, additional traffic will exacerbate this issue. Therefore, immediate action is needed to address these concerns.

I THEREFORE MOVE that the City Council instruct the Bureau of Engineering, with the assistance of the Department of Transportation, to report back with a comprehensive plan to close Blinn Avenue between Lomita Boulevard and Sandison Street to all vehicular traffic, as well as to restrict vehicular access to Drumm Avenue by creating cul-de-sacs at the intersections of Drumm and Cruces Street, 0 Street, and Colon Street. The plan should include a full scope of work and budget for both projects, with a report back to Council within 90 days.

Over the past decade, an average of 19,500 fireworks-related fires have been reported annually to fire departments nationwide. Fireworks have caused an estimated \$105 million in property damage each year, resulting in approximately 9,100 injuries annually. While fatalities are less common, fireworks-related incidents result in the deaths of an average of five people annually, often children.

The California Health and Safety Code, Section 12700, states that "any person that violates any provision of the State Fireworks laws or Regulations is guilty of a misdemeanor" being "punishable by a fine of not less than \$500, but not to exceed \$1,000 by imprisonment in the county jail for up to one year, or both". Under the Los Angeles Municipal Code (LAMC) Section 57.5608, possessing or discharging fireworks is classified as dangerous or illegal. This includes fireworks that are not certified as safe for public use and those that can cause injury or damage to property, including "safe and sane" varieties, within the City of Los Angeles. While "safe and sane" fireworks are less likely to explode or fly, they still pose significant risks, particularly to children.

Fireworks are inherently dangerous explosive devices, and every year, both children and adults suffer injuries and burns from their misuse. The City of Los Angeles should consider examining and potentially reinforcing local ordinances and advocating for more stringent state law provisions. In light of the recent Palisades, Eaton, and Hurst fires, the January 2025 windstorm, and other related fire incidents, protecting our communities from potential fire hazards, including those posed by illegal fireworks, must be an immediate priority.

I THEREFORE MOVE that the City Attorney, in consultation with the Los Angeles Fire Department (LAFD) and Chief Legislative Analyst (CLA), be requested to report in 30 days with pathways to strengthen provisions within the City ordinances and state laws governing fireworks, integrating ways that the City of Los Angeles can work to reduce the public safety risks associated with illegal fireworks and provide stronger deterrents against their use and sale. This report should specifically look to address the following provisions and the ways to increase enforcement:

- Los Angeles Municipal Code (LAMC) Sections applicable to fireworks and explosives:
  - o Increased penalties for the possession or use of illegal fireworks.
  - Introduce graduated fines or harsher consequences for repeat offenders.
  - Allow for civil fines against property owners where illegal fireworks are found to be used, sold, or stored.
- California Health and Safety Code Sections applicable to fireworks and explosives:
  - Stronger enforcement of California state restrictions on the sale, possession, and use of fireworks.
  - Advocate for increased penalties under state law, such as felony charges for large-scale possession or sale.

 Mandate collaboration with county, state, and federal agencies, such as the Bureau of Alcohol, Tobacco, Firearms, and Explosives, for investigations and interdictions of illegal fireworks imports to combat illicit fireworks smuggling or trafficking.

I FURTHER MOVE that the City Attorney, in consultation with the LAFD and CLA, be requested to report in 30 days on proposing the creation of restricted zones where even permitted firework shows may be banned entirely, such as near hospitals, schools, or highly populated residential areas. This should include strengthening permitting processes for the sale and public use of legal fireworks and ensuring only certified vendors are allowed to distribute them.

I FURTHER MOVE that the LAFD, in consultation with the CLA and City Administrative Officer (CAO), be directed to report in 30 days with a framework and required resources to implement enhanced public awareness campaigns to raise awareness about the dangers of illegal fireworks and the legal consequences.

I FURTHER MOVE that the LAFD and Police Department (LAPD), in consultation with the CAO, be directed to report in 30 days on additional ways along with required resources for the LAFD and LAPD to further collaborate through the use of joint operations or task forces for targeted enforcement to deter illegal fireworks sales and use.
