The Ventura Cahuenga Boulevard Corridor Specific Plan (Ord. 174,052), first adopted in 1991, established a Project Impact Assessment (PIA) Fee to fund Specific Plan transportation improvements and services, as well as pedestrian improvements. Section 12 of the Specific Plan sets forth guidance as to how Specific Plan PIA Fee funds may be used, with reference to a list of improvements and services. Section 12.A. of the Specific Plan allows the City Council to authorize additional improvements and services, upon recommendation by both the Director of Planning and the General Manager of the Department of Transportation (LADOT), subject to findings set forth in Section 12.B and subject to review by the Specific Plan Project Review Board.

On May 4, 2023, the Specific Plan Review Board voted to support the use of \$683,473 in PIA funds for two new landscaped medians on Van Nuys Boulevard from Moorpark Street to Hortense Street (C.F. 23-0599). On December 5, 2024, the Specific Plan Review Board voted to support the use of an additional \$617,373 for the project due to updated cost estimates for a total funding amount of \$1,300,846. The Planning Department and the LADOT support the use of PIA funds for this purpose.

Council action is required to transfer the funds to the Office of Community Beautification (OCB), which will allocate the funds to the Los Angeles Neighborhood Initiative under an existing contract to implement the project.

I THEREFORE MOVE that the Council AUTHORIZE:

- 1. 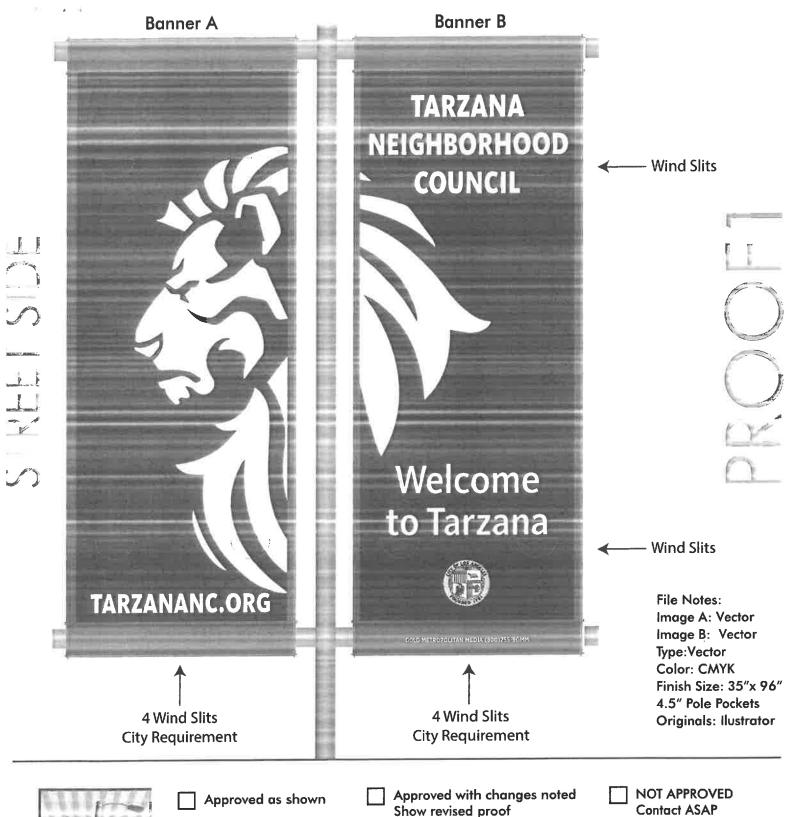

The Los Angeles Fire Department (LAFD) requires fund transfers to address shortfalls in various sworn and civilian salary accounts. The overspending is attributed to sworn deployments to the Palisades fire and other fire and wind storm related events in recent weeks. Due to continuing support for brush fire response and recovery, some salary accounts are poised to be depleted well in advance of the Midyear Financial Status Report. This includes:

- Sworn Overtime (001092) funds emergency overtime for first response and recovery operations.
- Overtime General (001090) supports fleet maintenance to deploy more apparatus to the field; payroll staff processing sworn retro payments; Revenue Management staff monitoring incident expenses for cost recovery; information technology staff ensuring that dispatch and field communications operate at uninterrupted levels; Advanced Providers supporting field needs; and Fire Prevention plan checkers beginning the process of recovery.
- Salaries As-Needed (001070) supports Administrative Interns assisting with Department operations, including payroll and human resources support, in view of position reductions and vacancies.

Adjustments between accounts are immediately needed to avoid depleting accounts. It is anticipated that the fiscal year will continue to experience significant weather related fires and storms.

I THEREFORE MOVE that, subject to the approval of the Mayor, the Controller transfer an amount of \$3,300,000 from the Salaries Sworn Account 001012 to the Sworn Overtime Account 001092; and, \$1,100,000 from the Salaries General Account 001010 to the Overtime General Account 001090 (\$1,000,000) and Salaries As-Needed Account 001070 (\$100,000), for total transfers of \$4.4 million to cover projected funding needs in these accounts.

Measure United to House LA was approved by the voters of the City in November 2022, adding section 21.9.2(b) to the Los Angeles Municipal Code, generating hundreds of millions of dollars to be invested in programs that support the development of affordable housing, income support for the most vulnerable, eviction protection and rental assistance for thousands of Angelenos.

The recent 2025 Los Angeles Wildfires have caused billions of dollars worth of destruction to homes and businesses, displacing families, workers, tenants, and neighborhood residents across Los Angeles. The economic impacts of the Los Angeles Wildfires has had a cascading effect across all sectors of the labor market and has destabilized the housing security of the most vulnerable workforce in Los Angeles.

There is an urgent need to distribute emergency rental assistance to prevent evictions and displacement of tenants impacted by the Los Angeles Wildfires in response to the January 7, 2025 Declaration of Local Emergency on Windstorms and Fire Weather, and to address the ongoing Declaration of Local Emergency on Housing and Homelessness in Los Angeles.

I THEREFORE MOVE that the Council instruct the Los Angeles Housing Department, with the assistance of the City Administrative Officer, disencumber \$15,000,000 and reallocate funds from the House LA Fund - Administration and appropriate these funds to the Emergency Rental Assistance Program to assist Angelenos impacted by the 2025 Los Angeles Wildfire.

LA Sanitation and Environment (LASAN) provides services to ensure the health and safety of our residents, communities, and the environment. Critical services include collection and recycling of solid resources materials for residential customers and City departments, the conveyance, collection and treatment of wastewater to meet regulatory requirements, and the management of the City's watershed to protect the beneficial uses of the receiving waters and comply with flood control mandates.

Based on an analysis of current expenditures, LASAN has determined that the Overtime General Account and the Contractual Services Account do not contain adequate appropriations to meet payroll and operational needs for the remainder of FY 2024-25. While a transfer of funds to meet this need is anticipated in the CAO's 2024-25 Third Financial Status Report, the timing of that report will not meet LASAN's immediate payroll and contractual services needs. Staff shortages and additional workload have necessitated greater use of overtime and contractual services.
