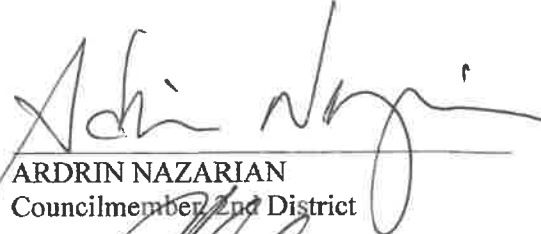
Campbell Hall (Episcopal), a California nonprofit public benefit corporation (Borrower), has requested that the California Enterprise Development Authority (CEDA) issue one or more series of its revenue bonds or other obligations, in an aggregate principal amount not to exceed \$65,000,000 (Obligations) for the purpose of financing, refinancing and/or reimbursing the acquisition, construction, improvement and equipping of the educational facilities (Facilities) located at 4533 Laurel Canyon Boulevard in Council District 2. The Facilities will be owned and operated by the Borrower.

No City funds are or will be pledged to support this project. The Obligations are payable solely from revenues or other funds provided by the Borrower. The City does not incur liability for repayment of the Obligations. The City is required by federal law to review and approve the issuance of bonds or revenue obligations for projects within its jurisdiction and conduct a public hearing.


In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the issuance of the Obligations, the Borrower has requested that the City conduct the required public hearing (TEFRA Hearing) and approve the issuance of the Obligations by CEDA.

I THEREFORE MOVE that City Council allow the California Enterprise Development Authority to issue bonds in an amount not to exceed \$65,000,000 to provide financing, refinancing, and/or reimbursement for the acquisition, construction, improvement and equipping of certain educational facilities located at 4533 Laurel Canyon Boulevard in Council District 2; and hold a TEFRA public hearing and adopt the attached Resolution at the City Council Meeting to be held on February 12, 2025 at 10:00 a.m., located at 200 North Spring Street, Room 340, Los Angeles, California 90012.

RESOLUTION

APPROVING THE ISSUANCE BY CALIFORNIA ENTERPRISE DEVELOPMENT AUTHORITY OF NOT TO EXCEED \$65,000,000 AGGREGATE PRINCIPAL AMOUNT OF CALIFORNIA ENTERPRISE DEVELOPMENT AUTHORITY REVENUE BONDS (CAMPBELL HALL (EPISCOPAL)), SERIES 2025 FOR THE PURPOSE OF FINANCING, REFINANCING AND/OR REIMBURSING THE COST OF ACQUISITION, CONSTRUCTION, IMPROVEMENT AND EQUIPPING OF EDUCATIONAL FACILITIES FOR THE BENEFIT OF CAMPBELL HALL (EPISCOPAL) AND OTHER MATTERS RELATING THERETO

WHEREAS, Campbell Hall (Episcopal), a California nonprofit public benefit corporation (the "Borrower") and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), has requested that the California Enterprise Development Authority (the "Authority") issue, from time to time, pursuant to a plan of finance, its tax-exempt revenue bonds or other obligations in an aggregate principal amount not to exceed \$65,000,000 (the "Bonds") for the benefit of the Borrower pursuant to Chapter 5 of Division 7 of Title 1 of the Government Code of the State (commencing with Section 6500) (the "Act"); and

WHEREAS, the proceeds of the Bonds will be used for the purpose of financing, refinancing and/or reimbursing the cost of acquisition, construction, improvement and equipping of certain educational facilities of the Borrower, including, but not limited to, a new multipurpose athletic and recreational activities facility, a dining facility, classrooms, science labs and administrative offices, a library, parking facilities and other related facilities, all located at the Borrower's campus at 4533 Laurel Canyon Boulevard, Los Angeles, California 91607 (the "Project"); and

WHEREAS, the issuance of the Bonds must be approved by the governmental unit on behalf of which the Bonds are issued and a governmental unit having jurisdiction over the territorial limits in which the Project is located pursuant to the public approval requirement of Section 147(f) of the Code; and

WHEREAS, the Project is located within the territorial limits of City of Los Angeles (the "City") and the City Council of the City (the "City Council") is the elected legislative body of the City; and

WHEREAS, the Authority and the Borrower have requested that the City Council approve the issuance of the Bonds by the Authority and the financing and refinancing of the Project with the proceeds of the Bonds pursuant to Section 147(f) of the Code; and

WHEREAS, the Project provides significant benefits to the City's residents through the Borrower's educational mission; and

WHEREAS, the Authority's issuance of the Bonds will result in a more economical and efficient issuance process because of the Authority's expertise in the issuance of conduit revenue obligations; and

WHEREAS, it is intended that this Resolution shall comply with the public approval requirements of Section 147(f) of the Code; *provided, however*, that this Resolution is neither intended to nor shall it constitute an approval by the City Council of the Project for any other purpose; and

WHEREAS, pursuant to Section 147(f) of the Code, the City Council of the City, following notice duly given, held a public hearing regarding the issuance of the Bonds and now desires to approve the issuance of the Bonds by the Authority;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the City Council of the City as follows:

Section 1. The City Council hereby finds and determines that all of the recitals are true and correct. The City Council finds that the Project will provide the significant benefits set forth in the recitals above. The City Council hereby approves the issuance of the Bonds by the Authority, which Bonds may be tax-exempt and/or taxable as approved by the Authority in its resolution, in an amount not to exceed \$65,000,000 to finance and refinance the Project. This resolution shall constitute approval of the issuance of the Bonds within the meaning of Section 147(f) of the Code and shall constitute the approval of the issuance of the Bonds within the meaning of the Act; *provided, however*, that this Resolution shall not constitute an approval by the City Council of the Project for any other purpose. The City shall not bear any responsibility for the tax-exempt status of the Bonds, the repayment of the Bonds or any other matter related to the Bonds.

Section 2. All actions heretofore taken by the officers, employees and agents of the City with respect to the approval of the Bonds are hereby approved, confirmed and ratified, and the officers and employees of the City and their authorized deputies and agents are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all certificates and documents which they or special counsel may deem necessary or advisable in order to consummate the Bonds and otherwise to effectuate the purposes of this Resolution.

Section 3. This Resolution shall take effect from and after its adoption.

BUDGET & FINANCE

On March 1, 2011, the Council adopted the 2010 Bicycle Plan, which required the establishment of a Bicycle Plan Trust Fund to collect developer mitigation fees to be used for bicycle-related projects and programs such as bicycle and multiuse paths, way-finding signage, bike racks, and other amenities (C.F. 10-2385-S2).

On February 18, 2020, NBCUniversal Media, LLC, on behalf of Universal Studios, LLC contributed \$375,000 in mitigation funds to the City for a project located at 100 Universal City Plaza. The funds were to be used to implement bicycle facilities in the vicinity of the project (C.F. 12-1657-S13).

The Bureau of Engineering and Department of Transportation, in collaboration with Council Districts 2 and 4, propose to use a portion of these funds to develop a 25% schematic design for a two-way Class IV bicycle facility connecting the forthcoming Segment 8 of the LA RiverWay biking/walking path to the Universal/Studio City Metro Station. This schematic design would be undertaken alongside the full 100% design of Segment 8 of the LA RiverWay, set to begin this year. Council approval is required to transfer these funds to the Bureau of Engineering to allow this work to proceed. Given limited funding available in the Bicycle Plan Trust Fund, staff should also seek funds for other related projects identified by the group during this process.

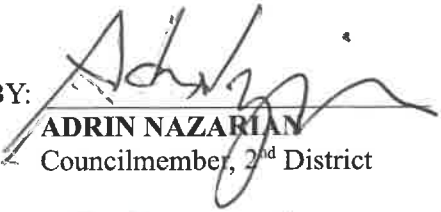
In addition, the Bureau of Engineering and Department of Transportation, in collaboration with Council Districts 2 and 4, also propose to include a separate 25% schematic design for a segment of the LA River Greenway walking path network on the north bank of the Los Angeles River from Colfax Avenue to Vineland Avenue. This schematic design would also be undertaken alongside the full 100% design of Segment 8 of the LA RiverWay.

I THEREFORE MOVE that the Council AUTHORIZE the Department of Transportation (LADOT) to transfer/appropriate \$70,000 from the Bicycle Trust Fund No. 55C, Account No. 94VN24 (NBC/Universal Bike Improvements), to the Bureau of Engineering Fund No. 100-78, Account No. 003040 (Contractual Services), to develop a schematic design for a two-way Class IV bicycle facility connecting the forthcoming Segment 8 of the LA RiverWay biking/walking path to the Universal/Studio City Metro Station.

I FURTHER MOVE that the Council INSTRUCT the City Administrative Officer to identify funding options to provide \$80,000 in funds for the completion of a 25% schematic design of a walking path on the north side of the Los Angeles River from Colfax Avenue to Vineland Avenue along with architectural, landscaping, and irrigation elements.

I FURTHER MOVE that LADOT be authorized to make any technical corrections or clarifications to the above fund transfer instructions in order to effectuate the intent of this Motion, including any corrections and changes to fund or account numbers.

The January 2025 firestorms, and specifically the experience of the Palisades fires, highlight significant opportunities to improve public safety preparedness, particularly in staffing and resource deployment during high-risk fire conditions.

The National Weather Service (NWS) provides reliable forecasting for Red Flag (RF) conditions, indicating when extreme weather, including high winds and dry conditions, creates significant fire risk in the region. The City's current deployment system allows for managerial discretion on staffing decisions during RF conditions. The City must consider a rule to staff up for RF days as an automatic process triggered by the NWS weather model.

Currently, we experience approximately 15 RF days annually in Los Angeles, during which the City's fire risk is dramatically elevated.

I THEREFORE MOVE that the City Council instruct the Los Angeles Fire Department (LAFD) to report on options to implement additional mandatory staffing citywide to enhance the LAFD's current deployment on Red Flag (RF) days. The report should detail a standardized staffing protocol for all RF days, ensuring full deployment of resources. The staffing model should consider enhancing the following units on all RF days, including personnel as necessary:

- 200 Series Engines: Fully staffed and operational at all times;
- Brush Patrols: Fully staffed and available for rapid deployment;
- 400 Series Engines: Ensure engines are staffed when repaired and operational;
- Water Tenders: Include both LAFD and Recreation & Parks water tenders to ensure there is sufficient water supply for firefighting in critical areas;
- Additional Battalion Command Teams: Staffed and deployed as needed to provide tactical leadership and coordination;
- Type 3 Engines: Fully staffed for wildland firefighting efforts; and
- Strategic Deployment: Firefighters to be strategically deployed throughout the very high-hazard severity zones, focusing on known fire corridors and other high-risk areas identified through historical data and fire modeling.

I FURTHER MOVE that the City Council instruct the City Administrative Officer (CAO), with consultation from the LAFD, to provide a cost estimate for the enhanced deployment model. Additionally, this should include the potential for a dedicated funding source in the LAFD budget to cover the costs associated with staffing and resource deployment on anticipated RF days.

In 2021, it was reported that a little more than 100 members of the Los Angeles Fire Department (LAFD), or 3% out of the total 3,300 members, lived outside of the State of California.

For the first time in 19 years, on January 7, 2025, the department urged all off-duty firefighters to provide their availability for recall. When members do not live within California, the Fire Chief's ability to successfully recall firefighters and deploy them urgently is significantly impacted, greatly reducing our ability to respond to the most critical emergencies.

I THEREFORE MOVE that the City Council instruct the Personnel Department, in coordination with the City Administrative Officer (CAO) and the Los Angeles Fire Department (LAFD), to report on the current total number of LAFD firefighters and personnel, and the current number of firefighters and personnel that live outside of the State of California.

I FURTHER MOVE that the City Council instruct the LAFD to report on the number of off-duty firefighters that were recalled on or immediately after January 7, 2025. This should include: (1) the number of firefighters who successfully made contact with the Department Operations Center to provide their availability for recall; (2) the number of off-duty firefighters who were recalled and deployed that live within California; (3) the number of off-duty firefighters who were recalled and deployed that live outside of California, which State the members live in, what time they were recalled, and what time they reported to their place of assignment; (4) the number of off-duty firefighters who live within California and refused recall; and (5) the number of off-duty firefighters who live outside of California and refused recall.

Government Efficiency

MOTION

Bureau of Street Lighting (BSL) designs, constructs, and maintains approximately 220,000 streetlights that illuminate two-thirds of the City. The system has over 400 different styles of lights, ranging from modern to historic and ornate, with some assets in the City nearly a century old. Streetlights are supported by a vast underground network of approximately 9,000 miles of conduit filled with 27,000 miles of copper wire that connects to 12,000 DWP service points.

While the issue of thefts and vandalism in electrical systems have always been present, the City first saw a sharp uptick in thefts damaging the lighting system between Fiscal Year (FY) 06/07 (9 incidents) to FY07/08 (443 incidents) – well over a 40-fold increase. Levels remained fairly consistent with an average of 500 incidents per year until FY17/18. Within two years the number of incidents grew 4-fold and has consistently been above 2,500 incidents since FY19/20. To date, there are over 2,800 theft and vandalism incidents putting FY24/25 on a course to be the all-time high.

Lighting is an important aspect of public safety and ensuring our infrastructure is in working order and maintained is a core function of City government. It is critical for Council to understand the process that BSL goes through in responding to outages and damaged streetlights and the timeline it takes to repair street and pedestrian lighting.

I THEREFORE MOVE that the Bureau of Street Lighting BE DIRECTED to report to the Government Efficiency, Innovation, and Audits on the existing process for repairing damaged street and pedestrian lighting infrastructure and the current timeline for repairs, as well as on potential bottlenecks or inefficiencies in the existing repair process.

I FURTHER MOVE that the Chief Legislative Analyst, with the assistance of the Bureau of Street Lighting, report to Government Efficiency, Innovation, and Audits with a comparative analysis of the street lighting repair process in other major cities, and how best practices in other cities can be adopted for the process in the City of Los Angeles.

ENERGY & ENVIRONMENT

Maintenance of public areas of the Los Angeles River within the City of Los Angeles is currently fragmented among multiple entities and internal City departments. This fragmentation leads to inconsistent service levels, uneven cost distribution, and most critically, confusion and extreme dissatisfaction for community members.

The recently established LA River Rangers program, housed with the Department of Public Works's Office of Community Beautification, has demonstrated success in addressing routine maintenance needs. With initial funding from finite state grants, this program has partnered with the LA Conservation Corps to perform essential tasks, including routine landscaping, clean up, and other critical activities that support the river's revitalization.


To ensure consistent and effective maintenance, these daily activities should be consolidated under a permanent LA River Rangers Program. Internal consolidation of daily maintenance activities will also aid the City in its regular collaboration with Los Angeles County, the Mountains Recreation and Conservation Authority, Santa Monica Mountains Conservancy, US Army Corps, and other entities responsible for the Los Angeles River.

To effectuate the transition of duties and resources to the LA River Rangers Program, henceforth, any and all contracts or agreements for services along the LA RiverWay, LA River Greenway, river parks, or other City-maintained areas along the Los Angeles River, must be reviewed and considered for consolidation within the scope of the LA River Rangers Program. Furthermore, any and all upkeep work performed by City forces along the LA River and its nearby public spaces and rights-of-way must also be evaluated for consolidation under the LA River Rangers Program, for maximum efficiency and clarity.

Ideally, the City should consolidate maintenance responsibilities in one City entity, i.e. the LA River Rangers. However, certain specialized scopes of operations & maintenance work, such as lighting, major repairs, homelessness services, and public safety, may not be appropriate for the LA River Rangers Program. Still, each topic of work should be evaluated for potential efficiencies and collaboration with the LA River Rangers program, if not for handoff.

I THEREFORE MOVE that the City Council INSTRUCT the City Administrative Officer, with assistance from the Chief Legislative Analyst, Department of Public Works, Department of Transportation, Department of Recreation and Parks, Bureau of Sanitation, and all other relevant agencies, to report back, within 60 days, with a report listing all current contracts (including their fees and term lengths), staff positions and costs, and other direct and indirect costs associated with Los Angeles River maintenance activities. The report should indicate which contracts and services could be performed by the LA River Rangers, and make recommendations for how the LA River Rangers take over said contracts and services. The report should also indicate full time and part time staff resources needed as well as any potential new contracts needed to holistically manage the daily maintenance needs of the LA RiverWay, LA River Greenway, river parks, or other City-maintained areas along the Los Angeles River.

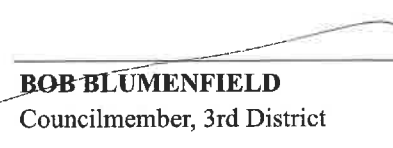
