1. DETERMINE, based on the whole of the administrative record, that the adoption of the accompanying ORDINANCE dated February 5, 2025, is exempt from the California Environmental Quality Act (CEQA) through Section 15061(b)(3) (common sense exemption) of the State CEQA Guidelines and Article II, Section 1 of the City CEQA Guidelines, and that none of the exceptions under CEQA Guidelines Section 15300.2 apply. If the City Council concurs with the CEQA analysis, it should adopt these CEQA determinations prior to or concurrent with its action on the draft ordinance; and, DIRECT the Los Angeles Housing Department to file Notices of Exemption with the County Recorder's Office following the adoption of the draft ordinance.
2. PRESENT and ADOPT the accompanying ORDINANCE dated February 5, 2025, approved as to form and legality by the City Attorney, adding Article 22 to Chapter IV of the Los Angeles Municipal Code to temporarily prohibit residential evictions solely based on housing persons or pets displaced by the January 2025 wildfires.

The FamilySource System (FSS) is the City's framework for delivering anti-poverty services and initiatives. Established in 2009, the FSS is a network of centers that works to break the cycle of intergenerational poverty. Each FamilySource Center (FSC) offers a comprehensive menu of social services and outreach programs to low—and moderate-income parents and guardians with children.

In 2023, the Community Investment for Families Department (CIFD) expanded the FSC system by soliciting bids from eligible organizations through a Request for Proposals. New Economics for Women was selected as the FSC operator for the Van Nuys service area.

In alignment with the FSS vision, the New Economics for Women (NEW) FamilySource Center offers comprehensive assessments to low-income families with school-age children, including emergency assistance, educational, health, benefits screening, psycho-social assessments, and financial coaching. The Kids First initiative within the Van Nuys FSC provides these vital services to additional vulnerable families within the San Fernando Valley.

CIFD was appropriated \$549,483 in its Contractual Services Account in the Adopted 2024-25 Budget (C.F. 24-0600) to operate the Kids First Program. Council action is necessary for CIFD to execute a contract amendment with New Economics for Women to provide these services at the Van Nuys FSC.

I THEREFORE MOVE that the City Council;

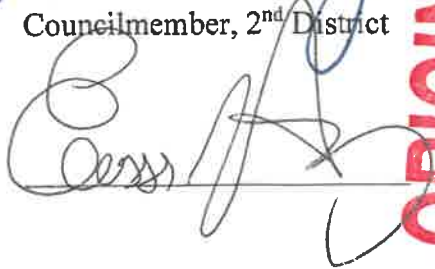

On June 26, 2024, the enacted 2024-25 California State Budget appropriated approximately \$69.8 million in General Funds for water recycling projects through the California State Water Resources Control Board (SWRCB) Water Recycling Funding Program (WRFP). The City of Los Angeles was awarded \$3 million in grant funds in the SWRCB's Clean Water State Revolving Fund 2024-25 Intended Use Plan (IUP) for the Donald C. Tillman Water Reclamation Plant (DCTWRP) Advanced Water Purification Facility (AWPF) Project.

The Project, located in Council District 6, includes the construction of a new state-of-the-art advanced water purification treatment train capable of producing up to 20 MGD of purified recycled water for groundwater replenishment. The Project's other components include the construction of a maintenance and warehouse facility, an ancillary warehouse facility, and an advanced water equalization basin as supporting elements for the treatment train. Once completed, the Project will help the City achieve its long-term goals to reduce imported water use, increase local water supplies, and diversify the City's water portfolio to enhance reliability and climate-change resiliency.

As a condition for executing a WRFP grant agreement, the SWRCB requires the City to adopt an authorizing resolution to designate the authorized representatives for the Project. Although a resolution was adopted through CF No. 17-1335 on February 2, 2018, the SWRCB has since updated the required resolution language and requested the City to adopt the new resolution. Per the IUP, the updated authorizing resolution must be adopted by March 31, 2025 for the Project to be guaranteed for WRFP grant funds in SFY 2024-25. There is no impact to the General Fund.

I THEREFORE MOVE that the City Council adopt the accompanying updated Authorizing Resolution (Transmittal 1), as required by the funding authority, identifying the Director and General Manager of LA Sanitation and Environment as the authorized representative to the California State Water Resources Control Board - Water Recycling Funding Program.

Water seepage issues been a long-standing issue along a segment of Temescal Canyon Road in Pacific Palisades. A new and critical situation occurred after the rains on January 25, 2025 at approximately 1,400 feet north of the intersection of Pacific Coast Highway. On February 2, 2025, the Council approved \$100,000 from the Capital Technology and Expenditure Program Fund for the Bureau of Engineering (BOE) to conduct a hydrogeologic study to determine the quantity and movement of the groundwater causing the issue (C.F. 23-0839).

The BOE has completed the study and is ready to proceed with repairs at this location. The scope of work for the repairs includes the following: removal and disposal of existing asphalt pavement and sidewalk; excavation of an approximate 45-foot by 125-foot area within the roadway; installation of subdrain pipes; and, construction of a new pavement section. Approval by the City Council and Mayor is required to appropriate the necessary funds for the repairs. There are sufficient funds available from completed projects to address these critical repairs.

I THEREFORE MOVE that the Council, subject to approval of the Mayor, transfer funds within Road Maintenance and Rehabilitation Program Special Fund No. 59V-50 as follows to conduct repairs to address water seepage on a segment of Temescal Canyon Road:

Section 22.171.10 of the Administrative Code provides that the City Council, the Cultural Heritage Commission, or the Director of Planning, may initiate consideration of a proposed site, building, or structure as a Historical-Cultural Monument. The Cultural Heritage Commission, after reviewing and investigating any such Council-initiated designation shall approve or disapprove in whole or in part the proposed inclusion and submit a report upon such action to the Council. In addition, Section 22.171.12 of the Administrative Code provides that there shall be a temporary stay of demolition, substantial alteration or removal or any such proposed location or structure pending designation.

The properties located at 700-702 Tuna Street; and 712-716 Tuna Street in San Pedro (*Japanese American Commercial Village Buildings*), are individually eligible for Historic Cultural Monument designation for both their historic association and architectural merit. These properties are significant for their important historic-cultural contribution they made to the development of Tuna Street—a once vibrant commercial corridor of the **Japanese American Fishing Village on Terminal Island** where there were over 3,000 residents of Japanese descent; and foremost, a community which tragically was the first in the nation to be removed and relocated due to President Franklin D. Roosevelt (D), *Executive Order 9066, issued on February 19, 1942*, resulting in the United States Military establishing curfews of all Japanese persons, and those of Japanese descent.

The Japanese American population on Terminal Island disappeared through this injustice but have never been forgotten. This community was the first in the nation to be forcibly removed and relocated to World War II internment camps. Immediately after the incarceration of the residents, their homes were demolished. After the war, many of them returned to find very little of their former fishing village and once-thriving community. The fact that any buildings remain is remarkable, and as such, those that remain need to be recognized for this contribution to the social history of Los Angeles, and also for their architectural significance inasmuch as both buildings were designed in a *Vernacular* architectural style, using common materials and simple detailing, and retain their basic form and continue to tell a crucial part of Terminal Island's story.

In addition, the buildings along with the Terminal Island Japanese American Fishing Village, as a whole, are also listed in *Survey LA*, the Citywide historic resources survey, as a historic resource; and more specifically, Section 3.2.5 (*Goal 5: Protect Historic Resources*) of the **Port of Los Angeles Master Plan (2018)**, states: '*the history of the Port, including significant periods such as the era of shipbuilding, commercial fishing, and the Japanese American Fishing Village, should continue to be memorialized, as appropriate, through monuments and preservation of associated existing buildings and sites.*'

As such, it is imperative that the City's historic-cultural treasures be celebrated, and foremost, that its historical sites be preserved for future generations, especially so wherein very few of the Historic-Cultural Monuments in the City are dedicated to the Asian American Pacific Islander community.

I THEREFORE MOVE that the Council initiate consideration of the properties located at **700-702 Tuna Street; and 712-716 Tuna Street, San Pedro, CA 90731**, *Japanese American Commercial Village Buildings*, as a City Historic-Cultural Monument under the procedures of Section 22.171.10 of the Administrative Code, and instruct the Planning Department to prepare the Historic Cultural Monument application for review and consideration by the Cultural Heritage Commission.

The Watts Coffee House located within City-owned property at 1827 East 103rd Street, Los Angeles, CA 90002 has long been a cultural and economic staple in the Watts community. Not only has it provided traditional American entrees and a variety of beverages, it has also served as a gathering place and an economic driver in the area. Unfortunately, in early 2024, economic hardship led to the permanent closure of the Watts Coffee House. The property now sits vacant and in need of a new operator.

It is essential that the City use its resources to help revitalize this landmark to ensure that the next operator aligns with community needs and enhances economic and workforce development opportunities. City Council action is needed to instruct the Economic and Workforce Development Department (EWDD) to assist in the development and execution of a Request for Information (RFI) to identify a qualified operator for the Watts Coffee House location. The goal is to attract proposals from individuals or organizations capable of managing the space in a way that:

- Sustains a thriving coffee house business that serves the community of Watts;
- Incorporates workforce training and development, particularly for local residents interested in the food service, hospitality, and business management industries; and
- Enhances job creation and provides economic mobility opportunities in the community.

Furthermore, it is important that EWDD collaborate in this effort with relevant stakeholders to develop an RFI that:

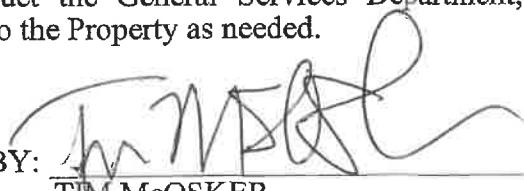
- Defines criteria for potential operators, including their experience, vision for the space, and commitment to community benefit.
- Identifies workforce development opportunities, such as barista training, culinary apprenticeships, or small business incubation programs.
- Ensures alignment with economic revitalization efforts and the long-term sustainability of the business.
- Engages community input to ensure the selection process reflects the needs and aspirations of Watts residents.

By leveraging EWDD's expertise in workforce and business development, this effort will ensure the Watts Coffee House continues to serve as a vibrant hub that celebrates culture, fosters local talent, and contributes to the economic vitality of Watts.

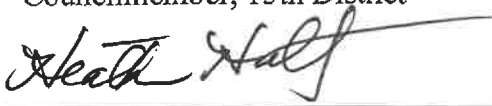

The Vincent Thomas Bridge Deck Replacement Project, set to begin in early 2026 with a full closure, is poised to cause significant disruption for residents, workers, businesses, and the international supply chain operating in the Harbor Area. Often referred to as “Harborgeddon,” this project will have far-reaching effects within the San Pedro Bay complex, as outlined in the California Department of Transportation’s (Caltrans) Final Environmental Impact Report (FEIR).

In response to the pending closure, the City Council has adopted Council File 23-0704, which requests a comprehensive report from Caltrans, City departments, in partnership with Los Angeles County and the Alameda Corridor Transportation Authority, on all proposed projects currently in design or construction during the Vincent Thomas Bridge Deck Replacement Project and asks for potential mitigation measures to address any impacts these projects might face. In light of Caltrans’ FEIR, revisiting Council File 23-0704’s report and ensuring much-needed environmental mitigations for the local community is necessary now more than ever.

A major concern that must be addressed before full closure is the current designation of detour routes. These local roads for these routes must be adequately repaired both before and after the Caltrans closure, as the increased truck and commuter traffic will add considerable strain on the local community, particularly in Wilmington. The potential impacts on local air quality, traffic flow, safety, environmental justice, and overall infrastructure in the Harbor Area cannot be overlooked. While this project is crucial for the Port of Los Angeles, it should not force the community to choose between necessary infrastructure and the protection of their health and environment.

I THEREFORE MOVE that the City Council instruct the California Department of Transportation (Caltrans), in partnership with the Los Angeles Department of Transportation (LADOT), the Board of Public Works, Los Angeles County, and the Alameda Corridor Transportation Authority, to report on an update to all proposed projects currently in design or under construction during the duration of the Vincent Thomas Bridge Deck Replacement Project. The report should include target dates for completion and identify additional mitigation measures to address any impacts on these projects caused by the bridge replacement.

I FURTHER MOVE that the City Council instruct the Bureau of Engineering (BOE), Bureau of Street Services (BSS), Department of Building and Safety (LADBS), LADOT, with assistance from the City Administrative Officer (CAO), and any other relevant departments, to commission a study exploring the viability of performing additional analysis on:

- The circulation impacts of the full closure on the existing local emergency evacuation routes and proposed detour routes;

- Environmental analysis and mitigations to the impacts on local communities where the detour routes are located;
- The detour routes' road conditions and the necessary repairs to bring them to a state of good repair; and
- The ability to repair the road conditions before and after the full closure.

I FURTHER MOVE that the City Council instruct the BOE, BSS, LADBS, LADOT, and any other relevant departments, to halt any pending approvals related to the Vincent Thomas Bridge Deck Replacement Project until this additional analysis has been completed.

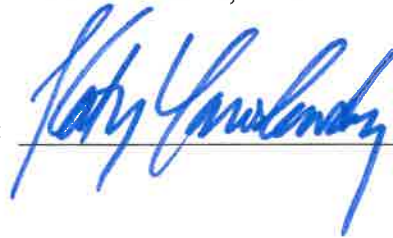

The National Weather Service (NWS) provides reliable forecasting for Red Flag (RF) conditions, indicating when extreme weather, such as high winds and dry conditions, creates a significant fire risk. These conditions increase the likelihood of dangerous wildfires, and proper staffing across all relevant departments is crucial for effective disaster management and response. Currently, the City's staffing deployment system provides managerial discretion on staffing decisions during RF conditions, but this should be reviewed across departments that are deployed in disaster management and response to ensure consistency and preparedness.

While Council File 25-0121 focuses on increasing staffing within the Los Angeles Fire Department (LAFD) for RF days, a more comprehensive approach is required to involve other city departments that play essential roles in managing these high-risk days.

I THEREFORE MOVE that the City Council instruct the City Administrative Officer (CAO) and Emergency Management Department (EMD) to consult with the Los Angeles Police Department (LAPD), Department of Transportation (LADOT), the Public Works bureaus, and any other relevant departments, to report on a plan for implementing additional mandatory staffing to enhance the City's response during Red Flag (RF) days. The report should include a standardized staffing protocol for the following departments to ensure full deployment of resources:

1. **Los Angeles Police Department (LAPD):** LAPD can play a critical role in evacuations, traffic control, and ensuring public safety during heightened fire risk. Report on the feasibility of including enhanced LAPD staffing and to pre-position officers in known high-risk areas, especially along fire corridors, should be considered.
2. **Los Angeles Department of Transportation (LADOT):** Pre-staging resources in coordination with LAPD and LAFD will ensure that transportation routes are clear and operational during emergencies. Report on the feasibility of including enhanced LADOT staffing and to specifically include LADOT personnel to assist in implementing evacuation routes and traffic management.
3. **Bureau of Street Services (BSS):** BSS can ensure that essential roads and infrastructure are cleared and maintained, especially in areas of known fire vulnerability. Report on the feasibility of including enhanced BSS staffing and to pre-position staff to support immediate response and accessibility needs.
4. **Bureau of Engineering (BOE):** BOE can assist with infrastructure assessments and mobilizing engineering resources for rapid deployment in high-risk zones. Report on the feasibility of including enhanced BOE staffing in the RF deployment to ensure the structural integrity of critical infrastructure such as water systems, roads, and bridges that could be impacted by fires.

5. **Additional Relevant Departments:** Other enhanced deployments by relevant departments that may be critical in responding to heightened fire conditions, including EMD, Public Works, and others, should be included in the coordinated staffing model.

I FURTHER MOVE that the City Council instruct the CAO and EMD, in coordination with LAPD, LADOT, BSS, BOE, and any other relevant departments, to report on options for strategic deployment of resources should focus on very high-hazard severity zones, fire corridors, and other high-risk areas identified through historical data and fire modeling. The report should look to include recommendations for LAPD and LADOT to be staged in the same locations as LAFD, so they can jointly review evacuation plans, monitor conditions, and collaborate on emergency procedures.

I FURTHER MOVE that the City Council instruct the CAO and EMD, in consultation with relevant city departments, to provide a cost estimate for the enhanced deployment model. This cost estimate should also include recommendations for identifying dedicated funding sources within each department's budget to cover staffing and resource deployment during anticipated RF days.

President Barack Obama Boulevard (commonly known as Obama Boulevard) spans 3.5 miles and connects South Los Angeles from Baldwin Hills to Leimert Park. This major thoroughfare is lined with residential dwellings, as well as numerous retail and commercial businesses.

During peak travel hours, Obama Boulevard experiences major traffic congestion that causes visibility issues for vehicles, thereby increasing the potential for collisions. Vehicles are often backed up for several blocks at streets that intersect with Obama Boulevard, creating public safety and quality of life concerns for the residents. To address this situation, immediate action is needed to install left turn restrictions.

I THEREFORE MOVE that the Council instruct the Department of Transportation to post the following traffic restriction signs to mitigate vehicle congestion and safety issues during peak driving hours:

- No Left Turn from 7:00 a.m. to 9:00 a.m. and 5:00 p.m. to 7:00 p.m. from South Sycamore Avenue going westbound onto Obama Boulevard; and
- No Left Turn from 7:00 a.m. to 9:00 a.m. and 5:00 p.m. to 7:00 p.m. from Obama Boulevard going southbound onto South Sycamore Avenue.

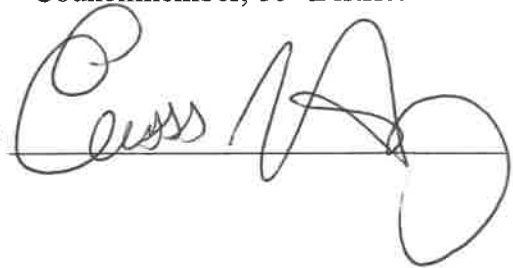
