GOVERNMENT OPERATIONS COMMITTEE REPORT relative to the transfer of Municipal Improvement Corporation of Los Angeles (MICLA) funds of \$1.6 million to the Department of General Services' (GSD) budgetary accounts and \$700,000 to a Bureau of Engineering (BOE) project account for the Lankershim Arts Center Project.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. APPROVE the overall project budget, scope, and schedule for the Lankershim Arts Center Rehabilitation as follows:
 - a. Phase I - Fire Life Safety, Lighting, HVAC Improvements: Completed in July 2023, for a cost of \$600,000.
 - b. Phase II – East Wall Structural Repair: Estimated completion in July 2025 for a cost of \$2.4 million.

- c. Phase III – Theatre Improvement and Decarbonization:
Estimated completion in January 2028 for a cost of \$5 million.
2. APPROVE the GSD Construction Forces Division Change Order of \$1,700,000 and additional project contingency of \$300,000, which increases the construction costs for Phase II of the Lankershim Arts Center Structural Repair project to \$2.4 million.
3. DIRECT the City Administrative Officer (CAO) to:
 - a. Coordinate with the BOE and Council District 2 (CD2) to effectuate the transfer of \$1,700,000 of approved Project specified MICLA funding to the GSD, as noted within the February 6, 2025 Municipal Facilities Committee (MFC) report, attached to the Council file.
 - b. Coordinate with the BOE and CD2 to transfer \$700,000 of Project specified MICLA fund to BOE accounts as noted in the February 6, 2025 MFC report, attached to the Council file, to fund the Phase III design consultant needed.
4. INSTRUCT the BOE to report to the MFC with a breakdown of costs for Phase III and potential funding sources.

Fiscal Impact Statement: The MFC reports that there is no immediate impact to the General Fund; however, due to unforeseen structural conditions, the project cost estimates have increased the projected shortfall to \$1.8 million which will be addressed through the 2025-26 and 2026-27 Capital Technology Improvement Expenditure Program requests.

This does not apply to Los Angeles County Metropolitan Transportation Authority (Metro) 28 by 28 transportation light rail projects, which will follow the established Master Cooperative Agreement (MCA) review process adopted by Metro and the City in 2023.

2. INSTRUCT the DCP to utilize the California Code of Regulations Title 14 Statutory Exemption Section 15272 - Olympic Games, as follows:

"California Environmental Quality Act does not apply to activities or approvals necessary to the bidding for, hosting or staging of, and funding or carrying out of, Olympic Games."

3. INSTRUCT the LADBS to establish a dedicated unit to manage and expedite all development services related to the 2028 Games Projects and projects related to other major events. This unit shall coordinate all development-related services for 2028 Games projects, ensuring priority handling of all 2028 Games-related applications and projects to minimize delays and streamline the approval and construction process, providing a single point of contact, collaborating with other City departments, agencies, and external stakeholders to ensure that Olympic projects meet all requirements, tracking progress on 2028 Games Projects, and reporting to the Council and Mayor's Office on an ongoing basis to ensure that timelines are being met.
4. APPROVE, with the concurrence of the Mayor, one exempt Resolution Authority enterprise-funded position of Deputy Superintendent of Building I at the LADBS to be used for the dedicated unit.

5. INSTRUCT the DCP, and the other departments mentioned in Recommendation No. 1 above, to provide the following:
 - a. A definition of temporary and permanent infrastructure.
 - b. Qualifying criteria for each for fast tracking; and how to be informed of the fast tracking process; and notification to the impacted Council office(s).
 - c. The creation of a process for fast tracking.
6. INSTRUCT the DCP, and the other departments mentioned in Recommendation No. 1 above, to approve a permitting process for fast tracking; and describe the process.
7. INSTRUCT the DCP, and the departments mentioned in Recommendation No. 1 above, to prepare the report with recommendations before the draft ordinance is prepared.



AUTHORIZE and DIRECT the Department of City Planning (DCP), in coordination with the City Attorney, Los Angeles Department of Building and Safety (LADBS), Department of Recreation and Parks, City Administrative Officer (CAO), Chief Legislative Analyst (CLA), Office of Major Events, and other relevant departments, to prepare a report with recommendations, including budgetary/fiscal impacts, and an accompanying draft ordinance to exempt Olympic and Paralympic temporary and permanent venues, training facilities, security perimeters, broadcast and media centers, transit infrastructure, live sites and fan zones, and associated structures (2028 Games Projects) from the requirements of City Planning approvals, zoning regulations, and conditions, if applicable, including but not limited to Conditional Use Permits (CUPs) and conditions tied to such permits, Site Plan Review requirements, height restrictions, setback requirements, limitations imposed by Specific Plans, and any other planning or zoning regulations; but not to exempt 2028 Games Projects from mobility improvements required under Measure HLA (Section 85.11 of Division Q of Chapter VIII of the Los Angeles Municipal Code) that could delay or impede the rapid deployment and or use of essential facilities, with an option for the Council to exclude specifically identified 2028 Games Projects from the ordinance. This does not apply to Los Angeles County Metropolitan Transportation Authority (Metro) 28 by 28 transportation light rail projects, which will follow the established Master Cooperative Agreement (MCA) review process adopted by Metro and the City in 2023, **nor to any cable-guided transportation projects and associated infrastructure.**

The 2023-24 Adopted Budget included \$250,000 within the Council Community Projects line item of the General City Purposes Fund for beautification work at the Bundy Triangle. On May 21, 2024, the Council authorized the transfer of this funding to the Bureau of Street Services (C.F. 24-0560). However, the Bureau of Street Services did not commence work prior to the end of the fiscal year, and this funding reverted to the Reserve Fund at year-end.

I THEREFORE MOVE that \$250,000 be transferred from the Reserve Fund to the Unappropriated Balance Fund No. 100-58 and transferred / appropriated therefrom to General City Purposes Fund No. 100-56, Account No. 000903 (Bundy Triangle Beautification), as the funds previously approved by the Council (C.F. 24-0560) were not encumbered or expended by the Bureau of Street Services before the end of Fiscal Year 2023-24 and inadvertently reverted to the Reserve Fund.

The City of Los Angeles' Bureau of Street Lighting (BSL) has made significant strides in deploying fiber optic technology to improve the city's infrastructure, supporting initiatives that enhance public safety and modernize communications systems. Their efforts have focused on integrating connections in key locations, creating a foundation that supports both current and future needs in urban development. Through BSL's Street Lighting Directive 423, which focused on expanding and improving the city's fiber optic conduit infrastructure, the Bureau has focused on increasing efficiency and providing equitable access to high-speed connections for public services and businesses.

As the City continues to expand its commitment to innovation, it is essential to consider how fiber optic expansion can be leveraged in critical areas such as through the Economic Workforce Development Department's (EWDD) Jobs and Economic Development Incentive (JEDI) Zones program. These zones provide economic development incentives within specific city geographies that aim to promote and expand business in Los Angeles. Businesses located in these zones can obtain various incentives including case management of the City development permit process, permit fee reductions, business consulting, and facade improvements. These zones represent a focus on communities that are historically underserved, and co-locating fiber-optic infrastructure in these zones will enable stronger public safety systems, more reliable communications, and increased opportunities for local businesses and residents to thrive in a digital-first environment.

By working together, EWDD and BSL can identify and prioritize areas within JEDI zones that could benefit from fiber optic conduit infrastructure.



The fabric of Los Angeles is made up of long-time restaurants from Jitlada in Hollywood to Canter's on Fairfax, from the Apple Pan on the Westside to the Pantry in Downtown LA. These establishments are more than just places to eat – they are cultural landmarks, community gathering spaces, and symbols of the city's rich history. Their success is built not only on their food, but also on the dedication of workers who have spent years, sometimes decades, contributing to their operations.

As Los Angeles continues to evolve, it is critical that the city recognizes and supports businesses that have demonstrated a long-term commitment to both their communities and their workers. Restaurants that provide stable, dignified jobs and fair wages contribute to the economic and social fabric of our neighborhoods. While some long-standing businesses have upheld these values, others have not always met this standard. The city should uplift businesses that foster longevity not just in name, but in the way they treat their workers.

A Legacy Restaurant Business support program could help sustain these institutions by providing resources and incentives, such as expedited permits and reduced parking requirements, that could promote worker retention, fair labor practices, and long-term stability.

I THEREFORE MOVE to direct the Chief Legislative Analyst in coordination with the Economic and Workforce Development Department, the City Attorney and the Bureau of Contract Administration to report on the feasibility of creating a program to support Legacy Restaurant Businesses that retain long-time workers;

On December 19, 2024, Los Angeles became a Sanctuary City. This important policy was put in place for the purpose of significantly limiting City resources used to aid federal immigration enforcement, including in support of Immigration and Customs Enforcement (ICE) and Customs and Border Patrol (CBP).

On February 28, 2025 reports via media and community members showed the Los Angeles Police Department present at multiple Federal enforcement operations throughout Los Angeles, including in Districts 1 and 9. These reports include photos of Federal enforcement agencies present, including Homeland Security Investigations, Immigration and Customs Enforcement, and US Customs and Border Patrol.


As federal immigration enforcement ramps up in Los Angeles, it is imperative that City staff have clear guidance and understanding about their responsibilities under the City's Sanctuary City Ordinance. Further, it is the responsibility of the City Council and other City leaders to reduce confusion and panic within our communities when these federal agencies are present, and be able to provide clarity on the rights of constituents, as well as what resources are available to them.

WE THEREFORE MOVE the City Council DIRECT the Los Angeles Police Department to report back on protocol and process used for all incidents that occurred on February 28, 2025.

WE FURTHER MOVE that the City Council REQUEST the City Attorney to report back in 15 days to the City Council with detailed protocol under the Sanctuary City Ordinance outlining allowed and disallowed interactions with the different federal agencies that participate in any immigration enforcement activities. The report should include definitions and jurisdictions of each federal agency, how they operate in practice in the City of Los Angeles historically, and how any law enforcement in the City of LA can and cannot interact with each of these agencies, especially when multiple agencies are present for an operation.
