Recommendations for Council action:

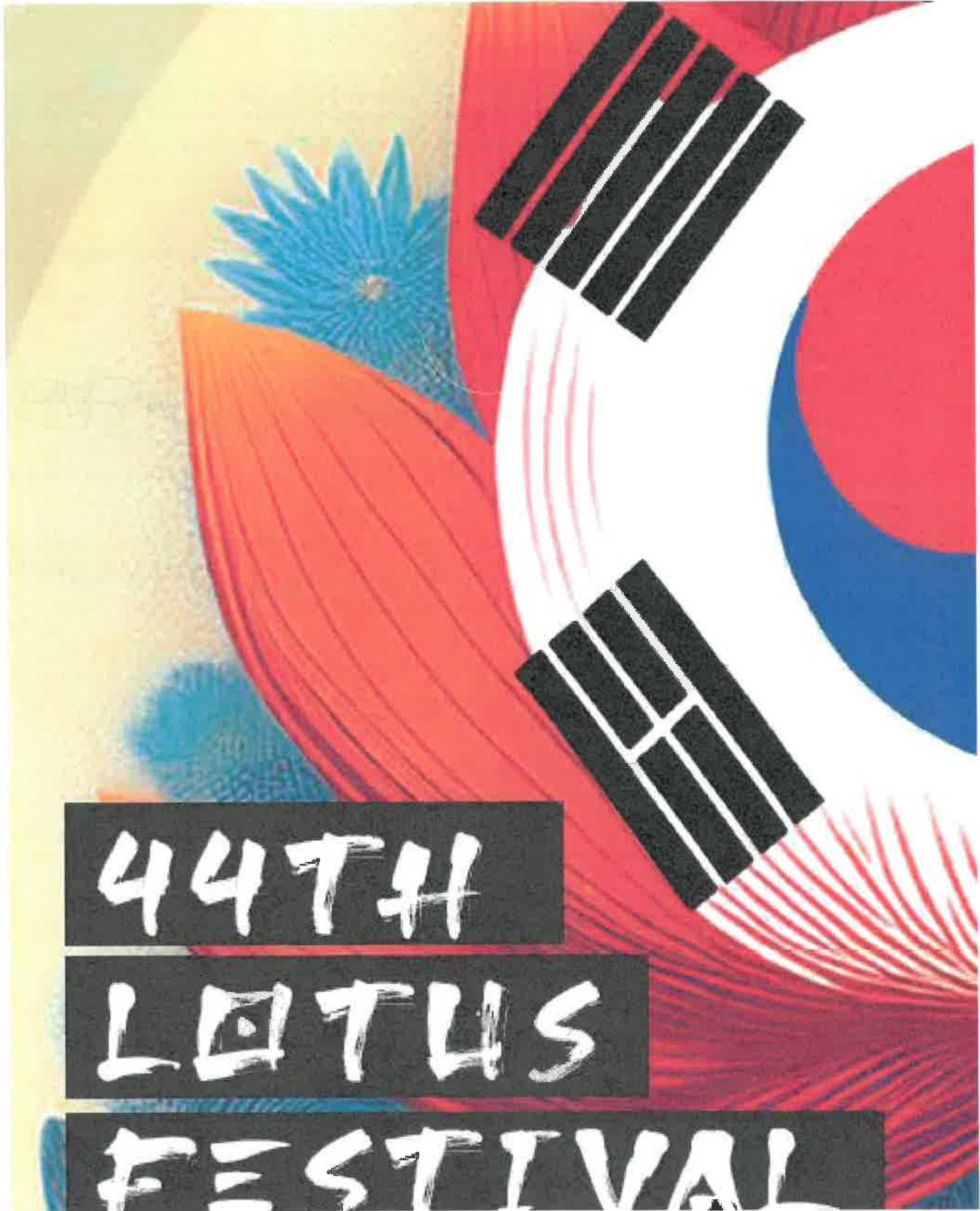

On June 21, 2017, the City Council approved the transfer of \$1,229,031 in CRA/LA Non-Housing Excess Bond Proceeds (EBP) available to Council District 7 from the Pacoima/Panorama City Redevelopment Project Area to the Department of Public Works, Bureau of Sanitation, for the Bradley Green Alley Project (C.F. 14-1174-S12). 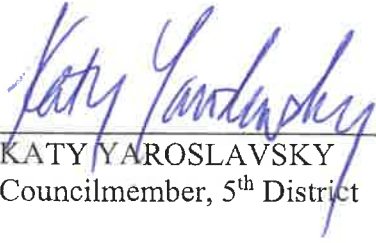

The Slauson Connect Project is a Proposition K “Kids for LA” project, which was formalized on October 1, 2020, upon City Council authorization to locate the Southern Pacific Trails project to be at the railroad right-of-way along the Slauson Avenue corridor.

The Project is sited as a node along Metro’s “Rail to River” project. The completion of the project will remediate blight, add much-needed open space, increase the availability of recreational opportunities, and enhance livability in an underserved neighborhood in South Los Angeles. The Southern Pacific Trail portion of the project is integrated into the park with decomposed granite and textured and graphically adorned concrete pathways, that will include historical and botanical educational opportunities along the path. It will facilitate pedestrian usage along the North edge of the site, and will guide patrons from the plaza area to the inspirational garden area. The Slauson Connect Project also entails a 12,000-square-foot multifaceted facility that will house flexible multipurpose classrooms rooms to accommodate a variety of recreation and community related programs, a childcare center, and after school classrooms, with a primary focus on youth recreational programming. The consolidation of both scopes noted above represent the Slauson Connect Project (Project).

The Project site, located at 5820 Normandie Boulevard, begins at the Northeast corner of Slauson Avenue and Normandie Boulevard, and stretches east to Budlong Avenue. The overall project site is approximately 81-foot-wide by 1,250-foot-long (or approximately 0.24 mile), totaling approximately 101,250 square feet or 2.32 acres.

The Bureau of Engineering (BOE) has solicited a design build RFP for the project, and received sealed bids on December 4, 2025, as approved by Ordinance 187616. The BOE Architectural Division has negotiated the bids and scope and are preparing to award the Project.

CD 9 has a vested interest in the Project's success and has committed \$1,451,157.64 to the Project. An appropriation and transfer of approximately \$1.45 million to the Engineering Special Services Fund is recommended for the construction of the project.

The Department of Public Health recently found that 51.4 percent of households in the city of Los Angeles are living with “housing burden,” spending 30 percent or more of their incomes on housing costs. In addition, 27.5 percent of those households are dealing with a “severe housing burden,” spending 50 percent or more of their incomes on housing. For those tenants, any small setback can lead to an accumulation of rental debt. This crisis disproportionately affects Black and brown Angelenos at the lowest income levels. Unpaid rent debt has and will continue to lead to evictions, and often small amounts of rental assistance are enough to stop this eviction pipeline.


In 2025, Council District 1 is averaging 99 eviction notices filed each and every week, with an average of \$3,656. While not all notices lead directly to eviction, a Public Counsel and UCLA School of Law study estimates that the real number of evictions could be triple that, as many tenants seemingly vacated their units simply by the threat of eviction by their landlords. Anything we can do to stabilize these tenants is paramount.

The FamilySource System (FSS) centers provide vital emergency assistance and supportive services, case management, and housing stabilization services. Council District 1 has the ability to respond to the increased need for emergency assistance services in Council District 1 through a unique partnership with the FamilySource Center based at Central City Neighborhood Partners - Westlake.

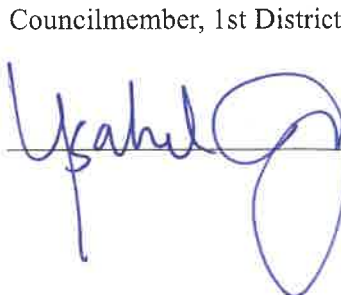
I THEREFORE MOVE that the Council:

1. **AUTHORIZE** the General Manager, or designee, of the Community Investment for Families Department to amend and restate City Contract No. C-145927 with Central City Neighborhood Partners - Westlake to increase the contract by \$100,000 for the provision of emergency assistance to residents in Council District 1 through June 30, 2025.
2. **AUTHORIZE** the City Controller to transfer \$100,000 from the Transfer of Floor Area Ratio Public Benefits Trust Fund No. 552, Dept. 14, Account No. 14001A to the Community Investment for Families Fund No. 100, Department 21, Account No. 003040 Contractual Services Account.
3. **AUTHORIZE** the Chief Legislative Analyst to make any technical corrections, clarifications, or revisions, as necessary, to implement the motion’s intent.

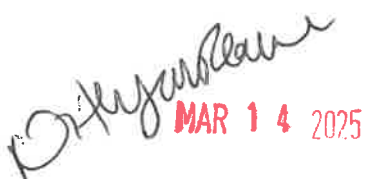

RESOLUTION

TRANSPORTATION

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, the Los Angeles Municipal Code Section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between 2:00 a.m. and 6:00 a.m.; and

WHEREAS, there is an increased problem with oversized salvage trucks that park overnight on a segment of Guthrie Avenue immediately adjacent to residential buildings, which constricts travel lanes and creates dangerous situations, as well as potential health and safety issues associated with materials stored in the vehicles;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to the Los Angeles Municipal Code Section 80.69.4, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 7 feet in height, during the hours of 2:00 a.m. and 6:00 a.m. along both sides of Guthrie Avenue between Venice Boulevard and La Cienega Boulevard.

BE IT FURTHER RESOLVED that upon the adoption of this Resolution, the Department of Transportation be directed to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed, at the above locations; and

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, the January 2025 wildfires were an unprecedented disaster in the City's history with costs of the disaster estimated between \$250 billion and \$275 billion; and

WHEREAS, the City, County, State, and other impacted cities have had to front-fund significant emergency response and recovery work to keep residents safe and expedite the region's rebuilding; and

WHEREAS, the Governor has submitted a letter to leadership within the House of Representatives requesting approximately \$39.7 billion in funding for a Supplemental Appropriation to support recovery efforts; and

WHEREAS, the proposed funding would support business loans and grants, tax credits and incentives for development of low-income housing, tax relief for residents impacted by the fires, public assistance to directly fund City, State, and County work to clear debris and repair critical infrastructure, aid for displaced workers and health and childcare services, and programs to prevent future wildfire disasters; and

WHEREAS, the City has already shown its commitment to taking swift and decisive action to lead recovery work and support the Palisades community in its rebuilding, despite the City facing significant financial constraints; and

WHEREAS, the continued successful recovery from the January 2025 wildfires is dependent upon the coordination of all levels of government, including financial support from the federal legislative branch;

NOW, THEREFORE, BE IT RESOLVED that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2025-2026 Federal Legislative Program SUPPORT for a Supplemental Appropriation for disaster funding to support recovery from the January 2025 wildfires as outlined in the Governor's letter to Congressional leadership seeking \$39.7 billion in funding.

MOTION

The City of Los Angeles continually progresses toward its overarching goals of preventing and ending homelessness, as reflected in the most recent data from the 2024 Greater Los Angeles Homeless Count, which is administered by the Los Angeles Homeless Services Authority (LAHSA). Compared to the prior year, the City saw a decrease of more than 10% in its population of people living unsheltered and an increase of over 17% in its population of people living in shelters, thanks to a variety of interventions on the part of City departments, Council District offices, the Mayor's Office, and LAHSA. These results are the result of historic investment in programs specifically designed to address street homelessness. In Fiscal Year 2023-2024, for example, the City allocated a combined total of \$1.28 billion to address the homelessness crisis in Los Angeles.

There are many regular reports regarding homelessness spending including, but not limited to: reports regarding the City's progress toward meeting its goals pursuant to the Roadmap agreement and the Alliance settlement, reports regarding the Homelessness Emergency Account and the Inside Safe initiative led by the Mayor's Office, and countless ad hoc reports and recommendations stemming from individual Council motions.

Currently, there are multiple Council committees through which reports about spending on homelessness programs are reviewed and analyzed, but the Council lacks a comprehensive resource to guide and inform budgeting and spending throughout the fiscal year. The need for centralized financial oversight and real-time monitoring was detailed in the recent audit by Alvarez & Marsal, upon their analysis of the City's financial and contracting data for Homelessness Services from June 1, 2020- June 30, 2024,

"Funding and the City's budget allocations for homelessness assistance services were not routinely reconciled with actual spending or contractual obligations. This lack of reconciliation led to confusion about the total amount expended on homelessness assistance services, which made it challenging to ascertain how budgets for multiple endeavors and funding sources were utilized or whether they achieved the intended outcomes."¹

By providing a holistic funding and expenditure document, the City will foster a more accountable and transparent budgeting process. This document will also support Councilmembers and City departments in holding contracted homeless service providers accountable for outcomes. Policymakers will also be able to consider these expenditures against outcomes data that LAHSA is working with the City to develop and provide regularly, and to make responsible, informed policy decisions.

I THEREFORE MOVE that the Council instruct the City Administrative Officer (CAO), the Chief Legislative Analyst (CLA) and the Housing Department (LAHD), in coordination with LAHSA to report back within 60 days and quarterly thereafter to Council with a single comprehensive breakdown of the City's homelessness budget, including all funding sources (including whether costs are reimbursable by the County or Federal government, etc.), committed funds, expenditures, and underspends for each program and contract the City holds related to homelessness, including, but not limited to:

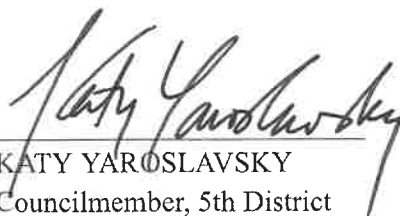

MOTION

The Sepulveda Basin is a critical asset for the City of Los Angeles , serving as a hub for recreation, environmental conservation, and flood management. The Sepulveda Basin Vision Plan is a comprehensive initiative that prioritizes flood capacity, ecological restoration, habitat preservation, climate resilience, and equitable community benefits. The Vision Plan emphasizes collaboration between local and federal agencies to address systemic inequities and environmental challenges in historically disadvantaged communities surrounding the Basin.

The Bureau of Engineering (BOE) serves as the lead agency in advancing the Vision Plan's implementation. To support this effort and reduce the City project costs, BOE seeks technical assistance through the Planning Assistance to States (PAS) program, authorized under Section 22 of the Water Resources Development Act (WRDA) of 1974. This program provides essential planning resources and expertise to enhance coordination with the U.S. Army Corps of Engineers, the City's Federal partner and landlord for this critical site.

The Sepulveda Basin and its adjacent areas include census tracts identified as historically disadvantaged under the Council on Environmental Quality's Climate and Economic Justice Screening Tool. This designation qualifies the City to request a fee waiver under Section 8119 of WRDA 2022, reducing financial burdens while advancing equitable infrastructure, climate resilience, and greenspace improvements for vulnerable communities in Council District 6 and across the San Fernando Valley.

I THEREFORE MOVE that the City Council authorize the Board of Public Works to apply for and accept technical assistance through the Federal PAS program by the deadline of 05/19/2025 to support the development and implementation of the Sepulveda Basin Vision Plan.

I FURTHER MOVE, that the Board of Public Works report back on details and feasibility of an implementation and cost-sharing document related to participation in the PAS, to negotiate and execute all necessary agreements or documents for participate in the PAS program, including a cost-sharing agreement, as appropriate within 30 days.

MOTION

In December 2024, as directed by the Mayor and City Council, the Community Investment for Families Department (CIFD), as the administrator of the Housing and Community Development Consolidated Plan, in collaboration with the City Administrative Officer (CAO), requested technical assistance (TA) from the U.S. Department of Housing and Urban Development (HUD) to maximize the use of Community Development Block Grant (CDBG) program delivery funds and implement best practices on the use of CDBG administrative funds for the Department of Aging (Aging), CIFD, Economic and Workforce Development Department (EWDD), and the Los Angeles Housing Department (LAHD). In January 2025, HUD assigned the Cloudburst Group (Cloudburst) to provide TA to the City. After the February 12, 2025 initial TA meeting, Cloudburst notified the City that they are unable to continue the TA because HUD has terminated all cooperative agreement/TA work as of February 25, 2025.

There is a critical need to continue the TA with Cloudburst to ensure CDBG program delivery and administrative funds are maximized and the City implements best practices. The City needs Cloudburst to (1) provide training and technical assistance to key City staff implementing CDBG funds (CIFD, LAHD, EWDD, Aging) on opportunities to increase program delivery charges to offset staff costs, including position review and recommendations for optimizing program design and deployment, and (2) to provide other administrative services to properly administer the City's HUD entitlement programs.

Cloudburst currently provides similar services to the City of Anaheim through Contract No. 14681 procured through a competitive Request for Proposal process. Due to the critical need and urgency, it is in the City's best interest to obtain the above-mentioned services from Cloudburst.

I THEREFORE MOVE that the City Council, subject to the approval of the Mayor, authorize the City Administrative Officer to enter into an agreement with Cloudburst Group by utilizing Contract No. 14627 between the City of Anaheim and The Cloudburst Group, as it relates to technical assistance and support on HUD entitlement programs, in accordance with Charter Section 371(e)(8).

I FURTHER MOVE that City Administrative Officer enter into a technical assistance contract with The Cloudburst Group for a one-year term, with the option to extend for an additional 12 months, in an amount not to exceed \$75,000 to be funded by CAO Fund 100/10, Account No. 003040, Contractual Services, subject to the review and approval by the City Attorney as to form and compliance with the City's contracting requirements.

I FURTHER MOVE that the CAO be authorized to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this motion.

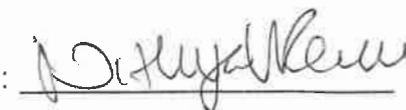
