AD HOC COMMITTEE ON THE 2028 OLYMPIC AND PARAOLYMPIC GAMES

MOTION

As the Host City for the 2028 Olympic and Paralympic Games (LA28), the City of Los Angeles has entered into significant contractual commitments, including the Host City Contract with the International Olympic Committee (IOC) and agreements with the LA28 Organizing Committee. These agreements outline responsibilities related to planning, funding, and delivering a successful Games experience—centered around an evolving Venue Plan that includes a mix of City-owned and non-City venues across the region.

While City-owned venues fall under the jurisdiction and budget oversight of the City, many LA28 venues are owned or operated by outside entities, including universities, sports franchises, and other local governments. These non-City venues may still require financial contributions or infrastructure support from the City of Los Angeles, directly or indirectly, to ensure their readiness for the Games.

It is essential that any funding agreements or public resource commitments related to these non-City venues are clearly defined, equitably negotiated, and transparent to both the Council and the public. The City must ensure it is not assuming financial risks, operational burdens, or liabilities for venues over which it has limited control—especially when public dollars are involved.

I THEREFORE MOVE that the City Council instruct the Chief Legislative Analyst (CLA), with the assistance of the City Administrative Officer (CAO), Office of the City Attorney, and in coordination with the LA28 Organizing Committee as needed, to report back in 7 days on:

- A full list of current and proposed non-City venues included in the LA28 Venue Plan;
- Any funding agreements, infrastructure support, or resource commitments currently in place or under consideration between the City and any non-City venue owners/operators;
- What contractual provisions have been or should be included in such agreements to clearly define:
 - Scope of City financial obligations (if any);
 - Responsibility for cost overruns, capital improvements, or operational disruptions;
 - Insurance, indemnification, and risk mitigation provisions; and
 - Transparency and audit requirements.
- The City's authority and options for negotiating terms to protect public funds and limit liability for venues outside of its ownership or control; and
- Recommendations to ensure consistency across all venue-related funding agreements and alignment with the City's broader goals for equity, sustainability, and fiscal responsibility.

MOTION

On February 6, 2025 Southern California Edison (SCE) submitted a supplemental notice to the California Public Utilities Commission regarding the Hurst Fire that ignited on January 7, 2025 near Saddle Ridge Road in Sylmar, California.

As stated, on Tuesday, January 7, 2025 at 10:10 p.m., under conditions of an extreme Santa Ana windstorm, a wildland fire named the Hurst Fire was reported in the Sylmar area. The Los Angeles Fire Department (LAFD) is investigating the fire and has suggested SCE's equipment caused the Hurst Fire. The Hurst Fire burned approximately 799 acres and was fully contained on January 16, 2025 requiring multiple first responders and significant public resources while deeply impacting the Council District 7 community with dangerous conditions including poor air quality and widespread power outages.

LAFD reported that the fire appeared to have originated in an area north of Saddle Ridge Road. SCE has a transmission tower in that area (Tower 6). Tower 6 supports the Gould-Sylmar 220kV and Eagle Rock-Sylmar 220kV circuits. At Tower 6 on the Eagle Rock-Sylmar 220kV circuit, hardware supporting the insulator string for the top phase bundles conductors separated and caused the top phase to fall on the middle phase resulting in both failing to the ground at the base of Tower 6. This resulted in a relay operation and a lock-out on the Eagle Rock-Sylmar 220kV circuit at 10:11 p.m. on January 7, 2025.

The repairs consisted of replacing all three insulator strings and hardware, including the damaged one, on the Eagle Rock-Sylmar 220kV circuit at Tower 6, replacing all three insulator strings and hardware on the adjacent Tower 1, three bundled conductor phases from dead end Tower 5 to dead end Tower 2, approximately 18,000 feet of 1590 MCM ACSR, telecom facilities and a section of skyline attached on the tower line. SCE is retaining this material as incident-related evidence. The cause of the Hurst Fire remains under investigation and SCE has stated it will continue to cooperate with fire investigators.

I THEREFORE MOVE that the City Council REQUEST the Office of the City Attorney, with support from the Chief Legislative Analyst, to report on potential legal action(s) that the City of Los Angeles may pursue against Southern California Edison related to the cause of the Hurst Fire.

Los Angeles continues to face an escalating threat of extreme weather events and natural disasters. In recent years, the City has experienced wildfires, atmospheric rivers, mudslides, and severe flooding, and in 2023, was even impacted by its first tropical storm in decades. Most recently, the region was struck by an unprecedented wildfire that saw hurricane-force winds drive multiple fires across the Los Angeles region, leading to widespread power outages, hazardous air quality conditions, emergency evacuations, and significant loss of life and structures. The increasing frequency and intensity of these disasters highlight the urgent need for the City to proactively strengthen its emergency preparedness and response capabilities.

Prior to the COVID-19 pandemic, the City of Los Angeles maintained an Emergency Standby Services contract that allowed for the rapid mobilization of critical resources, personnel, and infrastructure in the event of a disaster. These pre-event contracts encompass a broad range of emergency support services, including shelter operations, humanitarian aid, power and fuel support systems, debris removal, and emergency logistics. Such contracts serve as a critical tool for City leadership to effectively respond to emergencies and protect residents when disaster strikes.

Pre-event Emergency Standby Services contracts are a well-established best practice in the field of emergency management. The Federal Emergency Management Agency (FEMA) strongly advocates for these contracts due to their numerous benefits, including:

- **Speed & Readiness** Ensures immediate access to emergency services without delays caused by post-disaster procurement processes.
- **Cost Control & Efficiency** Establishes pre-negotiated rates, reduces financial uncertainty and excessive emergency spending.
- **Improved Logistics & Coordination** Streamlines disaster response efforts by integrating services under a single contract.
- Legal & Compliance Benefits Ensures procurement aligns with federal funding guidelines, minimizing the risk of reimbursement denials.
- Enhanced Resilience & Preparedness Strengthens the City's ability to mitigate, respond to, and recover from disasters in a timely manner.

By implementing a pre-event Emergency Standby Services contract, the City will not only improve its operational capacity to manage disasters but also expedite access to federal reimbursement for recovery efforts. These contracts do not incur costs unless activated, making them a fiscally responsible and proactive measure to ensure Los Angeles remains prepared for all future emergencies.

I THEREFORE MOVE that the City Council direct the Emergency Management Department, in coordination with the Chief Administrative Officer, General Services and the Bureau of Contract Administration, to develop and implement, within the next 6 months, a comprehensive pre-event Emergency Standby Services contract to enhance the City's disaster response capabilities.

RESOLUTION RULES. ELECTIONS. INTERGOVERNMENTAL RELATIONS

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council; and

WHEREAS, according to the California Child Welfare Council, human trafficking is a \$32 billion global industry, involving over 100,000 children in the United States; and

WHEREAS, within the United States, California consistently ranks number one in the number of human trafficking cases reported to the National Human Trafficking Hotline; and

WHEREAS, the Federal Bureau of Investigation has identified Los Angeles as one of the nation's high intensity child prostitution areas; and

WHEREAS, California law requires sex offender registration for those convicted of a wide variety of sexual offenses against minors; and

WHEREAS, California law requires sex offender registration for those engaged in specific "consensual" sex acts with a minor, including oral copulation, sodomy, and sexual penetration with a foreign object, if the offender is more than 10 years older than the minor; and

WHEREAS, Senate Bill (SB) 680 (Rubio), introduced on February 21, 2025, would require those convicted of engaging in unlawful sexual intercourse with a minor who is more than three (3) years younger than the offender, or if the offender is over 21 years of age and the minor is under 16 years of age, be required to register as a sex offender for ten (10) years; and

WHEREAS, SB 680 would require lifetime registration as a sex offender for those convicted of engaging in unlawful sexual intercourse with a minor who is more than three (3) years younger than the offender, or if the offender is over 21 years of age and the minor is under 16 years of age, if the offender received a prior conviction for the same offense;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2024-2025 State Legislative Program SUPPORT for SB 680 (Rubio) which would deter the sexual exploitation of children and create more consistent consequences for those who engage in unlawful sexual acts with a minor.

RESOLUTION

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, two residential segments in Council District Eight are experiencing an increased problem with oversized vehicles parking during all hours of the day, blocking visibility, constricting travel lanes, and blocking the safe exit and entrance to driveways. thereby creating a dangerous situation; and

WHEREAS, California Vehicle Code Section 22507 requires that with the exception of parking restrictions in alleys, a resolution that restricts the parking of vehicles. including but not limited to six feet or more in height, during all or certain hours of the day, will only apply in areas in which signs are posted giving notice of restrictions:

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to California Vehicle Code Section 22507, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height, from 6:00 p.m. to 6:00 a.m., along both sides of the following street segments:

- West 41st Place between South Western Avenue and Normandie Avenue.
- South Hobart Boulevard between West Martin Luther King Jr. Boulevard and West 42nd Place.

BE IT FURTHER RESOLVED that upon the adoption of this Resolution, the Department of Transportation be directed to post signs giving notice of the above restrictions for oversized vehicles, with those specific hours detailed; and

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.
