On June 20, 2023, the Bureau of Street Services (StreetsLA) and the California Department of Transportation (CalTrans) entered into a Cooperative Implementation Agreement (CIA No. D43CIAULA0001) where Caltrans agreed to contribute up to \$11,886,981 over two fiscal years (\$7,191,135 in FY 24/25 & \$4,695,846 in FY 25/26) for the Broadway-Manchester Multi Modal Green Street Project (Broadway-Manchester Project) (CD 8) in exchange for Caltrans Stormwater Permit compliance credit. In exchange for the Caltrans funding, it will receive Waste Load Allocation reduction credits commensurate with the amount of funding contributed to this regional project to support its waste discharge requirements.

The Broadway-Manchester Project is part of a strategic plan to bring active transportation, urban greening, and stormwater quality improvement to South Los Angeles. The plan is supported in partnership from a variety of resources such as the Safe, Clean Water Program, the Active Transportation Program, Infrastructure for Rebuilding America, and other grant funds. However, due to unforeseen circumstances with project administration the StreetsLA staff are unable to submit the required documentation to collect the \$7.2M toward this particular project for work to be completed in Fiscal Year 2024-25. Both the City of Los Angeles and it's project partner, Caltrans are at risk of losing the funding, which will lapse if the full amount of expenditures are submitted per the original agreement by the early May 2025 deadline required by the State of California.

The Bureau of Sanitation (LASAN), as the City's administrator on the Safe, Clean Water Program, has other projects in construction that meets Caltrans' and the City's stormwater discharge mitigation goals which could receive the funds in jeopardy on the Broadway-Manchester project. To ensure that the City does not lose the appropriated FY 24/25 funds of \$7,191,135, the City and Caltrans propose to amend the executed contract and include the MacArthur Lake Stormwater Capture Project (CD 1) and the Wilmington Neighborhood Greening Project (CD 15) in order to have enough combined expenditures this fiscal year to meet the terms of the agreement. StreetsLA will invoice Caltrans \$1,572,788.78 which will be reimbursed directly to the Broadway-Manchester Multi Modal Green Street Project as directed in original agreement (CF 23-0494). LASAN will invoice Caltrans for a total of \$5,618,346.22 between the MacArthur Lake Stormwater Capture Project and Wilmington Neighborhood Greening Project. The matter before Council is urgent due to the pressing deadline at Caltrans to secure the funds in this fiscal year, and thus the need for an expedited solution and approval by the City of Los Angeles to maintain the progress on this needed infrastructure project.

I THEREFORE MOVE to authorize the Bureau of Sanitation, Bureau of Street Services, and Board of Public Works, with assistance of the City Administrative Office, to proceed to execute amending the CIA between LASAN, StreetsLA and Caltrans to secure up to the remaining \$7,191,135 for the MacArthur Lake Stormwater Capture Project and the Wilmington Neighborhood Greening Project.

MOTION

The Civil, Human Rights & Equity Department initiated an investigation into allegations, made by an African American shopper, of discrimination at a CVS retail location. The investigation regarding allegations of discrimination revealed a discriminatory act which violated the Civil and Human Rights Law.

The incident in question occurred on November 19, 2023, when Mr. Justin Wills, an African-American male, entered the CVS store at 8490 W. Beverly Blvd., Los Angeles, CA 90048. While in the store, Mr. Wills had a verbal altercation with CVS staff. During the verbal altercation, the CVS staff person called Mr. Wills the N-word. This racial slur directed at Mr. Wills on account of his race prompted Mr. Wills to file a complaint with the LA Civil Rights Department.

Prior to the filing of a Notice of Violation, CVS indicated a desire to resolve the matter quickly and amicably. After engaging in settlement discussions, CVS Health Corporation agreed to a \$55,000 penalty.

The Civil and Human Rights Ordinance (Ordinance No. 186084) mandates that a portion of the penalties collected as compensatory penalties be paid directly to the complainant who filed the initial complaint with the department. These payments serve as a form of compensation to an individual for harm caused by the offending third party.

I THEREFORE MOVE that the Civil, Human Rights and Equity Department be authorized to accept \$55,000.00 from CVS Health Corporation;

I FURTHER MOVE the Civil, Human Rights and Equity Department to be authorized to deposit said funds into the Commission on Civil Rights Fund No. 64H Appropriation Unit 150000.

I FURTHER MOVE that \$27,500 be paid to Mr. Justin Wills from the Commission on Civil Rights Fund No. 64H Appropriation Unit 150000.

RULES. ELECTIONS, AND INTERGOVERNMENTAL RELATIONS

RESOLUTION

WHEREAS, the Los Angeles County Metropolitan Transportation Authority (Metro) governs a transit system that is foundational to the daily lives of millions of Angelenos; and

WHEREAS, Metro was created by the Los Angeles County Metropolitan Transportation Authority Reform Act of 1992 (AB 152), which unified the Southern California Rapid Transit District and the Los Angeles County Transportation Commission into a single authority, and established a carefully balanced 14-member board under California Public Utilities Code § 130051 to ensure balanced regional representation and strong local accountability; and

WHEREAS, the City of Los Angeles is home to nearly 40% of Los Angeles County's population, and the majority of Metro's largest and most consequential projects—such as the B Line, D Line (existing and Westside Extension), E Line, G Line, J Line, K Line (existing and Northern Extension), Regional Connector, LAX Airport Metro Connector, East San Fernando Valley Light Rail, Link Union Station, Sepulveda Transit Corridor, Vermont Transit Corridor, NoHo—Pasadena BRT, Rail to Rail Active Transportation Corridor—are either fully or substantially located within City boundaries; and

WHEREAS, in 2024, voters approved Measure G to expand the Los Angeles County Board of Supervisors and create a County Executive position, a major restructuring of County governance aimed at improving accountability and public input; and

WHEREAS, Senate Bill 220 (SB 220), introduced by State Senator Ben Allen, would bypass the existing legal process set by California Public Utilities Code § 130051(a) by unilaterally expanding Metro's Board to 18 members in 2029 and ultimately 22 members, before the Measure G reforms have a true implementation plan; and

WHEREAS, the existing 1992 AB 152 legislation explicitly includes a statutory provision which already provides for a structured, local process that directs Metro to submit a revised governance plan to the Legislature should the Board of Supervisors change—ensuring that public agencies and public stakeholders are part of an orderly and deliberative process; and

WHEREAS, the proposed changes in SB 220 would diminish the proportional role of the City of Los Angeles and other local municipalities in favor of centralization under County authority, despite City of Los Angeles residents bearing a large portion of the ridership, sales tax contributions, and infrastructure impact of Metro's operations; and

WHEREAS, the Westside Council of Governments, an intergovernmental body representing the cities of Beverly Hills, Culver City, Santa Monica, and West Hollywood, the Mayors of Inglewood, Glendale, Pomona, and Whittier, and Metro's Chief Executive Officer, among other LA County jurisdictions and organizations, have all developed statements of opposition to SB 220; and,

WHEREAS, Metro's history of successful transportation planning—including Measure M's subregional equity program, the 10-year review cycle, and extensive local project prioritization—demonstrates the 'agency's capacity to lead inclusive, locally accountable transportation governance;

NOW, THEREFORE, BE IT RESOLVED, that the Council of the City of Los Angeles strongly opposes SB 220 (Allen) and any attempt to restructure the Metro Board of Directors without a locally-led, publicly engaged consensus-based process, as already required by existing law; and

BE IT FURTHER RESOLVED, that the Council calls on the State Legislature to reject SB 220 outright and respect the rollout of Measure G, allowing local agencies and residents to shape Metro governance reforms as the new Supervisorial districts and County Executive role are established; and

BE IT FINALLY RESOLVED, that the Chief Legislative Analyst, with assistance from the City Administrative Officer, and relevant departments, be directed to transmit this resolution to the offices of Mayor Karen Bass, Governor Gavin Newsom, Senate President pro Tempore Mike McGuire, Speaker of the Assembly Robert Rivas, State Senator Ben Allen, Metro Chief Executive Officer Stephanie Wiggins, and the Metro Board of Directors.
