- 4. AUTHORIZE the Controller to transfer up to \$15,896 from Fund No. XXX, Account No. 46A299, to the General Fund No. 100/46, Revenue Source No. 5346, for reimbursement of grantfunded fringe benefits.
- 5. AUTHORIZE the Controller to transfer cash from Fund No. XXX/46 to reimburse the General Fund, on an as-needed basis, upon presentation of proper documentation from City departments.
- 6. AUTHORIZE the Mayor, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, authorize the Controller to implement the instructions.

<u>Fiscal Impact Statement:</u> The CAO reports that the approval of the recommendations within the CAO report dated February 19, 2025, attached to the Council file, will have no additional impact to the General Fund and will provide \$311,470 for personnel and operating expenses to support the Central Bureau Family Justice Center. The FY 23 FJ Grant is awarded on a reimbursement basis and requires grant recipients to upfront program expenditures. No matching funds are required for this grant.

The Huron Substation, Los Angeles Historic Cultural Monument #404 located at 2640 N Huron Street, is being refurbished by the not-for-profit Huron Station Playhouse as a theater and arts space, which includes a change of use from industrial to assembly space. As part of the change of use, it is necessary to cut into the adjacent street to install sprinkler service infrastructure. However, this section of Huron Street, from Avenue 26 to Avenue 28, was resurfaced by the Bureau of Street Services on June 24, 2024, which commenced the City's one-year moratorium on street cuts for this road segment.

The developer has stated that they were not aware of having received a 30-day notice of the planned resurfacing work. An exception to the City's one-year street cut moratorium is therefore necessary to allow the Department of Water and Power to cut into the street to install sprinkler service at this property to service the development.

I THEREFORE MOVE that the City Council approve an exception to the City's one-year, street cut moratorium on Huron Street to allow for the installation of sprinkler service at 2640 N Huron Street.

Weingart Tower II L.P. (Sponsor), a California limited partnership, has requested that the City of Los Angeles (City) through the Los Angeles Housing Department (LAHD) issue Multifamily Housing Revenue Bonds, in an amount not to exceed \$63,250,000 to finance the new construction of the 144-unit multifamily housing development known as Weingart Tower II (Project). The Project is located at 555-561 South Crocker Street in Council District 14 and will provide 142 units of affordable housing and two manager units.

In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the bond issuance process, LAHD conducted the required public hearing on March 11, 2025. Notice of the public hearing was published on March 4, 2025. LAHD is required to provide proof to the California Debt Limit Allocation Committee (CDLAC) that a TEFRA hearing has been conducted as part of the application process. The Sponsor has pledged to comply with all City and LAHD bond policies related to the work described in this Motion, including but not limited to payment of prevailing wages for labor and project monitoring with LAHD.

The City is a conduit issuer and is required by federal law to review and approve all projects within its jurisdiction and conduct a public hearing. The bond debt is payable solely from revenues or other funds provided by the Sponsor. The City does not incur liability for repayment of the bonds. To allow the bonds to be issued in accordance with CDLAC requirements, the Council should approve the minutes of the hearing and adopt the required Resolution (attached).

I THEREFORE MOVE that the City Council consider the attached results of the TEFRA public hearing held on March 11, 2025 for Weingart Tower II and adopt the attached TEFRA Resolution approving the issuance of bonds in an amount not to exceed \$63,250,000 to finance the new construction of a 144-unit multifamily housing development located at 555-561 South Crocker Street in Council District 14.

A RESOLUTION APPROVING FOR PURPOSES OF SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 THE ISSUANCE OR REISSUANCE OF BONDS OR NOTES BY THE CITY OF LOS ANGELES TO FINANCE OR REFINANCE THE ACQUISITION, REHABILITATION, CONSTRUCTION AND EQUIPPING OF A MULTIFAMILY RESIDENTIAL RENTAL PROJECT LOCATED WITHIN THE CITY OF LOS ANGELES.

WHEREAS, the City of Los Angeles (the "City") is authorized, pursuant to Section 248, as amended, of the City Charter of the City and Article 6.3 of Chapter 1 of Division 11 of the Los Angeles Administrative Code, as amended (collectively, the "Law"), and in accordance with Chapter 7 of Part 5 of Division 31 (commencing with Section 52075) of the Health and Safety Code of the State of California (the "Act"), to issue or reissue its revenue bonds or notes for the purpose of providing financing for the acquisition, construction, rehabilitation and equipping of multifamily rental housing for persons and families of low or moderate income; and

WHEREAS, the City intends to issue or reissue for federal income tax purposes certain bonds or notes (the "Bonds") the proceeds of which will be used to finance or refinance the acquisition, construction, rehabilitation and equipping of a multifamily rental housing project described in paragraph 6 hereof (the "Project"); and

WHEREAS, the Project is located wholly within the City; and

WHEREAS, it is in the public interest and for the public benefit that the City authorize the financing or refinancing of the Project, and it is within the powers of the City to provide for such financing or refinancing and the issuance or reissuance of the Bonds; and

WHEREAS, the interest on the Bonds may qualify for a federal tax exemption under Section 142(a)(7) of the Internal Revenue Code of 1986 (the "Code"), only if the Bonds are approved in accordance with Section 147(f) of the Code; and

BB HOUSING & HOMELESSNESS

MOTION

The Council District 8 Navigation Center, located at 729 W. Manchester Avenue, provides various services to people experiencing homelessness including hygiene, storage, case management, and access to resources for housing solutions. The service provider, Homeless Outreach Program Integrated Care System (HOPICS), has reported a leak in the shower floors of the facility that impacts program operations. The leak causes water to accumulate in the site's elevator pit, causing the elevator to be inoperable until the water is drained. Due to the leaks and to maintain operational elevators, two ADA-compliant showers at the facility have been taken offline for repairs, impacting client services.

The General Services Department (GSD) Construction Forces Division has assessed the site for repairs and provided a repair estimate of \$41,874, which includes a 20 percent contingency. In coordination with the City Administrative Officer, Homeless Housing, Assistance, and Prevention Round 2 (HHAP-2) funding has been identified to support the cost of repairs.

I THEREFORE MOVE that the City Council:

- 1. APPROPRIATE up to \$41,874 of unspent HHAP-2 Funds from Fund No. 64J/10, Account No. 10V755, Real Estate Consulting Services to HHAP-2 Fund No. 64J/10, Account No. 10V772, FC-2 A Bridge Home Operating Costs; and

MOTION

The devastation caused by January's fires has continued long after the flames were extinguished. Through lost jobs, shuttered businesses, and widespread economic hardship, families across Los Angeles are facing increased housing insecurity. The Eaton and Palisades fires destroyed over 12,000 homes, leaving tens of thousands of Angelenos without a home and adding immense stress to our city's ongoing housing crisis. Studies show that rent in the region has already increased by 20%. Unfortunately, over the past three months, bad actors in the real estate industry have taken advantage of this terrible crisis to illegally inflate the price of rental housing, knowing that disaster survivors and vulnerable tenants will have little choice but to pay. California Penal Code 396, which remains in effect in Los Angeles County until January 7th, 2026, outlaws rental increases of greater than 10% as well as rental listings that exceed 160% of Fair Market Rent. Despite this, The Rent Brigade, a grassroots collective of tenant advocates and researchers in Los Angeles, has published research uncovering over 4,500 violations of Penal Code 396 rent-gouging over the past few months, amounting to over \$17,000,000 unlawfully gouged from the pockets of tenants in the City of Los Angeles every month.

The City Attorney, as well as the County District Attorney and the State Attorney General, have the authority to investigate and charge individuals and corporations who violate statewide price-gouging laws. Thus far, however, enforcement has been limited, with only a handful of individuals and corporations charged under California Penal Code 396(e). This lack of deterrent has driven sustained illegal price gouging in the rental market: The Rent Brigade's research shows that unlawful rent-gouging is increasing steadily, week-over-week. Moreover, their April report revealed the outsized role that corporate landlords have played in driving up rental prices across the City of Los Angeles.

In light of these challenges, the City must act decisively to enforce price-gouging laws and deter bad actors from breaking the law to harm tenants, including by increasing transparency about its efforts to do so.

I THEREFORE MOVE that the City Council instruct the Chief Legislative Analyst to work with the City Attorney and other City entities as necessary, to produce monthly reports on the City's response to complaints of price gouging in the rental housing market, received by any City Department, for the duration of the statewide emergency order declared in response to the January 2025 fires and for six months after, and that such monthly reports include, but are not limited to:

- A count of the price gouging complaints ("complaints") received by the City;
- The average response times between receipt of a complaint and the initiation of investigations and any enforcement by the City;
- A categorization and count of the City's responses to complaints, including enforcement actions;
- A geographic breakdown of the complaints and of City enforcement actions
- A list of repeat offenders about whom the City received complaints;
- Any recommendations for improving enforcement and increasing deterrence of illegal rent gouging;
