For nearly five decades, Simie Seaman has been one of Wilmington's most dedicated advocates and community leaders. Since making Wilmington her home, she has played a pivotal role in numerous organizations, championed efforts for historic recognition, and helped shape the community through her leadership in key projects.

Simie co-founded and currently serves as President of the Wilmington Historical Society. She has been a Board Member and volunteer for the Friends of the Banning Museum for 18 years, and a member for 34 years. She founded the Banning Park Neighborhood Association, serving as President for five years, and the Wilmington Preservation Guild, serving as President for three years. As a founding Board Member of Wilmington's Neighborhood Council—the first in the City of Los Angeles—she continues to serve in that role today. Her civic engagement also includes the Drum Barracks Civil War Museum, Banning Wrigley Historic Neighborhood Watch, and over 40 years as an LAPD Neighborhood Watch Block Captain.

Simie has been instrumental in preserving Wilmington's history. She led successful efforts to secure Los Angeles Historic-Cultural Monument status for Banning Park, the Avalon Mexican Fan Palms, and the Lakme Avenue Camphor Trees. She was a driving force behind the Banning Park Historical Preservation Overlay Zone. She also contributed to the book *Images of America: Wilmington*, documenting the city's early visual history.

Her lifetime of work has left an indelible mark on Wilmington—both by preserving its history and by being a part of it.

The City is home to a large and diverse immigrant population that contributes significantly to our communities, economy, and culture. In recent months, heightened federal immigration enforcement activity has created fear and uncertainty among many residents, particularly in neighborhoods with high immigrant populations. In order to ensure that all Angelenos are informed of their legal rights, it is critical that the City leverage its resources and visibility to provide clear, accessible "Know Your Rights" information to the public.

The Bureau of Sanitation (LASAN) operates a large fleet of trash collection vehicles that travel daily through every community in Los Angeles, reaching millions of residents and businesses each week. This fleet presents a unique opportunity for high-visibility public education and outreach. By displaying large "Know Your Rights" banners on the sides of trash trucks and affixing smaller informational stickers, LASAN can help disseminate vital information directly into neighborhoods where it is most needed.

To ensure cultural and linguistic accessibility, LASAN should collaborate with the Civil and Human Rights and Equity Department and the Community Investment for Families Department, which already maintains strong relationships with immigrant rights nonprofit organizations. Working together, these departments can engage trusted local partners such as the Salvadoran American Leadership and Educational Fund, the Coalition for Humane Immigrant Rights, and the Central American Resource Center, among others. This collaboration can help develop content that is accurate, legally sound, multilingual, and tailored to the needs of Los Angeles' diverse immigrant communities.

I THEREFORE MOVE that the City Council INSTRUCT the Bureau of Sanitation, with the assistance from the Community Investment for Families Department, and in partnership with local nonprofit organizations such as the Salvadoran American Leadership and Educational Fund, the Coalition for Humane Immigrant Rights, the Central American Resource Center, and others, to promote the "Know Your Rights" public awareness campaign using LASAN's trash truck fleet. As the housing crisis continues to threaten the wellbeing of untold Angelenos, major public institutions are increasing their efforts to increase the region's supply of affordable housing. In 2021, the Board of Directors of the Los Angeles County Metropolitan Transit Authority (Metro) approved a revised Joint Development (JD) program, with the goal of creating 10,000 units of housing — at least half of which will be affordable — on Metro-owned land by 2031.

Similarly, the Los Angeles Unified School District (LAUSD), stemming from a 2024 "Workforce and Family Housing Needs Assessment" indicating 43 percent of respondents were housing insecure, is in the process of launching a Housing Initiative, to deliver affordable housing for their employees on district-owned property, with potential Board approval early next year.

This past spring, the Los Angeles Community College District (LACCD) announced the launch of its own Housing Initiative and the release of a Request for Proposals, to increase the availability of housing for the District's 200,000-plus students.

With a number of sites either identified or under consideration by Metro, LAUSD, and LACCD located in the City, there should be a concerted effort to fully support these programs, as this fully aligns with the goals and strategies included in the Citywide Housing Incentive Program.

WE THEREFORE MOVE that the City Council instruct the Department of City Planning (DCP) to formally engage the Los Angeles County Metropolitan Transit Authority (Metro), the Los Angeles Unified School District (LAUSD), and the Los Angeles Community College District (LACCD) for the purposes of establishing regularized, ongoing discussions regarding their respective housing initiatives, wherein DCP can provide technical assistance, land use and zoning analyses, and updates on policy developments concerning land use and housing;

**WE FURTHER MOVE** that the City Council instruct DCP to report back within 120 days on the following:

- Identifying limitations within existing City incentives for sites zoned for public facilities or owned by public agencies, and potential programmatic remedies;
- Furnishing recommendations to reduce any barriers for the timely approval and construction of dense, mixed-use multifamily developments and potential revenue generation opportunities at identified project sites and in the adjoining communities;

WE FURTHER MOVE that the City Council instruct the Chief Legislative Analyst, in consultation with DCP, the Department of Building and Safety, the Housing Department, Los Angeles Fire Department, Department of Water and Power, Bureau of Sanitation, Department of Transportation, Department of Recreation and Parks, and Bureau of Streets Services to report back within 120 days on recommendations to execute master development agreements and/or Memoranda of Understanding between the relevant departments and Metro, LAUSD, LACCD, and/or their development partners in order to reduce or streamline processes and timelines related to entitlements, inspections, permits, and approvals. CLA shall review any agreements five years after execution, to assess for effectiveness, delivery of community-serving uses, and adherence to committed neighborhood engagement and accountability, and shall provide recommendations for potential modifications or repeal.

# MOTION

The Bureau of Street Services operates the City's asphalt plants which manufacture asphalt sufficient to meet the City's needs. The asphalt the City produces is composed of 50 percent of recycled asphalt concrete, which has resulted in tons of pavement being diverted from landfills and instead reused in repaving. However, the City has the capacity to manufacture a significantly larger volume of asphalt than it currently produces. Given efficiencies that would be realized were the City to increase its asphalt production capacity and the sustainability of the asphalt concrete mix that the City is capable of producing, the City should explore its ability to sell the asphalt it produces in the open market.

The Bureau of Street Services also generates mulch in the course of its regular tree trimming work. Revenue from the sale of asphalt and mulch could be used to fund further improvements in the public right-of-way, fund work on the City's Mobility Plan, and enhance the accessibility and usability of our sidewalk and street systems.

Additionally, the City should ensure that its asphalt is being used to conduct repairs and backfills when non-City entities are cutting into City streets so that the paving on City streets have a uniform composition. Moreover, the City should require all of its departments, including the proprietary departments, to use the City-produced asphalt.

I THEREFORE MOVE that the City Administrative Officer (CAO), with the assistance of the City Attorney and Bureau of Street Services, be instructed to report back on the feasibility of authorizing departments and bureaus to sell goods they produce, including asphalt and mulch, and to prepare and present the necessary documents to allow for the sale of these goods, including a ballot measure for the June 2026 election if required.

I FURTHER MOVE that the CAO, with the assistance of the City Attorney and Bureau of Street Services, be instructed to report on the feasibility of requiring the proprietary departments to use City-produced asphalt and to prepare and present the necessary documents to codify this requirement, including a ballot measure for the June 2026 election if necessary.

I FURTHER MOVE that the Bureau of Engineering and the Bureau of Street Services, with the assistance of the City Attorney, be instructed to report on the materials requirements for resurfacing street cuts and report on the feasibility of requiring non-City entities to use City-produced asphalt for repairing street cuts.

When roadways are congested, it is often difficult or impossible for emergency vehicles to get to their destination. When drivers cannot move out of a travel lane, emergency vehicle response times increase, potentially with catastrophic results. One option is to require the implementation of wider bike lanes to accommodate police and fire vehicles.

I THEREFORE MOVE that the Council instruct the Departments of Transportation and City Planning, in coordination with Bureau of Street Services and the Bureau of Engineering, to report on options and recommendations that would require bike lanes to provide sufficient width for emergency vehicle access.

The City's procurement of services is bound by numerous regulations to ensure transparency, fairness, and accountability. That said, the City's processes can delay the ability to act expeditiously and may hinder a company's willingness to undertake work with the City. There are several ways to enhance the speed and effectiveness of public procurement, including:

- Implementing an integrated e-procurement system;
- Standardizing and pre-approving contracts;
- Streamlining the approval and decision-making processes;
- Adopting agile and outcome-based procurement;
- Providing regular training for procurement staff on best practices, contract negotiation, risk management, and the use of digital tools;
- · Leveraging data analytics and predictive procurement;
- Reducing legal and regulatory bottlenecks;
- · Implementing performance-based contracting;
- Improving interagency coordination; and
- Creating procurement innovation units that test new procurement models, pilot emerging technologies, and recommend reforms.

By examining these strategies, the City can significantly improve procurement speed and efficiency.

I THEREFORE MOVE that the Council instruct the Department of Transportation, in coordination with the City Attorney, to report on the current processes for contracting and provide recommendations to improve the speed and efficiency of the Department's procurement process to create a more responsive and effective system.

In 2006, the Los Angeles Department of Transportation (LADOT) began advertising on its vehicles through a service provider. The transit vehicle advertising contractor markets and sells advertising space inside and outside of the Commuter Express buses, Community DASH buses, and the Cityride Paratransit service vehicles.

The Department's Transit Advertising Content Policy and Guidelines allow commercial and promotional advertising, as well as governmental advertising and public service announcements. Moreover, LADOT retains the right to display exterior advertisements on up to five percent of the buses and up to 50 percent of the interior space for the optional use by LADOT or other City agencies to share information of public concern.

Advertising community and special events on DASH buses is a perfect opportunity for the City to reach community members who may not hear of the events through traditional ways. Such an effort would have the capacity to target local audiences with creative design concepts and ideas that can be highly engaging.

I THEREFORE MOVE that the Council instruct the Department of Transportation to report on the steps necessary to require Community DASH buses to advertise all special events that are adjacent to the transit route.
