Fiscal Impact Statement: The DOT reports that there is no negative impact to the General Fund. The 2025-26 Adopted Budget assumes \$14.4 million in additional revenue from increased parking meter rates as described in the report. Conservatively, implementing the new parking facility rates and extended hours of operation for parking meters have the potential to generate at least \$1.7 million in total gross revenue in Fiscal Year (FY) 2025-26, if implemented by January 1, 2026. The DOT will report back on additional parking revenue estimates to help inform the FY 2026-27 budget process.

SUBSTITUTE RESOLUTION

WHEREAS, California Vehicle Code Section 22507(a) authorizes local authorities to establish by ordinance or resolution, the designation of certain streets upon which preferential parking privileges are given; and

WHEREAS, the Los Angeles Municipal Code (LAMC) Section 80.58 establishes the Preferential Parking Program; and

WHEREAS, LAMC Section 80.58(d) provides that Temporary Preferential Parking Districts (TPPD) may be established by Council Resolution; and


WHEREAS, residents located on the block indicated below are faced with a lack of on-street parking throughout the day;

NOW, THEREFORE BE IT RESOLVED that the City Council, pursuant to Los Angeles Municipal Code Section 80.58(d), hereby establishes a Temporary Preferential Parking District, number to be assigned by the Department of Transportation, consisting of West 16th Place from West Boulevard to Vineyard Avenue **and Lafayette Road from Venice Boulevard to St. Charles Place;**

BE IT FURTHER RESOLVED, that upon approval of the TPPD through the adoption of the Resolution, LADOT is authorized to post or remove parking restrictions on the blocks noted above with the following parking restriction:

No Parking Anytime, Permits Exempt

BE IT FURTHER RESOLVED, that LADOT be directed to take appropriate steps to prepare, issue, and require payments for permits from residents of the TPPD in accordance with the LAMC.

The Los Angeles Neighborhood Land Trust (LANLT), a non-profit organization, works to address the critical shortage of parks and green spaces in low-income communities of color within Los Angeles County. Their work aims to advance environmental justice, improve public health, and foster community resilience by creating safe and accessible green spaces. LANLT has added 22 acres of accessible green space to Los Angeles by helping create 30 parks and gardens since 2002.

LANLT has been working with the Watts Towers Arts Center (WTAC) and the local community for over a decade on project development to co-create a holistic design of the Watts Towers Arts Center Campus (WTACC). The WTACC is located in the heart of Watts, consists of five acres of land, and hosts the WTAC and the Charles Mingus Youth Arts Center (CMYAC).

LANLT, at its own expense, has created a development plan for the WTACC and is prepared to begin construction. The construction will include transforming the site into a welcoming cultural campus that includes a wellness walk, interactive play elements, an outdoor amphitheater, and California native shade trees and grassland gardens to welcome visitors of all ages.

Before LANLT can begin construction, the Bureau of Engineering (BOE) will review LANLT's development plans to ensure the designs comply with the City's public space design best practices. After gaining BOE's approval, LANLT may proceed with moving construction approvals through the City.

Portions of the WTACC are under the jurisdiction of the Department of Recreation and Parks (RAP), while other areas fall under the authority of the Department of General Services (GSD). In order for LANLT to enter and perform work in the areas under GSD's jurisdiction, GSD must be authorized to allow LANLT to access GSD's property.

The Department of Cultural Affairs will accept the donation of the services and completed facilities on site upon completion of work by the LANLT, and provide a plan and funding mechanism for ongoing maintenance and repairs on the completed site as part of the annual budget process.

I THEREFORE MOVE that the City Council authorize the Department of General Services and the Recreation & Parks Department to grant, upon completion of the Bureau of Engineering's review and approval, an appropriate use rights agreement to the Los Angeles Neighborhood Land Trust for access to the necessary areas at the Watts Towers Arts Center Campus to perform work needed for the development of the site in connection with the Watts Tower Arts Center Campus project.

MOTION

Pursuant to State Vehicle Code Section 21101.4, the City is authorized to undertake the temporary closure of public streets, alleys, and walkways to mitigate criminal activity. When necessary for the continued mitigation of criminal activity, temporary closures authorized under Section 21101.4 may be extended for "eight additional consecutive periods of not more than 18 months each."

On December 9, 2022, the City Council approved the temporary street closure of 121st Street between Figueroa Street and Hoover Street for a period of 18 months and in May 2024 the Council called for an 18-month extension of the closure (C.F. 14-0958). The street closure was requested by nearby residents and was supported by the Los Angeles Police Department who both reported numerous crimes occurring at this location including robberies, assaults, prostitution, and theft from vehicles.

In order to continue this important street closure, the City Council should authorize the City Engineer to extend the closure period.

I THEREFORE MOVE that the City Engineer be instructed to report with recommendations on extending the temporary closure of 121st Street between Figueroa Street and Hoover Street for an additional eighteen months for reasons of public safety.

RULES, ELECTIONS, INTERGOVERNMENTAL RELATIONS

The City of Los Angeles is committed to creating and maintaining safe and welcoming spaces for all Angelenos. Neighborhood Councils, as the grassroots level of government, often hold meetings in locations where youth and families are present, including schools, community centers, and libraries. Ensuring that these meetings remain safe and transparent is critical to preserving the public's trust and engagement.

Neighborhood Councils also serve as an important entry point for civic engagement, where young people often participate, volunteer, or observe local decision-making. Because these meetings provide opportunities for leadership development and community involvement, it is especially important that participants and their families feel confident that these spaces are free from potential risks. Strengthening safeguards will help preserve the integrity of the Neighborhood Council system and encourage broader participation from residents of all ages.

Given that some individuals who seek election, appointment, or selection to serve on Neighborhood Councils may have prior criminal histories requiring them to register as sex offenders, it is important that the City explore ways to promote transparency and accountability. In particular, the disclosure of whether a candidate or appointee is a registered sex offender is necessary to safeguard the wellbeing of youth who may participate in or be present at Neighborhood Council meetings. Establishing such a safeguard reflects the City's commitment to protecting our young people and ensuring that our neighborhood governance spaces are safe, inclusive, and transparent.

I THEREFORE MOVE that the City Council REQUEST the Board of Neighborhood Commissioners, with assistance of the Department of Neighborhood Empowerment, the City Clerk, and the City Attorney, to report back on the feasibility of requiring Neighborhood Council applicants to disclose their status as registered sex offenders, and to evaluate the feasibility of prohibiting individuals on the registry from serving on Neighborhood Councils through election, appointment, or selection.

I FURTHER MOVE that the City Council REQUEST the Board of Neighborhood Commissioners, with the assistance of the Department of Neighborhood Empowerment and the City Attorney, to work with the Los Angeles City Charter Commission to explore and report back on the feasibility of incorporating a disclosure requirement, as well as any related prohibitions, into the City Charter, with the goal of strengthening safeguards for youth and ensuring that Neighborhood Council spaces remain safe and secure.

Across the country, social service programs are facing ongoing reductions in federal support. These cutbacks extend far beyond the programs that receive direct federal dollars, creating additional strain on every level of government.

These funding reductions also affect the resources California relies on to support local governments in addressing housing insecurity or homelessness, particularly through the Homeless Housing, Assistance and Prevention (HHAP) program.

The City of Los Angeles began receiving HHAP funding in the Fiscal Year 2020/2021 budget, and these funds have been critical in sustaining vital programs in Skid Row and neighborhoods citywide. In addition to supporting essential services, HHAP funding has played a key role in closing gaps in the production of interim housing sites.

The State of California has indicated that HHAP funding is limited and may not continue if the current federal fiscal climate continues. While some HHAP resources are anticipated for Fiscal Year 2026/2027, the State has not fully committed to HHAP 7 or funding beyond 2027.


LAHSA is projected to run out of HHAP funding in 2026, which will also have an impact on the City's funding requirements in Fiscal Year 2026/2027, adding to possible shortfall in the System.

Given the City's reliance on HHAP funding to support homelessness programs, it is essential to evaluate how these dollars are used and prioritize the most effective services. This review will guide strategic investments, improve efficiency, and prepare the City for potential program reductions or transitions as funding declines.

I THEREFORE MOVE that the City Administrative Officer, in partnership with the Chief Legislative Analyst, the Los Angeles Homeless Services Authority, the Los Angeles Housing Department, and any other relevant departments, report on the following:


- An overview of all programs that are currently supported by HHAP funding;
- An analysis of program efficacy, by service type (i.e., outreach, street medicine, rehousing strategies, etc.); and
- A matrix that lists all HHAP funded programs, highlighting opportunities for consolidation, recommendations for ramp down, and which services would traditionally fall under the jurisdiction of other governmental agencies (i.e. the County of Los Angeles) that we should negotiate transfer of responsibility.

Council District (CD) 8 has been disproportionately impacted by decades of disinvestment and redlining, leaving it blighted with brownfields and contaminated sites that remain unremediated. These conditions, coupled with a lack of accessible food options and adequate housing, present ongoing challenges for the district. A promising opportunity has emerged through collaboration with the Bureau of Sanitation (BOS) to remediate the site at 9402 S. Broadway, with plans to develop a high-quality grocery store, retail spaces and over 180 housing units.

One of the primary barriers to transformative investments in the district is the significant contamination of land abandoned long ago. With advancements in science, technology, and sustainable policies, we now have the tools to address these brownfields directly. The United States Environmental Protection Agency (EPA) has a funding opportunity to support agencies in reducing environmental and public health risks in communities disproportionately affected by hazardous materials. The EPA's Brownfields Cleanup Grant provides funding for a recipient to carry out cleanup activities at brownfield sites owned by the applicant. The redevelopment of 9402 S. Broadway is an ideal candidate for EPA's Brownfields Cleanup Grant funding, as it would remediate a brownfield, revitalize land for safe community use, and provide access to much-needed food and housing. The BOS Citywide Brownfields Program, which oversees brownfields projects and grants in Los Angeles, will coordinate the application process to ensure compliance with funding requirements and maximize the City's chances of success.

I THEREFORE MOVE that the Bureau of Sanitation, with the support of the Economic and Workforce Development Department and any other necessary departments, be authorized to apply for the United States Environmental Protection Agency (EPA) Brownfields Cleanup Grant to secure funding for the remediation of brownfield sites in Council District 8.

I FURTHER MOVE that the Bureau of Sanitation, with the assistance of the City Administrative Officer, report back on the acceptance of the grant award and outline the necessary administrative and legislative steps required to leverage EPA funds for the project.
