If the Council approves an allocation of \$150,000 to the BSL – 3D Printing for the Public Right-of-Way project, it would reduce the remaining IF Balance, which is currently \$2,768,922.75. Savings from the IF Balance may be used to address the current city-wide financial crisis and the overspending in the 2024-25 Fiscal Year. Additionally, funding this program may incur unfunded and ongoing costs.

In 2018, the Los Angeles Department of Transportation (LADOT), Foothill Transit, and Antelope Valley Transit Authority (AVTA) together received a federal grant in the amount of \$3,316,998 from the Federal Transit Administration (FTA) (CA-2024-148) to jointly construct two bus layover facilities on unimproved downtown Los Angeles properties that were being leased from Caltrans. One portion of the grant (\$1,027,005) was designated to improve the West 17th Street and South Grand Avenue layover site (Grand Lot Project) and the other portion of the grant (\$2,289,993) was designated to improve the lot located at the intersection of East 16th Street and Maple Avenue.

The funding agreement with FTA, executed in 2024, named the LADOT as the Designated Recipient of the total grant award; LADOT as the lead on the East 16<sup>th</sup> Street and Maple Avenue project and Foothill Transit as the lead on the Grand Lot Project. Since that time, LADOT determined that the East 16<sup>th</sup> Street and Maple Project was an inefficient location for a bus layover site. These funds will be repurposed, with FTA approval, to address a funding shortfall for the Harbor City Zero Emission Bus Yard Development Project. This project will provide additional bus capacity during the upcoming 2018 Olympic and Paralympic Games.

The LADOT is required to enter into a Subrecipient Agreement with Foothill Transit in order to "pass through" the FTA grant funds and implement the Grand Lot Project. Under terms of the agreement, Foothill Transit will be required to provide the mandatory matching funds and will be responsible for providing any additional funding necessary to complete the Project. As required by the grant, the City must front-fund payments to Foothill Transit, which will then be reimbursed by the FTA.

I THEREFORE MOVE that the Council AUTHORIZE the Los Angeles Department of Transportation (LADOT) to:

- Negotiate and execute a Subrecipient Agreement with Foothill Transit for the Federal Transit Administration (FTA) Award (CA-2024-148) in the amount of \$1,027,005 that was awarded to the City as the Designated Recipient for the development of a bus layover facility located at West 17th Street and South Grand Avenue (Grand Lot Project);
- Accept and deposit \$1,027,005 in FTA grant funds from the FTA Award (CA-2024-148) into Proposition A
  Local Transit Fund No. 385-94 and appropriate therein to a new account, entitled "FTA Grant Foothill Transit
  Front Funds Grand Lot Project," and authorize LADOT to utilize this account to front-fund grant-funded
  work by Foothill Transit, as the Subrecipient, for an amount up to \$1,027,005;
- 3. Execute a budget revision in the existing grant award with FTA (CA-2024-148) to reallocate the \$2,289,993 from the East 16<sup>th</sup> Street and Maple Avenue lot improvement project to the Harbor City Zero Emission Bus Yard Development Project; and
- 4. Make any corrections, clarifications or revisions to the above instructions, including any new instructions, in order to effectuate the intent of this Motion, and including any corrections and changes to fund or account numbers; said corrections/clarifications/changes may be made orally, electronically or by any other means.

## MO TION CLERK FOR PLACEMENT ON NEXT

In 2017, the Los Angeles County Metropolitan Transportation Authority (Metro) eliminated the SR-710 North freeway extension project between Alhambra and Pasadena. As a result of the freeway project discontinuation, Metro redirected funding to the development and implementation of mobility improvement projects on local arterials and freeway interchanges experiencing congestion. Within the City, the funding is limited to projects in the communities of Northeast Los Angeles and El Sereno.

On February 26, 2019, the Council authorized the Department of Transportation and the Bureau of Engineering (BOE) to enter into a Memorandum of Understanding (MOU) with Metro in order to receive SR-710 funds for four projects (C.F. 19-0110). In 2020, the Council authorized another MOU with Metro for the receipt of SR-710 funds for nine projects (C.F. 19-1566).

On May 9, 2023, the Council authorized reallocating funds from some of the previously approved SR-710-funded projects including \$2,000,000 to a new project entitled 6th Street Viaduct Park, Arts, and River Connectivity (PARC) Street and Transit Improvements (C.F. 23-0074). On December 13, 2023, the Council further authorized BOE and the Bureau of Street Service to revise the MOU with Metro for the de-obligation and allocation of funds for projects identified including the Sixth Street PARC project relative to SR-710 funds (C.F. 23-1362).

On August 1, 2025, the Measure M Funding Agreement between the BOE and Metro was signed and executed to receive \$2,000,000 for the construction of the 6th Street PARC Street and Transit Improvement.

I THEREFORE MOVE that the Bureau of Engineering be authorized to accept and deposit \$2,000,000 in grant funds from the Los Angeles County Metropolitan Transportation Authority into the Engineering Special Services Fund No. 682-50 and appropriate a like amount therein to a new account entitled "Sixth Street Viaduct - Park, Arts, and River Connectivity (PARC) Improvement Project - Street and Transit Improvements" for the construction of the 6th Street PARC Street and Transit Improvements.

I FURTHER MOVE that the Bureau of Engineering, with the assistance of the City Administrative Officer and Department of Public Works, Office of Accounting, be authorized to utilize MICLA Fund No. 298-50, Account No. 50CPKM (Sixth Street Park, Arts, and River Connectivity (PARC) Improvement Project), approved in the 2025-26 Adopted Budget, to front-fund grant-funded work for an amount up to \$2,000,000.

I FURTHER MOVE that the Bureau of Engineering be authorized to make any corrections, clarifications or revisions to the above fund transfer instructions, including any new instructions, in order to effectuate the intent of this Motion, and including any corrections and changes to fund or account numbers; said corrections/ clarifications/ changes may be made orally, electronically or by any other means.

#### MOTION

The Port of Long Beach, together with our Port of Los Angeles, is implementing "America's Green Gateway," the Pier B On-Dock Rail Support Facility that will enhance on-dock rail capacity at the Port of Long Beach's shipping terminals while reducing environmental impacts. The project is expected to be completed in 2032 and will connect on-dock rail facilities to the Alameda Corridor railway. The project is a significant step toward meeting the on-dock rail goals established by the San Pedro Bay Ports Clean Air Action Plan.

The project's goals are commendable and projected outcomes are encouraging, but the project does not come without impact to the surrounding communities, with the project footprint extending into eastern Wilmington in Council District 15. The Port of Long Beach has acknowledged this and, working alongside the Neighborhood Council, has committed \$1 million in community impact funds associated with the Pier B project. These funds will deliver community priority projects, including public signage for the Wilmington community, which acknowledges the Port of Long Beach's contribution. It would be most appropriate to create an account within the Public Works Bureau of Engineering to hold these funds.

I THEREFORE MOVE that the City Council authorize the City Controller to establish a new account within the Engineering Special Services Fund No. 682-50, entitled "Port of Long Beach Pier B Project Community Impact Funds" for the purpose of appropriating community impact funds received by the Bureau of Engineering from the Port of Long Beach in connection with the Port of Long Beach's Pier B Project.

## ARTS, PARKS, LIBRARIES, AND COMMUNITY ENRICHMENT

#### MOTION

The Department of Recreation and Parks (RAP) operates one of the most extensive municipal recreation and parks systems across the country, with more than 450 parks, 180 recreation centers, 60 swimming pools, and 13 golf courses. Through its wide range of programs, classes, and community events, RAP provides opportunities for health, recreation, and social connection that serve as the foundation of neighborhood well-being across Los Angeles.

Many cities throughout California already differentiate between City residents and non-City residents in their recreation and park programming to ensure fair cost recovery and to prioritize access for their own residents. For example, South San Francisco charges non-City resident rates for youth enrichment and camp programs, as well as for non-City resident pool rentals. In Pasadena, non-City residents pay higher fees for recreation programs, swim lessons, and facility rentals. Similarly, Cupertino imposes higher non-City resident rates for athletic field rentals and recreation classes. Aligning Los Angeles with these practices would help bring the City up to speed with its peers while generating additional funding to reinvest in RAP's programming, maintenance, and capital needs.

Establishing non-City resident fees for RAP activities and programs would allow the Department to reinvest additional revenue back into the recreation system, such as supporting the long-term sustainability of programming, enhancing service delivery, and ensuring continued affordability for Los Angeles residents.

I THEREFORE MOVE that the Department of Recreation and Parks, with the assistance of the City Administrative Officer and the Office of the City Attorney, report back on the feasibility of establishing non-City resident fees for Recreation and Parks programs, classes, and activities in order to align with practices in other California jurisdictions. This report should include:

- A comparison of resident and non-City resident fee structures used by other major California cities;
- Projected revenue estimates under various fee adjustment scenarios;
- An evaluation of how differential fees may affect low-income households, seniors, and other populations
  that rely on RAP's affordable programming, including potential mitigation strategies such as fee
  waivers, scholarships, or income-based adjustments;
- A legal analysis regarding potential challenges related to establishing differential fees for non-City residents; and

Recommended forms of identification that would be considered valid for City residents.

#### MOTION

Any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must first be adopted in the form of a Resolution by the City Council.

The Ports of Los Angeles (POLA) and Long Beach (POLB) together comprise the San Pedro Bay Port Complex, an economic engine supporting millions of jobs. Being the largest maritime gateway in the Western Hemisphere, for more than a century, California's ports, particularly the San Pedro Bay Port Complex, have served as the backbone of the state and national economy, facilitating trade and providing good-paying, middle-class, union jobs that sustain working families and communities.

The Ports have also been leaders in environmental innovation. Under the San Pedro Bay Clean Air Action Plan, the Ports have committed to achieving 100 percent zero-emission cargo-handling equipment by 2030 and zero-emission drayage trucks by 2035. Since 2005, the Ports have reduced diesel particulate matter by 92 percent, nitrogen oxides by 71 percent, sulfur oxides by 98 percent, and greenhouse gas emissions by 20 percent, making them the cleanest and most efficient Port complex in the world.

As the tidelands trustee and operator of the Port of Los Angeles, the City must reaffirm its authority to regulate and set policy for the implementation of local air quality measures, grounded in collaboration, accountability, and community benefit, as well as continuing to advance environmental progress, economic stability, and workforce protections.

I THEREFORE MOVE that the City Council direct the Chief Legislative Analyst (CLA), with consultation from the Port of Los Angeles (POLA), to report on a framework that allows the City to promote legislation, rules, regulations, and policies that advance air quality protections, but do not include either of the following:

- Any cap on cargo throughput or limiting operations caps at the Port of Los Angeles; and
- Any use of public investment for automated, remotely controlled, or remotely operated equipment that displaces workers.
