 2017 PRIMARY NOMINATING ELECTION**

LOS ANGELES – Los Angeles City Clerk Holly L. Wolcott reminds voters that electronic versions of the Official Sample Ballot (OSB), also known as the E-Sample Ballot, and multilingual voter assistance are available for the March 7, 2017 Primary Nominating Election through the Los Angeles County Registrar-Recorder/County Clerk's (LA RR/CC) website: lavote.net. There voters may access their E-Sample Ballot in English and the 12 Federally and City-mandated languages: Armenian, Chinese, Farsi, Hindi, Japanese, Khmer, Korean, Russian, Spanish, Tagalog, Thai, and Vietnamese.
