## NOTICE OF AVAILABILITY 2020 LOS ANGELES MUNICIPAL ELECTIONS GENERAL INFORMATION FOR CANDIDATES PAMPHLET

**LOS ANGELES** (September 18, 2019) — City Clerk Holly Wolcott announced today that the General Information for Candidates pamphlet for the 2020 Primary Nominating and General Municipal Elections is now available. This pamphlet provides vital information and legal deadlines for individuals interested in becoming a candidate for Los Angeles City Council Districts 2, 4, 6, 8, 10, 12, and 14 and Los Angeles Unified School District (LAUSD) Board of Education Districts 1, 3, 5, and 7. The Primary Nominating Election will be held on Tuesday March 3, 2020.

Candidate filing will take place at The City Clerk - Election Division located at Piper Technical Center 555 Ramirez St, Los Angeles 90012. The filing period for the Declaration of Intention to Become a Candidate begins Monday, November 4, 2019 and ends Saturday, November 9, 2019.\* The filing period for Nominating Petitions begins Saturday, November 9, 2019\* and ends Wednesday, December 4, 2019. Our office will be closed for the Thanksgiving holiday on Thursday, November 28, and Friday, November 29, 2019.

## OCCUPATIONAL DESIGNATION ON BALLOT

Candidates for office, other than the incumbent, may have printed on the ballot their principal professions, vocations, or occupations in **not more than three words**. No proper name, other than a geographic place, may be used as part of the designation. Incumbents shall have printed on the ballot, at their option, the word "Incumbent" or the words designating their elective office [Election Code Section 306].

**CIRCULATING PETITIONS:** Circulators of Nominating Petitions shall be at least 18 years of age [Election Code Section 307(f)].

### VALID SIGNATURES - WHERE OBTAINED:

MEMBER OF LOS ANGELES CITY COUNCIL – from qualified, registered voters of the Council District in which you are running [Charter Section 422(a)];

MEMBER OF BOARD OF EDUCATION OF LOS ANGELES UNIFIED SCHOOL DISTRICT – from qualified, registered voters of the Board of Education District in which you are running [Charter Section 422(a)].

**FILING PETITIONS:** Nominating Petitions\* must be filed at the City Clerk's Election Division Office beginning Saturday, November 9\*\* through Wednesday, December 4, 2019, between 8:00 a.m. and 5:00 p.m., Monday through Friday. All sections of a Petition must be filed at the same time [Election Code Sections 111(b) and 310(a)].

**SUPPLEMENTAL PETITIONS:** If a Petition is found to be insufficient prior to the deadline for filing Petitions, a Supplemental Petition\* may be filed. No Supplemental Petitions\* are accepted for filing after the last day specified for filing Petitions – Wednesday, December 4, 2019 [Charter Section 422(c) and Election Code Section 310(j)].

## CAMPAIGN FINANCE REQUIREMENTS

The Political Reform Act of 1974 is a California state law that requires candidates and their campaign committees to disclose financial information to the public.

Candidates must file a Statement of Economic Interests (CA Form 700) to disclose their personal financial interests. In addition, candidates and their campaign committees must periodically file Recipient Committee Campaign Statements (CA Form 460 or 470) to disclose their contributions and expenditures.

Candidates may not solicit contributions or engage in fundraising until after they have filed all of the following forms:

- Candidate Intention Statement (CA Form 501)
- Intent to Solicit & Receive Contributions (EC Form 12)
- Statement of Understanding (EC Form 13)

All campaign finance forms must be filed with the Los Angeles City Ethics Commission.

Candidates and committees are subject to campaign finance laws, such as contribution limits and disclaimer and disclosure requirements for campaign communications.

City Council candidates may participate in the matching funds program, which helps qualified City Council candidates fund their campaigns.

**SALARY:** \$2,000 per month for each member who actually attends all meetings [Education Code Section 35120].

For a Board Member who devotes his or her entire time to the duties of serving as a member of the Board of Education for the LAUSD and who receives no compensation, fee, or honorarium from any other source, shall be paid a full time salary of \$125,000.<sup>2</sup>

**QUALIFICATIONS:** Registered voter of Los Angeles Unified School District at the time of nomination and election, and resident of the Board District since at least October 5, 2019 [Charter Sections 407(a) and 803].

## DECLARATION OF INTENTION

The first official step in running for office is to complete a Declaration of Intention to Become a Candidate\*, which is available at the City Clerk's Election Division Office on the following dates:

FILING DATES: First Day - *Mon., November 4, 2019*  
[Charter Section 421(a)] Last Day - *Sat., November 9, 2019*  
(Closes at 12 noon on Saturday, November 9, 2019)

### WITHDRAWING DECLARATION OF INTENTION

You may withdraw your Declaration of Intention to Become a Candidate no later than *Saturday, November 9, 2019* [Charter Section 421(b)].

### NOMINATING PETITIONS

The second official step in running for office is to obtain and file a Nominating Petition\*. The Petition will be issued only to you or your representative. The representative must have your written and signed authorization.

ISSUE AND FILING DATES: First Day - *Sat., November 9, 2019*  
Last Day - *Wed., December 4, 2019*  
[Charter Section 422 (b)]  
(Closes at 12 noon on Saturday, November 9, 2019)

**Note:** The office will be closed on Monday, November 11, 2019 in observance of the Veterans' Day Holiday and Thursday, November 28 and Friday, November 29, 2019 for the Thanksgiving holiday.

### WITHDRAWING NOMINATION

You may withdraw your nomination no later than *Monday, December 9, 2019* [Charter Section 423].

**SIGNATURES AND FILING FEE - ALL OFFICES:** Pursuant to Charter Section 422(a), each candidate shall do one of the following:

1. Pay a filing fee in the amount of \$300 and file a Nominating Petition\* with the City Clerk, bearing the signatures of no less than 500 and no more than 1,000 voters (500 signatures must be valid);

or

2. Waive the filing fee and file a Nominating Petition\* with the City Clerk, bearing the signatures of no less than 1,000 and no more than 2,000 voters (1,000 signatures must be valid).

### FILING FEE IS NON-REFUNDABLE

\*Only forms provided by the City Clerk will be accepted.
