CITY CLERK CERTIFIES OFFICIAL LIST OF CANDIDATES

2022 PRIMARY NOMINATING ELECTION

LOS ANGELES (March 18, 2022) - Today, Los Angeles City Clerk Holly L. Wolcott released the official list of 65 candidates who have qualified to appear on the ballot for the June 2022 Primary Nominating Election.

In preparation for the consolidation of the City's June 7, 2022 Primary Nominating Election with the County of Los Angeles' Statewide Primary Election, a random alphabet drawing was conducted by the Secretary of State's Office. This public drawing determined the order in which candidates will be listed in each race. Attached is the list of certified candidates to appear on the June ballot according to the Secretary of State's random alphabet order.

For individuals who wish to become write-in candidates, the Write-In Candidate Filing period is April 11, through May 24, 2022.
