LAST DAY TO FILE NOMINATING PETITIONS

COUNCIL DISTRICT 6 SPECIAL ELECTION

LOS ANGELES (**December 30, 2022**) — Los Angeles City Clerk Holly L. Wolcott reminds all candidates for the 2023 City of Los Angeles Council District 6 Special Election that the deadline to file their completed nominating petition, and a supplemental petition, if required, is Wednesday, January 4, 2023, at 5:00 p.m.

In order to appear on the April 4, 2023 ballot, candidates for the Los Angeles Council District 6 must file a nominating petition. When filing a nominating petition, each candidate must choose to either: a) pay a filing fee of \$300 and submit at least 500 valid signatures from registered voters of Council District 6, or b) waive the filing fee and submit at least 1,000 valid signatures from registered voters within Council District 6.

Candidates who initially do not meet the required number of qualified voters' signatures may file supplemental petitions. However, all supplemental petitions must be filed by the same deadline as nominating petitions; Wednesday, January 4, 2023 at 5:00 p.m.

Although the City Clerk's Office is open for in-person services, appointments are recommended. Appointments can be made on a first-come, first-served basis by calling (213) 978-0444 or by visiting the City Clerk's website at: clerk.lacity.org/election. Pursuant to Ordinance 187219, proof of either full COVID-19 Vaccination or a negative COVID-19 test result conducted within the last 72 hours will be required to enter City buildings. To slow the spread of Coronavirus (COVID-19), the Office of the City Clerk - Election Division strongly recommends wearing a face mask to enter City buildings. Please note that while it is strongly recommended, it may be required at the time.
