### NOTICE OF AVAILABILITY OF THE GENERAL INFORMATION FOR CANDIDATES PAMPHLET 2024 PRIMARY NOMINATING AND GENERAL MUNICIPAL ELECTIONS

LOS ANGELES (**September 22, 2023**) - Los Angeles City Clerk Holly L. Wolcott announced today that the General Information for Candidates pamphlet for the 2024 Primary Nominating and General Municipal Elections is now available. This pamphlet provides vital information and legal deadlines for individuals interested in becoming a candidate for Council Districts 2, 4, 6, 8, 10, 12, and 14 (even-numbered) and Los Angeles Unified School District - Board of Education Offices 1, 3, 5, and 7 (odd-numbered).

The Primary Nominating Election will be held on March 5, 2024, and the General Municipal Election (Runoff) will be held on November 5, 2024. Candidates who are interested in running for City Council or Los Angeles Unified School District (LAUSD) offices must live in the respective district by October 7, 2023. The filing period for the Declaration of Intention to Become a Candidate begins November 6, 2023 and ends November 11, 2023. The period for filing Nominating Petitions begins November 11, 2023 and ends December 6, 2023.

The Office of the City Clerk administers candidate filing for the City of Los Angeles and the Los Angeles Unified School District. The City's Primary Nominating Election will be held Tuesday, March 5, 2024 and the General Municipal Election will be held Tuesday, November 5, 2024. ## OCCUPATIONAL BALLOT DESIGNATIONS

Candidates for office may have printed on the ballot their principal professions, vocations, or occupations in **not more than three words**. No proper name, other than a geographic place, may be used as part of the designation. Incumbents shall have printed on the ballot, at their option, the word "Incumbent" or the words designating their elective office [Election Code Section 306].

**CIRCULATING PETITIONS:** Circulators of Nominating Petitions shall be at least 18 years of age [Election Code Section 307(f)].

### VALID SIGNATURES - WHERE OBTAINED:

**MEMBER OF LOS ANGELES CITY COUNCIL** – from qualified, registered voters of the applicable Council District. [Charter Section 422(a)];

**MEMBER OF BOARD OF EDUCATION OF LOS ANGELES UNIFIED SCHOOL DISTRICT** – from qualified, registered voters of the applicable Board of Education District. [Charter Section 422(a)].

**FILING PETITIONS:** Nominating Petitions must be filed at the Office of the City Clerk – Election Division beginning Saturday, November 11, 2023 (*Open 8 a.m. to 12 p.m.*), through Wednesday, December 6, 2023, between 8 a.m. and 5 p.m., Monday through Friday. All sections of the Petition must be filed at the same time [Election Code Sections 111(b) and 310(a)].

**SUPPLEMENTAL/REPLACEMENT PETITIONS:** If a Petition is found to be insufficient prior to the deadline for filing Petitions, a Supplemental Petition may be filed. If a specific section is lost or damaged, a Replacement Petition section may be issued. All Petitions must be obtained from the Office of the City Clerk – Election Division. Petitions will NOT be accepted for filing after the last day specified for filing Petitions – Wednesday, December 6, 2023 [Charter Section 422(c) and Election Code Section 310(j)].

## CAMPAIGN FINANCE REQUIREMENTS

### City Council and Board of Education Candidates and City Ballot Measure Committees

Candidates and committees are required to disclose financial information to the public by filing a Statement of Economic Interests (State Form 700) and a Recipient Committee Campaign Statement (State Form 460), in addition to other required forms. These forms must be filed with the City Ethics Commission.

Candidates and committees are also subject to other campaign finance laws, such as requirements regarding political communications. City candidates may also elect to participate in the public matching funds program.

More information regarding the campaign finance laws is available in the candidate guide that is available on the City Ethics Commission's website. Please contact the City Ethics Commission for additional guidance.

### **FORM 700 - STATEMENT OF ECONOMIC INTERESTS**

Each candidate shall file a Statement of Economic Interests with the City Ethics Commission, which itemizes investments, interest in real property held by the candidate on the date of declaration of candidacy, and sources of income received during the 12 months prior to the date of filing.

Last day to establish residency within applicable City/District boundaries.

### NOVEMBER 6, 2023, MONDAY

First day to file a Declaration of Intention to Become a Candidate. First day to file a Statement of Economic Interests.

### NOVEMBER 11, 2023, SATURDAY (Open 8 a.m. to 12 p.m.)

Last day to file a Declaration of Intention to Become a Candidate or to withdraw said declaration. First day to obtain Nominating Petitions. First day to file Nominating Petitions.

### DECEMBER 6, 2023, WEDNESDAY\*

Last day to obtain and file Nominating Petitions.

### DECEMBER 11, 2023, MONDAY

Last day to withdraw Nominating Petitions.

### DECEMBER 14, 2023, THURSDAY

Secretary of State conducts Random Alphabet Drawing to determine the candidate order on the ballot.

### FEBRUARY 20, 2024, TUESDAY\*\*

Last day to register to vote in the Primary Nominating Election.†

### MARCH 5, 2024, TUESDAY

#### PRIMARY NOMINATING ELECTION

Last day to vote in the Primary Nominating Election.

### APRIL 4, 2024, THURSDAY

Last day for the County of Los Angeles to certify results for the Primary Nominating Election.

Last day to register to vote in the General Municipal Election.†

### NOVEMBER 5, 2024, TUESDAY

#### GENERAL MUNICIPAL ELECTION

Last day to vote in the General Municipal Election.

### DECEMBER 5, 2024, THURSDAY

Last day for the County of Los Angeles to certify results for the General Municipal Election.

**Please note:** The City of Los Angeles only conducts Candidate Filing and Petition Filing activities for municipal elections.

\* The office will be closed on Thursday, November 23, and Friday, November 24, 2023, in observance of the Thanksgiving holiday.

\*\* Monday, February 19, 2024, is the last day to register due to the Presidents' Day Holiday.

†**Conditional Voter Registration:** Eligible Los Angeles County residents who miss an election's registration deadline can still vote at any Vote Center in L.A. County. Under California Election Law, Conditional Voter Registration (CVR) allows a prospective voter to conditionally register and cast a ballot.

**SALARY:** \$51,000.<sup>2</sup> for members of the Board of Education with outside employment [Charter Section 804].

Or

A Board Member who devotes his/her/their entire time to the duties of serving as a member of the Board of Education for the LAUSD and who accepts no compensation, fee, or honorarium from outside employment, shall be paid a full-time salary of \$127,000.<sup>2</sup>

**QUALIFICATIONS:** Registered voter of Los Angeles Unified School District at the time of nomination and election, and resident of the Board District since at least October 7, 2023 [Charter Sections 407(a) and 803].

## DECLARATION OF INTENTION

The first official step in running for office is to complete a Declaration of Intention to Become a Candidate form, which is furnished by the City Clerk. This is processed in the Election Division on the following dates:

**FILING DATES:** [Charter Section 421(a)]

First day - *Monday, November 6, 2023*

Last day - *Saturday, November 11, 2023*

(*Open 8 a.m. to 12 p.m.*)

(The office will be open on Veteran's Day, Friday, November 10, 2023.)

**Appointments are strongly recommended.**

### WITHDRAWING DECLARATION OF INTENTION

The Declaration of Intention to Become a Candidate may be withdrawn no later than *Saturday, November 11, 2023* [Charter Section 421(b)].

## NOMINATING PETITIONS

The second official step in running for office is to obtain and file a Nominating Petition. Petitions are issued only to the candidates or their representatives. The representative must have the candidate's written and signed request.

**ISSUE AND FILING DATES:** [Charter Section 422 (b)]

First day to issue/file - *Saturday, November 11, 2023*

(*Open 8 a.m. to 12 p.m.*)

Last day to issue/file - *Wednesday, December 6, 2023*

**Note:** The office will be closed on, Thursday, November 23, and Friday, November 24, 2023, in observance of the Thanksgiving holiday.

### SIGNATURES AND FILING FEE - ALL OFFICES:

Pursuant to Charter Section 422(a), each candidate shall do one of the following:

1. Pay a filing fee in the amount of \$300 and file Nominating Petitions on the form prepared by the City Clerk bearing at least 500 valid signatures;

Or

2. File Nominating Petitions on the form prepared by the City Clerk, bearing at least 1,000 valid signatures.

**\*\*\*FILING FEE IS NON-REFUNDABLE\*\*\***

### WITHDRAWING NOMINATION

Candidates may withdraw their Nominating Petitions no later than *Monday, December 11, 2023* [Charter Section 423].
