LAST DAY TO FILE NOMINATING PETITIONS

2024 PRIMARY NOMINATING ELECTION

LOS ANGELES (November 29, 2023) - Los Angeles City Clerk Holly L. Wolcott reminds all candidates for the 2024 Primary Nominating Election that the deadline to file their completed Nominating Petition, and a Supplemental Petition, if required, is Wednesday, December 6, 2023, at 5:00 p.m.

In order to appear on the March 5, 2024, ballot, candidates for Council Districts 2, 4, 6, 8, 10, 12, and 14, and Los Angeles Unified School District - Board of Education Offices 1, 3, 5, and 7, must file a Nominating Petition. When filing a Nominating Petition, each candidate must choose to either: a) pay a filing fee of \$300 and submit at least 500 valid signatures from registered voters within their applicable jurisdiction, or b) waive the filing fee and submit at least 1,000 valid signatures from registered voters within their applicable jurisdiction.

Candidates who initially do not meet the required number of qualified voters' signatures may file Supplemental Petitions. However, all Supplemental Petitions must be filed by the same deadline as Nominating Petitions, which is **Wednesday**, **December 6**, **2023**, **at 5:00 p.m**.

Nominating Petition filing will be available by appointment. Walk-ins will be accepted on a first come, first serve basis depending on availability. Candidates can schedule their appointments and obtain additional information by calling the Election Division or by visiting our website and selecting the "Municipal Elections" section on the City Clerk's website at: clerk.lacity.gov/elections.

The list of candidates who have filed a Nominating Petition is posted on the City Clerk's election website under "Municipal Elections - Nominating Petition Filing List." The list will be updated when Nominating Petitions have been processed.

The Office of the City Clerk administers candidate filing for the City of Los Angeles and the Los Angeles Unified School District. The City's Primary Nominating Election will be held Tuesday, March 5, 2024, and the General Municipal Election will be held Tuesday, November 5, 2024.
