CANDIDATE FILING DEADLINES FOR THE 2007 CITY OF LOS ANGELES COUNCIL DISTRICT 7 SPECIAL ELECTION

Los Angeles City Clerk Frank T. Martinez reminds all candidates that filing for the 2007 City of Los Angeles Council District 7 Special Election begins *Saturday, December 9, 2006*. To appear on the March ballot, candidates for the office of Los Angeles City Council District 7 must file a Declaration of Intention to Become a Candidate. *The deadline for filing the Declaration of Intention to Become a Candidate is 5:00 p.m. on Thursday, December 14, 2006*. During candidate filing, office hours are: Monday to Friday, 8:00 a.m. to 5:00 p.m. and Saturday, 8:00 a.m. to 12:00 p.m.

NOMINATING PETITION CIRCULATION BEGINS DECEMBER 9, 2006 AND ENDS DECEMBER 28, 2006

Saturday, December 9, 2006 is the first day candidates may <u>pick up</u> their Nominating Petitions and *Thursday, December 14, 2006* is the *first day* candidates may <u>file</u> their Nominating Petitions. *Thursday, December 28, 2006* is the *last day* to pick up <u>or</u> file Nominating Petitions. Nominating Petitions are available at the Office of the City Clerk – Election Division at 200 N. Spring St., Room 285, Monday through Friday from 8:00 a.m. to 5:00 p.m. and Saturdays from 8:00 a.m. to 12:00 p.m. You must have filed both a Declaration of Intention to Become a Candidate with the City Clerk - Election Division <u>and</u> a Statement of Economic Interests (Form 700) with the City Ethics Commission in order to receive nominating petitions.

Filing Fees and/or required signatures: All candidates must either pay a filing fee of \$300 and submit valid signatures of at least 500 but not more than 1,000 registered voters within the district, *or* waive the filing fee and submit valid signatures of at least 1,000 but not more than 2,000 qualified, registered voters within the district.
