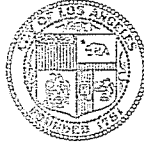
REQUESTS TO MAKE BALLOT ARGUMENTS REGARDING TWO PROPOSED BALLOT MEASURES

Los Angeles Interim City Clerk Karen E. Kalfayan announced that individuals wishing to be designated to write arguments related to the proposed City of Los Angeles Special Gang and Youth Violence Prevention, After-School and Job Training Programs Tax ballot measure or the Update of Low Rent Housing Authorization ballot measure should submit written requests to Council President Eric Garcetti no later than 2:00 p.m. on Monday, July 28, 2008. Council President Garcetti's letter and a form, which may be used to make requests, are attached.

The Rules and Government Committee will consider the designations at a special meeting on Tuesday, August 5, 2008 (time and location to be posted separately). Designated authors will be notified by the City Clerk and will be provided with the necessary forms and detailed instructions.

SUBJECT: BALLOT ARGUMENTS PERTAINING TO THE NOVEMBER 4, 2008 STATE GENERAL ELECTION

To Interested Parties:

The City Council has adopted ordinances calling a Special Election to be consolidated with the November 4, 2008 State General Election to be held on the same day to place the following measures on the ballot:

- City of Los Angeles Special Gang and Youth Violence Prevention, After-School and Job Training Programs Tax
- Update of Low Rent Housing Authorization

Section 605 (c) of the City Election Code specifies that the President of the City Council, with the approval of the Rules and Government Committee, may designate a person or association of persons to write arguments and/or rebuttal arguments for and against the adoption of any measure to be placed on the ballot. In making a designation, the President of the City Council shall give preference in the following order: (1) An elected officer of the City; (2) an appointive officer of the City; (3) bona fide associations of citizens; (4) individual voters.

Individuals wishing to be designated to write arguments related to the above measures should submit written requests to my office no later than 2:00 p.m. on Monday, July 28, 2008. A form letter, which may be used for this purpose is attached for your convenience. A copy of your request should also be forwarded to the Office of the City Clerk, City Hall, Room 395, Attn: Claudia Dunn.

The Rules and Government Committee will consider my designations at a special meeting on Tuesday, August 5, 2008. Designated authors will be notified by the City Clerk and will be provided with the necessary forms and detailed instructions.
