## LAST DAY TO FILE CANDIDATE DECLARATION OF INTENTION AND FIRST DAY TO FILE NOMINATING PETITIONS

**LOS ANGELES** (November 6, 2012) – Los Angeles City Clerk June Lagmay reminds all candidates running for office that the last day to file a Declaration of Intention to Become a Candidate for the 2013 City of Los Angeles Primary Nominating Election is **Saturday, November 10, 2012 at 12:00 p.m.** 

In order to appear on the March 5, 2013 Primary Nominating Election ballot, candidates for Mayor, City Attorney, City Controller, and Los Angeles City Council Districts 1, 3, 5, 7, 9, 11, 13 and 15; Los Angeles Unified School District Board of Education Districts 2, 4 and 6, and Los Angeles Community College District Board of Trustees Seats 2, 4 and 6 must file a Declaration of Intention to Become a Candidate, and submit a qualifying nominating petition.

Candidates who have filed their Declaration of Intention to Become a Candidate may obtain their nominating petitions **beginning Saturday**, **November 10**, **2012**. The period to file completed nominating petitions ends on **Wednesday**, **December 5**, **2012** at **5:00** p.m.

All candidates must file their Declaration of Intention and nominating petitions at the Office of the City Clerk - Election Division during the periods as noted below:
