**COMMUNITY FACILITIES DISTRICT NO. 9 (DOWNTOWN STREETCAR) SPECIAL ELECTION**  
**VOTING INFORMATION AND IMPORTANT DATES**

**LOS ANGELES** (November 7, 2012) — Los Angeles City Clerk June Lagmay reminds those living within the boundaries of the Community Facilities District No. 9 (Downtown Streetcar) that the deadline to register to vote for this all Vote-By-Mail (VBM) Special Election is **Monday, November 19, 2012**. The boundaries of the Downtown Streetcar District are roughly the area within the borders of Temple Street, Los Angeles Street, 14th Street/Pico Blvd, 110 Freeway, 5th Street, Grand Avenue and Olive Street. The Special Election will be held on **Monday, December 3, 2012**. Current registered voters within the boundary will start to receive their Official Sample Ballots (OSBs) and Voter Information Pamphlets (VIPs) starting approximately November 7, 2012. Ballots will be mailed out on November 13, 2012.

The purpose of the Downtown Streetcar Special Election is to submit to the qualified electors within the boundary the proposals necessary to establish the Downtown Streetcar; i.e., to incur bonded indebtedness in an amount not to exceed \$85 million, to levy a special tax within the Community Facilities District, and to establish an appropriations limit for the Community Facilities District in the amount of \$85 million.

For this all VBM election, voters may mail in their voted ballots, to be received no later than December 3, 2012, or vote in person at the Office of the City Clerk – Election Division, again no later than December 3, 2012. Please refer below for details and pertinent dates:
