CITY CALLS FOR REQUESTS TO MAKE BALLOT MEASURE ARGUMENTS 2013 PRIMARY NOMINATING ELECTION

LOS ANGELES (November 21, 2012) — Los Angeles City Clerk June Lagmay today announced that Council President Herb J. Wesson, Jr. is calling upon individuals and organizations who wish to write arguments concerning the two measures to appear on the City of Los Angeles March 2013 Primary Nominating Election ballot to submit requests to him **no later than 2:00 p.m. Tuesday**, **December 4, 2012**. Ballot arguments in favor of and against these measures will be published in the Voter Information Pamphlet which is mailed to all registered voters.

The City Council has voted to place on the March 2013 Primary Nominating Election ballot these two measures:

- **Proposition A** Neighborhood Public Safety and Vital City Services Funding and Accountability Measure.
- **Charter Amendment B** Fire and Police Pension Plan; Cost Neutral Purchases of Retirement Credit by Certain Members.

Council President Wesson will designate applicants from the request pool to be considered by the City Council's Rules and Elections Committee at its special meeting on Wednesday, December 5, 2012 at 8:30 a.m. Designated authors will be notified by the City Clerk and provided with the necessary forms and detailed instructions.

The attached letter from Council President Wesson further explains the ballot measure argument submission process. Also attached is the form to request to be the designated author of a ballot argument in favor of or against a measure.

SUBJECT: BALLOT ARGUMENTS: MARCH 5, 2013 CITY PRIMARY NOMINATING ELECTION

The City Council has adopted resolutions to place the following Ballot Measures before the voters on the March 5, 2013, City Primary Nominating Election:

Neighborhood Public Safety and Vital City Services Funding and Accountability Measure. Proposition A.

Fire and Police Pension Plan: Cost Neutral Purchases of Retirement Credit By Certain Members. Charter Amendment B.

Section 605(c) of the City Election Code specifies that the President of the City Council, with the approval of the Rules and Elections Committee, may designate a person or association of persons to write arguments and/or rebuttal arguments for and against the adoption of any measure to be placed on the ballot. In making a designation, the President of the City Council shall give preference in the following order: (1) an elected officer of the City; (2) an appointive officer of the City; (3) bona fide associations of citizens; (4) individual voters.

Individuals wishing to be designated to write arguments related to the above measures should submit written requests to my office no later than 2:00 p.m. on December 4, 2012. A form which may be used for this purpose is attached for your convenience. A copy of your request should also be forwarded to the Office of the City Clerk, City Hall, Room 395, Attention: Shannon Hoppes. Please note, elected officials and City employees submitting ballot arguments do so in their personal capacity.

The Rules and Elections Committee will consider my designations at a special meeting on Wednesday, **December 5, 2012 at 8:30 a.m**. Designated authors will be notified by the City Clerk and will be provided with detailed instructions and the necessary forms to proceed.
