RANDOM ALPHABET DRAWING TO DETERMINE ORDER OF CANDIDATES ON THE BALLOT

2013 PRIMARY NOMINATING ELECTION

LOS ANGELES (December 3, 2012) — Los Angeles City Clerk June Lagmay announced today that her office will hold a public drawing to determine the order that candidates for the 2013 Municipal Elections will appear on the March and May 2013 ballots. The drawing will be **on Monday, December 10, 2012 at 9:00 a.m.** in the Los Angeles City Council Chamber, located in Room 340 of Los Angeles City Hall. *Please note that this is a revised date* (see attached the updated 2013 General Information for Candidates pamphlet).

Pursuant to the City Election Code Section 313, the City Clerk conducts a public random drawing of the letters of the alphabet within five business days following the last day for filing nominating petitions. The sequence in which the letters are drawn will constitute the order that candidates' names will be listed under each office in the races for Mayor, City Attorney, City Controller, Los Angeles City Council, the Los Angeles Unified School District Board of Education, and the Los Angeles Community College Board of Trustees. The same order will be used for both the March 5, 2013 Primary Nominating Election and, if a runoff election is needed, the May 21, 2013 General Municipal Election.

The Office of the City Clerk - Election Division will certify and release the final list of candidates who have qualified to appear on the March 2013 ballot after all signatures on each candidate's nominating petition are verified. Final verification of signatures will be completed no later than Saturday, December 15, 2012.

MAY 14, 2013, TUESDAY

Last day to apply by mail for a Vote-By-Mail Ballot for General Municipal Election.

MAY 20, 2013, MONDAY

Last day to vote a Vote-By-Mail Ballot in the Election Division Office for General Municipal Election.

MAY 21, 2013, TUESDAY GENERAL MUNICIPAL ELECTION

JUNE 11, 2013, TUESDAY

Last day for official canvass and certification of results for General Municipal Election.

DECLARATION OF INTENTION

The first official step in running for office is to complete a Declaration of Intention to Become a Candidate form, which is furnished by the City Clerk. This is done in the Election Division on the following dates:

FILING DATES: First Day - Mon., November 5, 2012 [Charter Section 421(a)] Last Day - Sat., November 10, 2012 (Closes at noon on November 10th)

WITHDRAWING DECLARATION OF INTENTION

You may withdraw your Declaration of Intention to Become a Candidate no later than *Saturday*, *November 10*, *2012* [Charter Section 421(b)].

NOMINATING PETITIONS

The second official step in running for office is to obtain and file a Nominating Petition. Petitions are issued only to you or your representative. The representative must have your written and signed request.

ISSUE AND First Day – Sat., November 10, 2012 FILING DATES: Last Day – Wed., December 5, 2012 [Charter Section 422(b)] (Closes at noon on November 10th)

Note: The office will be closed on Veteran's Day, Nov. 12, 2012 and Thanksgiving holidays, Nov. 22 & 23, 2012.

WITHDRAWING NOMINATION

You may withdraw your nomination no later than *Monday, December* 10, 2012 [Charter Section 423].

SIGNATURES AND FILING FEE - ALL OFFICES: Pursuant to Charter Section 422(a), each candidate shall do one of the following:

1. Pay a filing fee in the amount of \$300 and file with the City Clerk a petition for nomination, on the form prepared by the City Clerk, bearing the signatures of no less than 500 and no more than 1,000 petitioners (500 signatures must be valid);

or

2. File a petition for nomination, on the form prepared by the City Clerk, bearing the signatures of no less than 1,000 and no more than 2,000 petitioners (1,000 signatures must be valid).

FILING FEE IS NON-REFUNDABLE

VALID SIGNATURES - WHERE OBTAINED:

MAYOR, CITY ATTORNEY and CITY CONTROLLER – from qualified, registered voters within the City of Los Angeles [Charter Section 422 (a)];

MEMBER OF LOS ANGELES CITY COUNCIL – from qualified, registered voters of the Council District in which you are running [Charter Section 422(a)];

MEMBER OF BOARD OF EDUCATION OF LOS ANGELES UNIFIED SCHOOL DISTRICT – from qualified, registered voters of the Board of Education District in which you are running [Charter Section 422(a)];

MEMBER OF BOARD OF TRUSTEES OF LOS ANGELES COMMUNITY COLLEGE DISTRICT – from qualified, registered voters within the Los Angeles Community College District [Education Code Section 5223].

FILING PETITIONS: Nominating Petitions must be filed at the Election Division office beginning Saturday, November 10* through Wednesday, December 5, 2012, between 8:00 a.m. and 5:00 p.m., Monday through Friday. All sections of your petition must be filed at the same time [Election Code Sections 111(b) and 310(a)].

SUPPLEMENTAL PETITIONS: If the petition is found to be insufficient prior to the deadline for filing petitions, you may file a supplemental petition. These petitions must be obtained from the Election Division. No supplemental Petitions are accepted for filing after the last day specified for filing Petitions – Wednesday, December 5, 2012 [Charter Section 422(c) and Election Code Section 310(j)].

OCCUPATIONAL DESIGNATION ON BALLOT

Candidates for office, other than the incumbent, may have printed on the ballot their principal professions, vocations, or occupations in **not more than three words.** No proper name, other than a geographic place name, may be used as part of the designation. Incumbents shall have printed on the ballot, at their option, the word "Incumbent" or the words designating their elective office [Election Code Section 306].

FORM 700 - STATEMENT OF ECONOMIC INTERESTS

All candidates shall file Statements of Economic Interests with the City Ethics Commission which itemize investments and interest in real property held by the candidate on the date of declaration of candidacy, and sources of income received during the 12 months prior to the date of filing.
