**FIRST DAY TO FILE CANDIDATE DECLARATION OF INTENTION  
AND OBTAIN NOMINATING PETITIONS**

LOS ANGELES UNIFIED SCHOOL DISTRICT (LAUSD), BOARD DISTRICT 1 SPECIAL ELECTION

**LOS ANGELES** (January 31, 2014) – Potential candidates for the LAUSD, Board District 1 Special Election will soon be able to take the first step to legally and officially declare their candidacy by filing a Declaration of Intention to Become a Candidate (DOI) with the Office of the City Clerk-Election Division. The DOI filing period begins on Monday, **February 10, 2014** at 8:00 a.m., and ends Tuesday, **February 18, 2014** at 5:00 p.m. Filing a DOI and submitting a qualifying nominating petition are required in order to appear on the June 3, 2014 LAUSD, Board District 1 Special Election ballot.

Candidates may pick up their nominating petitions after they file their Declaration of Intention (February 10, 2014 through March 7, 2014 as described above). However, the period to file completed nominating petition begins on Tuesday, **February 18, 2014** at 8:00 a.m., and ends Friday, **March 7, 2014** at 5:00 p.m.

To summarize, candidates for LAUSD, Board District 1 must file their Declaration of Intention and nominating petitions at the Election Division during the periods as noted below:

**Nomination Petition Filing Period:**

February 18 - March 7, 2014 \*
