#### **SUMMARY**

In the BOAC Resolution dated February 18, 2021, LAWA requests approval of an amendment to the Department's right-of-way agreement with SoCal Gas. LAWA reports that the right-of-way agreement allows for the construction of the Receiving Station- X Project and permanent rights for operation and maintenance of the new SoCal Gas infrastructure. Existing SoCal Gas infrastructure are located on LAWA property at the southeast corner of Pershing Road and Westchester Parkway. New utility connections to existing natural gas and other related utility services are needed to support operation of the proposed project. The proposed amendment allows SoCal Gas to relocate existing infrastructure so that it is not in conflict with the duct bank that needs to be installed for the project.

On February 18, 2021, BOAC approved the proposed amendment to the LAWA right-of-way agreement with SoCal Gas.

At its meeting held March 23, 2021, the Trade, Travel, and Tourism Committee recommended that Council approve the proposed amendment, as recommended by BOAC.

Recent news reports have shed light on the continued gender disparities between men and women college basketball players. Photos shown on social media comparing workout spaces between National Collegiate Athletic Association (NCAA) men's and women's training facilities are evidence of unequal treatment of college athletes. The players at the men's tournament have benefited from an enormous, wellstocked workout complex in downtown Indianapolis, Indiana. However, the women's teams, who will play their tournament in San Antonio, Texas, appear to have only a rack of hand weights and a few yoga mats.

The NCAA has apologized and further acknowledged an additional contrast between the two tournaments, which includes different methods of coronavirus testing for athletes. The method used at the men's event is the polymerase chain reaction (PCR) test, which is considered the gold standard of virus testing. It is highly accurate in detecting infections. The method for the women's tournament is a rapid antigen test, which is less expensive and provides swift results, but it is also more likely to yield false negatives.

Gender inequities are unacceptable and systems should be established to encourage sports corporations to adopt equitable pay and treatment of men and women in sports. Below are a few examples of the challenges women in sports have faced and overcome over time:

- In 1967, women were not allowed to enter the Boston Marathon. Kathrine Switzer entered that year as "K.V. Switzer" to hide her gender. She completed the race and women were officially allowed to enter the Boston Marathon in 1972 and the Olympics in 1984.
- In 1976, Chris Ernst, a two-time Olympic rower and captain of the Yale University women's crew, led 18 teammates to protest the lack of shower facilities at the athletic office. In protest, they stripped to their waists with the words "Title IX" drawn in blue marker on their backs and chests. In two weeks, the women rowers had new lockers and shower facilities.
- In 2007, after pressure from the tennis star Venus Williams, Wimbledon announced that women tennis players would receive prize money equal to men. Subsequently, Williams won \$1.4 million for her fourth Wimbledon victory, the same amount as the men's champion, Roger Federer.
- In 2017, the women's national hockey team announced that it would boycott the coming world championship if the U.S.A. Hockey Association did not increase women's wages. Less than two weeks later, the team reached a four-year agreement with the Association, which provided a \$2,000 training stipend per month, larger bonuses, and other benefits equal to the men's national team.

It is imperative that the City of Los Angeles explore its policy and legal options to ensure that any sporting event that requires a City permit abide by a gender equity policy that guarantees equal pay and compensation, comparable training facilities, transportation, and medical care.

I THEREFORE MOVE that the City Council instruct the Civil, Human Rights, and Equity Department and the Commission on the Status of Women, with the assistance of the City Attorney, to report to Council with options to establish gender equity policies in sports, a whistleblower program to expose unfair practices, and a process to encourage the hiring of more women as sports executives.

In 2020, the United States saw a nearly 150% national increase in hate crimes against members of the Asian-American and Pacific Islander ("AAPI") communities, which has sparked widespread safety concerns in Los Angeles, particularly among members of the AAPI communities who make up approximately 12% of the population of the City.

This rise in anti-AAPI violence has occurred consistent with a coordinated barrage of racist, anti-AAPI conspiracy theories related to the COVID-19 virus. The City of Los Angeles not only condemns anti-AAPI violence, but likewise condemns the anti-AAPI hate speech that, in large part, is responsible for inciting it.

The Civil + Human Rights and Equity Department, formed in December 2020, is charged with maintaining and strengthening the City's diversity, equity, and accountability, focusing on reducing bias and injustices. The Civil + Human Rights and Equity Department is in the best position to facilitate actions on behalf of the City to stop Asian hate, bias and discrimination.

I THEREFORE MOVE that the Civil + Human Rights and Equity Department be directed to coordinate with other City departments, including without limitation, LA Sanitation & Environment Department, the Department of Cultural Affairs, and Los Angeles Department of Transportation, to initiate a public messaging campaign, in collaboration with artists from the AAPI communities, against anti-AAPI hate speech.

On September 9, 2020, the Controller released a report, Meeting the Moment: An Action Plan to Advance Proposition HHH, which is currently being vetted by the Council's Personnel, Audits, & Animals Welfare Committee (Council File No. 20-1145). One of the recommendations of the report, is to amend the Adaptive Reuse Ordinance (Ordinances No. 172571 and 175038) to permit by-right Supportive Housing and Transitional Housing in adaptive reuse projects.

Proposition HHH, the Permanent Supportive Housing & Facilities Infrastructure Stabilization Ordinance (Ordinance No. 185523), Council File No. 17-0090-S1), was overwhelmingly approved by the voters in 2016, and authorized the city to issue up to \$1.2 billion in general obligation bonds to partially subsidize the development of up to 10,000 supportive housing units for individuals and families experiencing homelessness with the aim of reducing homelessness by acquiring, developing, or remodeling supportive housing and facilities, including transitional housing, restrooms, showers, health clinics and storage. Therefore, the goals of HHH were clear, to use HHH funds to support new affordable housing units, temporary shelters and service facilities, and also provided for a citizen oversight and a yearly financial audit by the City Controller.

In 2019, the Controller recommended reallocating funds to lower-cost projects and streamlined permitting. In the 2020 report, the Controller recommends that the city should focus on a viable plan that would spend available HHH dollars by constructing transitional housing and prioritize adaptive reuse. These latest recommendations are critical, inasmuch as the Controller further determined that homelessness in the city has jumped to 41,290 according to the 2020 Greater Los Angeles Homeless Count, up to 16 percent from 2019, and 45 percent since the passage of Proposition HHH in 2016.

While the Adaptive Reuse Ordinance may be used to facilitate the conversion of older, economically distressed or historically significant buildings from commercial office space into other residential uses, such as hotel rooms, live/work spaces, and apartment and condos, Supportive Housing and Transitional Housing are currently not defined as a 'project' or considered 'main uses' in the city's Municipal Code, and therefore, ineligible for adaptive reuse. The Planning Department and the Department of Building and Safety, need to explore the feasibility of amendments to the Adaptive Reuse ordinance to capture supportive and transitional housing as eligible conversion projects, inasmuch as the Department of Building and Safety already permits supportive and transitional housing as an accessory to the residential use.

I THEREFORE MOVE that the Council instruct the Planning Department, with the assistance of the Department of Building and Safety, and in consultation with the City Attorney, to prepare a report with recommendations as to the feasibility of amending the Adaptive Reuse Ordinance (Ordinances No. 172571 and 175038), as follows: (1) amend the definition of an Adaptive Reuse project in Municipal Code Section 12.22 A.26, to include Supportive Housing and Transitional Housing as eligible dwelling uses for conversion; (2) waive minimum Floor Area per dwelling unit, or guest room, for Supportive Housing and Transitional Housing developments; (3) allow the required number of offstreet parking spaces to be the same as the number of spaces that existed on the site, or reduced to the Supportive Housing, or Transitional Housing parking requirements; (4) allow by-right conversions of Supportive Housing and Transitional Housing through Adaptive Reuse projects citywide.

Los Angeles faces an unprecedented housing crisis that has contributed to an unprecedented homelessness crisis, in which tens of thousands of people suffer on our streets daily. As the deadly COVID-19 virus continues to spread, it is an urgent public health and moral priority that we provide shelter for people currently living on our streets using all available tools at our disposal.

The City has declared a shelter crisis due to the significant number of people experiencing homelessness in Los Angeles; this crisis requires both construction of new and acquisition of existing buildings that can be converted into supportive housing and transitional housing, which provide access to assistance and services for individuals and families who are homeless or at risk of experiencing homelessness.

The City's Comprehensive Homeless Strategy also includes identifying opportunities for adaptive reuse of existing private properties that are capable of being converted into Transitional and Supportive Housing, with special focus on hotels and motels. In response, in 2018, the City Council approved both the Interim Motel Conversion and the Permanent Supportive Housing Ordinances to reduce regulatory and procedural barriers to the production of affordable housing. Since 2018, the City has approved 42 PSH projects resulting in over 3,500 beds, with thousands more in the pipeline. This strategy to repurpose existing buildings has proved successful in providing greater flexibility to struggling building owners, while also meeting the goal to provide inexpensive, affordable housing options to address our housing crisis.

Early in the pandemic, the City, the County and the Los Angeles Homeless Services Authority quickly brought more than 7,000 vulnerable people indoors in a period of a few months. Project Roomkey, the central initiative of this effort, secured more than 4,000 rooms in 37 hotels between the City and County of Los Angeles, which served more than 6,000 people. While Project Roomkey provides urgent, interim housing, Project Homekey further seeks to acquire hotels and motels that can permanently convert to supportive housing.

As the City's economy recovers from the fallout of the COVID-19 pandemic, and tourism returns to Los Angeles, it is reasonable to expect that hotels will see more business. The City should explore options for adaptive reuse of existing buildings throughout the City that go beyond just hotels and motels. In particular, commercial office buildings could potentially be converted into housing. With more companies moving to remote work, it is also feasible that some commercial buildings will sustain vacancies into the next year. The City should consider whether underutilized office and commercial buildings could be reasonably converted into housing.

I THEREFORE MOVE that the City Council instruct the Department of City Planning, Department of Housing and Community Investment Development, and City Attorney, in consultation with the Department of Building and Safety and the Los Angeles Fire Department, to report back with feasibility of and recommendations for expanding the provisions of the existing Interim Motel Conversion Ordinance to existing commercial office buildings.

I FURTHER MOVE that the Council instruct City Attorney to prepare draft changes to the Motel Conversion Ordinance that would allow the repurposing or adaptation of commercial office buildings into supportive and <u>transitional housing</u> with supportive services.

WHEREAS, annual global production of plastic has reached 335,000,000 tons and continues to rise; the United States alone discards 30,000,000 tons each year; and

WHEREAS, projections estimate that by 2050, the mass of plastic pollution in the ocean will exceed the mass of fish; additionally, plastic negatively affects marine ecosystems and wildlife, as demonstrated by countless seabirds, turtles, and marine mammals dying from plastic ingestion or entanglement; and

WHEREAS, before 2017, the United States was sending 4,000 shipping containers full of waste to China every day, including two-thirds of the state's potentially recyclable materials. However, China has implemented the National Sword policy resulting in the loss of markets for low-value plastic packaging that was previously considered recyclable; and

WHEREAS, the loss of markets for recyclable material has added huge costs to local programs for the disposal and diversion of material; for many cities in the state, recycling has turned from a profitable business into an activity that impacts their budget and general funds; and

WHEREAS, SB 54 (Allen, Stern, and Wiener) seeks to address the crisis by establishing the Plastic Pollution Producer Responsibility Act which would prohibit producers of single-use, disposable packaging or single-use, disposable food service ware products from offering for sale or distribution such packaging or products on or after January 1, 2032, unless they are recyclable or compostable; and

WHEREAS, the proponents of SB 54 maintains that businesses selling products have a responsibility to ensure that their packaging and products are minimizing waste, including ensuring materials used are reusable, recyclable, or compostable; and

WHEREAS, the measure's intent is consistent with City efforts to minimize the impact of plastics in our local habitats and waterways; including the implementation of the Disposable Plastic Drinking Straws Ordinance and the Plastic Bag Ban;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 54 (Allen, Stern and Wiener), the Plastic Pollution Producer Responsibility Act, which would prohibit producers of single-use, disposable packaging or single-use, disposable food service ware products from offering for sale or distribution such packaging or products on or after January 1, 2032, unless they are recyclable or compostable.

## RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal government body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, because of the global climate crisis, it is imperative for the State of California to expand the diversity of renewable energy resources and storage solutions; and

WHEREAS, hydrogen, produced from non-fossil fuel sources, otherwise known as "Green Hydrogen", is a viable renewable and storage resource; and

WHEREAS, Senate Bill 18 (SB 18), introduced by Senator Skinner, does the following:

- Defines Green Hydrogen;
- Adds green hydrogen to the state's clean energy and climate planning, through both the Integrated Resources Plan (IRP), which outlines how utilities will integrate clean resources into the state's electricity mix, and CARB's Scoping Plan, which outlines how the state plans to meet its GHG emissions reductions goals;
- Expands on SB 100 (DeLeon, 2017), which required California to use 100% zero-carbon electricity by 2045, by allowing green hydrogen to be considered a zero-carbon resource;
- Directs the PUC to include Green Hydrogen in any future energy storage procurement directives, and to ensure that green hydrogen is on equal footing with other storage options for purposes of Resource Adequacy planning and procurement; and

WHEREAS, SB 18 advances Green Hydrogen by requiring the California Air Resources Board (CARB) and other state agencies to start planning so that California can take full advantage of Green Hydrogen; and

WHEREAS, the Los Angeles Department of Water and Power (LADWP) is undertaking an unprecedented project to store and use hydrogen as a fuel at its Intermountain Power Project (IPP) facility in Delta, Utah; and

WHEREAS, with unique resources at its disposal, IPP represents a first-of-its-kind opportunity for the western energy grid. Any project at IPP will benefit from the availability of renewable resources, transmission resources, and underground storage capabilities; and

WHEREAS, by adding Green Hydrogen to the State's resource mix of renewable energy and storage, SB 18 will allow LADWP to more expeditiously meet, and possibly exceed, the renewable energy and storage requirements of SB 100.

NOW, THEREFORE, BE IT RESOLVED, that by adoption of this Resolution, with the concurrence of the Mayor, the City of Los Angeles hereby, in its 2021-2022 State Legislative Program takes the position of SUPPORT for SB 18 (Skinner).

WHEREAS, the 2020 Greater Los Angeles Homeless Count identified more than a 16 percent increase in homelessness, raising the new total to more than 41,000 unhoused residents in the City, and this estimate comes prior to the COVID-19 pandemic, which has exacerbated the homelessness crisis; and

WHEREAS, this double digit increase in homelessness underscores the need for more decisive action and intergovernmental partnerships to address homelessness in Los Angeles; and

WHEREAS, the Los Angeles Times previously reported on a study from 2017 that found that one in every five Los Angeles Community College District students is experiencing homelessness, and that these students would greatly benefit from temporary or permanent housing, or a safe parking intervention appropriately located on Los Angeles Community College District property; and

WHEREAS, the Community College District owns several underutilized properties within their system that could be used for temporary and long term use for homeless programs; and

WHEREAS, current State law limits the ability of community college districts to best utilize their property and facilities; and

WHEREAS, currently pending in the California State Senate is SB 330 (Durazo), which would authorize community college districts to enter into joint occupancy agreements with a private person, firm, or corporation to provide students and employees with affordable housing; and

WHEREAS, the bill would permit the Los Angeles Community College Board of Trustees to provide housing and services to students experiencing homelessness, as previously requested by Resolution (O'Farrell-Martinez, C.F. 21-0002-S2);

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for SB 330 (Durazo), which would authorize community college districts to enter into joint occupancy agreements with a private person, firm, or corporation to provide students and employees with affordable housing.

### RESOLUTION

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, AB 1400 (Kalra), introduced on February 19, 2021, would establish a single payer health care system called the California Guaranteed Health Care for All program (CalCare) to cover all Californians; and

WHEREAS, despite gains made with the Affordable Care Act, 2.7 million Californians remain uninsured while another 12 million, comprising one-third of Californians with medical insurance, cannot afford their insurance co-pays or deductibles so are underinsured, and 5.2 million Californians lack dental insurance; and

WHEREAS, the COVID pandemic has exposed the instability and unsustainability of the current profit driven health system, with historic unemployment forcing many Californians to lose their employer sponsored health insurance at the same time hospitals have laid off thousands of doctors and nurses; and

WHEREAS, even after COVID, inadequate access to health care will increase preventable disease, erode trust in the medical establishment, and magnify trauma and mortality in the event of another public health crisis; and

WHEREAS, AB 1400 (CalCare) would enshrine health care as a human right by guaranteeing comprehensive, lifetime, high-quality care to all California residents, and establish a health care cost control system; and

WHEREAS, CalCare would provide every California resident freedom in their choice of providers and guarantee health care free at the point of service for all necessary medical care including prescription drugs; hospital, surgical, and outpatient services; primary and preventive care; emergency services; reproductive care; hearing, dental and vision care; and long-term care; and

WHEREAS, CalCare would save millions in taxpayer dollars now spent on premiums and administrative bureaucracy that provide often inadequate coverage for government employees, and would ease the burden on municipal resources for handling the emergency needs of uninsured residents; and

WHEREAS, federal policy empowers states, as laboratories of democracy, to use Affordable Care Act innovation waivers to develop locally tailored approaches to health coverage, including by removing barriers to states that seek to implement universal single-payer approaches;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 1400 (Kalra), which would create the California

Guaranteed Health Care for All program, or CalCare, to provide comprehensive universal single-payer health care coverage and a health care cost control system for the benefit of all residents of the state.

# **BUDGET & FINANCE**

### MOTION

The effects of the COVID-19 pandemic on the small business community in the City of Los Angeles have forced business owners to function at limited capacities, or to shut their doors entirely, to comply with public health requirements. The revenue shortfalls have been significant, and business recovery from those revenue losses will be slow as they reopen at limited capacities.

An area of immediate concern for retaining these struggling businesses is the annual business tax payment requirement by the City. The Office of Finance (Finance) processed 164,629 business tax payments for the 2020 tax period. This year, Finance has processed 103,836 payments; however, there is a significant number of businesses that have not made any payments due to their revenue losses. Finance does provide small businesses with an option to enter into an agreement for payment installments; however, the appropriate threshold for repayment (\$1000 minimum) must be met. There are approximately 16,000 small businesses in the City of Los Angeles that were unable to meet the minimum threshold to enter that agreement, still have yet to pay their basic required fees, and have been accruing penalty fees.

I THEREFORE MOVE that the Council REQUEST that the City Attorney, with the assistance of the Office of Finance, draft an ordinance to provide the following relief:

- 1. Lower the threshold for a business to enter into a payment installment agreement with the City from \$1000 to \$300.
- 2. Eliminate the interest for monthly business tax installments for businesses that have elected to pay their business tax via the installment plan.
- 3. Extend the business tax deadline to 2/28/2022 for the fund/classes that pay non-GRT tax and have been forced to stay closed due to the City's SAH order

4. Extend the LAPD and LAFD permit renewal fee deadlines to 6/30/2021.
