<u>Financial Policies Statement:</u> The CAO reports that the recommendations in this report comply with the City's Financial Policies as the recommended transactions are required to achieve and maintain a structurally balanced budget.

<u>Debt Impact Statement:</u> The CAO reports that the issuance of Municipal Improvement Corporation of Los Angeles (MICLA) debt is a General Fund obligation. The issuance of MICLA for the Fire Fleet Replacement Equipment approved in the 2020-21 City Budget will cause the City to borrow approximately \$15.0 million at an approximate 5.5 percent interest rate over 10 years. The total estimated debt service is \$19.9 million, including interest of approximately \$4.9 million. During the life of the bonds, the estimated average annual debt service is \$2.0 million over ten years.

In accordance with the City's Debt Management Policy, the City has an established debt ceiling to guide in evaluating the affordability for future debt. The debt ceiling for non-voted direct debt as a percentage of General Fund revenues is 6.0 percent. The City is currently at 3.13 percent for 2020-21. The issuance of debt for the projects is already included in the debt ratio.

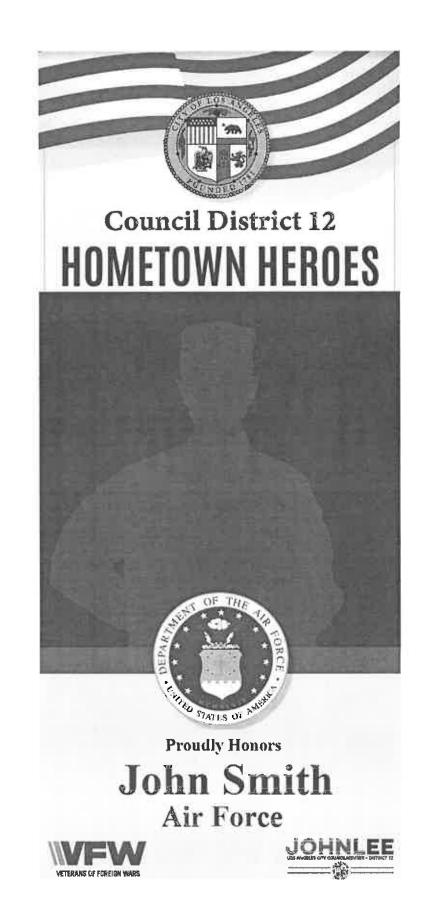

Since 2013, CalEnviroScreen has been used by the State to identify which communities in California suffer most from the cumulative burden of pollution and socioeconomic vulnerability. It does this by accounting for multiple sources of pollution in and around neighborhoods as well as the demographic characteristics of residents. The tool has routinely shown that communities in the city of Los Angeles, particularly the Northeast San Fernando Valley, South LA, Boyle Heights, and the Harbor Area are some of the most polluted in the state.

CalEnviroScreen is increasingly used to make policy and funding decisions. Many state programs, particularly the Greenhouse Gas Reduction Fund, require neighborhoods to meet a certain CalEnviroScreen score threshold in order to be eligible for funding. CalEnviroScreen is also used or cited by wide array of funders and policy makers outside of the state government.

For this reason, it is imperative that the environmental conditions in Los Angeles area be adequately reflected in CalEnviroscreen and that the city is prioritized for funding. As the state's largest city and one of the most pollution burdened regions, Los Angeles must engage with the State on the update of CalEnviroScreen.

I THEREFORE MOVE that the Chief Legislative Analyst and the Bureau of Sanitation prepare a comment letter to the California Office of Environmental Health Hazard Assessment on the Draft CalEnviroScreen version 4.0. This letter should address whether the environmental justice issues and demographic conditions in Los Angeles are adequately reflected in the tool. It should also urge the State to prioritize California's most pollution burdened areas for funding.

WHEREAS, Any official position of the City of Los Angeles, with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, SB 57 (Wiener), introduced on December 7, 2020, would allow Los Angeles County, City and County of San Francisco, and the City of Oakland to authorize the operation of an Overdose Prevention Program (OPP), also known as a Supervised Injection Services Program, for adults that satisfy specified requirements; and

WHEREAS, Overdose Prevention Programs would create a space where medical staff could monitor a patient's use of controlled substances, thereby mitigating the public health risks of communicable diseases and overdose deaths; and

WHEREAS, Drug overdose continues to be a leading cause of accidental death in California; and in January 2021, the LA County Department of Public Health co-released a report titled, *Recent Trends in Mortality Rates and Causes of Death Among People Experiencing Homelessness in Los Angeles County*, with the Department of the Medical Examiner-Coroner, the Departments of Health Services and Mental Health, the LA County CEO Homeless Initiative, and the Los Angeles Homeless Services Authority to launch a homeless mortality prevention initiative (HMPI); and

WHEREAS, Page 16, recommendation # 9 in the aforementioned report makes the recommendation to support Overdose Prevention Program legislation at the state level amongst a list of policy recommendations and to implement an OPP in LA County to better address the needs of individuals with substance use disorders and those experiencing homelessness, as OPP can serve as an important engagement opportunity for high-risk populations; and

WHEREAS, Across the County of Los Angeles, the percentage of overdose deaths involving fentanyl, a powerful synthetic opioid, tripled between 2018 and 2020. In the first seven months of 2020, the overdose rates for individuals experiencing homelessness in Los Angeles County saw an increase of 33.2% from January to July alone, illustrating the need for a significant public health intervention; and

WHEREAS, In 2010, nearly 4,000 new cases of HIV were attributed to unsafe injections, and heroin overdose mortality in the United States nearly tripled between 2010 and 2014; and

WHEREAS, A recent study projects that Overdose Prevention Programs, like the ones proposed by SB 57, could save jurisdictions \$3.5 million annually per site by reducing the incidence of HIV and Hepatitis C and increasing the number of people entering treatment; and

WHEREAS, Similar supervised Overdose Prevention Programs have expanded around the world and have resulted in decreases of injection-related harms among intravenous drug users. Vancouver is one example, where overdose rates decreased by 35% following the opening of one supervised injection site; and

WHEREAS, The 2020 Greater Los Angeles Homeless Count showed 66,436 people in Los Angeles County experiencing homelessness, a 12.7% rise from the 2019 point-in-time count; and

WHEREAS, Homeless populations face increased risk with regard to health risks surrounding controlled substance use, including overdoses and communicable diseases, evidenced by the Los Angeles County Department of Public Health data showing that 926 homeless people died in the county in the first seven months of 2020, a 26% increase over the same period the previous year--with nearly 30% of those deaths caused by drug overdoses in 2020; and

WHEREAS, The City of Los Angeles is well-positioned to be one of the jurisdictions to pilot and evaluate health programs that have proven effective in reducing the number and rate of fatal drug overdoses, as well as reducing emergency room use and hospitalizations related to drug overdose; and

WHEREAS, SB 57 is consistent with the movement away from the criminalization of mental health and substance use disorders and the criminalization of homelessness, in favor of public health approaches;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby: includes in its 2021-2022 State Legislative Program SUPPORT for SB 57 (Wiener) which would allow the City of Los Angeles and the County of Los Angeles to open Overdose Prevention Program sites in an effort to reduce overdoses and communicable diseases and partner those sites with medical and health professionals to offer counseling and services; and SEEK AMENDMENT to include the City of Los Angeles in the list of jurisdictions authorized to operate an Overdose Prevention Program.

WHEREAS, Assembly Bill 585 (Rivas) would establish the Extreme Heat and Community Resilience Program and require the Office of Planning and Research to administer the program; and

WHEREAS, AB 585 (Rivas) would require the Office of Planning and Research to coordinate the state's efforts to address extreme heat and facilitate the implementation of local, regional, and state climate change planning into effective projects through awarded grants; and

WHEREAS, AB 585 (Rivas) would establish the Extreme Heat and Community Resilience Fund in the State Treasury and moneys in the fund would implement the Program;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 585 (Rivas) which would establish the Climate change: Extreme Heat and Community Resilience Program in order to mitigate the impacts of climate change, extreme heat and reduce greenhouse gas emissions.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, California has an unprecedented shortage of housing. According to California Housing Partnership Corporation, 1,299,120 low-income renter households in California do not have access to an affordable home; and

WHEREAS, one observer and researcher of the Great Recession found that foreclosed properties in the urban core and inner-ring suburbs of the Los Angeles region were much more likely to be purchased by corporate investors rather than owner-occupants, signaling a longer-term transfer of wealth out of the hands of Black and Latino communities by and into those of real estate investors that were able to sweep up foreclosed properties during the Great Recession; and

WHEREAS, currently, 500,000 properties in California are owned by corporations, and over 250,000 properties are owned by entities that own 10 or more properties; and

WHEREAS, 67% of rental units in Los Angeles are owned by investment vehicles according to a recent report by Strategic Action for a Just Economy (SAJE); and

WHEREAS, growing research suggests that large corporate landlords are more likely to acquire available homes, raise rents, evict tenants, and operate rental units with habitability issues, as compared to smaller mom and pop landlords; and

WHEREAS, tenants, tenant advocates, and local officials often report that they do not know who truly owns their home or a particular property in the community, because owners hide behind Limited Liability Corporations and similar legal structures, despite the fact that property records and ownership have been historically transparent in America for the good of the public. The rise of LLCs and other legal entities has made it harder for tenants to know who owns their home and how to address problems, as well as making it harder for law enforcement agencies to investigate and prosecute crimes, such as money laundering; and

WHEREAS, COVID-19 has created physical, emotional and financial distress for millions, with the federal Consumer Financial Protection Bureau finding that 11 million Americans are worried about imminent foreclosure or eviction for failure to make housing payments; and

WHEREAS, nearly one-fifth (17%) of renters in California — over 2 million families — were behind in their rent payments as of the beginning of January 2021; and

WHEREAS, recent analysis by Neighborhood Housing Services of LA County and the UCLA Center for Neighborhood Knowledge found that compared with non-Hispanic Whites, African American households experienced more pandemic job losses resulting in financial difficulties in paying for usual household expenses, are nearly one and a half times as likely to have difficulty paying a mortgage, feel less financially secure about the immediate future and are over twice as likely to have low confidence in meeting next month's mortgage payments. Further, the foreclosure notice rate is over one and a half times as great in Black neighborhoods. The paper concluded that thousands of African Americans will lose their homes if no actions are taken; and

WHEREAS, currently pending before the California State Assembly is AB 1199 (Gipson) which would require disclosure to the Secretary of State's Office of the beneficial owners of a corporation, Limited Liability Company, Limited Partnership, Trust, or any other similar entity that owns property in California; and

WHEREAS, these disclosures would include the number of units for each qualified property owned by such corporations, Limited Liability Companies, Limited Partnerships, Trusts and similar entities entity in the previous calendar year that were offered for rent or lease; and

WHEREAS, AB 1199 would require the Secretary of State to create a searchable database, updated annually, on the Secretary of State's internet website, with the information provided by such corporations, Limited Liability Companies, Limited Partnerships, Trusts and similar entities; and

WHEREAS, AB 1199 would further create an excise tax on large corporate landlords that own 10 or more single family properties, or 25 or more single and multifamily properties, in this state during the calendar year, in order to discourage the further consolidation and commodification of single family homes, to create opportunities for families to purchase homes and build wealth, and to fund essential services. It is the intent of the Legislature to enact legislation that would increase the tax rate based on the overall number of properties and if the landlords receives a certain number of code violations issued by the building department or health department of a city or county; and

WHEREAS, the revenue generated from this excise tax would be disbursed into The Homes for Families Fund which shall be created in the State Treasury, and where the dedicated and eligible uses of the funds would include: rental assistance and relief for California tenants; support for legal services to prevent evictions, harassment, and violations of law by landlords; providing services and programs for persons experiencing homelessness; supporting the preservation and production of affordable housing, housing counseling services to promote home ownership; job training apprenticeship programs: and support for landlords that own fewer than 10 properties and have lost rental income from tenants due to COVID-19.

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2020-2021 State Legislative Program SUPPORT for AB 1199 (Gipson) which would create transparency relating to property ownership in the state, and impose a tax on larger corporate landlords with revenue generated from the tax going to support critically needed services such as homebuyer education, tenant and mom and pop landlord relief, homeless prevention, and job training apprenticeship programs.

WHEREAS, parents should be able to leave their children with youth-serving organizations without the fear that their children may be subjected to abuse while in the care of such an organization;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 506 (Gonzalez), which would require youth-serving nonprofits to establish policies that protect children from abuse, including background checks and training, in order to receive insurance coverage; and mandate long-term volunteers who supervise children to report abuse.

WHEREAS, AB 525 can assist in providing a secure, reliable, and affordable renewable energy source to serve the needs of Californian's and improve air quality in a variety of communities throughout the State;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT for AB 525 (Chiu) that seeks to develop a strategic plan to implement at least 10,000 megawatts of offshore wind energy developments installed off the California coast by 2040, with an interim target of 3,000 megawatts installed by 2030.

MOTION

After the passage of the City of Los Angeles' Premium Hazard Pay for On-Site Grocery and Drug Retail Workers Ordinance, (the Ordinance), Ralphs Grocery Co. and Food 4 Less have announced the closure of three allegedly underperforming stores within the City of Los Angeles. During the public debate prior to the passing of the ordinance, there were threats that the passage of the Ordinance could force the closure of stores due to the cost. After the passage of the ordinance, the message from store representatives was that these closures had been long planned, adding claims that these stores were losing millions of dollars per year. These companies and their parent company, the Kroger Co., have offered the same explanation for closure of stores in other jurisdictions that have enacted similar hazard pay ordinances.

Ralphs and Food 4 Less are the only stores that have announced closures in the aftermath of the Ordinance, yet other grocery stores may be contemplating similar action. Additionally, there are markets which have recognized the hardship and sacrifices of their workers during the pandemic, and we should also examine their practices.

The City has an interest in considering whether it should take legislative action to address these closures and potentially future closures of other grocery stores especially in areas of the City that are commonly known as Food Deserts. In order to do so, the City Council should seek information from the grocery stores and their executive management to better understand their actions and inform the City Council on ways that might protect the City and its residents from the consequences of these types of closures.

I THEREFORE MOVE that, in order to evaluate future legislative action, the City Council exercise its authority under Charter Section 217 and any other applicable laws, including its authority to examine witnesses and compel the attendance of witnesses and the production of evidence, to determine, among other things, the reasons why the Kroger Co., Ralphs Grocery Co. or Food 4 Less have closed these stores.

I FURTHER MOVE that, CLA and City Clerk, with the assistance of the City Attorney, be instructed to formally request the appearance of executives of a number of stores within 30 days, and if they decline appear, issue subpoenas as authorized in the City Charter and any other applicable laws.

I FURTHER MOVE the outcome of these hearings should be to help shape future legislative policy regarding worker protections, essential services in long-neglected communities, and strategies to address Food Deserts.
