Approval of the recommendations in this report will extend the FY 2016 Program to Prepare Communities for CCTA Grant performance period and related agreement term limits through May 31, 2022 to continue support for grant objectives. Due to COVID-19 related cancellation and delays of training plans, existing grant funding will also be modified for various grant agreements. The agreement with vendor Sensemakers, Inc. will be increased by \$3,896 from \$120,000 to \$123,896 to resume planning meetings, and the subrecipient agreement with Orange County will be reduced by \$95,973 from \$280,000 to \$184,027 as a result of cancelled trainings. Of the \$95,973, \$50,000 will be reprogrammed to the LAPD to develop FY16 CCTA exercises. The remaining amount of \$45,973 is pending reallocation.

#### MOTION

Since its launch in 2019, Westside Fast Forward has advanced key mobility solutions for Westside residents and commuters. Projects have benefited every neighborhood and every mode of transportation, from new mobility options like bike share and microtransit to new turn signals and crosswalks. Major transit construction projects like the Purple Line Extension, LAX Automated People Mover, and the Sepulveda Transit Corridor have achieved critical milestones toward connecting the Westside with the rest of the Los Angeles region. These are the alternatives that a city of forward-looking people demand and deserve.

Westside Fast Forward includes dozens of critical signal and intersection improvements in Council Districts 5 and 11 that will help move people more efficiently and safely. These projects were selected based on constituent requests and LADOT traffic and safety data. Ten new locations require funding in order to install left-turn phasing, enhanced pedestrian crosswalks, and/or entirely new signals. Westside Fast Forward also includes larger bicycle, pedestrian, and first/last mile projects connecting neighborhoods and destinations that require funding for planning, engineering, community engagement, and/or construction. There is sufficient funding available in special accounts that are designated specifically for transportation projects on the Westside, from special fees collected on developments on the Westside.

I THEREFORE MOVE that the City Council authorize the Department of Transportation (LADOT) to appropriate funding to implement the following mobility and safety projects as part of the Westside Fast Forward Initiative, as follows:

- \$4,151,750 within the Coastal Transportation Corridor Specific Plan (CTCSP) Fund 447 from available cash balance to a new account entitled "Westside Fast Forward Phase II Traffic Signals Project-Coastal;"
- \$600,000 within the Coastal Transportation Corridor Specific Plan (CTCSP) Fund 447 from available cash balance to a new account entitled "Westside Fast Forward Neighborhood Network Project-Coastal;"

### MOTION

The legacy and impact of John Lewis presents several lessons in our work to reimagine a more equitable Los Angeles. From student activist to elder statesman, longtime Congressman John R. Lewis continuously led the charge for racial and social equity. For more than three decades, he encouraged our nation's youth "to get into good trouble" and he modeled how to achieve it.

As the son of sharecroppers and a student of nonviolence, his personal history parallels that of the civil rights movement. At the age of 16, John Lewis applied for a library card from the local Pike County Library in Troy, Alabama, but was refused because of his race. Sadly, he never returned to Pike County library until 40 years later, in 1998, for his own book signing, Walking in the Wind: A Memoir of the Movement.

A disciple and colleague of Dr. Martin Luther King Jr., he was among the original 13 Freedom Riders who challenged segregated interstate travel in the South in 1961. As the founder and early leader of the Student Nonviolent Coordinating Committee, he was on the frontlines of the "Bloody Sunday" voting rights protest in Selma, Alabama. He also coordinated lunch counter sit-ins, many times against the blows of angry mobs and violent attacks, challenging racial segregation and other indignities of second-class citizenship.

More than a half century later, after the killing of George Floyd and countless other victims, barriers still remain in our fight to achieve equity. Racism, police brutality and inequality continue to disadvantage to African Americans and other ethnic groups, preventing communities of color from achieving their full potential.

In the wake of the deep civil unrest that gripped our nation in the Summer of 2020, Meg Deloatch, creator and executive producer, and her fellow writers for the Netflix show, Family Reunion, began sharing these painful stories related to racial profiling and other difficult topics. Many of the story lines in Family Reunion, now in its second season, seek to recognize and share the diverse, multi-generational histories of Black lives.

In remembrance of the late Representative John Lewis, a painting of the Congressman, as seen in the Black Lives Matter Plaza, in Washington, DC, will be featured in forthcoming episodes. The painting marks one of his last public appearances before his death, amid nationwide protests over the death of George Floyd.

In commemoration of his leadership and advocacy, the Netflix has proposed donating the painting that will be featured in the show to the Los Angeles Public Library.

Representative John Lewis' remarkable life journey is a salient reminder for us all to remain committed and resilient in the push for change. His life offers important lessons for contemporary generations on how to confront racial violence and transform American democracy. To honor his legacy, we must all continue to "get in good trouble, necessary trouble, and redeem the soul of America". The opportunity to view his portrait at the Los Angeles Central Library will be a notable reminder of his life and work.

I THEREFORE MOVE that the Los Angeles Public Library be authorized to accept the gift by Netflix of a painting of Congressman John Lewis, and to thank the donor on behalf of the City."

#### MOTION

The COVID-19 Pandemic has taken a huge toll on local businesses and the tourism industry. All across the county, businesses were forced to close in order to stop the spread of the SARS-COV-2 virus. El Pueblo, the cultural and historical center of the City, was particularly hard hit as its customer base is driven by people's ability to travel and sight-see. The merchants' doors have remained shuttered for almost a year and business is only beginning to pick back up again.

To ensure that the merchants at El Pueblo would not go out of business, the City has taken previous actions (C.F. Nos. 19-0600-S180 and 20-0882) to subsidize El Pueblo's operating budget with General Fund dollars and to waive merchant rent payments from July 1, 2020 to December 31, 2020.

In light of the current pace of economic recovery, the merchants' inability to pay rent has continued throughout fiscal year 2020-21, and similarly, the General Fund has continued to subsidize the Department's operating budget to offset these revenue losses. Council action is now needed in order to waive rent payments for the period January 1, 2021 through June 30, 2021. This action will have no additional General Fund impact, inasmuch as the Department's revenue shortfall has been addressed in the financial status reports and the fiscal year is about to close. Further, the Department is on schedule to repay a Reserve Fund loan authorized in the Mid-Year Financial Status Report by the year-end.

I THEREFORE MOVE that the Council authorize the El Pueblo de Los Angeles Historical Monument to waive rental payments for El Pueblo de Los Angeles Historical Monument merchants for the period January 1, 2021 through June 30, 2021.

I FURTHER MOVE that any rent previously paid for the period January 1, 2021 through June 30, 2021 shall be credited towards future rent due.

I FURTHER MOVE that the City Attorney be requested to modify any contracts with El Pueblo merchants to effectuate the aforementioned rental waiver.

# MOTION

California Governor Gavin Newsom recently announced a \$100 billion California Comeback Plan that includes a \$12 billion investment to address homelessness. There are significant investments in homelessness prevention, rental support, new housing opportunities for people at risk of homelessness and for homeless families, and grants to local governments to transition the homeless to more stable housing. Additionally, the Plan includes a \$1.5 billion investment to clean public spaces near highways and transform public spaces through arts and cultural projects. This clean-up initiative is expected to create an estimated 15,000 jobs, including for people experiencing or exiting homelessness, at-risk youth, veterans, and formerly incarcerated individuals.

I THEREFORE MOVE that the Chief Legislative Analyst and City Administrative Officer be directed to report on the \$100 billion California Comeback Plan, including the State's \$1.5 billion investment to clean public spaces near highways, and identify the amounts of funding and planned expenditures from the \$100 billion that will benefit the City of Los Angeles.

In March 2020, the Los Angeles City Council adopted an Ordinance that temporarily prohibits evictions of residential and commercial tenants for failure to pay rent due to the COVID-19 pandemic. Residential tenants have up to 12 months following the expiration of the local emergency period to repay any past due rent. The local emergency period is March 4, 2020 to the end of the local emergency as declared by the Mayor. The Ordinance does not eliminate any obligation to pay lawfully charged rent. Under the City's Ordinance, renters are afforded more protections than those provided under State law, as well as the federal eviction moratorium ordered by the Director of the Centers for Disease Control and Prevention.

According to a Housing Community and Investment Department (HCID) survey that queried participants in the City's rental assistance program, approximately 67 percent of respondents reported that they were behind in rent. Estimates of the average amount of rent owed ranged from \$4,200 to \$7,000. Nearly 278,000 renter households in the City earn less than 30 percent of the area median income and even with 12 months to pay, these households will be severely burdened with paying their back rent.

The City of Philadelphia's Eviction Diversion Program enables landlords and tenants to arrive at an agreement that works for both parties, without having to go to court. The program is designed to assist landlords with tenants who have had difficulty paving rent due to a COVID-19 related hardship. Benefits of diversion and mediation include helping tenants avoid an eviction, while also helping landlords avoid vacancies and unit turnover costs. The Philadelphia Municipal Court recently ordered that landlords cannot file an eviction action until they first apply for rental assistance with the city's Emergency Rental Assistance program. Upon completing the application, the landlord will be automatically enrolled in the Eviction Diversion Program as well. This novel approach seeks to divert eviction actions towards existing rental assistance programs and mediation. This type of program should be studied to determine the feasibility of implementing a similar program in Los Angeles.

I THEREFORE MOVE that the Housing and Community Investment Department be directed to study the feasibility of implementing an eviction diversion program modeled after the City of Philadelphia program, in which landlords are required to access rental assistance and mediation before they are permitted to file an eviction action.

#### MOTION

Chlorine, the chemical that kills bacteria and keeps water clean, is in short supply due to a fire at a chemical plant in Louisiana last August that was damaged by Hurricane Laura. Chlorine is used to prevent and kill algae. More importantly, it also helps protect swimmers from waterborne illnesses by preventing pools from becoming a hotbed for mosquitos.

As the summer pool season is poised to begin, pool owners should brace for a price jump of about 58% from June through August, compared with the same period a year earlier, according to IHS Markit data cited in a Goldman Sachs report on the chlorine shortage. Not only is a price jump concerning, but the potential lack of chlorine will hinder efforts to maintain water cleanliness as the summer season approaches.

The City must take steps to educate pool owners about the chlorine shortage, identify alternatives for pool owners to keep their pools sanitary, and other possible solutions to this health and safety issue.

I THEREFORE MOVE that the Bureau of Sanitation be directed and the Department of Water and Power be requested to report on mitigating alternatives for water quality in light of the chlorine shortage to assist pool owners in the City of Los Angeles.

Los Angeles is home to the largest concentrations of Central American individuals from outside of their respective countries. Coupled with inhumane actions from the previous presidential administration, a sudden spike in migration led to thousands awaiting asylum hearings at the southern US border, with some eventually finding their way to cities and towns nationwide. In 2019, the Council adopted motion O'Farrell-Wesson (CF: 19-0777), directing the Housing and Community Investment Department (HCID) to report on the shelter and housing needs facing unaccompanied minors in the City that have been held in custody through the Office of Refugee Resettlement (ORR).

On January 13, 2020, HCID issued a report which outlined a recommendation to award a sole source contract to the Salvadoran-American Leadership and Education Fund (SALEF), due to the specific expertise required to effectuate the intent of the City. The SALEF pilot program is aimed at keeping transition aged youth, defined as between the ages of 16-24 years old, who have been processed through the Office of Refugee Resettlement

The Office of Refugee Resettlement states that approximately 90% of arriving unaccompanied minors have someone in the United States that they could connect with, including direct family, a relative or close friends. The recent opening of two Emergency Intake Centers (EIC) in Los Angeles County at the Pomona Fairplex and Long Beach, in coordination with Los Angeles County Behavioral and Mental Health Departments to provide social services, demonstrates the need for wrap-around services as family reunification takes place.

The Housing and Community Investment Department, in coordination with Los Angeles County and service partners, should provide an updated report with recommendations to further assist transition aged youth (TAY) processed through the Office of Refugee Resettlement.

I THEREFORE MOVE that the Council INSTRUCT the Housing and Community Investment Department, with the assistance of the City Administrative Officer and Chief Legislative Analyst, to report on the City's Unaccompanied Minors Pilot Program (CF: 19-0777 Motion O'Farrell-Wesson), with recommendations to expand opportunities for collaboration and program scope, including budgetary needs.

I FURTHER MOVE to REQUEST that the Los Angeles County Office of Immigrant Affairs present to the City Council regarding Countywide strategies to assist unaccompanied minors in the City of Los Angeles, including available resources and programs, gaps in capacity and recommendations for strengthening coordination of services for this population.

#### RESOLUTION

WHEREAS, preservation of affordability covenants is an effective way to maintain and increase the number of affordable units in the City and to ensure that people are not displaced due to excessive rent increases:

WHEREAS, any program to preserve expiring covenants will require a significant funding commitment to provide financial incentives to owners and make other strategic investments to extend affordability covenants; and

WHEREAS, it is anticipated that the State Budget will have an estimated \$38 billion surplus, of which a portion should be proposed for innovative housing preservation strategies; and

WHEREAS, the State should ensure that funding is available for local jurisdictions to preserve affordable housing for its low income residents, especially during these challenging times;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program SUPPORT and/or SPONSORSHIP of legislation or administrative action that would provide funding to preserve affordable housing covenants.
