For Tuesday, June 22nd The Federal Transit Administration (FTA), an agency within the U.S. Department of Transportation, provides financial and technical assistance to local public transit systems, including buses. subways, light rail, commuter rail, trolleys and ferries. FTA also oversees safety measures and helps develop next-generation technology research.

On April 21, 2021, the FTA issued a Notice of Funding Opportunity for the Pilot Program for Transit-Oriented Development (TOD) Planning FY 2021. The FTA announced the availability of \$10.052,572 (grant amounts range from \$250,000 to \$2,000,000) in Pilot Program for TOD Planning funding to support comprehensive planning associated with new improvement projects that integrate land use and transportation planning in transit project corridors; and examine ways to improve economic development and ridership, foster multimodal connectivity and accessibility, improve transit access for pedestrian and bicycle traffic, engage the private sector, identify infrastructure needs, and enable mixeduse development near transit stations.

The City is applying for a grant in the total amount of \$1,000,000 with a minimum 20 percent City matching requirement. The services covered in this grant work include outreach, market studies, and Transit Neighborhood Planning.

FTA is seeking comprehensive planning projects covering an entire transit project corridor, rather than proposals that involve planning for individual station areas or only a small section of the corridor, and thereby ensure that planning work reflects the needs and aspirations of the local community and results in concrete, specific deliverables and outcomes.

(Sponsor), a California limited partnership, has requested that the City of Los Angeles (City) through the Housing and Community Investment Department (HCID) issue Multifamily Housing Revenue Bonds, in an amount not to exceed \$29,000,000, to finance the new construction of an 89-unit multifamily housing project known as Beacon Landing (Project) located at 311-345 N. Beacon Street in Council District 15. The Project will provide 88 units of affordable housing and one manager's unit.

In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the bond issuance process, HCID conducted the required public hearing on May 26, 2021. Notice of the public hearing was published on May 19, 2021. HCID is required to provide proof to the California Debt Limit Allocation Committee (CDLAC) that a TEFRA hearing has been conducted as part of the application process.

The City is a conduit issuer and is required by federal law to review and approve all projects within its jurisdiction and conduct a public hearing. The bond debt is payable solely from revenues or other funds provided by the Sponsor. The City does not incur liability for repayment of the bonds. The Sponsor has pledged to comply with all City and HCID bond policies related to the work described in this motion, including but not limited to payment of prevailing wages for labor and project monitoring. To allow the bonds to be issued in accordance with CDLAC requirements, the Council should consider the minutes of the hearing and adopt the required Resolution (attached).

#### CITY OF LOS ANGELES

A RESOLUTION APPROVING FOR PURPOSES OF SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 THE ISSUANCE OF BONDS OR NOTES BY THE CITY OF LOS ANGELES TO FINANCE THE ACQUISITION, REHABILITATION, CONSTRUCTION AND EQUIPPING OF A MULTIFAMILY RESIDENTIAL RENTAL PROJECT LOCATED WITHIN THE CITY OF LOS ANGELES.

WHEREAS, the City of Los Angeles (the "City") is authorized, pursuant to Section 248, as amended, of the City Charter of the City and Article 6.3 of Chapter 1 of Division 11 of the Los Angeles Administrative Code, as amended (collectively, the "Law"), and in accordance with Chapter 7 of Part 5 of Division 31 (commencing with Section 52075) of the Health and Safety Code of the State of California (the "Act"), to issue its revenue bonds or notes for the purpose of providing financing for the acquisition, construction, rehabilitation and equipping of multifamily rental housing for persons and families of low or moderate income; and

WHEREAS, the City intends to issue for federal income tax purposes certain bonds or notes (the "Bonds") the proceeds of which will be used to finance the acquisition, construction, rehabilitation and equipping of a multifamily rental housing project described in paragraph 6 hereof (the "Project"); and

WHEREAS, the Project is located wholly within the City; and

WHEREAS, it is in the public interest and for the public benefit that the City authorize the financing of the Project, and it is within the powers of the City to provide for such financing and the issuance of the Bonds; and

WHEREAS, the interest on the Bonds may qualify for a federal tax exemption under Section 142(a)(7) of the Internal Revenue Code of 1986 (the "Code"), only if the Bonds are approved in accordance with Section 147(f) of the Code; and

WHEREAS, pursuant to the Code, Bonds are required to be approved, following a public hearing, by an elected representative of the issuer of the Bonds (or of the governmental unit on behalf of which the Bonds are issued) and an elected representative of the governmental unit having jurisdiction over the area in which the Project is located; and

WHEREAS, this City Council is the elected legislative body of the City and is the applicable elected representative required to approve the issuance of the Bonds within the meaning of Section 147(f) of the Code; and

WHEREAS, pursuant to Section 147(f) of the Code, the City caused a notice to appear in the Los Angeles Times, which is a newspaper of general circulation in the City, on May 19, 2021, to the effect that a public hearing would be held with respect to the Project on May 26, 2021 regarding the issuance of the Bonds; and WHEREAS, the Los Angeles Housing and Community Investment Department held said public hearing on such date, at which time an opportunity was provided to present arguments both for and against the issuance of the Bonds; and

WHEREAS, the minutes of said hearing have been presented to this City Council;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Los Angeles, as follows:

 The recitals hereinabove set forth are true and correct, and this City Council so finds. This Resolution is being adopted pursuant to the Law and the Act.

2. Pursuant to and solely for purposes of Section 147(f) of the Code, the City Council hereby approves the issuance of the Bonds by the City in one or more series up to the maximum amount below and a like amount of refunding bonds, pursuant to a plan of financing, to finance or refinance the Project. It is intended that this Resolution constitute approval of the Bonds: (a) by the applicable elected representative of the issuer of the Bonds; and (b) by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Project is located, in accordance with said Section 147(f).

3. Pursuant to the Law and in accordance with the Act, the City hereby authorizes the Los Angeles Housing and Community Investment Department to proceed with a mortgage revenue bond program designed to provide housing within the City of Los Angeles for low- and moderate-income persons through the issuance of the Bonds for the Project, in one or more series and in an amount not to exceed that specified in paragraph 6 hereof.

4. Notwithstanding anything to the contrary hereof, the City shall be under no obligation to issue any portion of the Bonds described in paragraph 6 hereof to be issued by the City for the Project prior to review and approval by the City and the City Attorney of the documents, terms and conditions relating to such Bonds.

#### MOTION

Avalon 1355 Partners, LP (Sponsor), a California limited partnership, has requested that the City of Los Angeles (City) through the Housing and Community Investment Department (HCID) issue Multifamily Housing Revenue Bonds, in an amount not to exceed \$17,843,000, to finance the new construction of the 54-unit multifamily housing project known as Avalon 1355 (Project) located at 1335-1359 N. Avalon Boulevard in Council District 15. The Project will provide 53 units of affordable housing and one manager's unit.

In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the bond issuance process, HCID conducted the required public hearing on May 26, 2021. Notice of the public hearing was published on May 19, 2021. HCID is required to provide proof to the California Debt Limit Allocation Committee (CDLAC) that a TEFRA hearing has been conducted as part of the application process.

The City is a conduit issuer and is required by federal law to review and approve all projects within its jurisdiction and conduct a public hearing. The bond debt is payable solely from revenues or other funds provided by the Sponsor. The City does not incur liability for repayment of the bonds. The Sponsor has pledged to comply with all City and HCID bond policies related to the work described in this motion, including but not limited to payment of prevailing wages for labor and project monitoring. To allow the bonds to be issued in accordance with CDLAC requirements, the Council should consider the minutes of the hearing and adopt the required Resolution (attached).

#### CITY OF LOS ANGELES

A RESOLUTION APPROVING FOR PURPOSES OF SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 THE ISSUANCE OF BONDS OR NOTES BY THE CITY OF LOS ANGELES TO FINANCE THE ACQUISITION, REHABILITATION, CONSTRUCTION AND EQUIPPING OF A MULTIFAMILY RESIDENTIAL RENTAL PROJECT LOCATED WITHIN THE CITY OF LOS ANGELES.

WHEREAS, the City of Los Angeles (the "City") is authorized, pursuant to Section 248, as amended, of the City Charter of the City and Article 6.3 of Chapter 1 of Division 11 of the Los Angeles Administrative Code, as amended (collectively, the "Law"), and in accordance with Chapter 7 of Part 5 of Division 31 (commencing with Section 52075) of the Health and Safety Code of the State of California (the "Act"), to issue its revenue bonds or notes for the purpose of providing financing for the acquisition, construction, rehabilitation and equipping of multifamily rental housing for persons and families of low or moderate income; and

WHEREAS, the City intends to issue for federal income tax purposes certain bonds or notes (the "Bonds") the proceeds of which will be used to finance the acquisition, construction, rehabilitation and equipping of a multifamily rental housing project described in paragraph 6 hereof (the "Project"); and

WHEREAS, the Project is located wholly within the City; and

WHEREAS, it is in the public interest and for the public benefit that the City authorize the financing of the Project, and it is within the powers of the City to provide for such financing and the issuance of the Bonds; and

WHEREAS, the interest on the Bonds may qualify for a federal tax exemption under Section 142(a)(7) of the Internal Revenue Code of 1986 (the "Code"), only if the Bonds are approved in accordance with Section 147(f) of the Code; and

WHEREAS, pursuant to the Code, Bonds are required to be approved, following a public hearing, by an elected representative of the Bonds (or of the governmental unit on behalf of which the Bonds are issued) and an elected representative of the governmental unit having jurisdiction over the area in which the Project is located; and

WHEREAS, this City Council is the elected legislative body of the City and is the applicable elected representative required to approve the issuance of the Bonds within the meaning of Section 147(f) of the Code; and

WHEREAS, pursuant to Section 147(f) of the Code, the City caused a notice to appear in the Los Angeles Times, which is a newspaper of general circulation in the City, on May 19, 2021, to the effect that a public hearing would be held with respect to the Project on May 26, 2021 regarding the issuance of the Bonds; and

WHEREAS, the Los Angeles Housing and Community Investment Department held said public hearing on such date, at which time an opportunity was provided to present arguments both for and against the issuance of the Bonds; and

WHEREAS, the minutes of said hearing have been presented to this City Council;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Los Angeles, as follows:

1. The recitals hereinabove set forth are true and correct, and this City Council so finds. This Resolution is being adopted pursuant to the Law and the Act.

2. Pursuant to and solely for purposes of Section 147(f) of the Code, the City Council hereby approves the issuance of the Bonds by the City in one or more series up to the maximum amount below and a like amount of refunding bonds, pursuant to a plan of financing, to finance or refinance the Project. It is intended that

this Resolution constitute approval of the Bonds: (a) by the applicable elected representative of the issuer of the Bonds; and (b) by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Project is located, in accordance with said Section 147(f).

3. Pursuant to the Law and in accordance with the Act, the City hereby authorizes the Los Angeles Housing and Community Investment Department to proceed with a mortgage revenue bond program designed to provide housing within the City of Los Angeles for low- and moderate-income persons through the issuance of the Bonds for the Project, in one or more series and in an amount not to exceed that specified in paragraph 6 hereof.

4. Notwithstanding anything to the contrary hereof, the City shall be under no obligation to issue any portion of the Bonds described in paragraph 6 hereof to be issued by the City for the Project prior to review and approval by the City and the City Attorney of the documents, terms and conditions relating to such Bonds.

### RULES, ELECTIONS, INTERGOVERNMENTAL RELATIONS

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, City of Los Angeles employees do not pay Social Security taxes and are subject to the Windfall Elimination (WEP) and Government Pension Offset provisions; and

WHEREAS, currently if a member of the Los Angeles City Employee's Retirement System (LACERS) receives a pension from LACERS and is eligible for Social Security benefits from previous work outside of the City of Los Angeles, Social Security's Windfall Elimination and Government Pension Offset provisions reduce Social Security benefits received by members; yet this is not applied universally and can have significant financial implications for retirement members, especially those with lower income; and

WHEREAS, in 2020, about 1.9 million people (or about 3% of all Social Security beneficiaries) were affected by the WEP; and anyone who worked for the City of Los Angeles is likely to experience a reduction of their Social Security benefit; these reductions can be substantial, up to one-half of one's pension, and research has shown that the WEP reduces benefits disproportionately for lower-earning households; and

WHEREAS, the Windfall Elimination Provision only affects the benefit of the retiree, however, an employee's spouse may be eligible to also receive a benefit based on the retiree's work history and earnings and there is another provision called the Government Pension Offset that will reduce the benefit received by a retiree's spouse or surviving spouse who is receiving a government pension from employment where Social Security taxes were not paid; and

WHEREAS, currently pending in Congress is a bill, HR 82, the Social Security Fairness Act of 2021, which would rectify inequities resulting from the Windfall Elimination and Government Pension Offset provisions; and

WHEREAS, the Board of the Los Angeles City Employees Retirement System has requested that the City support HR 82 and any similar legislation which would rectify inequities resulting from the Windfall Elimination and Government Pension Offset provisions;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 Federal Legislative Program support for HR 82, the Social Security Fairness Act of 2021, and any similar legislation which would rectify inequities resulting from the Social Security Windfall Elimination and Government Pension Offset provisions, as further detailed in the text of this Resolution.

### RESOLUTION RULES, ELECTIONS, INTERGOVERNMENTAL RELATIO

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, immigrant farmworkers make up an estimated 73 percent of agriculture workers in the United States and are considered "essential workers" by the U.S. Department of Homeland Security; and

WHEREAS, farmworkers put food on our tables and stimulate the economy - from dairy farms in Wisconsin to strawberry fields in California and apple orchards in Washington; and

WHEREAS, agricultural work requires great skill and is relentless, exhausting, and often involves dangerous and hazardous working conditions; and

WHEREAS, all across the country, farmworkers spend extremely long hours harvesting crops in all types of weather while risking injury or illness from heavy equipment or pesticide exposure; and

WHEREAS, undocumented farmworkers often find themselves working for abusive employers who exploit them for cheap labor and, in many cases, are not paid for their labor; and

WHEREAS, according to the American Farm Bureau Federation the U.S. agriculture industry needs 1.5 to 2 million workers each year and, in 2019, 56 percent of California farmers reported being unable to find all the workers they needed over the last five years; and

WHEREAS, on March 18, 2021, the House passed H.R. 1603 – The Farm Workforce Modernization Act of 2021 – which would provide undocumented farmworkers and their families with a path to legal immigration status and citizenship, revise the H-2A agricultural guestworker program to address some employer and worker concerns, and impose mandatory employment verification (E-Verify) in agriculture; and

WHEREAS, the City of Los Angeles should support H.R. 1603 to create a path for legal immigration status for undocumented farmworkers, create protections for farmworkers and employers, and ensure the industry grows its pool of available workers;

### **BUDGET & FINANCE**

The City of Los Angeles is taking leadership during this crucial time of economic recovery by making it easier for businesses to be connected to contracting opportunities. In view of this priority, this Council has requested the Chief Procurement Officer (CPO) to leverage the current development of the City's solicitation platform and expand its capabilities from a solely City focused platform to a broader regional focused platform. This regional platform will function as a centralized portal that can house public and private procurement and contracting activities for both the City and the region. In order to support the success of this platform, the CPO was allocated \$500,000 through the budgeting process for Fiscal Year (FY) 2021-22 for operational needs and \$250,000 for marketing outreach to businesses. While the funding was made available for the CPO, the budget did not include the position authorities.

The regular authorities outlined in this Motion will be responsible for establishing two sections within the Office of the CPO. The two sections are the Regional Portal Development and Administration Section and the Procurement Policy and Process Section. These sections will be crucial to the initial implementation of a strategic procurement ecosystem in future phases of the Office of the CPO, which will build upon the areas of procurement policy, process improvement, innovation, vendor relations, and active contract management.

I THEREFORE MOVE that Council, subject to the approval of the Mayor, approve the following five regular authorities, subject to allocation by the Personnel Department and pay grade determination by the City Administrative Officer (CAO) in the Department of General Services to staff the CPO's initiatives.

### INFORMATION, TECHNOLOGY AND GENERAL SERVICE.

#### MOTION

Mitigating and preparing for climate change is a moral imperative for the City of Los Angeles. One source of local greenhouse gas emissions and smog-forming pollutants over which the City has direct control is our municipal fleets, which total around 13,000 vehicles. The City has demonstrated a high level of leadership in this area, having procured over 900 electric vehicles across all LA City fleets to date. Still, we have further to go.

While a wide range of zero-emission options are available in the light-duty vehicle sector, Original Equipment Manufacturers (OEMs) are now bringing viable zero-emission medium- and heavy-duty vehicles to market that can meet the City's operational needs and cost constraints -vehicles like box trucks, step-in vans, and more specialized equipment like refuse collection vehicles and street sweepers.

Given advances in technology and zero-emission vehicle availability, it is time to formally put in place the fleet procurement guidelines that have been outlined in LA's Green New Deal. These include a 100% zero-emission procurement requirement for all new light-duty vehicle purchases and a Zero-Emission First procurement policy that applies to all other vehicles. Doing so will ensure the City's continued leadership in responding to the climate crisis. It is critical that we clearly define our vehicle procurement policy and rules, make deliberate investments to enable a zero emission municipal fleet, and ensure adequate oversight and enforcement mechanisms are in place.

I THEREFORE MOVE that the City Council direct the General Services Department's Fleet and Supply Divisions, working with any other relevant divisions or departments and, as needed, the Mayor's EV Task Force, the Chief Procurement Officer, and the City Administrative Officer, to report within 60 days with proposed rules to meet the intent of the Zero-Emission First procurement policy and a proposed compliance or certification process.

I FURTHER MOVE that the Council direct the General Services Department to report on staffing and funding needs to ensure that EV charging infrastructure, or any other zero-emission fueling infrastructure, will be installed in parallel to or in anticipation of a future 100% zero-emission municipal fleet.

I FURTHER MOVE that the Council direct LAPD and LAFD to report within 60 days on their short, medium, and long-term plans to transition their fleets to zero-emission vehicles, inclusive of specialty and pursuit-rated vehicles (excluding aerial equipment).

**I FURTHER MOVE** that the Council direct LADOT to report within 60 days on the progress toward meeting the bus-electrification targets previously established by Council.

I FINALLY MOVE that the Council request that Los Angeles World Airports (LAWA), the Port of Los Angeles (POLA), and the Los Angeles Department of Water and Power (LADWP) to report within 60 days on how they will codify and implement the Zero-Emission First fleet procurement rule.

### ECONOMIC DEVELOPMENT & JOBS

#### MOTION

While the federal government, as well as State and local jurisdictions took measures to mitigate the impact of the COVID-19 pandemic, the most vulnerable communities, many who did not receive any type of financial assistance, continue to recover from the devastating economic and health impacts of the COVID-19 pandemic.

Among the most vulnerable communities severely impacted by the COVID-19 pandemic are sidewalk vendors who were not only largely left out of any type of federal coronavirus direct stimulus payments but have also experienced an increase in targeted physical attacks.

Sidewalk vendors have turned their vulnerability into strength. Irrespective of the working conditions, the potential danger of working on the street, their ability to sell, the harassment they endure, still know that it is only option they have as a means to put food on the table to feed their families.

Given that there are still many challenges for vendors to obtain the appropriate documentation to continue their vending activities, the City is in a position to assist by extending the reduced cost of the vending operating permit as the impacts of the COVID-19 pandemic begin to settle.

On September 8, 2020, the City Council approved an amendment to the Los Angeles Municipal Code Section 42.13.B.2 to extend the reduced cost (\$291) of the sidewalk vending operating permit until July 1, 2021 (C.F. 13-1493). It is imperative that this action be further extended through July 1, 2022 to continue to assist sidewalk vendors.

I THEREFORE MOVE that the City Attorney be requested to prepare an ordinance to amend Section 42.13.B2 of the Los Angeles Municipal Code to extend the reduced cost (\$291) of the sidewalk vending operating permit until July 1, 2022.

#### MOTION

Buildings are the largest source of carbon emissions across Los Angeles, and they account for 32% of the City of Los Angeles' emissions within our municipal sector. If we are to become a carbon-neutral city, then we must begin the process of implementing an aggressive decarbonization and electrification program for our municipal buildings now.

Building decarbonization includes the implementations of energy efficiency measures, the electrification of gas-powered building systems, and generation of renewable energy. By undertaking multi-pronged, complementary decarbonization strategies in our municipal buildings, we can reduce operational costs, improve local air quality, and demonstrate solutions that can be replicated in the private sector and in other cities throughout Los Angeles County and beyond.

As our electric grid has shifted to cleaner, renewable energy sources, the electrification of previously gas-powered systems within our City buildings, in particular, has become an increasingly critical step to reduce the City's total carbon emissions. From 2008 to 2017, municipal building emissions from electricity sources fell 44% due to the Los Angeles Department of Water and Power's evolving electrical energy-generation mix. In the same time period, however, power that was used on-site by gas-powered equipment like HVAC systems, chillers, and boilers, only saw a 3% emissions reduction.

Fully electrifying our City buildings will also have significant health benefits for our communities. Burning combustible fuels in buildings produces air pollutants indoors as well as outdoors. The negative health impacts that result from these air pollutants are disproportionately felt by vulnerable, frontline communities. To reduce and reverse these impacts, it is critical that the City lead by example in reducing emissions from municipal assets that contribute to this pollution.

Fortunately, some of the initial steps that will allow the City to begin this work in earnest have already been taken. In the course of complying with the Existing Building Energy and Water Ordinance, the General Services Department has already commissioned over 100 energy and water building audits. These audits have served as a valuable first step, indicating which buildings are our highest energy consumers and offering insights into interventions that will help reduce energy consumption. Now, these audits can also be used as the basis for preparing building decarbonization/electrification plans. In addition, the LA100 study has already demonstrated that as we decarbonize our energy grid, there will be substantial opportunities to decarbonize our building sector as well—and that in doing so, health benefits will rise as costs fall.

Los Angeles has no path to becoming a carbon-neutral city without a bold and robust building decarbonization effort. We know our goal, and we know that it has never been more urgent. The time to begin the hard work of getting there is now.

I THEREFORE MOVE that the City Council direct the General Services Department, working with the Bureau of Engineering, the Recreation and Parks Department, the Los Angeles Public Library, the City Administrative Officer, and any other City departments as needed, to report back within 60 days with an assessment that will identify the staffing and/or contractual services needed to develop a full cost-estimate, timeline, and plan to retrofit prioritized municipally-owned buildings to achieve net-zero energy. The assessment should build upon the previously performed energy and water audits and account for the development of: (1) a prioritization methodology to identify buildings with maximum projected benefits of retrofits; and (2) a procurement/funding plan for immediate retrofitting of the top-ten high-priority buildings to serve as a model for the process of decarbonizing/electrifying the remainder of the City's municipal buildings going forward. Finally, the assessment should consider the advantages of pursuing a contract for retrofits through an energy service contract, a Request for Qualifications process, and a Request for Proposal process, making a recommendation on which type of procurement process the City should pursue in order to retrofit the entire municipal building portfolio.
