CATEGORICAL EXEMPTION and PUBLIC WORKS COMMITTEE REPORT relative to the vacation of an L-shaped alley northerly of Riverside Drive and westerly of Riverton Avenue, VAC-E1401370 (Vacation).

Recommendations for Council action:

4. That the sum of \$50,000 shall be the aggregate maximum sum of any payment or payments of a City reward in this instance.
5. That the offer of reward shall be in effect for six months from the date of the advertisement of the reward by the City Clerk.

I FURTHER MOVE that the City Clerk be directed to cause notices and/or advertisements to be duly published according to the requirements of Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code, and to thereby cause the offer of reward to become effective.

National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie to make our neighborhoods safer, more caring places to live. National Night Out enhances the relationship between neighbors and law enforcement while bringing back a true sense of community. Furthermore, it provides a great opportunity to bring police and neighbors together under positive circumstances.

Millions of neighbors take part in National Night Out across thousands of communities from all fifty states, U.S. territories and military bases worldwide on the first Tuesday in August. Neighborhoods host block parties, festivals, parades, cookouts and various other community events with safety demonstrations, seminars, youth events, visits from emergency personnel, exhibits and much, much more.

Many technological advances have occurred since National Night Out was founded in 1984, that could help facilitate communication and collaboration between residents and law enforcement throughout the year. The Los Angeles Police Department should be a national leader and at the forefront of using technology to build relationships with community members, yet one of their primary tools for providing information to the public - the Department's official website, LAPDOnline.com - is confusing, difficult to navigate and lacks up-to-date, accurate information.

I THEREFORE MOVE that the Los Angeles Police Department (LAPD), with the assistance of the Information Technology Agency (ITA), and City Administrative Officer (CAO) be directed to report with recommendations on creating a community-building campaign and toolkit that will make it easier for residents to form new Neighborhood Watch programs and allow existing Neighborhood Watch associations better access to resources that will allow them to improve community public safety.

I FURTHER MOVE that the LAPD, ITA, and CAO report back on making improvements to LAPDOnline.org that would incorporate the following:

- User Interface & User Experience optimization
- The ability to search by address for LAPD Division, recent crime statistics, reporting district, basic car area, Community Police Advisory Board meetings and Senior Lead Officer
- Information and resources about how to start a neighborhood watch program
- Information about how to report a crime in progress
- Information about how to provide tips on a past crime

Illegal street racing and drag racing on local roads is an ongoing nuisance and public safety issue throughout Los Angeles. The problem has seen an increase in the San Fernando Valley, where drivers and participants take over select streets and intersections to race, rev engines, and perform stunts. Criminal enforcement has been the primary method used to curtail this activity. However, the short time frame and transitory nature of the events, the City's limited authority to increase fines and penalties, as well as an overabundance of locations, makes law enforcement challenging. A coordinated effort of enforcement and traffic management strategies is needed to develop techniques in areas known for street racing.

Illegal street racing generally occurs over a short section of a wide, straight local road with low levels of traffic volumes and easy access to freeways and major arterials that allow participants to quickly disperse. These characteristics render traffic engineering techniques, particularly traffic calming measures, an effective and cost-efficient means of deterring illegal racing, since they can be targeted to the specific locations. Traffic calming is a tool designed to limit travel speed by introducing physical roadway geometric changes. Examples include, but are not limited to, speed humps, rumble strips, raised center medians, curb extensions, and traffic circles. In light of the increasingly dangerous nature of illegal street racing, the City should examine the feasibility of both temporary and permanent traffic calming measures in these

I THEREFORE MOVE that the Council instruct the Department of Transportation and the Bureau of Street Services, in coordination with the Los Angeles Police Department Street Racing Task Force, to report with recommendations on a menu of traffic calming measures that can be implemented at locations where illegal street racing occurs, including temporary devices that can be quickly installed and removed. The report should include a map overlaying known racing corridors and intersections with Vision Zero traffic data.

I FURTHER MOVE that the Department of Transportation and the Los Angeles Police Department Street Racing Task Force meet on a quarterly basis and jointly report to Council Offices regarding data and updates to street racing in their respective districts.

I FURTHER MOVE that the Department of Transportation, the Bureau of Street Services and the Los Angeles Police Department Street Racing Task Force identify key racing intersections and provide recommended street treatments and programmatic steps to pilot these treatments in Council District 7, and further, Citywide.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal government body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, in October 2015, the Southern California Gas Company (SoCalGas) discovered a blowout of its natural gas well at the Aliso Canyon Storage Facility; and

WHEREAS, the Aliso Canyon natural gas blowout was the largest release of natural gas in American history and it resulted in the evacuation of thousands of residents in its vicinity. The blowout released an estimated 97,100 metric tons of methane and 7.300 metric tons of ethane into the atmosphere; and

WHEREAS, the natural gas blowout revealed deficiencies in regulatory oversight, including well inspections, emergency preparedness, and the responsibility for associated costs including mitigation efforts; and

WHEREAS, Governor Brown, in 2017, directed various State agencies to address the matter, and study the permanent closure of the Aliso Natural Gas Storage Facility. In 2019, Governor Newsom sent a letter to the California Public Utilities Commission (CPUC) asking for the process to be expedited, while still maintaining reliable and affordable energy service; and


WHEREAS, in January of 2021, CPUC Staff analysis of our energy system found potential reliability and affordability impacts and risks associated with limiting Aliso Canyon, and recommended increasing the inventory at the facility;

WHERE, based on that CPUC Staff analysis, in May of 2021, several large natural gas customers appealed to the CPUC to raise the inventory at Aliso Canyon. The request to raise Aliso Canyon's inventory was supported by Southern California Edison, the Utility Reform Network, and Southern California Gas Company.


WHEREAS, in June 2021, this Council passed a Resolution calling for the State to accelerate the permanent closure plan of Aliso Canyon; and

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby opposes any increase in natural gas storage at the Aliso Canyon facility, unless and until it is more clear that reliable and affordable energy service is at risk.



RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, every year, a number of people are killed or injured across the state by reckless motorists engaged in speed contests, exhibitions of speed, or by individuals participating in illegal "sideshow" events; and

WHEREAS, "sideshows" are illegal events where two or more individuals block highways to and engage in motor vehicle exhibitions of speed, motor vehicle stunts and other dangerous activities in front of a crowd; and

WHEREAS, under current law, individuals who are convicted of engaging in a motor vehicle speed contest can be imprisoned for up to 90 days, be fined up to \$1,000, have their driver's license suspended from 90 days to six months and have their vehicle immediately impounded for up to 30 days; and

WHEREAS, individuals engaging in an exhibition of speed may be imprisoned for up to 90 days, be fined up to \$500 and have their vehicle impounded immediately for up to 30 days; and

WHEREAS, current law does not specifically allow for the suspension of driver's licenses of individuals convicted for exhibition of speed violations which occurred during a "sideshow" event; and

WHEREAS, AB 3 (Fong) would provide that, in addition to the existing penalties, a person engaging in a motor vehicle exhibition of speed while participating in a "sideshow," as defined, may have his or her driver's license suspended of from 90 days to six months; and

WHEREAS, "sideshows" are incredibly dangerous for participants, spectators and the general public, and the penalties for exhibition of speed at one of these events should include the ability to suspend an individual's driver's license;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021 - 2022 State Legislative Program SUPPORT for AB 3 (Fong), which would provide that in addition to existing penalties, a person engaging in a motor vehicle exhibition of speed, while participating in a "sideshow," may have his or her driver's license suspended from 90 days to six months.



As a result of the COVID-19 pandemic, our federal and state governments launched a multitude of relief and stimulus programs to offer assistance to families and individuals in need. These programs ranged from tax benefits to help for homeowners and renters to assistance with heating and cooling needs and other utilities.

Now, eighteen months into the pandemic, many of these programs have expired or are set to expire soon, such as the federal eviction moratorium which expired on Saturday, July 31, 2021. The expiration of these programs comes at a time when cases are surging as a result of the Delta variant and we have yet to reach an adequate threshold for vaccinations. Lower-income households are inherently more at risk, as they are less likely to have savings and more likely to have been employed in COVID-affected industries. With millions of families struggling to get by, the burden will shift to local municipalities to offer assistance.


The State of California recently approved the nation's largest rent relief program in the country, with over 5.2 billion dollars being allocated for 100% of back-rent and assistance for landlords and renters. Officially labeled "Housing is Key," the program furthers the goals identified in the first round of rental assistance, which was highly informed by the initial Los Angeles rent subsidy program. The Los Angeles rent subsidy program was the largest in the nation, appropriating over 100 million dollars in direct aid. The new State program once again helps renters and landlords across California directly impacted by COVID-19.


Collectively, Los Angeles residents have the highest concentrated need in the entire state. The Los Angeles Housing Department is the City's lead agency with respect to the new State program and the department must be fully prepared to serve Angelenos filing for the state subsidy the moment the program goes live. Already, Council Offices and other city agencies are receiving requests from residents for rental assistance and guidance.

The Los Angeles Housing Department should report back immediately with a clear and helpful plan that meets the moment to provide direct assistance and information to all Angelenos. Although radio, television, and internet announcements will be key in disseminating information, the City portal will handle tens of thousands of requests to help verify eligibility requirements. We need assurances that the City is prepared the moment the State begins processing requests. Importantly, the department must also take into account costs to the City, including staffing and workforce challenges that exist due to the COVID-19 pandemic.

The City must apply the best method in order to identify the need, and deliver assistance to the City's residents in the most efficient, impactful and equitable manner possible.

I THEREFORE MOVE that the Los Angeles Housing Department report to Council with recommendations to effectuate the "Housing is Key" State of California COVID-19 Rent Relief program meant to help renters and landlords to apply for and receive the State sponsored 100% rent buy-back assistance.
