On July 18, 2020 at approximately 12:20am, 31-year-old Kevin Yarbrough was walking near the entrance of a mobile home park located at 1025 McFarland Avenue in Wilmington, when he was approached by an unknown person, who then produced an automatic weapon and fired at Mr. Yarbrough from close range, fatally wounding him. The suspect then fled in an unknown direction on a bicycle. Detectives are continuing to investigate this crime, but have not identified the suspect. Detectives believe that a reward may compel members of the public to provide information on the identity of the person responsible for this crime.

The person responsible for this crime represents an ongoing threat to the safety of the people of Los Angeles; therefore, it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of the person responsible for the death of Kevin Yarbrough.

I THEREFORE MOVE that by adoption of this Motion, the City Council provide an offer of reward for information leading to the identification, apprehension, and conviction of the person responsible for the death of Kevin Yarbrough on July 18, 2020, and in support thereof, make the following findings pursuant to Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code:

1. That the death of Mr. Yarbrough was caused by the willful misconduct of one or more persons.
2. That this offer of reward is consistent with and taken for the immediate protection of the public peace, health and safety of local residents, as well as visitors to the City, and is consistent with the need to arrest and convict the person or persons who, because of not being apprehended, could by their actions further terrorize and present a continuing and immediate menace to the rights of persons in the City.
3. That what happened to the victim is an especially disturbing crime and therefore, as a matter of public policy, the City hereby offers a reward as an added inducement for persons to come forward with information leading to the identification, apprehension and conviction of the person responsible for the death of Kevin Yarbrough.
4. That the sum of \$50,000 shall be the aggregate maximum sum of any payment or payments of a City reward in this instance.
5. That the offer of reward shall be in effect for six months from the date of the advertisement of the reward by the City Clerk.

I FURTHER MOVE that the City Clerk be directed to cause notices and/or advertisements to be duly published according to the requirements of Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code, and to thereby cause the offer of reward to become effective.



MOTION

The City of Los Angeles has a tremendous opportunity to create a vibrant community center on the Westside, utilizing former Fire Station 62, which currently sits empty at the corner of South Centinela Avenue and West Windward Avenue in Mar Vista.


Instead of enhancing and serving the neighborhood, this building has sat vacant for over a decade and has the potential to become a public safety hazard. Over the years, the site has fallen prey to theft, vagrancy, graffiti and illegal dumping. Before his retirement due to illness, former Councilmember Bill Rosendahl promised Mar Vista that he would help turn the site into a community center, for use by the Mar Vista Community Council, other local groups, and as a site for city officials and agencies to hold public meetings and office hours. Councilmember Rosendahl sought to partner with the Mar Vista-based Friends of Historic Fire Station 62, a registered 501(c)3 non-profit organization. This organization was created by the local community and Mar Vista Community Council to engage in a full spectrum of neighborhood-focused services including, but not limited to: Community Emergency Response and Training (CERT); art, culture and educational classes; grassroots democracy and government education sessions; green technology and sustainability efforts; and community history lessons.

Council District 11 seeks to repurpose former Fire Station 62 as the Bill Rosendahl Community Center. In 2014, Council District 11 worked with General Services to address and resolve public safety nuisance abatement issues on the property. Given the existing public safety concerns with this vacant parcel, however, it is vital that the City act quickly to facilitate rehabilitation of the property to serve the people of Mar Vista and the 11th District. The City has a unique opportunity to honor Councilmember Rosendahl's legacy to the community through partnership with Mar Vista-based Friends of Historic Fire Station 62.

On June 27, 2017, Council authorized the City to enter into a three-year Option to Lease (Agreement) with Friends of Historic Fire Station 62 (FHFS) for the decommissioned Fire Station No. 62 (FS 62), located at 3631-3635 South Centinela Avenue in Council District 11 (C.F. 16-0492). The terms of the Agreement (C-131624) provided FHFS, a non-profit, 501(c)3 corporation, exclusive and irrevocable rights to lease the property at a future date, provided that it obtains sufficient capital funding within the original three-year term to fully fund the repair and rehabilitation of the building. On June 24, 2020, Council approved an extension. Since FHFS fundraising was stymied by the COVID-19 pandemic, and the group lost nine months of the original three-year term while the original agreement was being formalized, it would be prudent for the City to renew the original option to lease, on the same terms and conditions as the original Agreement. Such a renewed agreement would allow the organization greater opportunity to raise funds or partner with other organizations to do so, as well as provide time that may be needed for the City to coordinate with the State on compliance with the newly-revised Surplus Land Act, to the extent applicable.

I THEREFORE MOVE that the Department of General Services, in consultation with the City Administrative Officer and the City Attorney, be directed to grant a renewed option to lease to Friends of Historic Fire Station 62 based on the terms of original Agreement (C-131624), for use of the City-owned former Fire Station 62, located at 3631-35 South Centinela Avenue in the community of Mar Vista, subject to compliance with applicable requirements of the Surplus Land Act, on the same terms and conditions as the original Agreement, and authorize City staff to make any technical changes, including dates, to effectuate the intent of this motion.



RESOLUTION

PUBLIC WORKS

WHEREAS, the Los Angeles Municipal Code (LAMC) Section 41.18(c)(3) states that no person shall sit, lie, sleep, or store, use, maintain, or place personal property, in or upon any street, sidewalk, or other public right-of-way, within the distance stated on the posted signage (up to a maximum of 1,000 feet) of a designated facility, opened after January 1,2018, that provides shelter, safe sleeping, or safe parking to homeless persons, or that serves as a homeless services navigation center;

WHEREAS, the LAMC section 41.18(d) states No person shall be found to be in violation of any prohibition set forth in Subsection (c), unless and until: (i) the City Council has taken action, by resolution, to designate a specified area or areas for enforcement against sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right-of-way; (ii) the City has posted signage at the designated area or areas set forth in the resolution, with such signage including reference to any required findings adopted in the resolution, and giving notice of the date after which no sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right-of-way will be allowed; and (iii) at least 14 calendar days have passed from the date on which the signage is posted at the designated area or areas.

WHEREAS, there exists within Council District 15, 11 facilities opened after January 1,2018, that provide shelter, safe sleeping, or safe parking to homeless persons, or that serve as a homeless services navigation center;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to Los Angeles Municipal Code (LAMC) Section 41.18(c)(3) and 41.18(d) hereby prohibits sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, in or upon any street, sidewalk, or other public rights-of-way within a radius of 1,000 feet from the following designated facilities that provides shelter, safe sleeping, or safe parking to homeless persons, or that serves as a homeless services navigation center:

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence or the Mayor; and

WHEREAS, there are significant gaps in coverage in the U.S. health care system for individuals with serious mental illnesses that often lead to homelessness; and

WHEREAS, Medicaid is the largest payer of mental health services in the country and it is necessary to expand Medicaid coverage; and

WHEREAS, it is important to provide in-patient beds to individuals experiencing mental health crises who, without the services, often end up in the prison system or on the streets; and

WHEREAS, currently pending in Congress is a bill, H.R. 2611, the Increasing Behavioral Health Treatment Act, which would repeal the Medicaid Institutions for Mental Disease (IMD) payment prohibition and would require states to submit a plan to increase access to outpatient and community-based behavioral health care; and

WHEREAS, the IMD payment prohibition is a policy that prohibits the federal government from providing Medicaid matching funds to states for services delivered to certain Medicaid-eligible individuals who are in hospitals or nursing facilities that provide diagnostic services, treatment, or care to people with mental diseases; and

WHEREAS, the Increasing Behavioral Health Treatment Act will remove the IMD exclusion for states that have submitted a plan to increase access to outpatient and community-based behavioral health care services, increase availability of crisis stabilization services, and improve data sharing and coordination between physical, mental health, and addiction treatment providers; and


WHEREAS, Los Angeles County supports H.R. 2611 and, if the federal legislation passes, the County will be able to develop the necessary inpatient and care services for people with serious mental illnesses; and

WHEREAS, it is in the City's interest to support the Increasing Behavioral Health Treatment Act because it would provide vulnerable populations in the City who have mental illnesses with the necessary care and services they need and potentially help reduce the number of individuals who fall into homelessness;

NOW, THEREFORE, BE IT RESOLVED, with concurrence of the Mayor, that by adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-22 Federal Legislative Program SUPPORT of H.R. 2611, Increasing Behavioral Health Treatment Act, which would repeal the Medicaid Institutions for Mental Disease payment prohibition and help provide adequate inpatient and or residential mental health treatment beds for individuals in need of critical services.

In 2013, a mass shooting near Santa Monica City College took the lives of six people and injured four more. In 2014 a bank robbery in Stockton and a shooting spree in rural Tehama County in 2017 killed six. In 2019, a 16-year-old killed two students and injured three others before killing himself at a school in Santa Clarita. And the next year, as protests over police violence filled city streets, Steven Carrillo used a machine gun to shoot two security guards at a federal building in Oakland and a sheriff's deputy in an ambush in Santa Cruz. All of these shootings were committed using 'ghost guns' – weapons that are assembled from parts or kits that include one unfinished piece, typically the frame or receiver, which is the part of the gun regulated under federal law.

The kits, which cost between \$400 and \$525 come in cardboard boxes containing steel barrels, plastic frames, and a number of small plastic and metal parts. Because the parts are not finished guns, they mostly escape California's gun control laws and, once assembled, have a feature that distinguishes them from manufactured weapons: no serial number. Not only will the assembled guns have no serial numbers, but because they are sold as unfinished kits they are exempt from laws requiring background checks and waiting periods. There are no federal restrictions on who can buy ghost gun kits, how many kits or parts someone can purchase, and they are intentionally marketed as unregulated and untraceable to appeal to persons prohibited from purchasing firearms legally.

Sending a wave of weapons without serial numbers or known purchasers onto our streets creates obvious dangers, and officials say the number of these guns has soared. In 2020, Carlos A. Canino, the Special Agent in charge of the ATF Los Angeles Field Division noted that 41 percent of cases are turning up ghost guns, and last month, during an announcement of a new federal strike force launched by the U.S. Department of Justice focused on disrupting the illegal flow of weapons into Los Angeles and the sale of ghost guns locally, LAPD Chief Michel Moore said these guns now account for a third of all weapons recovered by the Department.

The ease with which these guns can be ordered and assembled, and the difficulties in tracing them have made them readily available throughout California. At the same time, shootings and homicides have surged since the onset of the COVID-19 pandemic, and Los Angeles has been no exception. As of July, 2021 homicides were up nearly 30 percent over last year and shootings were up 43 percent. The city ended 2020 with 350 homicides, the most in a decade. Ghost guns have been a "significant influencer" in the surge of gun crime, according to Chief Moore, "because they give criminals who aren't allowed access to firearms the ability to get weapons."

The City of San Diego recently approved an ordinance that prohibits buying, selling or possessing the frame of an unfinished gun unless it has a serial number — essentially treating the unfinished part like a completed firearm. A violation would be a misdemeanor. The City of Los Angeles should follow suit.

I THEREFORE MOVE that the City Attorney be requested to draft an ordinance prohibiting the possession, purchase, sale, receipt and transportation of non-serialized, unfinished frames and unfinished receivers, and non-serialized firearms with the City of Los Angeles.

PUBLIC WORKS

The City of Los Angeles' Equestrian Facilities Trust Fund contains annually assessed Equine License Fees paid by equestrian riders in Los Angeles, and the funds are devoted to "provide for construction of new equestrian facilities". Shadow Hills is a horse-keeping community in Council District 7 intersected by Sunland Blvd, a major corridor with heavy traffic. To provide the equestrian community with safe passage, a High-Intensity Activated Crosswalk (HAWK) beacon signal is needed at Sunland Blvd and Johanna Ave, to enable equestrians to cross from the established bridle path running along the north side of Sunland Blvd to the trail system on the south side, and thereby strengthen connectivity through the Foothills horse-keeping communities.

There are sufficient funds in the City's Equestrian Facilities Trust Fund which can be transferred to the Department of Transportation and the Bureau of Street Lighting to start the planning and project design which is necessary to move forward with the project. Action is needed to begin work on this effort by transferring money from the Equestrian Facilities Trust Fund and to instruct the involved City departments to identify a contractor for the construction of the project.

I THEREFORE MOVE that the Council, subject to the approval of the Mayor:

1. Authorize \$455,500 in the Equestrian Facilities Trust Fund No. 212 be appropriated to a new Account in the Department of Transportation Trust Fund No. 840-94, entitled "Sunland Blvd at Johanna Ave Improvement";
2. Authorize transfer therefrom \$5,000 to Transportation's General Fund 100, Department 94, Overtime Account Number 001090 for staff design cost, and transfer therefrom \$5,000 to Street Lighting's General Fund 100, Department 84, Overtime Account Number 001090 for staff design cost;
3. That the Bureau of Contract Administration immediately informs the departments when the above-described improvements are completed and accepted by Contract Administration,
4. Authorize the Chief Legislative Analyst, or her designee, to make technical corrections or revisions as may be necessary to implement the intent of this motion.


