The City recently executed a new contract with Urban Alchemy as part of the Skid Row Cleaning Program. Under the contract, managed by the Board of Public Works, Urban Alchemy is responsible for removing litter from City sidewalks, gutters, tree wells, and planters; sidewalk "sharp" pickup and safe disposal; reporting vandalism on public infrastructure; removing overflowing debris from City trash cans; and collecting and reporting large refuse items in the public right-of-way within the Skid Row area.

This Urban Alchemy Skid Row Clean Team operates eight hours a day, seven days a week, performing a vital service that helps prevent the buildup of trash and debris for residents experiencing homelessness on our City streets awaiting services and housing interventions. Under the program and as a general company practice, Urban Alchemy recruits and hires individuals who are or have experienced homelessness and/or are formerly incarcerated to their staff as well as their Skid Row Clean Team. As a result, the program is providing local employment opportunities to individuals who may have few options to earn a steady income, while performing much needed services in our City.

The Skid Row Cleaning Program launched in 2019 and, due to its success, has continued each successive year, funded by the Homeless, Housing, Assistance, and Prevention Program. The current contract runs through the next year with two one-year extension options. Given the ongoing positive work that is done under this program, the Council should assess this program's effectiveness and its potential scalability for expansion to other areas of the City.

I THEREFORE MOVE that the Board of Public Works, with the assistance of the Bureau of Sanitation, be instructed to report on the efficiency and effectiveness of the work performed by the Urban Alchemy Clean Team in Skid Row to reduce litter and bulky item trash and to report on the feasibility of expanding this program Citywide.

HOUSING

The City of Los Angeles' Home Sharing Ordinance was adopted by the City Council in 2018. Despite the passage of this much-needed ordinance, enforcement of unpermitted and non-compliant home sharing operations has posed a consistent challenge for the City since the ordinance's adoption. A *Los Angeles Times* investigation in 2020, for example, found that thousands of unpermitted rentals, including units covered by the Rent Stabilization Ordinance, were listed on hosting platforms and that a majority of unlicensed hosts were never penalized by the City. In addition, according to a recent McGill University report prepared for Better Neighbors LA, over 35% of Los Angeles' advertised short-term rental listings have been illegal since the home sharing ordinance went into effect. The report also found that as of September 2019, short-term rentals had removed 7,300 housing units from the City's long-term housing market.

The consequences of insufficient enforcement are significant. Short-term rentals have destabilizing effects in communities by removing units from the housing market and creating quality-of-life issues for neighbors. During an affordable housing crisis especially, the City must not allow rent stabilized units to be removed from the City's housing stock and tenants to to be subjected to displacement pressures without decisive enforcement. While the Planning Department has made important strides in identifying and citing unpermitted listings, the expeditious citation and de-listing of non-compliant properties remains a challenge that will require interagency coordination between various City departments to address. Doing so, however, is an essential step in our ongoing efforts to stabilize and protect our neighborhoods.

I THEREFORE MOVE that the City Council instruct the Planning Department, with the assistance of the Department of Building and Safety, the Housing and Community Investment Department, Los Angeles Police Department, the City Attorney's Office, the Office of Finance, and any other City departments, as needed, to report back within 90 days with an analysis that considers the following:

- Recommendations for how the City can address, among other issues that may emerge in the report-back process, non-compliant hosts renting out properties listed as a primary residence in which they do not live, the conversion of critical affordable housing stock such as rent-stabilized units and covenanted affordable housing units into short-term rentals, the conversion of multifamily residential structures to short-term rentals, short-term rentals engaging in a commercial uses/activities, and properties being rented for longer periods of time than is permitted;
- Enforcement mechanisms that could be implemented in the City of Los Angeles, such as escalating citations and fines, license revocations, and criminal penalties;

- The home sharing regulatory and enforcement models of other cities, including but not limited to, Austin, New Orleans, and San Francisco, nationally, and Lisbon, Portugal, Toronto, Canada, and Berlin, Germany, internationally;
- Strategies for ensuring that all home-sharing platforms operating within the City of Los Angeles enter into platform agreements requiring the sharing of data with the City;
- Strategies for implementing and/or improving real-time data collection, trend monitoring, address identification, compliance monitoring, monthly status reports, and the processing of violations by City departments and complaints by residents; and
- The hiring of additional staff or the creation of a dedicated unit, office, or department that would consolidate the various aspects of home sharing compliance and enforcement in one multidisciplinary team.

I FURTHER MOVE that the City Council instruct the Planning Department, working with the Department of Building and Safety, the Information Technology Agency, and any other relevant City departments, to report back within 90 days with a plan for the creation of a centralized, digital database or platform that is updated on a continual basis to better coordinate data tracking of non-compliant properties for monitoring and enforcement purposes.

I FURTHER MOVE that the City Council instruct the Planning Department, working with the Department of Building and Safety, the Information Technology Agency, and any other relevant City departments, to ensure, within 90 days, that the public be able to view on an existing or new publicly accessible online database or platform whether any property in the City has a Home-Sharing License, a Home-Sharing License Renewal, or an Extended Home-Sharing License.

The City of Los Angeles (City) is one of the largest employers in the region, employing more than 40,000 people across 44 departments. From street repairs and park programming to infrastructure development and sanitation services, these departments collectively work to maintain the health, well-being and safety of our communities. Beyond these services, the City hires for a diverse field of occupations that are relatively stable, well paid, and with career pathways.

Current demographic and economic trends continue to transform the employment needs of City departments. The City's workforce is aging, creating a greater demand for operational positions. Current data shows that close to 46% of City employees are expected to retire, projected to leave many jobs vacant and unfilled over the upcoming few years. Moreover, the COVID-19 pandemic has exacerbated these trends, with many employees participating in the City's Separation Incentive Program.

To meet this challenge, the City has enacted a series of policies and measures, including the Targeted Local Hire and Bridge to Jobs Programs, to promote equitable opportunities in the City's hiring practices. To build on the success of these programs, the City can do more to address occupational shortages, improve cultural competency, and deliver opportunities to targeted workers facing the greatest barriers to employment. Currently, the City's Department of Public Works (DPW) is providing important leadership in targeted hiring efforts, by collaborating with the Los Angeles Black Worker Center (LABWC) to develop a training program that improves recruitment of Black workers for jobs in the six DPW bureaus.

Another viable high road training model to implement is Los Angeles County's (County) PLACE Program (The Preparing Los Angeles for County Employment). High Road Training Partnerships (HRTPs), according to the California Workforce Development Board (CWDB), are "industry-based, worker-focused training partnerships" that provide employers with a skilled workforce, while ensuring that workers have ample opportunities for economic mobility. HRTPs can help to address issues of workforce equity, job quality, and environmental sustainability.

To advance equity and job quality, PLACE connects individuals with identified barriers to employment, particularly those with lived experiences of homelessness and justice-involvement, to permanent, full-time County jobs. Individuals are recruited for County jobs, prepared for those jobs and the associated civil service exam, and if successful, placed on an eligible list for hire into the County. The program offers pre-employment education customized for selected departments, intensive case management and support aligned with the principles of a trauma-informed approach.

Since 2018, PLACE has successfully recruited, trained and hired more than 115 individuals with barriers to employment, in partnership with the Departments of Public Works, Parks and Recreation, Beaches and Harbor, Health Services and the Fire

Department in Los Angeles County. Seventy percent (70%) of PLACE graduates are hired into full-time permanent positions in County departments.¹ Ninety-four percent (94%) of PLACE hires passed their probation period on the job.

As one of the largest employers in the Los Angeles region, the City has an opportunity to lead by example and invest in innovative programs that enable our most vulnerable residents to get good, quality jobs and build better lives that support their families and communities. This requires a heightened investment in new models of workforce innovation and a strengthened commitment to resolve systemic issues that impair equitable hiring and the creation of career pathways.

I THEREFORE MOVE that the City Council instruct the Personnel Department, with assistance of the City Administrative Officer (CAO), the Chief Legislative Analyst (CLA), and City Attorney, and in consultation with community stakeholders such as the Worker Education & Resource Center (WERC), to develop a plan in 90 days with recommended steps for implementing a Citywide Career Pathways Pilot Program, modeled after the County's PLACE Program, to recruit, train and hire future City employees, that includes High Road Training Components and ensures the success of participants with the greatest barriers to secure City employment. This plan should:

- Evaluate current and future occupational needs across City job classifications and work with City departments to identify entry-and-mid-level classifications within and beyond the Targeted Local Hire and Bridge to Jobs Program;
- Assess barriers that prevent targeted populations from applying and gaining access to entry-and-mid-level civil service careers, including the type of competitive examinations (written and oral) used across job classifications and evaluative practices for hiring; and
- Identify key partners, potential funding sources, and any adjustments that may be necessary, consistent with civil service requirements, in City recruitment, application and exam practices.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, the COVID-19 pandemic has significantly impacted the writing industry, which further accelerated the decline in full-time writing positions in newsrooms and other publications; and

WHEREAS, in April 2020, the New York Times estimated that 36,000 workers at news outlets had been laid off, or had their positions reduced; and

WHEREAS, the 1935 Federal Writers' Project was included as one of the New Deal jobs programs, and employed writers, librarians, clerks, researchers, editors, and historians for a number of purposes, including documenting the effects of the Great Depression; and

WHEREAS, the 1935 Federal Writers' Project provided employment to roughly 10,000 individuals over its duration; and

WHEREAS, HR 3054 (Lieu), the 21st Century Federal Writers' Project Act, would create a modern version of the 1935 Federal Writers' Project, aimed at recording the societal impacts of the COVID-19 pandemic in the United States; and

WHEREAS, HR 3054 would provide \$60 million in funding to nonprofit institutions of higher education, newsrooms, public or nonprofit libraries, and communications unions or guilds to support unemployed and underemployed writers working to record the impacts of the COVID-19 pandemic on American society;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 Federal Legislative Program SUPPORT for HR 3054 (Lieu), the 21st Century Federal Writers' Project Act, which would create a grant program to provide funding for organizations to employ individuals to document the broad impacts and effects of the COVID-19 pandemic in the United States.

TRANSPORTATION

MOTION

California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, those vehicles that are six feet or more in height, on identified City streets during certain hours. The Los Angeles Municipal Code Section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between certain times. Areas have experienced public safety issues associated with large vehicles that are parked overnight and block travel lanes, thereby creating hazardous conditions. The Department of Transportation can post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed in the resolutions.

It is important to understand the Department of Transportation process for citing and towing oversized vehicles. It is also important to understand the role of the Los Angeles Police Department and Police Commission Investigation Division in this process.

I THEREFORE MOVE that the Department of Transportation and the Police Department with the assistance of the Police Commission Investigation Division be directed to report in 30 days on the current process for towing oversized vehicles in violation of posted signs.

RESOLUTION

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, the Los Angeles Municipal Code Section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between 2:00 a.m. and 6:00 a.m.; and

WHEREAS, there is an increased problem with oversized vehicles parking along a segment of Sherman Grove Avenue in the Sunland community where large vehicles are often parked overnight and constrict travel lanes, thereby creating dangerous situations;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to the Municipal Code Section 80.69.4, and the California Vehicle Code Section 22507, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 7 feet in height, during the hours of 2:00 a.m. and 6:00 a.m., along both sides of Sherman Grove Avenue between Le Berthon and Hillrose Streets.

BE IT FURTHER RESOLVED that upon the adoption of the Resolution, the Department of Transportation be directed to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed, at the above locations; and

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.
