

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, in 2018, 63 percent of California voters voted in favor of Proposition 12 (Prop 12), the Farm Animal Confinement Initiative, which established minimum space requirements based on square feet for calves raised for veal, breeding pigs, and egg-laying hens; and

WHEREAS, the approval of Prop 12 represented incremental progress from the requirements mandated by Proposition 2, whose overwhelming passage in 2008 began a national movement to improve conditions for hens, calves and pigs; and

WHEREAS, currently pending in Congress and Senate are H.R. 4999 (Hinson) and S. 2619 (Marshall), the Exposing Agricultural Trade Suppression Act (EATS Act), which seek to prevent state and local jurisdictions from interfering with the production and distribution of agricultural product in interstate commerce; and

WHEREAS, introduction of the EATS Act comes after unsuccessful legal challenges to the constitutionality of Prop 12 when in July 2021, the ninth Circuit Court of Appeals affirmed the dismissal of a lawsuit filed by the National Pork Producers and American Farm Bureau Federation, which alleged that Prop 12 violated the Commerce Clause of the Constitution by placing an undue burden on interstate commerce; and

WHEREAS, the EATS Act is a regressive measure that intends to invalidate laws designed to protect animals from inhumane conditions;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 Federal Legislative Program OPPOSITION to H.R. 4999 (Hinson) and S. 2619 (Marshall) which would prevent State and local jurisdictions from interfering with the production and distribution of agricultural product in interstate commerce.

RESOLUTION ULES, ELECTIONS, INTERGOVERNMENTAL RELATIONS

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, the City of Los Angeles decriminalized sidewalk vending in 2017 and began a process in 2018 to create a formal program for regulating vending, including through the establishment of a permitting system and the creation of rules and regulations to govern the practice of vending in public spaces (C.F. 13-1493); and

WHEREAS, despite these laudable goals, the City continues to face barriers to formalizing its street vending economy—especially with regard to food vending—such that only 165 out of the estimated 10,000 food vendors in the City of Los Angeles have been issued permits; and

WHEREAS, under these conditions, the vast majority of food vendors in Los Angeles are still operating informally, which not only means that vendors face the threat of citations, fines, and the confiscation of their carts and wares, but also that local government agencies in Los Angeles have limited means for ensuring food safety and other elements of public safety in the context of food vending; and

WHEREAS, it is to the detriment of vendors, the City, and the general public that Los Angeles has not been more successful in formalizing sidewalk vending; and

WHEREAS, the greatest obstacle to vendors securing necessary permits to vend legally is the regime of food safety regulation established by the California Retail Food Code (CRFC) and Los Angeles County's Department of Public Health (DPH); and

WHEREAS, many provisions established by CRFC and DPH are misaligned with the practical realities of sidewalk vending, are nearly impossible to include in the design of a food vending cart intended for sidewalk use, and/or make a code-compliant cart prohibitively expensive for low-income entrepreneurs; and

WHEREAS, the current system for regulating food vending thus makes it nearly impossible for food vendors to secure a health permit from DPH, without which they cannot secure a vending permit from the City of Los Angeles; and

WHEREAS, research from the UCLA School of Law Community Economic Development Clinic and non-profit organizations such as Inclusive Action and Public Counsel has shown that there are several changes that both the State and County can implement that would make health compliance significantly more feasible for vendors while having no negative impact on food safety; and

WHEREAS, other cities such as New York City and Portland, Oregon, have put in place more realistic food safety regulations in order to ensure sidewalk vendors can comply and have not witnessed any negative impacts on public health; and

WHEREAS, creating a more inclusive, practical system for regulating food safety—one in which vendors can actually engage—would result in significant benefits to public health by ensuring that vendors can operate in full view of public health authorities; and

WHEREAS, the Department of Public Health of the County of Los Angeles is currently studying the feasibility of several changes to its own food safety regulations, which in some cases impose additional burdens on food vendors beyond those created by State regulation; and

WHEREAS, if the City of Los Angeles is to make any significant progress in formalizing its food vending sector, we require urgent action from the State Legislature to amend elements of the CRFC that make compliance infeasible for vendors;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-2022 State Legislative Program support for or sponsorship of legislation or administrative action to enact changes to the California Retail Food Code that will make it more sensitive to the context of sidewalk vending while ensuring food safety, including but not limited to:

- Streamlining approvals for code-compliant carts, including by giving more discretion to local health authorities;
- Revising regulations around the slicing of fruits and vegetables and the hot-holding of prepared foods to establish clear and easy-to-follow safety protocols that account for the types of foods commonly sold by sidewalk vendors;
- Simplifying onerous sink requirements; and
- Expanding the definition of safe locations for food preparation, in part by making the Cottage Food and Microenterprise Home Kitchen program more inclusive of sidewalk vendors.

MOTION

The City of Los Angeles must take the lead in pursuing environmental justice in our coastal communities. Recent debates over land return at Bruce's Beach are just one example of the painful legacy of racism and exclusion that was for too long built into our land use policies. The Coastal Zone must be made accessible to all Angelenos. As a City we must heal those communities harmed by a legacy of discriminatory practices.

The California Government Code §65040.12 defines "environmental justice" as the fair treatment of people of all races, cultures, and incomes with respect to the development, adoption, implementation, and enforcement of environmental laws, regulations, and policies. Furthermore, AB 2616 (Burke) amended the Coastal Act in 2016 to give all local governments, including the City of Los Angeles, the authority to consider environmental justice, or the equitable distribution of environmental benefits, when acting on a coastal development permit.

Subsequently, in 2019, the California Coastal Commission unanimously approved an 'Environmental Justice Policy' to ensure equitable access to clean, healthy, and accessible coastal environments. This policy document recognizes the injustices carried out against indigenous communities, communities of color, and other marginalized populations through discriminatory land use policies. However, local jurisdictions like the City of Los Angeles remain squarely responsible for ensuring equitable and fair housing practices, as the Coastal Commission lost authority to protect and create affordable housing in 1981.

To empower our local decision makers to advance State policy and Coastal Commission guidance, the City of Los Angeles would benefit from a similar framework to integrate environmental justice and equity into land use decisions in the Coastal Zone that require a Coastal Development Permit. A 'Coastal Equity and Environmental Justice Policy' would not only place our local determinations in greater conformity with Chapter 3 of the California Coastal Act of 1976, but take a step towards correcting decades of injustice and exclusionary land use practices.

I THEREFORE MOVE the City Council DIRECT Los Angeles City Planning in coordination with the Department's Office of Racial Justice, Equity, and Transformative Planning to report back within 60 days with a work program to develop a 'Coastal Equity and Environmental Justice Policy' that will inform future land use policy, promote greater public participation and engagement with underrepresented and/or underserved communities, and be reflected in project determinations in the Coastal Zone.

I FURTHER MOVE that City Council DIRECT Los Angeles City Planning, with assistance from Los Angeles Housing Department and other relevant agencies, to report back with a detailed analysis within 60 days on topics related to housing equity and access in the Coastal Zone; including, but not limited to:

- historic housing and demographic trends;
- displacement and gentrification effects on historically marginalized populations;
- impact of new development and housing typologies (e.g. small lots, mansionization) on available market rate and affordable housing stock; and
- the cumulative impacts of historic downzoning and land use policy on housing capacity.

I FURTHER MOVE that City Council INSTRUCT the Los Angeles City Planning, with assistance from Los Angeles Housing Department and other relevant agencies, to develop and present Environmental Justice policy and program recommendations as part of the upcoming Venice Local Coastal Program, Venice Community Plan, and the "Plan for a Healthy Los Angeles" updates.

I FURTHER MOVE that the City Attorney be requested to prepare and present an Ordinance to add the park listed above to the list of parks closed at various times as specified in Los Angeles Municipal Code Section 63.44.

I FURTHER MOVE that the Board of Recreation and Parks Commissioners be requested to concur with the above recommendations and to instruct the Park Rangers to enforce the new operating hours at the park listed above seven days a week.

WHEREAS, the film and television industry is a huge economic engine in California and in 2019 created 212,520 direct jobs paying an estimated \$28 billion in wages and supported 664,810 jobs through payments to on local vendors and other businesses, and

WHEREAS, the creation in 2014 of the California Film & Television Tax Credit Program, with the support of a strong Labor-Management coalition, revitalized the industry, brought back thousands of union jobs and contributed to the industry's prosperity, and

WHEREAS, the International Alliance of Theatrical Stage Employees ("IATSE") is the union that represents 52,000 skilled crew and craftspeople living and working in California including production and department coordinators, writers' assistants, cinematographers, costumers, grips, script supervisors, technicians, designers, and other essential below-the-line employees that are the backbone of the industry and their hard work, skill and dedication helps to create the magic of movies & TV, and

WHEREAS, workers have risked their health and safety for the last year and a half, working through the COVID-19 pandemic to ensure that the motion picture and television production industry emerged intact and who have worked day and night to return production to pre-pandemic levels; and

WHEREAS, IATSE is currently in collective bargaining with the Alliance of Motion Picture and Television Producers ("AMPTP"), and are seeking similar working conditions the studios already afford union counterparts in other countries, including Canada and throughout Europe, and

WHEREAS, IATSE and AMPTP have reached a deadlock over work practices for its members in this State and across the country, and

WHEREAS, if IATSE and AMPTP cannot come to an agreement and IATSE calls for a strike authorization vote of their members, that a strike would risk shutting down California State film and television production, and

WHEREAS, the strike would impact not only all of the 13 IATSE Hollywood Locals, but also locals across the State that together represent 52,000 working women and men who live in our State, and

WHEREAS, behind every great film and TV show is a great film and TV crew who create the magic of TV and movies that has gotten so many people through the pandemic and that they look forward to seeing on the big screen,

NOW, THEREFORE, BE IT RESOLVED, that the City of Los Angeles urges Alliance of Motion Picture and Television Producers and International Alliance of Theatrical Stage Employees to bargain in good faith and to come to an agreement on a fair contract that addresses safety concerns.

MOTION

The Active Transportation Rail to Rail Corridor Project consists of one corridor in two phases of development. Segment A is the Rail to Rail component and Segment B is the Rail to River component. Together they form one route, stretching from South Los Angeles to the Los Angeles River.

The Rail to Rail segment of the project connects the Metro Blue Line to the future Crenshaw/LAX Line. Approximately 5.6 miles in length, the project stretches east along the Harbor Subdivision rail right-of-way following Slauson Avenue from Inglewood through South Los Angeles to the Blue Line Slauson Station. The project will convert the underutilized railroad right-of-way into a multi-purpose transportation corridor, including creating a new east-west pedestrian and bicycle corridor, connections to numerous transit lines, and enhancing the existing and future bicycle network. Segment A has concluded the environmental review and clearance, as well as the preliminary design phase. The project is now entering the final design and construction phases.

1 THEREFORE MOVE that the City Council instruct the Bureau of Engineering, with the assistance of the Department of Transportation and the Bureau of Street Lighting, StreetsLA and any other relevant City department, to negotiate a Memorandum of Understanding (MOU) with the Los Angeles County Metropolitan Transportation Authority that commits the City to fund and construct up to \$30 million in necessary improvements in the City's right-of-way for the Rail to Rail Corridor Project, with funding sources to be determined, including the preparation of a multiyear funding plan and time line for design and construction, with the final MOU to be presented to Council for approval.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, the Immigration and Nationality Act (INA) defines a child as a person who is unmarried and under 21 years of age; and

WHEREAS, if someone applies for lawful permanent resident (LPR) status as a child, but turns 21 years of age before being approved for LPR status (also known as getting a Green Card), that person can no longer be considered a child for immigration purposes and must file a new application for consideration; and

WHEREAS, "documented dreamers" are young immigrants who are issued H-4 visas as dependents of visa holders, and on average, were brought to the U.S. at the age of five and have been living in the country for an average of 12 years; and

WHEREAS, the extensive Green Card backlog forces parents to wait many years to receive permanent residence and, as a consequence, their dependent children risk losing the opportunity to properly adjust their immigration status; and

WHEREAS, if the child turns 21 years of age before their parents can qualify for a Green Card, the child loses both their H-4 visa status and their eligibility for permanent residence through their parent's application; and

WHEREAS, according to the CATO Institute, the phenomenon known as "aging out" forces thousands of "documented dreamers" to become undocumented, leave the country, or identify a qualifying temporary status designation to remain the U. S.; and

WHEREAS, "documented dreamers" do not qualify for programs such as the Deferred Action for Childhood Arrivals as it does not allow participation by individuals who already have temporary legal status; and

WHEREAS, the America's Children Act has been introduced in Congress to: 1) create a category for legal permanent residence for "documented dreamers" who are regarded as a dependent of any work visa holder (H1-B) who has resided legally in the U.S. for not less than 10 years and graduated from a U.S. university; 2) require that the age of a dependent child is the same as specified when a permanent residence application was filed; 3) create an extension of nonimmigrant status for dependents of work visa holders past their 21st birthday; 4) authorize children who are part of the Green Card backlog to work in the U.S., if they meet the age requirement; and, 5) allow "aged out" dependents to reclaim their place in line if their parents receive Green Cards and wish to sponsor them under the family-based system;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by adoption of this Resolution, the City of Los Angeles hereby includes in the 2021-2022 Federal Legislative Program SUPPORT for H.R. 4331 and S. 2753, known as the America's Children Act, which would provide a pathway to citizenship for "documented dreamers."

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, the Los Angeles Municipal Code Section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between 2:00 a.m. and 6:00 a.m.; and

WHEREAS, a commercial area of Chatsworth is experiencing public safety issues associated with large vehicles that are parked overnight adjacent to businesses and block travel lanes, thereby creating hazardous conditions;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to the Los Angeles Municipal Codes Section 80.69.4, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height, during the hours of 2:00 a.m. and 6:00 a.m. along the following street segments:

• Both sides of Lemarsh Street from Reseda Blvd to Lindley Ave

BE IT FURTHER RESOLVED that upon the adoption of this Resolution, the Department of Transportation be directed to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed;

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.
