

(Urban Place) for the creation of a new 501(c)6 non-profit business association to administer the Greater Leimert Park Village / Crenshaw Corridor Business Improvement Districts' (BID) operations. 
Urban Place has fulfilled the initial scope described in their contract, however the BID's new board members have requested further assistance with establishing BID operations, including:

1. Working with Board officers to establish a bank account;
2. Facilitating a contract between the City of Los Angeles and the new non-profit corporation;
3. Creating a 2022 budget for Board consideration and approval;
4. Working with the Board to identify, review and help select a BID administrator;
5. Updating the BID portal with any required documents;
6. Overseeing initial Board meetings; and
7. Establishing and facilitating BID administrator training on the new organization, Management District Plan, City policies, the BID portal, board meeting procedures and policies that comply with the Brown Act, and financial policies.

Action is needed to authorize a supplemental agreement with Urban Place for the above listed services.

On October 21, 2021, in New Mexico, Halyna Hutchins, the cinematographer for the film, "Rust," was tragically killed and the film's director, Joel Souza, was injured when a handgun held by actor/co-producer Alec Baldwin discharged during a rehearsal. Baldwin had been told by the assistant director who handed him the gun that it was "cold," which means not loaded with real ammunition. That apparently was incorrect.

This incident has raised questions about the efficacy of using real weapons on movie and television shoots. Existing film industry regulations and protocols are intended to prevent real firearms and live ammunition from resulting in tragedies such as this one. Unfortunately, the reliability of these regulations and protocols depends upon the level of experience, diligence and professionalism of the weapons master or armorer employed to oversee the maintenance, safekeeping and use of such weapons.

The ongoing investigation in New Mexico has already uncovered indications that, in all likelihood, they weren't followed on the set of "Rust." Such deviations from the prescribed procedures can lead to dangerous situations such as that which occurred on this set. It appears that live ammunition rounds found their way onto the set and the prescribed chain-of-custody for the handgun in question was broken, resulting in at least one live round being loaded in the gun used in the accident, with fail-safe measures not being employed.

There previously have been similar tragedies on movie and television sets involving the misuse of handguns, including the death of actors Jon-Erik Hexum and Brandon Lee, which also could be attributed to breakdowns in the on-set rules and procedures. Comments from the "Rust" crew indicate that the Baldwin incident is not the only firearms-related problem to have occurred on this shoot, and the crew member who handed the gun to Baldwin previously had firearm-related problems in at least one previous film job.

The Los Angeles Times and a member of the California State Legislature have recently suggested that the best way to avoid these kinds of incidents would be to more forcibly regulate the presence of live ammunition and firearms that are used in the context of moviemaking. State Senator David Cortese has announced his intention to introduce legislation to ban "live" or "hot" guns on movie and television productions in California. In a recent editorial the Times opined that, because technology has reached a point where the use of guns can economically be replaced with technology and that guns are used in production more often than they are in real life, there is no need for real guns or live ammunition in such productions. This would reduce the industry's dependence upon the reliability of crewmembers assigned to manage firearms and ammunition on sets and on location.

Formally prohibiting the presence of operable firearms and live ammunition on TV and film shoots would be the ultimate fail-safe measure and would not be an impediment to the creation of realistic action in productions.

I THEREFORE MOVE that the City Attorney be requested to draft an ordinance prohibiting operable firearms and live ammunition from the sets and locations of television and motion picture productions taking place within the City of Los Angeles.

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies, proposed to or pending before a local, state, or federal government body or agency, must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, the Housing Element of the General Plan, also called "*the Plan to House LA*," identifies the City's housing needs and opportunities and establishes clear goals and objectives to inform future housing decisions, and when the ongoing update to the Housing Element is completed, it will guide the creation and implementation of the City's housing policy from 2021 to 2029; and

WHEREAS, State law requires the City to update its Housing Element every eight years and demonstrate sufficient zoned capacity for housing to accommodate the number of units identified in the Regional Housing Needs Assessment (RHNA); and

WHEREAS, the Planning Department is working alongside the Housing & Community Investment Department (HCIDLA) on the update to the Housing Element, inasmuch as cities throughout California must submit their updates to the State of California Department of Housing and Community Development this year; and

WHEREAS, updating and submitting the City's Housing Element is time-consuming as the City must provide an inventory and analysis of sites that are available for housing development and identify the development of programs that eliminate barriers to housing, assist in the development and preservation of lower and moderate-income housing, address the needs of the homeless population, and conduct an extensive public outreach process to ensure community support for the final program; and

WHEREAS, Senate Bill 9 (Atkins) (the "Bill" or "SB 9"), entitled the California Home Act, was signed into law by the Governor on September 19, 2021 and becomes effective on January 1, 2022. The Bill amends Government Code Section 66452.6, and adds two new Government Code Sections 65852.1 and 66411.7; and the Bill will require cities and counties, including charter cities, to provide for the ministerial (or "by right") approval of a housing development containing two residential units of at least 800 square feet in floor area ("duplex") and a parcel map dividing one existing lot into two "lot split" within a single-family residential zone for residential use; and


WHEREAS, the option to submit an addendum to the Housing Element to the State of California Department of Housing and Community Development would allow the City, and greater Southern California region, to continue to collaboratively work to address our housing and homelessness crisis with sufficient time to ensure that our housing policies and programs are effective; and

WHEREAS, on May 3, 2021, the Southern California Association of Governments (SCAG) requested a six-month extension to submit SCAG region cities and counties Housing Element updates that seek to address the state's housing crisis, and based on SCAG's RHNA Allocation Plan, adopted in March 2020, the City's 2021-2029 Housing Element must accommodate a total of 456,643 units, of which 184,721 units must be affordable to lower-income households (Very Low and Low); and

WHEREAS, the City's revised Housing Element must be adopted by the Council no later than October 15, 2021, or the City could lose eligibility for significant sources of affordable housing funding currently provided by the State;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2021-22 State Legislative Program SUPPORT for any legislation or administrative action that would allow a local jurisdiction to submit an addendum to their adopted housing element to calculate the additional capacity added by SB 9 (Atkins) and as part of *Adequate Sites for Housing* in the Housing Element, which require that cities and counties have adequate land zoned for housing to accommodate expected population growth.



Extreme heat is the deadliest climate risk facing Los Angeles. It is exacerbated by the urban heat island effect, which occurs when pavement, roofs, and other surfaces absorb heat emitted from the sun, instead of reflecting it back into the atmosphere. The recent UN Intergovernmental Panel on Climate Change "Code Red" report projects that as global temperatures rise, the frequency and intensity of heat waves will increase commensurately. Los Angeles experiences the most extreme heat waves within the state and the California Fourth Climate Change Assessment Report estimates that the temperature in the city will continue to increase by four to five degrees over the next few decades.

Extreme heat can lead to heat-related illness, such as heat exhaustion and heat strokes, and aggravate pre-existing health conditions, like diabetes and heart disease. In September 2021, Los Angeles County experienced a record-high temperature of 121 degrees, which increased emergency room visits by ten times and took seven lives. The County Department of Public Health found that since 2005, heat-related hospitalizations have greatly increased, especially in the San Fernando Valley.

Low-income communities often suffer most from extreme heat waves. Approximately 30% of Los Angeles households with an income of less than \$50,000 a year do not have an air conditioning system, and vulnerable and elderly Angelinos rely on a network of cooling centers to stay safe on the hottest days. In both Phoenix and Tucson, landlords are required to provide cooling for tenants and there is a right to a maximum 82 degree indoor temperature, while Los Angeles codes have no such requirement. Workers also face increasing dangerous exposure to heat exhaustion which diminishes productivity and jeopardizes health and safety.

Extreme heat impacts all Angelinos by stressing our City's basic infrastructure. It reduces cloud coverage and creates dry conditions that can increase the risk of wildfires. Stretches of the Metro and Metrolink network have had to shut down or reduce service to ensure heat does not cause rails to buckle or power wires to sag. Heat waves can cause our power grid to fail on the days electricity is most needed to provide life-saving cooling. Because these heat events impact such a broad swath of our economy and infrastructure, a coordinated and holistic approach is merited.

The Los Angeles Sustainable City Plan sets goals to decrease urban temperatures by at least 1.7 degrees by 2025 and 3 degrees by 2035, including strategies being implemented by multiple departments. Based on the research findings from the Los Angeles Urban Cooling Collaborative (LAUCC), led by TreePeople, one in four lives lost during heat waves could be saved if the City strategically increases tree canopy cover and installs cool surfaces.

With the rise of extreme heat events, some cities have created the position of a Chief Heat Officer (CHO). These positions raise awareness about the deadly impacts of extreme heat, set clear goals and metrics to track the impacts, collaborate across departments to develop new policies and programs, and convene stakeholder groups to work with community and public health organizations.

In order to efficiently implement effective policies targeting heat, Los Angeles should consider establishing a CHO. A CHO would set city-specific metrics and track data on urban heat and extreme heat events, convene stakeholder groups, hold departments accountable to deliver on goals, and support efforts in the Department of Public Works, Emergency Management Department, Department of Building and Safety, Fire Department, Department of Recreation and Parks, Planning Department, the Department of Water and Power, and other agencies. In addition to establishing policies, the CHO can raise awareness

about the severity of extreme heat waves through public education campaigns and partnerships with non-profit organizations.

I THEREFORE MOVE that the Chief Legislative Analyst, with the assistance of the City Administrative Officer, report back within 90 days on options to establish a City of Los Angeles Chief Heat Officer (CHO). The report should describe the potential responsibilities of the CHO, recommended governance, position authority, and annual budget. The CHO should be responsible for creating a Heat Action Plan, which at minimum should include the establishment of an early warning system, interagency emergency response plan (as described in CF#21-1167), and opportunities to reduce exposure using long-term strategies. The report should be prepared in consultation with relevant city departments and informed by non-profit organizations and community groups with expertise on extreme heat such as LAUCC members and participants in the CEMO Community Assemblies process. The report should also consider funding strategies, including opportunities for foundation or federal or state grant funding, including from the Governor's FY 21-22 budget.

I FURTHER MOVE that the Department of Water and Power report on the strategies it is taking to mitigate the impacts of extreme heat on the power system, including opportunities to expand customer-facing programs such as demand response and energy efficiency programs, and expanding the tree distribution program for eligible ratepayers.

I FURTHER MOVE that the Department of Buildings and Safety report on the feasibility of updating building codes to require that all new and existing buildings provide cooling or be cooling-ready; develop energy efficiency requirements for new and existing buildings that will reduce the load on the power sector and save customers on utility costs; and expand requirements under the cool roof ordinance to coat and treat non-roof surfaces with "cool" materials, including parking structures, and public buildings and infrastructure throughout the City.

I FURTHER MOVE that the Department of Emergency Management, with the assistance of the Department of Recreation and Parks and the Climate Emergency Mobilization Office, report on opportunities to improve the network of cooling centers, including non-traditional models for public and community partnership that engage local nonprofits and houses of worship in providing such spaces and in identifying Angelenos most vulnerable to heat.

I FURTHER MOVE that StreetsLA report on the impacts of its comprehensive Cool Streets LA program with recommendations for its expansion, particularly in the San Fernando Valley.

I FURTHER MOVE that the Department of City Planning report on strategies to expand access to cool spaces, to sustain and increase tree canopy cover, and to encourage or require access to more green spaces and shade hubs (such as "cool routes" or "safe routes to school") in neighborhoods, including progress on its Climate Action Plan.

WHEREAS, while other low-wage, high-violation industries have seen legislation aimed at reform, fast-food has not; and


WHEREAS, a lack of industry-specific protections has left California fast food workers vulnerable to a slew of employment violations; and

WHEREAS, California fast food workers have been organizing for 8 years to demand higher wages, safer workplace and an end to systemic wage theft, sexual harassment, discrimination and health and safety issues throughout the industry; and

WHEREAS, the COVID-19 pandemic exacerbated the fast food industry crisis. Researchers from the University of California, San Francisco found that line cooks had a 60% increase in mortality associated with the pandemic and that Latino(a) food service workers saw a 39% increase in mortality; in response to pandemic conditions, fast food workers took unprecedented action, filing more than 200 health and safety complaints and leading more than 300 strikes across the state to demand safer workplaces and a stronger voice on the job; and

WHEREAS, big corporations like McDonald's make billions of dollars in profits, but their frontline workers must rely on safety net programs to support their families; according to a joint report from UCLA and UC Berkeley, this costs California taxpayers \$4 billion annually; and

WHEREAS, fast food corporations not only fail to adequately protect and support workers, they also fail to support franchise operators; parent companies like McDonald's retain control over franchise operations and take a lion's share of profits, but they push the liabilities and risks of conducting those operations onto franchisees; franchisees also need the power and ability to push back against predatory corporate practices that eat into their profit

margins and force them to cut corners at the expense of workers; and

WHEREAS, it is evident that sector-wide improvements are urgently needed for California's fast food industry; and
