TRADE, TRAVEL, AND TOURISM COMMITTEE REPORT relative to modernizing the Los Angeles International Airport (LAX) by improving transit, reducing traffic, and pollution through the use of the LAX Transportation Management Operation (TMO), and related matters.

Recommendation for Council action, pursuant to Motion (Bonin – Harris-Dawson - Koretz):

INSTRUCT the Los Angeles World Airports (LAWA) to report back to Council within 120 days with the following:

a. An approach and timeline for setting its multi-year organizational and transit improvement goals for the recently established TMO, including vehicle miles traveled reduction. This includes the strategies LAWA will seek to implement, the metrics that will be tracked to ensure goals are met, proposed annual budget for the TMO, and a chart noting the management reporting structure of the organization. The report should also include details on how LAWA will track employee commute behavior and use this information to inform improvements to programs such as FlyAway, Metro, Iride, and regional bus providers. Finally, it should include an outreach strategy to provide ongoing information to the Board of Airport Commissioners, the public, particularly the Westchester Playa Neighborhood Council, employers participating in the TMO, City Council, the Los Angeles Department of Transportation (LADOT), and the Los Angeles County Metropolitan Transportation Authority (LA Metro).

- b. A strategy for the TMO office to capture data on badged employee working hours and commuting patterns; and how the data can be used to address, any gaps in commuter programs or public transit, work with participating employers to advise them on known problems late/early shift workers may have accessing transit, work internally with LAWA commuter program management and regional transit operators to improve service, and communicate improvements made to affected employers and employees.
- c. The financial and legal feasibility of LAWA-operated ride share, employee shuttle, and FlyAway services to be provided at no cost, reduced cost, or subsidized cost to airport-based employees with the goal of making those services cost competitive with driving alone in privately owned vehicles; and fully or partially subsidized transportation for airport employees via non-LAWA-operated transit services like LA Metro, LADOT, or other regional transit providers should be studied with consideration of what costs would be appropriately covered by the private sector employers, and what costs could be provided by LAWA through the TMO.
- d. Strategies to improve the competitiveness of public transit and commuter programs to airport workers, including but not limited to lowering the cost disparities between monthly parking passes, FlyAway employee transit passes, and existing or to be established employer commuter programs.
- e. The feasibility, including time and resources required, to establish an independent non-profit to administer an airport area TMO organization that encompasses employers in the City of LA, El Segundo, and nearby County unincorporated areas.

Recommendation for Council action, pursuant to Motion (Bonin – Krekorian - Koretz):

INSTRUCT the Los Angeles World Airports (LAWA) to report back to Council within 120 days with the following:

- a. Opportunities to generate power via renewable sources across the properties it owns at LAX, Van Nuys, and Palmdale. This should include the current status of projects under consideration and estimated timelines for completion of these projects should they be pursued. It should also discuss opportunities to cite those renewables, including on privately owned buildings at the airports, and on opportunities to site renewable energy systems with energy storage.
- b. Recommendations to increase use of sustainable aviation fuels (SAF) at LAX, including needed regulatory reforms statewide or nationally. The report should also discuss the availability of SAF at scale in the near-term for use at LAX, the carbon dioxide lifecycle emissions of those available fuels, and an estimation of the percentage of fuel used at LAX that can be feasibly be converted to SAF.
- c. The percentage of ground-based vehicles operating at LAX and Van Nuys that are zero emissions vehicles (both the LAWA fleet and private operators' fleets), incentive programs LAWA currently has in place to phase out emissions generating vehicles, electrification goals and timelines of the programs, whether these timelines can be feasibly accelerated, and whether the emissions factor targets within the existing ground support equipment emission Reduction Policy can be reduced further. The report should also include whether additional funding of LAWA's Electric Incentive Program may be necessary to expedite fleet-wide performance targets or lower the emission factors within the existing timelines.
- d. Any plans to electrify parking facilities, including the current percentage of passenger and employee parking spaces that offer electric vehicle charging, LAWA's multi-year goals to increase these

- percentages, and whether the strategy includes more favorable parking permit terms and costs for electric vehicles.
- e. A timeline to study an accelerated Sustainability Action Plan that would achieve carbon neutral facilities by 2035. The report should include a discussion of catalytic policy changes and investments to develop zero emissions transportation and buildings by that date.

- a. Good Jobs at LAX
  - i. Enhanced enforcement of existing LAX worker protections.
  - ii. Explore options, including but not limited to improving LAWA certification procedures, to better ensure use of responsible

airline contractors in passenger service, janitorial, security and ramp services at LAWA facilities.

### b. Transportation and Traffic Reduction

- Reduced or subsidized public transportation or reduced cost transportation options for airport workers to discourage use of single occupancy vehicles.
- ii. Work with relevant partners to improve frequency, reliability, and availability of airport-serving transit service.
- iii. Establish parking cost reductions for carpooling airport workers with no viable mass transit or commuter programs available either due to geographic distance or time of day schedule issues.
- iv. Explore potential sources of revenue to help fund commuter transit services and programs.
- v. Ensure safety in public transportation and parking facilities serving airport workers, working with relevant partners, through infrastructure improvements like lighting, cameras, emergency phones, and public safety personnel.

# c. Community Environmental/Health Studies

- Stronger protections for clean air and environmental health including investments in new technologies, procedures and infrastructure to reduce emissions and reduce pollution in flight path communities.
- ii. Accelerate transition to zero emissions ground equipment, ground vehicles, airport equipment, all airport buildings and infrastructure including electrification and renewable energy generation.
- iii. Working with the Air Quality Management District, determine effective ways to monitor air quality, including jet engine emissions, in nearby and flightpath communities, and how to fund such monitoring.

#### d. Enforcement and Monitoring

 Ensure worker representation on a LAWA advisory committee, such as the LAX Area Advisory Committee, that LAWA reports to on MOU status on at least a quarterly basis. ii. Develop a partnership between LAWA and MOU signatories, including consultation with signatories as LAWA advances MOU initiatives through the regulatory process, in an effort to ensure successful implementation of the agreement.

#### MOTION

In 2020-21, as a result of the financial impact of the COVID-19 Pandemic, the City implemented several cost-cutting measures affecting numerous departments and programs. These included the Separation Incentive Program, which resulted in the retirement of 1,377 City employees, and a Citywide Hiring Freeze, which prevented departments from filling critical positions.

The Department on Disability (Department) reports that it currently does not have sufficient staff resources to serve families with disabled individuals. Along with the increased workload resulting from the COVID-19 Pandemic, the Department has been responding to various City emergencies, including the 27th Street explosion, the California fire season, and, most recently, the MacArthur Park closure. Additionally, the Department is required by law to ensure that its website and documents are accessible to individuals with disabilities under Section 508 of the Rehabilitation Act and Title II of the Americans with Disabilities Act. As the Department is increasingly dependent on web-based solutions for personnel and public-facing functions, it is critical that the Department immediately fill its website-related positions.

The 2021-22 Adopted Budget restored several positions in the Department with six months funding, which were not anticipated to be filled prior to January 2022. The Department has requested to fill these positions earlier in order to address critical workload needs.

I THEREFORE MOVE that the City Council authorize the Department on Disability to hire the following positions, previously approved in the 2021-22 Adopted Budget, prior to January 2022: one Systems Analyst, one Graphics Designer II, and one Community Program Assistant II.

I FURTHER MOVE that the City Council instruct the Department on Disability to work with the City Administrative Officer and the Personnel Department to fill these positions quickly, well before January 2022.

#### PLANNING & LAND USE MANAGEMENT **MOTION**

The Mulholland Scenic Parkway Specific Plan (MSPSP) was adopted in 1992 to preserve the existing ecological balance and protect prominent ridges, streams, and environmentally sensitive areas, among other goals. The MSPSP established a Design Review Board (DRB) made up of seven appointed members including an appointee chosen by the Santa Monica Mountains Conservancy. The DRB is a diverse body with representation from architects, engineers, geologists, and area residents who provide a strong familiarity with this geography and community.

The MSPSP provides a set of environmental protection measures, grading limits, and building standards that are imposed on projects. It also establishes a "design review process" overseen by the DRB to implement over 90 rigorous guidelines that ensure all proposed projects minimize harm to the ecological balance of the Santa Monica Mountains, maintain compatibility with the community, and do not obstruct the views from Mulholland Drive.

On March 30, 2021, the Director of Planning released a memorandum to supersede the 1998 Director of Planning's memorandum and to reinterpret the Project Permit Compliance and Design Review Procedures for Visible and Non-Visible Projects in the MSPSP by removing non-visible projects from the purview of the DRB. Long-standing practice in the City has been to require virtually all new projects in the area to be subject to the provisions of the MSPSP and reviewed by the DRB (C.F. 98-1384).

This reinterpretation of the MSPSP may reduce the City's ability to protect our Wildland Urban Interface and manage our threatened natural resources, especially as the City's wildlife corridor and ridgeline protection policies have yet to be adopted. The City must continue to move towards achieving the principles of natural community conservation planning to effectively protect and conserve our ecology, while continuing to allow appropriate development and growth.

I THEREFORE MOVE that the Planning Department report back within 90 days on how the Specific Plan—particularly provisions C, G, H, I, K, and L—is in substantial conformance with the intent to manage development in environmentally sensitive areas in the absence of DRB review for all projects, visible and non-visible.

I FURTHER MOVE that the Planning Department report back within 90 days with an update on existing and future natural community conservation efforts such as the Wildlife Pilot Study, Ridgeline Protection Ordinance, and Hillside Construction Regulations, and with recommended strategies to introduce for Citywide implementation; and

I FURTHER MOVE that the Planning Department report back within 90 days with an analysis that:

- Assesses and identifies parcels of land that are appropriate for conservation as determined by trustee agencies such as the California Department of Fish and Wildlife and the Santa Monica Mountains Conservancy;
- Identifies fully protected species—as well as candidate, sensitive, or species of special status as determined by state or federal agencies—within these parcels; and
- Recommends additional measures required to comprehensively conserve and manage the City's natural biological diversity and encourage compatible and appropriate growth and development within these parcels.

## RESOLUTION PLANNING & LAND USE MANAGEMENT

WHEREAS, the Santa Monica Mountains Conservancy (SMCC) was created by the California State Legislature through the Conservancy Act (Act) in 1979 to preserve thousands of acres of parkland for wildlife, native plants, and public recreation within the Santa Monica Mountains Zone (Zone) and since that time, it has helped to preserve and open to the public over 75,000 acres of parkland in both urban and wilderness settings; and

WHEREAS, Section 33001 of the Public Resources Code identifies the Zone as "unique and valuable economic, environmental, agricultural, scientific, educational, and recreational resource that should be held in trust for present and future generations;" and

WHEREAS, public agencies reviewing projects under California Environmental Quality Act (CEQA) must notify trustee agencies and consult with them at various points in the environmental review process; and

WHEREAS, a trustee agency is defined as "a state agency that has jurisdiction by law over natural resources affected by a project, that are held in trust for the people of the State of California;" and

WHEREAS, on July 26,2021, the California Attorney General's office issued an advice letter to the SMMC confirming that the SMMC must be considered a CEQA trustee agency for projects affecting natural resources in the Zone, as defined in the Act; and

WHEREAS, additionally SMMC's Eastern Santa Monica Mountains Habitat Linkage Planning Map delineates the majority of habitat blocks and connecting wildlife corridors between the 405 and 101 freeways and should be considered for planning, conservation, and environmental impact analysis purposes; and

WHEREAS, it is a goal of the City to conserve and manage development in environmentally sensitive areas through efforts such as natural community conservation planning;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby recognizes the Santa Monica Mountains Conservancy as a trustee agency pursuant to the California Environmental Quality Act, which would require the City of Los Angeles to notify and consult with SMMC at various points in the CEQA review process on projects that may affect natural resources within the Santa Monica Mountains Zone, as defined in the Conservancy Act.

**BE IT FURTHER RESOLVED,** that the City of Los Angeles hereby recognizes the Big Wild-Topanga State Park, Eastern Santa Monica Mountains, and Griffith Park Area Habitat Linkage Habitat Linkage Planning Maps as well as future spatial habitat protection maps prepared by SMMC to ensure the protection and conservation of sensitive habitat areas.

The COVID-19 pandemic continues to present a major public health threat in the City of Los Angeles, most critically to vulnerable populations. In the past months, the City of Los Angeles has taken decisive action to combat the pandemic including the adoption of ordinances requiring City workers to be fully vaccinated as a condition of employment; and requiring all persons to provide proof of vaccination or a negative COVID-19 test for establishments including restaurants and gyms. City workers have until December 18, 2021 to provide proof of vaccination or face disciplinary action.

The Fire Department (LAFD) serves as the primary responder for emergency incidents in the City including response to fires and medical emergencies. As of October 28, 2021, approximately 69 percent of the LAFD's sworn workforce has been fully vaccinated. As the deadline to provide proof of vaccination approaches, the City must ensure that the LAFD can avoid service disruptions in the event of a loss of sworn personnel directly resulting from noncompliance with the City's vaccination requirement.

I THEREFORE MOVE that the City Council instruct the Fire Department (LAFD), with assistance of the City Administrative Officer and the Personnel Department, to report with a plan to maintain adequate sworn personnel staffing levels in the event of substantial noncompliance with the City's vaccination requirement for City workers.
