The Applicant shall encourage, to the best of their ability and to the satisfaction of the Los Angeles Department of Transportation (LADOT), vehicular ingress and egress off of San Vicente Boulevard only by using signage, traffic cones, and/or other measures to minimize vehicle traffic along the alley.
 - c. 6.c. The Applicant shall restrict all loading in the alley and along residential streets. All commercial loading shall occur on San Vicente Boulevard along the Project frontage, to the satisfaction of LADOT. The Applicant shall inform vendors and deliveries of this requirement.
 - d. 6d. No vehicles associated with the construction or operation of the hospital shall be permitted to block vehicular or pedestrian access to the alley, through any means, including by parking, idling, or generally queuing vehicles in, adjacent to, or along the alley.

- e. 6e. The Applicant shall install signage in the alley and striping along the alley pavement stating that parking, idling, or general queuing of vehicles is prohibited.
- 5. ADVISE the applicant, pursuant to LAMC Section 12.32 G:
 ... the Council may decide to impose a permanent Q Condition ...
 identified on the zone change map by the symbol Q in brackets ...
 There shall be no time limit on removal of the brackets around the [Q]
 Qualified designation nor on removal of the [T] Tentative designation.
 After the conditions of the permanent [Q] Qualified classification have been fulfilled, the brackets surrounding the Q symbol shall be removed.
- 6. ADVISE the applicant that, pursuant to State Public Resources Code Section 21081.6, the City shall monitor or require evidence that mitigation conditions are implemented and maintained throughout the life of the project and the City may require any necessary fees to cover the cost of such monitoring.

On December 8, 2021, the Public Works Committee instructed the Bureau of Street Services (BSS) and the Office of the City Administrative Officer (CAO) to report on the required timing of authorization for the positions needed to construct improvements in the City's public right-of-way for the Rail to Rail Corridor Project. BSS and the CAO determined that position authority is required for 103 positions within BSS, which includes 10 Targeted Local Hire opportunities, in order to deliver the scope elements in the Rail to Rail Corridor Project work plan.

In 2017, the City began the process to replace our current 20-year-old payroll system, PaySR, with a modern human resources and payroll (HRP) application. The HRP system being implemented, Workday, will be the City's first centralized system with robust HR functionality. The system provides significant opportunities for new efficiencies, greater transparency, and consistency in HR practices across the City. However, the implementation of such a system is a complex effort that involves replacing the limited functionality of the current system and introducing City staff to new concepts and procedural changes that are necessary to adopt a modern HR system effectively.

The Personnel Department's HRP staff are responsible for designing the HRP system to comply with relevant City authoritative documents while ensuring that user departments' business needs are met. The seismic shift from disparate manual HR processes across more than 40 departments to a single electronic system cannot be understated. For the HRP project to launch successfully, Personnel staff have been working with HR staff from every department to gather process requirements, establish citywide standards and best practices, garner support for the system implementation, and actively lead departmental staff through the change management process. The project has an aggressive phased implementation timeline with the Human Capital Management (HCM) and some compensation components going live in the first phase in April 2022 and the Payroll, Time Tracking, Benefits, Absence, and remaining compensation components going live during the second phase in December 2022.

Once the HRP system goes live, the Personnel Department's scope of responsibilities will broaden. Along with the tasks listed above, the Personnel HRP Team will lead the development, coordination, and facilitation of training and provide user support for all departmental HR sections. Most HR employee transactions will be processed through Workday from beginning to end, as opposed to the manual process employed today which relies heavily on staff having to route paper forms physically. The Personnel Department will be the lead agency administering and supporting the adoption of these digitized processes by end-users. The centralized nature of the system will also amplify Personnel's role in working with departments to ensure HR transactions are processed in accordance with Civil Service rules and procedures. In addition to providing support post-go-live, the Personnel HRP Team will continue to work on system enhancements, fixes, and configuration updates necessary to meet the City's needs, including changes related to MOU negotiations. Additional systems staff will be needed for login administration, security administration, report development, and technical support for external HR systems that will interface with Workday.

Significant concerns have been raised that this high-stakes project is understaffed. The City is making a substantial investment in Workday (we are currently negotiating a close to \$11 million one year extension to the Workday contract due to the complexity of this project) and it would be unwise to understaff the Personnel Department as it develops, implements, and maintains this system. Insufficient staffing of the HRP team will compromise the necessary levels of stress-testing for the new system, will delay the transition to Workday, and will impede the efficient processing of HR transactions due to a lack of training and support. HR and payroll processes are tightly integrated and highly complex, requiring major commitments by staff to fully vet the system. Not allocating the requisite resources will result in large-scale payroll errors with enormous financial consequences for the City and an overwhelming burden on employees to rectify those errors post-implementation.

With Phase 1 go-live approaching in just a few months, the Personnel Department needs to onboard new staff as soon as possible so they can receive adequate training and, in turn, provide support to system users. In the immediate term, additional staffing will ensure a successful implementation of Workday with minimal

disruption to citywide operations, a high level of responsiveness to department and user requests for support, timely system design fixes and changes, and quality frontline training support. In the long-term, additional staffing will ensure consistency in personnel transactions across all City departments, more efficient processing of HR transactions, accurate reporting across all departments, greater transparency in HR transactions, and better adherence to processes laid out in City governing documents. In addition, the Personnel Department as a whole is critically tight on staffing resources due to attrition exacerbated by Separation Incentive Program (SIP) retirements and new responsibilities related to implementing the vaccine mandate.

Based on an assessment of the expectations and needs of the HRP project and related efforts, the Personnel Department requested new position authorities in its upcoming FY 2022-23 proposed budget. However, resources are needed immediately to support go-live sustainability and ongoing design efforts related to Phase 2 of the project.

I THEREFORE MOVE that Council, subject to the approval of the Mayor, approve the following ten resolution authorities, subject to allocation by the Personnel Department and pay grade determination by the City Administrative Officer (CAO), to staff the Personnel Department's HRP efforts. The cost of these positions will be funded by the Personnel Department's existing budgeted salary resources.

According to a study conducted by the United States Chamber of Commerce Foundation, two out of three working parents changed their childcare arrangements due to the COVID-19 pandemic. A vast amount of these parents had to leave the workforce entirely, which may have lasting impacts on the economy even after the pandemic ends. In an effort to mitigate one of the most basic challenges - that of childcare - we must expend resources, as we once did, to support our employees in accessing reliable, affordable, and high quality childcare services.

On December 23, 2021, a man entered a Burlington Coat Factory store in North Hollywood and proceeded to randomly assault customers. The Police Department (LAPD) responded to the incident after receiving multiple reports of the assaults. Officers arrived at the scene and after confronting the suspect, opened fire. The suspect would be pronounced dead at the scene. Tragically, a stray bullet fatally struck a 14-year-old Valentina Orellana Peraita who was in a dressing room at the scene.

This most recent incident represents one of several Officer Involved Shootings in the City within the past few years. Each Officer Involved Shooting is investigated by the Force Investigation Division and the Office of the Inspector General for compliance with the LAPD's Use of Force Policies. As several of these investigations remain pending, the Department should provide an update on the status of investigations opened in 2021, as well as a comparative analysis

TERSONNEL, AUDITS, & ANIMAL WELFARE

During the 2021-22 City budget process, the Los Angeles Police Department (LAPD) was instructed to report on positions and tasks performed by the sworn workforce that should be performed by civilian staff. Although the LAPD identified several positions, it was noted that more time was needed for a comprehensive assessment of sworn staff performing civilian duties.

In past years, the LAPD was able to make progress in the recovery of civilian staffing reductions resulting from the Early Retirement Incentive Program (ERIP). The implementation of the Separation Incentive Program (SIP) further resulted in the loss of civilian staff and may have necessitated the reassignment of sworn personnel to those functions. In recognition of the need for additional hiring, the Personnel Department also requested additional staff support for hiring both civilian and sworn positions.

As many businesses return to in-person functions, it is important that the City field the adequate level of sworn police officers to ensure public safety. Further, with recent reductions to the LAPD workforce, it is all the more important that the existing sworn workforce be maximized and assigned to public safety functions.

I THEREFORE MOVE that the City Council instruct the LAPD, with the assistance of the City Administrative Officer, to report on the number of sworn officers performing civilian functions and provide recommendations on further minimizing this practice including increasing hiring for civilian positions.

Vicente Fernández was born in Huentitán el Alto, Jalisco, Mexico in 1940. "Chente" as he was lovingly known by his millions of fans, was an internationally renowned legend of Mariachi music and an icon of Mexican culture both at home and here in the United States.

Throughout his long and storied career, he recorded 50 albums, sold more than 65 million records and appeared in more than 35 films. He was also the recipient of countless awards including three Grammys and eight Latin Grammys. His contributions to music and culture have been recognized throughout the world, including right here in Los Angeles on the Historic Hollywood Walk of Fame.

While Fernández established his professional career in a humble pueblo in Mexico, his reach covered every corner of the globe with his limitless talent and musical influence. His music became the soundtrack of the lives of Latino families throughout Los Angeles. Songs about love, heartbreak, betrayal, and his love for Mexico can be heard in almost every neighborhood of this city on any given day.

Fernández had a tremendous impact on Mariachi music. Staples like "Volver Volver" and his rendition of "El Rey" are mainstays at backyard parties and mariachi concerts. Nowhere is this impact more apparent than in our city's very own Mariachi Plaza in Boyle Heights.

It is appropriate that the City of Los Angeles rename Bailey Street, near Mariachi Plaza, to "VICENTE FERNÁNDEZ Street." in honor of Vicente Fernández's legacy and for his impact on the residents of Los Angeles.

The renaming will enable all people who travel the street to recognize the road as a fixed landmark within the City of Los Angeles dedicated to celebrating the legacy of Vicente Fernández.

Cityride, administered by the Los Angeles Department of Transportation (LADOT), is a transportation assistance program for individuals age 65 or older and qualified persons with disabilities residing in the City of Los Angeles and select areas of Los Angeles County. The program offers Cityride participants reduced costs for the purchase of Cityride Dial-A-Ride services and permitted taxicab rides and free DASH bus rides.

The taxicab industry provides a vital mobility service in Los Angeles. For business travelers and tourists, taxis provide connections between hotels, the airport, and regional destinations. For seniors, low-income residents, and people with disabilities, taxis provide essential transportation to medical appointments, employment, and services. Since 2017, the City of Los Angeles has worked to update its outdated taxicab franchise system and replace it with a modern regulatory system that better meets the public's mobility needs and supports a healthier industry.

A report from the UCLA Labor Center reinforces the need for urgent intervention by the City to support the taxi industry, and more specifically to ensure a living wage for drivers. The report details in stark terms the decimating impact of competition from Transportation Network Companies (TNCs) like Uber and Lyft, as well as more recent losses from COVID's impact on the travel industry. In particular, State regulation of TNCs has created a "race to the bottom" for taxi drivers that is not sustainable while preempting tools that the City could otherwise use to guarantee a living wage. According to the report, some studies show that taxicab drivers now earn less than the \$15 per hour minimum wage after expenses. The status quo of declining ridership and declining income has caused a greater than 60 percent reduction in the number of taxi drivers over the last decade—ultimately impacting the public's access to taxicab services.

In response to these pressures on the industry, the Los Angeles Department of Transportation (LADOT) has proposed a comprehensive new regulatory system designed to provide better service to the public and win back market share with a more competitive taxi industry (CF# 10-0996-S1). These reforms are largely consistent with the taxicab industry-supported AB 1069 (Low), now codified in Government Code 53075.5, which aims for a streamlined regulatory system that increases taxicab company independence and improves interoperability across jurisdictions. However, this same law limits the City's ability to set minimum rates, blocking the most direct tool for ensuring driver income. The City must instead work toward that goal with the tools that are available to it: data transparency, oversight, and promotion of the industry.

In effect, the new regulatory system will relaunch the taxicab industry in Los Angeles. This new system will feature new technology, better customer service, more reliable experiences, greater flexibility for the industry, and stronger oversight. LADOT should take the opportunity to help the industry reintroduce itself to the public with a Taxi Action Plan that goes beyond just implementing new regulations and includes affirmative steps to support customers, support drivers, and support the industry as a whole. Working together, LADOT and the industry can offer a competitive and attractive mobility option that creates good jobs and advances the City's equity and environmental goals.

WE THEREFORE MOVE that the City Council direct the Los Angeles Department of Transportation (LADOT) to report in 90 days with a Taxi Action Plan that includes at least the following:

 A public education campaign, including resources needed and available, to promote the use of taxicabs, including how to request a ride via mobile app, and promotion of enrollment in existing taxicab subsidy programs, such as LADOT's CityRide program.

- Criteria for the expansion of taxicab stands at regional destinations, including projected demand and input from industry.
- An update on implementation of regional permitting, as provided by AB 1069 (Low), including any additional steps needed to encourage participation by other jurisdictions in Los Angeles County.
- A proposed scope of services and resources needed for program evaluation that includes a study
 of driver income using new data received via LADOT's Mobility Data Specification API, to be
 completed 15 months after program launch.

WE FURTHER MOVE that the City Council request the Board of Taxicab Commissioners in conjunction with LADOT to, within 120 days:

- Consider the adoption of a rule that would set a program-wide maximum fleet size of no greater than 20,000. Future increases of this maximum fleet size shall require findings based on customer wait times, vehicle utilization, and driver income.
- Consider the adoption of a rule that would set a minimum rate for app-based trip requests. This
 rate shall be based on a calculation of driver take-home pay that guarantees a driver shall earn at
 least the City's minimum wage for the time engaged in transporting a passenger, after expenses
 and before tips.
