CONSIDERATION OF MOTION (KREKORIAN for KORETZ – MARTINEZ – RODRIGUEZ) relative to the below market sale of 25 sets of Firefighting equipment to the First-In-Fire Foundation.

Recommendations for Council action:

1. FIND that the First-In-Fire Foundation is eligible to purchase 25 sets of turnout coats/pants, Firefighting helmets and gloves, ballistic vests and helmets at below market value (\$1.00) in accordance with Los Angeles Administrative Code Sec. 22.547 (Donation of Surplus City Equipment), as the recipient is a non-profit organization that has been established exclusively to further the services provided by the City.
2. REQUEST the City Attorney to expedite preparation of appropriate documents to effectuate the sale and transfer.
3. **INSTRUCT the City Clerk to inform First-In-Fire Foundation [Marc S. Cohen, Founding Chairman of the Board, (323) 933-8164,**

137 North Larchmont Boulevard, #468, Los Angeles, CA 90004] that the surplus equipment must be claimed within 90 days from the date of Council approval of the request or notification of availability of the equipment, whichever occurs later, at which time the equipment will revert to the City's surplus equipment pool for disposal by the Department of General Services.
