- 3. AUTHORIZE the BPW to amend an existing contract with Gang Alternatives Program (C-136595) to increase the ceiling amount of the contract by and additional \$705,000.
- 4. INSTRUCT the City Administrative Officer (CAO) to conduct a review and report in 120 days, on additional funding needed to support the graffiti removal and maintenance efforts on the Sixth Street Viaduct Bridge for the remainder of the 2022-23 Fiscal Year.
- 5. AUTHORIZE the BPW and CAO to make any changes or corrections to the fund transfer instructions in order to effectuate the intent of this matter.
- 6.
