RESOLUTION

WHEREAS, monkeypox can lead to significant, acute health impacts, including severe pain, hospitalization, long- term symptoms, and, in some instances, death; and

WHEREAS, on July 23, 2022 the World Health Organization determined that a multi-country outbreak of monkeypox constitutes a Public Health Emergency of International Concern; and

WHEREAS, the United States Centers for Disease Control and Prevention reported that California has experienced nearly 800 confirmed probable cases of monkeypox as of August 1, 2022; and

WHEREAS, the Governor of the State of California proclaimed the existence of a state of emergency for monkeypox on August 1, 2022; and

WHEREAS, the President of the United States declared monkeypox a public health emergency on August 4, 2022; and

WHEREAS, the Los Angeles County Department of Public Health identified 423 confirmed monkeypox cases in Los Angeles County as of August 2, 2022; and the Los Angeles County Board of Supervisors on the same day proclaimed a Local Health Emergency for the County; and

WHEREAS, on August 2, 2022, the Mayor of the City of Los Angeles, pursuant to his powers under Administrative Code section 8.27, declared the existence of a Local Emergency due to the spread of the monkeypox; and

WHEREAS, in his August 2, 2022 Declaration of Local Emergency, the Mayor ordered and declared in his Declaration of Emergency that during the local emergency, the powers, functions, and duties of the City's Emergency Operations Organization shall be those prescribed by state law and by ordinances and resolutions of the City; and

WHEREAS, by August 4, 2022, the number of cases had increased to 6,617 in the United States, 826 in California, and 478 in Los Angeles County;

NOW THEREFORE, the Council of the City of Los Angeles RESOLVES that:

- A local emergency regarding monkeypox existed in the City of Los Angeles (City) within the meaning of Los Angeles Administrative Code Section 8.21, et seq., at the time of the Mayor's August 2, 2022, Declaration of Local Emergency, which the City Council hereby ratifies; and
- 2. Because the local emergency continues to exist, there is a need to continue the declared state of local emergency, which the City Council hereby ratifies; and
- 3. In accordance with Los Angeles Administrative Code section 8.21 et seq., all appropriate City departments, agencies, and personnel are instructed and requested to continue to perform all duties and responsibilities to represent the City in this matter to prevent and abate the emergency and receive, process, and coordinate all inquiries and requirements necessary to obtain whatever State and Federal assistance that may become available to the City and/or to the citizens of the City who may be affected by the emergency; and
- The General Manager of the Emergency Management Department is hereby instructed to advise the Mayor and City Council on the need to extend the state of local emergency; and
 The City Clerk is hereby instructed to place on the City Council's agenda the continuation of the state of local emergency not more than 30 calendar days after adoption of this

- Resolution and then not more than 30 calendar days after every subsequent adoption that continues the declared state of emergency, until such time as the Council votes not to continue the state of emergency or rescinds this instruction; and
- 6. The City Clerk is hereby instructed to forward copies of this Resolution to the Governor of the State of California, the Director of the Office of Emergency Services of the State of California, the Los Angeles County Office of Emergency Management, and the Los Angeles County Board of Supervisors.

The Los Angeles County Natural History Museum Foundation (Borrower), a California nonprofit public benefit corporation, has requested that the California Enterprise Development Authority (CEDA) issue one or more series of its revenue bonds or other obligations, in an aggregate principal amount not to exceed \$22,500,000 (Obligations), for the purpose of financing and refinancing the design, construction, equipping, furnishing, installation, expansion, and improvement of the facilities located at 900 West Exposition Boulevard (Facilities) in Council District 9. The bond proceeds will also be used to pay certain costs of issuance. The Facilities are owned by the County of Los Angeles and operated by the Borrower and will be used in its mission to provide opportunities for people to unite with nature, culture, and each other.

No City funds are or will be pledged to support this project. The Obligations are payable solely from revenues or other funds provided by the Borrower. The City does not incur liability for repayment of the Obligations. The City is required by federal law to review and approve the issuance of bonds or revenue obligations for projects within its jurisdiction and conduct a public hearing.

In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the issuance of the Obligations, the Borrower has requested that the City conduct the required public hearing (TEFRA Hearing) and approve the issuance of the Obligations by CEDA.

I THEREFORE MOVE that City Council allow CEDA to issue bonds in an amount not to exceed \$22,500,000 to provide financing and refinancing for the design, construction, equipping, furnishing, installation, expansion and improvement of facilities located at 900 West Exposition Boulevard in Council District 9; and hold a TEFRA Hearing and adopt the attached TEFRA Resolution at the City Council Meeting to be held on August 23, 2022 at 10:00am, located at 200 North Spring Street, Room 340, Los Angeles, California, 90012.

RESOLUTION

APPROVING THE ISSUANCE OF REVENUE BONDS OR OTHER OBLIGATIONS BY THE CALIFORNIA ENTERPRISE DEVELOPMENT AUTHORITY IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$22,500,000 FOR THE PURPOSE OF FINANCING, REFINANCING, OR REIMBURSING THE COST OF ACQUISITION, DESIGN, DEVELOPMENT, CONSTRUCTION, REHABILITATION, IMPROVEMENT AND EQUIPPING OF FACILITIES FOR THE BENEFIT OF THE LOS ANGELES COUNTY NATURAL HISTORY MUSEUM FOUNDATION AND OTHER MATTERS RELATING THERETO HEREIN SPECIFIED

WHEREAS, the Los Angeles County Natural History Museum Foundation, a nonprofit public benefit corporation, duly organized and existing under the laws of the State of California (the "Borrower"), has submitted and the California Enterprise Development Authority (the "Authority") has accepted, an application requesting the Authority to issue, from time to time, pursuant to a plan of finance, its tax-exempt revenue bonds or other obligations in an aggregate principal amount not to exceed \$22,500,000 (the "Obligations") for the benefit of the Borrower pursuant to Chapter 5 of Division 7 of Title 1 of the Government Code of the State (commencing with Section 6500) (the "Act"); and

WHEREAS, the proceeds of the Obligations will be used for the purpose of (a) financing, refinancing, or reimbursing the Borrower for the cost of designing, constructing, installing, equipping and furnishing new museum facilities known as the Commons located at 900 West Exposition Boulevard, Los Angeles, California 90007 (the "Facilities") and (b) paying certain costs of issuance of the Obligations; and

WHEREAS, the issuance of the Obligations must be approved by the governmental unit on behalf of which the Obligations are issued and a governmental unit having jurisdiction over the territorial limits in which the Facilities located pursuant to the public approval requirement of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"); and

WHEREAS, the Facilities are located within the territorial limits of the City of Los Angeles (the "City") and the City Council of the City (the "City Council") is the elected legislative body of the City; and

WHEREAS, the Authority and the Borrower have requested that the City Council approve the issuance of the Obligations by the Authority and the financing, refinancing, or reimbursing of the Borrower for the cost of the Facilities with the proceeds of the Obligations pursuant to Section 147(f) of the Code; and

WHEREAS, the Facilities will provide significant benefits to the City's residents by expanding the Museum's facilities to provide opportunities for people to unite with nature, culture, and each other; and

WHEREAS, the Authority's issuance of the Obligations will result in a more economical and efficient issuance process because of the Authority's expertise in the issuance of conduit revenue obligations; and

WHEREAS, it is intended that this Resolution shall comply with the public approval requirements of Section 147(f) of the Code; provided, however, that this Resolution is neither intended to nor shall it constitute an approval by the City Council of the Facilities for any other purpose; and

WHEREAS, pursuant to Section 147(f) of the Code, the City Council of the City, following notice duly given, held a public hearing regarding the issuance of the Obligations and now desires to approve the issuance of the Obligations by the Authority; and

WHEREAS, in recognition of the City's objective of addressing the needs of residents with disabilities, the Borrower has agreed that (a) any Facilities to be constructed with the proceeds of the Obligations will comply with the Americans with Disabilities Act, 42 U.S.C. Section 12101 et seq. and the 2010 ADA Standards, Chapter 11 of Title 24 of the California Code of Regulations, (b) the Borrower will not discriminate in its programs, services or activities on the basis of disability or on the basis of a person's relationship to, or association with, a person who has a disability and (c) the Borrower will provide reasonable accommodation upon request to ensure equal access and effective communication to its programs, services, and activities.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the City Council of the City as follows:

Section 1. The City Council hereby finds and determines that all of the recitals are true and correct. The City Council finds that the Facilities will provide the significant benefits set forth in the recitals above. The City Council hereby approves the issuance of the Obligations by the Authority, which Obligations may be tax-exempt and/or taxable as approved by the Authority in its resolution, in an amount not to exceed \$22,500,000 to finance, refinance, or reimburse the Borrower for the cost of the Facilities and to pay financing and costs of issuance of the Obligations. This resolution shall constitute "host" approval and "issuer" approval of the issuance of the Obligations within the meaning of Section 147(f) of the Code and shall constitute the approval of the issuance of the Obligations within the meaning of the Act; provided, however, that this Resolution shall not constitute an approval by the City Council of the Facilities for any other purpose. The City shall not bear any responsibility for the tax-exempt status of the Obligations, the repayment of the Obligations or any other matter related to the Obligations.

Section 2. All actions heretofore taken by the officers, employees and agents of the City with respect to the approval of the Obligations are hereby approved, confirmed and ratified, and the officers and employees of the City and their authorized deputies and agents are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all certificates and documents which they or special counsel may deem necessary or advisable in order to consummate the Obligations and otherwise to effectuate the purposes of this Resolution.

Section 3. This Resolution shall take effect from and after its adoption.

Soil erosion has impacted a portion of Balboa Boulevard (near the address of 12000 N Balboa Boulevard), just south of the intersection with Knollwood Drive. In this area, an erosion gully has developed on the slope that borders the east side of Balboa Boulevard. A new bulkhead retaining structure, with a total length of approximately 88 feet, and partial reconstruction of the sidewalk and hillside are needed to restore lateral support to the roadway and sidewalk to improve safety to pedestrians.

I THEREFORE MOVE that the Council AUTHORIZE:

The City of Los Angeles (City) owns [thousands] of properties within the City limits. The City's Asset Evaluation Framework (C.F. 12-1549-S3) establishes a uniform procedure to evaluate these properties for new uses that may better serve a community's needs, such as affordable housing, economic development opportunities, recreational or cultural space.

The Sawtelle neighborhood in West Los Angeles faces a shortage of outdoor recreation and cultural space for the community. While larger City-owned sites are being considered for housing development, smaller sites may provide an opportunity to add these badly-needed amenities to the neighborhood.

To further this objective, the lot located at 11312 Idaho Avenue (APN 426-100-9900), owned by the City and currently operated as a small parking lot, should be evaluated for use as a potential recreation or cultural space. Located in close proximity to several other Department of Transportation parking lots, it may be that this property can better serve the community if put to an alternative use.

I THEREFORE MOVE that Council direct the City Administrative Officer, with the assistance of the Chief Legislative Analyst, General Services Department, Department of Transportation, Department of Cultural Affairs, and any other relevant departments and stakeholders, to initiate a review of the City of Los Angeles-owned parking lot located at 11312 Idaho Avenue (APN 426-100-9900), with a priority focus to determine the suitability for development with outdoor recreational or cultural amenities and open space, in conformance with the procedure set forth for the City's Asset Evaluation Framework, and report back to the City Council within 60 days.

I FURTHER MOVE that if the City Administrative Officer, through the course of its evaluation, discovers a nearby City-owned property that may be more efficiently used for these purposes, evaluate these additional sites and report back to the City Council within 60 days.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal government body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, for many decades the United States Supreme Court has stated consistently and unequivocally that nothing in the United States Constitution prohibits states and local governments from imposing reasonable regulations on firearms, including prohibitions on possession by certain individuals and on carrying firearms in sensitive places; and

WHEREAS, recent rulings by the Court have abandoned well-established understanding of the Second Amendment and will now force local jurisdictions, including Los Angeles, to issue permits to carry concealed weapons (CCWs) much more broadly than has ever previously been the case; and

WHEREAS, these recent rulings gravely endanger the public's safety in Los Angeles and other cities by compelling the issuance of CCWs to potentially thousands of applicants who previously would have been denied the ability to carry concealed weapons in public; and

WHEREAS, legislation currently pending in the California State Legislature, SB 918 (Portantino) seeks to comport California law with the recent Supreme Court rulings while still preserving reasonable public safety protections; and

WHEREAS, among other things, SB 918 would specify certain sensitive locations where firearms cannot be carried, notwithstanding the issuance of a CCW permit; and

WHEREAS, Los Angeles and other local jurisdictions may have particular needs to restrict CCW permit holders from carrying firearms in sensitive locations or engaging in other dangerous activities relevant to that locality that are not currently specified in the statewide prohibitions of SB 918; and

WHEREAS, SB 918 would also permit local governments to require psychological testing of an applicant as a condition for issuance of a CCW permit, and such psychological testing is a vitally important tool to determine whether an individual is a danger to themselves or others before a CCW permit is issued; and

WHEREAS, SB 918 prohibits the licensing authority from charging an applicant more than two hundred dollars (\$200) for psychological testing, but in Los Angeles such testing would cost the Los Angeles Police Department far more than that, thus creating an unfunded state mandate and putting the taxpayers of Los Angeles in the position of subsidizing the issuance of CCW permits; and

WHEREAS, under current law, Section 26205 of the California Penal Code requires a licensing authority to give written notice indicating whether an application is approved or denied within 90 days of the initial application for a new license or a license renewal, and a period of 90 days will be wholly inadequate to meet the anticipated demand for new licenses while also ensuring public safety;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2022-2022 State Legislative Program SUPPORT for SB 918 (Portantino) IF AMENDED (i) to permit full cost recovery for processing of license



applications and psychological testing, (ii) to state explicitly that local governments may adopt additional restrictions on the allowable activities of a CCW permit holder beyond those specified in the bill, and (iii) to amend Section 26205 of the Penal Code to require a local licensing authority to give written notice indicating whether an application is approved or denied within "a reasonable amount of time" rather than setting an arbitrary time limit.
