In addition, the recommendations authorize the LAPD to execute a Sixth Amendment with the LACMTA to extend the term by six months through December 31, 2022 and increase the contract budget by \$54 million to \$483,485,497. The proposed Sixth Amendment also incorporates a non-disparagement clause, as required by LACMTA. All other terms remain the same. The Highland Park Pool and Bathhouse has provided a recreation space for the community of Highland Park since its construction in 1948. Presently, the pool and bathhouse are not heated and therefore only usable in the summer months and unavailable to the community for the majority of the year. Highland Park Pool offers summertime programming including swimming lessons for Angelenos of all ages, a Junior Lifeguard Program, a Swim Team for ages 7 - 17, and daily access for lap swimming and aquatic recreation. Scholarships and sponsorships for participation in these programs are offered through The LA84 Foundation, Operation Splash, and SwimLA work to ensure equitable access to pool programming. However, the sad reality is that the closest elite swimming programs are located in Pasadena and South Pasadena and inaccessible for most residents of Highland Park, geographically and financially. We have the opportunity to correct this inequity and bring a state-of-the-art aquatic facility with year-round programming to the Highland Park and surrounding Northeast LA community.

In the 2004 Department of Recreation and Park's Pool Condition Assessment Report, department staff noted that the Highland Park Pool and Bathhouse required significant improvements and recommended replacement of the entire facility. The Department reaffirmed these recommendations in 2018, once again recommending replacement of the over 70 year old pool with a modern facility that would better meet the needs of the approximately 60,000 residents of Highland Park.

I THEREFORE MOVE that \$700,000 from the CD14 Real Property Trust Fund No. 696 and \$300,000 from the AB 1290 Fund No. 53P, Account No. 281214 (CD14 Redevelopment Projects - Services) be transferred to a new account in the Engineering Special Services Fund No, 682, Department No. 50, entitled "CD14 Pool Project - Highland Park", for any design, project, and/or City staff costs associated with the development, construction, and/or completion of the Highland Park pool projects; and,

I FURTHER MOVE that the Bureau of Engineering be authorized to make any necessary technical and accounting corrections in order to effectuate the intent of this motion.

NEIGHBORHOOD & COMMUNITY ENRICHMENT

MOTION

Skateboarding is one of the most accessible and popular sports for youth in cities. It's relatively low-cost, fun, athletic, and provides a sustainable mode of transportation. Skateparks provide a space for youth and adults to positively interact through a shared interest. New skateparks in urban areas have an ability to rejuvenate unused spaces. As interactive public spaces, skateparks have slowly begun to shape the way we think about urban design.

Once fully built and operational, the Watts Skatepark will be the thirtieth skatepark in the city of Los Angeles. Of the city's thirty skateparks, six of them are in the Fifteenth Council District. This council district has served as a unique model for implementing a community-based vision of successful skatepark designs with local input. The City has an opportunity to rethink its public space for design activation and can incorporate recreation and work with its local communities to accomplish its goal.

As of today, we are not aware of any type of comprehensive planning effort underway or completed that thoroughly documents where skateparks are currently located and where skateparks should be built, located, and maintained. Such a study would provide a blueprint for growth and expansion of the skateparks. The City of Los Angeles should start such a planning process and immediately identify funds available to prepare such a study.

I THEREFORE MOVE that the City Council instruct the Department of Recreation and Parks, and any other overseeing departments, to provide an inventory on the condition of all existing skateparks in the city of Los Angeles.

I FURTHER MOVE that the City Council instruct the City Administrative Officer to identify funds for hiring of a consultant team to develop a planning exercise to develop a strategic plan or master plan for identifying sites for new skateparks as well as reporting on best practices for planning existing skateparks in the city of Los Angeles. The City Administrative Officer should also report back to the Neighborhoods and Community Enrichment Committee within 45 days on such funding opportunities and an outline of next steps in developing such a strategic or master planning effort.

MOTION

Los Angeles is home to a large number of vacant and abandoned buildings. In addition to being a potential source of blight in their neighborhoods, these buildings can pose a significant hazard to public health and safety. Just this month, a fire that started in a vacant house spread to two nearby apartment buildings in Westlake, leaving residents from 20 units without a home.

The Department of Building and Safety has nearly 600 open Vacant Building Abatement (VBA) cases for abandoned buildings in the City of Los Angeles that require ongoing monitoring, securing, and, in some cases, demolition. The City's ability to respond to these buildings has been constrained by both staffing and regulatory obstacles.

The Department of Building and Safety has the authority to secure vacant properties if an owner fails to do so, but staffing levels are not sufficient to regularly monitor buildings that may subsequently be breached. The City also has the authority to demolish vacant or abandoned properties if they are found to constitute a public nuisance, but the protocols currently in use rely on procedures and legal guidance that are more than twenty years old and that are not responsive to the current needs on the ground.

The process from first identifying these buildings as targets for demolition to final approval can take up to nine months. When the Department of Building and Safety first identifies a building, they must contact the owner and allow a period of ten days to respond. If the owner does not take action in this time, the Department begins inspections to gather evidence that the building complies with the definition of a public nuisance. The Department currently requires evidence of repeated entries, but due to staffing limitations, they are only able to inspect most buildings once a month or less. After sufficient evidence has been gathered, which can take several months, the Department must prepare a packet of evidence and submit it to the Board of Building and Safety Commissioners for approval. The Board meets monthly, so this final step can add months more to the process.

The City should take steps now to adapt our response to abandoned buildings to proactively address the significant public safety threats—especially from fires—posed by these properties.

I THEREFORE MOVE that the City Council instruct the Los Angeles Department of Building and Safety, with the assistance of the City Attorney's Office, the Department of City Planning, and any other relevant departments, as needed, to report back within 30 days with recommendations to shorten the timeline for securing, and, where required, declaring an abandoned building a public nuisance for the purpose of its demolition. The report should include a description of staffing increases necessary to conduct building inspections more efficiently and resolve cases more expeditiously, in addition to an identification of phases of the public nuisance determination process that may be expedited or streamlined.

PUBLIC SAFETY

Domestic violence often reaches the most vulnerable populations in their own homes and notably affects women in communities of color. Firearm access within a household experiencing domestic violence increases the potential for homicide by 500 percent. Consequently, the City must ensure that firearm access prohibition and relinquishment orders are effectively enforced to protect families from gun violence.

Existing California law allows civil courts to temporarily prohibit the purchase or possession of firearms by individuals who pose significant risk to themselves or others through Gun Violence Restraining Orders (GVROs) and Domestic Violence Restraining Orders (DVROs). Further, if an individual subject to a GVRO or DVRO is in possession of a firearm, they are required to relinquish all firearms or ammunition within 24 hours. As the local law enforcement agency, the Los Angeles Police Department (LAPD) serves and tracks GVROs, accepts relinquished firearms pursuant to GVROs and DVROs, and may be required to execute search warrants if an individual is determined to have firearms they have not relinquished.

Senate Bill 320 (Eggman), effective January 2022, established new procedures for courts to notify law enforcement agencies of violations of firearm relinquishment orders, requiring law enforcement agencies to take action as soon as practical to enforce the order. The LAPD is currently in the process of establishing internal procedures to comply with the new State law.

The City of Los Angeles must remain committed to exploring and supporting common sense domestic violence and gun violence safety measures. Accordingly the LAPD should provide an overview of domestic violence cases, existing challenges to enforcing court orders, as well as resources required for additional workload potentially generated by SB 320 compliance.

I THEREFORE MOVE that the City Council direct the Los Angeles Police Department to:

- 1. Provide an overview of the LAPD's response to domestic violence incidents, providing relevant statistics such as the number of incidents per year, procedures for response, and any other information tracked relating to domestic violence; and
- 2. Report on challenges to enforcing gun relinquishment provisions of court orders and best practices implemented in other jurisdictions relating to firearm restraining order enforcement; and
- 3. Report on new DVRO enforcement procedures as they relate to SB 320 (Eggman) as well as the additional resources needed to adequately address any potential increase in GVRO enforcement resulting from SB 320.

WHEREAS, even when microfibers are captured by wastewater treatment plants, they can be reintroduced to the natural environment through the spread of sewage sludge as fertilizer, ultimately compromising agricultural fields and food production; and

WHEREAS, AB 1628 (McKinnor), currently pending before the State Assembly, would require all new washing machines sold for residential, commercial, and state use in California on and after January 1, 2029, to contain a microfiber filtration system in order to mitigate the effects of microplastics in the environment;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 State Legislative Program support of AB 1628 (McKinnor), which would require all new washing machines sold for residential, commercial, and state use in California to contain a microfiber filtration system in order to mitigate the effects of microplastics in the environment.

RESOLUTION RULES, ELECTIONS, INTERGOVERNMENTAL RELATIONS

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, domestic violence is a major public health and safety issue, affecting one in four women and one in ten men; and

WHEREAS, the danger posed by domestic violence is further exacerbated by firearm access, and in addition to increasing the risk of gun violence, the possession of a firearm by abusers can prevent domestic violence victims from seeking the help they need; and

WHEREAS, preventing any dangerous individual from purchasing or possessing firearms is an essential first step in safeguarding the public safety and preventing the death of our loved ones; and

WHEREAS, existing California law prohibits the purchase or possession of firearms for individuals who have been convicted of certain crimes, including a life time prohibition for felony domestic violence convictions; and

WHEREAS, individuals subject to a protective or restraining order, including domestic violence protective orders, are also prohibited from purchasing or possessing firearms and are required to relinquish any firearms in their possession during the duration of the order; and

WHEREAS, currently pending before the California State Legislature is AB 36 (Gabriel) which expresses the intent of the Legislature to enact legislation to prohibit a person subject to a domestic violence protective order from owning, possessing, purchasing, or receiving a firearm for an additional three years after the domestic violence protective order has expired, unless the court finds the person to not be a threat to public safety; and

WHEREAS, this bill would enact preventative measures to further secure domestic violence victims and give them peace of mind to recover from the traumatic experience of domestic violence and associated legal processes; and

WHEREAS, the additional years would also serve to ensure that individuals who have been subject to domestic violence restraining orders have the time to rehabilitate and no longer present a threat to themselves or others; and

WHEREAS, the City of Los Angeles must remain committed to exploring and support common sense domestic violence and gun safety regulations;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 State Legislative Program SUPPORT for AB 36 (Gabriel) which expresses the intent of the Legislature to enact legislation to prohibit a person subject to a domestic violence protective order from owning, possessing, purchasing, or receiving a firearm for an additional three years after the domestic violence protective order has expired, unless the court finds the person to not be a threat to public safety.

In the last few years, multiple developments, from commercial to residential, have been planned and are being constructed in Downtown San Pedro and the LA Waterfront. This resurgence has spurred local and visitor traffic, leading to greater demand for parking.

California Government Code Section 1090 prohibits public officials, such as city employees and elected officials, from having a personal financial interest in contracts they enter into in their official capacity on behalf of the City. Government Code section 1092 provides that a contract that violates section 1090 may be voided by any party.

CF 20-0859 (Krekorian, Harris-Dawson) called for the City Council to take actions that would create additional deterrence to prevent those doing business with or seeking approvals from the City to engage in corrupt activity to induce public officials to violate the trust of the people of Los Angeles. The full Council was not given an opportunity to act on the motion, and the Council File expired.

The Federal investigation and indictments that led to felony corruption convictions against former Councilmembers Jose Huizar and Mitchell Englander, and that involved other city employees, made clear that the City must take additional steps to safeguard against fraud and corruption. The urgent need to fight such fraud and corruption and restore the public trust certainly has not diminished since the original motion was introduced.

I THEREFORE MOVE that the City Council request the City Attorney to prepare and present an ordinance prohibiting any property owner or developer from seeking any discretionary approval or entitlement in the future from the City of Los Angeles, if the City Council or any court determines that such property owner or developer has induced or conspired to cause a violation of Government Code Section 1090, had any engagement in illegal demolitions, or otherwise engaged in criminal conduct to defraud the City or any other government entity.

I FURTHER MOVE that the City Council request the City Attorney to present a report within 30 days, in closed session if appropriate, exploring options regarding pursuing civil remedies against those who have violated, or induced or conspired to cause a violation of, Government Code Section 1090, or otherwise engaged in criminal conduct to defraud the City by, among other things, depriving or conspiring to deprive the public and the City of their right to the honest services of employees of the City, including potential causes of action for recovery of subsequent resulting economic harm and injunctive relief.

I FURTHER MOVE that the City Council instruct the Chief Legislative Analyst, with assistance of the City Attorney and the Department of City Planning, to report to the Council within 90 days with recommendations for potential ordinances and/or Charter revisions that would permit the City Council in the future to rescind approvals or entitlements, to void development agreements and other contracts, and to cancel pending development applications, under appropriate circumstances, where such approvals, entitlements, agreements, contracts or applications have been induced or influenced by corruption, fraud or other criminal conduct (including, but not limited to, the potential ordinance submitted by the City Attorney to the Council through report #R-20-0228 dated August 6, 2020).
