HOUSING AND HOMELESSNESS COMMITTEE REPORT relative to a citywide rehousing strategy for people experiencing recreational vehicle (RV) homelessness; and related matters.

Recommendations for Council action:

- APPROVE the City Administrative Officer's (CAO) proposed citywide rehousing strategy for people experiencing RV homelessness, as outlined in the CAO report dated February 10, 2023. attached to the file.
- 2. DIRECT the CAO to report to Council on a quarterly basis with performance and outcome data related to the implementation of the citywide rehousing strategy for people experiencing RV homelessness, including, but not limited to data and metrics on the number and location of RVs being used as dwellings, the number of persons experiencing RV homelessness, potential California Vehicle Code and Los Angeles Municipal Code violations, outreach contacts, service referrals, housing or other placements, refusals and more.
- 3. INSTRUCT the Directors and General Managers, Bureau of Sanitation (BOS), the Los Angeles Police Department (LAPD), the Los Angeles Department of Transportation (LADOT), Bureau of

Street Services, other relevant City departments; and, REQUEST the Los Angeles Homeless Services Authority (LAHSA) to coordinate all RV outreach and rehousing operations through the CAO's citywide outreach team.

4. REQUEST the LAHSA, working with the CAO, to:

- a. Report to Council in 30 days with detailed utilization data for the City's current safe parking sites, including utilization rates in program years prior to the onset of the COVID-19 pandemic in March 2020.
- b. Report to Council in 45 days with a plan to establish 24-hour safe parking locations for RVs that will include on-site case management, housing navigation services, vehicle maintenance services, such as pumping septic tanks, and hygiene services, and with recommendations for changes to the Safe Parking program requirements to lower barriers of entry for people experiencing RV homelessness.
- 5. REQUEST the City Attorney, working with the CAO, LAPD, LADOT, and other departments as necessary, to draft a waiver form for an individual to voluntarily relinquish their vehicle to the City.
- INSTRUCT the BOS to report on the feasibility, cost and funding necessary to launch a citywide mobile RV waste disposal program, including a consideration of expanding Council District 2's ServeLA program.

7. INSTRUCT the CAO to:

- a. Release a Request for Information for privately-held properties, including parking lots or other large vacant spaces that can be used for short-term RV storage.
- b. Include, in its prioritization of RVs to be served through the Citywide strategy, factors including RVs with larger numbers of people living in them, families with minor children, the condition of the RVs, and the condition and characteristics of

the surrounding area such as fire sensitivity.

- 8. INSTRUCT the CAO, with the assistance of the Chief Legislative Analyst (CLA), to:
 - a. Work with the Mayor's Office and Council offices, LAHSA, and nonprofit service providers, to prioritize encampments that include people experiencing RV homelessness for the Inside Safe Initiative.
 - Prioritize programs within the Citywide Rehousing Strategy for People Experiencing RV Homelessness to correspond with available funding.
 - c. Report to Council on the City's Encampment Resolution Fund application prior to submission and solicit input from Council on locations to include.

<u>Fiscal Impact Statement:</u> The CAO reports that approval of the recommendations in this report will not have an immediate impact on the General Fund as funding recommendations will be provided in a future report. However, should the proposed framework be adopted and funding is needed for the initiatives there may be an approximate fiscal impact of up to \$141.6 million.

<u>Financial Policies Statement:</u> The CAO reports that the City's Financial Policies indicate that interim requests for expanded department programs should only be considered under extreme circumstances. The Mayor and Council's significant commitment to addressing the homelessness crisis necessitates approval of this request. Therefore, the recommendation of this report complies with the City's Financial Policies as this interim budget request addresses an urgent Citywide need.

HOUSING AND HOMELESSNESS COMMITTEE REPORT relative to the implementation and analysis of the pilot recreational vehicle (RV)-to-Home program in Council District 7; and related matters.

Recommendations for Council action:

- 1. INSTRUCT the City Administrative Officer (CAO) to report to Council in 60 days with recommendations for implementing the adopted citywide rehousing strategy for people experiencing RV homelessness in targeted locations across the City based on several factors, such as 2022 Point-in-Time Count RV data, or 2023 Point-in-Time Count RV data if available, needs of the people experiencing RV homelessness, the environmental, health, and safety conditions of the RVs, surrounding roads and other spaces, and public rights of way, concerns from constituents, and Council priorities, and including an updated cost analysis and implementation plan.
- 2. REQUEST the City Attorney to conduct an analysis of the adopted citywide rehousing strategy for people experiencing RV homelessness, as outlined in the CAO report dated February 10, 2023, attached to Council file No. 22-1313 and as further understood here, including an assessment of contracting and procurement options available under the declaration of a local homelessness emergency and subsequent action by Council to provide additional relief under the emergency order.
- INSTRUCT the Department of City Planning to conduct an analysis
 of the zoning considerations of implementing RV temporary storage
 citywide.
- 4. DIRECT the Los Angeles Police Department and the Los Angeles Department of Transportation to report to Council within 45 days on the feasibility of aligning their internal departmental policies with existing law and clarifying what type of vehicle (or factors relating to

said vehicle) are to be considered in determining when a vehicle is in fact abandoned thus making it subject to towing and disposal.

5. REQUEST the Los Angeles Homeless Services Authority to report to Council within 45 days with a detailed analysis of RVs being used as dwellings for people experiencing homelessness according to the 2022 and 2023 Point-in-Time Counts, including using and sharing with the City geospatial data to conduct spatial analyses, pattern and hot-spot analyses, and mapping of RVs across the City.

HOUSING AND HOMELESSNESS COMMITTEE REPORT relative to the establishment of a Right to Counsel Ordinance and program; and related matters.

Recommendations for Council action, as initiated by Motion (Raman – et al. – Harris-Dawson):

 INSTRUCT the Los Angeles Housing Department (LAHD), with assistance from the City Attorney and any other City departments, as needed, to report within 60 days with recommendations for the establishment of a Right to Counsel ordinance and program, subject to the availability of funds, for tenants facing eviction in the City. The recommendations should build upon the Los Angeles Housing + Community Investment Department's November 1, 2019 report regarding recommendations for a City of Los Angeles Eviction Defense Program, in addition to lessons learned from the establishment and implementation of the COVID-19 Response Eviction Defense Program, and should utilize the National Coalition for a Civil Right to Counsel's Model Legislation as a model for best practices for the development of a City ordinance. Specifically, the recommendations should consider including the following:

- a. Coverage for tenants at 80 percent of the Area Median Income or below who live in the City.
- b. Full legal representation for any judicial or administrative proceedings to evict or terminate the tenancy or housing subsidy of a covered individual, including first appeals at the discretion of contracted legal service providers.
- c. A requirement that landlords provide notice to tenants of the right to counsel when tenancies are initiated and attached to any termination notice in the primary language of the tenant.
- d. A requirement that the LAHD work with designated community groups to engage and educate tenants about their rights and provide tenants with navigation services.
- e. An annual reporting requirement on the number of individuals served, case outcomes, and engagement and education efforts.
- f. An implementation time line of no more than five years, prioritizing vulnerable individuals based on zip codes and/or criteria developed by the LAHD in collaboration with contracted legal service providers and community based organizations.
- g. As in the Right to Counsel ordinances in other jurisdictions, a provision clarifying that the Right to Counsel program be established and operated "subject to appropriation" of the

necessary funds.

- 2. INSTRUCT the LAHD, with assistance from the City Administrative Officer (CAO), Chief Legislative Analyst (CLA), the City Attorney and any other City departments, as needed, to report within 60 days with a detailed cost breakdown for the Right to Counsel ordinance and program and staffing needs, in addition to a prospective year-by-year spending plan for the implementation of the program subject to funding becoming available.
- DIRECT the LAHD to engage housing providers when developing recommendations to establish the Right to Counsel ordinance and program.

HOUSING AND HOMELESSNESS COMMITTEE REPORT relative to improving evaluation processes, contract procedures and timely payments between the City and the Los Angeles Homeless Services Authority (LAHSA); and related matters.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- REQUEST the Controller to consolidate the accounts within each funding source to fit into the program categories contained in Recommendation A of the Los Angeles Housing Department (LAHD) report dated February 28, 2023, attached to Council file No. 21-1458, beginning Fiscal Year 2022-23. The request should identify existing accounts or establish new appropriation accounts in the City's Financial Management System that can span different funding sources.
- 2. DIRECT the LAHD to include contract provisions in all contracts that require cost allocation plans for sub recipients in order to finalize any contract agreement with the LAHSA.
- 3. APPROVE the Timeline (Attachment A of the LAHD report dated February 28, 2023) for LAHD-LAHSA-Sub recipient contracting so as to create a consistent and realistic expectation for when agreements may be executed, sub recipients may expect to receive payment, and when services may start to be procured.
- 4. DIRECT the City Administrative Officer (CAO) and the LAHD to:
 - a. Align data reporting requirements for the CAO with the Scopes of Work outlined in each LAHD/LAHSA contract for all funding sources. The requirements of the Scopes of Work in any of the contracts would be required to match any applicable

metrics required by the CAO.

- b. Design a single quarterly reporting structure that encapsulates data from all programs under all funding sources to be made available, equally to the LAHD and CAO, and further, to Council upon request.
- 5. DIRECT the LAHD to work in coordination with the CAO, Chief Legislative Analyst (CLA), and LAHSA to align reporting requirements and measurable goals stated in all LAHSA contracts with an updated version of the Enhanced Comprehensive Homelessness Strategy to reflect the new landscape of homeless services in the City.
- 6. INSTRUCT the CAO to analyze the existing ordinance to provide greater flexibility within the contracts process to enable grantees to receive payment more rapidly, and report on the administrative cap status for each funding source related to homelessness.
- 7. DIRECT the LAHD to include the billing cycle provision contained in Recommendation G of the LAHD report dated February 28, 2023, to all future LAHSA contracts.
- 8. INSTRUCT the LAHD to include a grievance-like procedure in all of its contracts with the LAHSA which would allow for clearer communication between all three parties.
- 9. INSTRUCT the CAO, in partnership with the LAHD, to review the administrative cap rate for all General Funded LAHSA contracts and report with recommendations in the best interest of City tax payers.

Of this amount, \$21.68 million is for transfers, appropriations, and expenditure authority for the Bureau of Sanitation, \$8 million for the Los Angeles Zoo Department, \$7.38 million for the Department of Transportation, \$4.86 million for the Bureau of Street Lighting and \$13.91 million is for other City funds. All transfers and appropriations are based on existing funds, reimbursements, or revenues. There is no immediate General Fund impact for operations and maintenance costs as a result of these recommendations (Attachment No. 3 of said CAO report).

The CAO reports in the addendum that the transfers, appropriations, and expenditure authority totaling \$3.33 million are recommended in the CAO report. Of this amount, \$772,000 is for transfers, appropriations, and expenditure authority for the CAO, \$601,502 for BOE, \$531,688 for General Services Department, and \$1,425,026 is for other City funds. All transfers and appropriations are based on existing funds, reimbursements, or revenues. There is no immediate General Fund impact for operations and maintenance costs as a result of the recommendations.

<u>Financial Policies Statement:</u> The CAO reports that the actions recommended in this report comply with the City's Financial Policies.

Debt Impact Statement: The CAO reports that the issuance of Municipal Improvement Corporation of Los Angeles (MICLA) debt is a General Fund obligation. The issuance of MICLA for the reauthorization of CTIEP projects included in this report would cause the City to borrow \$16,572,785 at an approximate 5.5 percent interest rate over 20 years. The total estimated debt service for the CTIEP projects is \$27,740,000, including interest of approximately \$11,167,000. The issuance of MICLA for the Bureau of Sanitation Automated Litter Bin Deployment Vehicles would cause the City to borrow \$2,800,000 at an approximate 5.5 percent interest rate over 10 years. The total estimated debt service for the vehicles is \$1,700,000, including interest of approximately \$420,000. During the life of the bonds, the combined estimated average annual debt service is \$1,807,000 over the first 10 years and \$1,387,000 over the following 10 years.

Actual interest rates may differ as rates are dependent on market conditions at the time of issuance. The CAO cannot fully predict what interest rates will be in the future. In accordance with the City's Debt Management Policy, the City has an established debt ceiling to guide in evaluating the affordability for future debt. The debt ceiling for non-voted direct debt as a percentage of General Fund revenues is 6 percent. The 2022-23 Adopted Budget non voter-approved debt ratio is 2.97 percent. The issuance of debt for these projects will not cause the City to exceed the six percent non-voter-approved debt limit.

The CAO reports in the addendum that there is no debt impact to the General Fund as a result of the recommendations in the addendum as there are no new debt issuance authorizations recommended.





The Board of Harbor Commissioners is anticipated to approve at its meeting of March 30 several agreements for as-needed air quality services at the Port. The current agreements are set to expire on April 6. However, extensions of the new contracts cannot be executed until after the April 19 Council meeting concludes due to the Council's March 28 to April 7 recess.

All the involved firms providing services support the Harbor Department with the implementation of the CAAP including: identifying new and emerging emission reduction technologies; preparation of health risk assessments for CEQA; assisting with the annual Port-wide emissions inventory and grant writing.

Due to the timing issues of the Harbor Department, immediate action is needed for the Council to waive review of the above action in order that the service contracts may go into effect prior to the April 6 termination date of the existing contracts.

In an effort to improve safety, visibility and public access to the San Pedro community, San Pedro Welcome Park and Bandini Canyon Park, on January 23, 2015, the City Council authorized the acquisition of the property located at 427 N. Gaffey Street at the terminus of the 110 Harbor Freeway (Council File 15-0052).

Currently, an outdoor advertising company is illegally occupying space on the property with a large billboard. The lease was originally entered into by the previous property owner in 2008. The original Purchase and Sale Agreement required the previous owner assign the billboard space lease to the City. This lease expired at the end of 2022, but the billboard remains in place.

On February 1, 2023, Council authorized the Department of General Services to issue all necessary notices instructing the billboard owner and lessee to remove the billboard and support structure, vacate the property and restore it to its original condition (Council File 15-0052-S2). Council also authorized the Department of General Services to expeditiously demolish and remove the billboard and expiration of the lease. Despite this action, the billboard remains in place, and the City should take steps to ensure that the City has the ability to deal with similar issues in the future, and that tenants who act in bad faith are accountable for their actions.

I THEREFORE MOVE that the Department of General Services, with the assistance of the City Attorney, be directed to report on the feasibility of summarily removing billboards from City properties leased to private entities that are in "holdover" status and charging all costs of removing billboards back to the holdover tenants.

I FURTHER MOVE that the City Attorney be requested to prepare and present a draft ordinance that would deem holdover billboard tenants on City property to be "irresponsible permittees" and not eligible for future building permits for a term of five years from the offending holdover tenancy.

WHEREAS, existing law defines "gravely disabled" as either a condition in which a person, due to a mental health disorder, is unable to provide personal needs such as food, clothing, or shelter or is mentally incompetent; and

WHEREAS, State Senator Susan Talamantes Eggman has introduced Senate Bill 43 which would expand the definition of "gravely disabled" to also include a condition that will result in substantial risk of serious harm to the physical or mental health of a person due to a mental health disorder or substance use disorder; and

WHEREAS, the bill defines "scrious harm" as causing significant deterioration, debilitation, or illness due to a person's inability to carry out personal or medical care and selfprotection; and

WHEREAS, the City should support this legislation because it would broaden the definition of gravely disabled to incorporate more individuals who are vulnerable and are not able to provide necessary personal and medical care to themselves;

NOW, THEREFORE, BE IT RESOLVED, that by adoption of this resolution, the City of Los Angeles hereby includes in its 2023-24 State Legislative Program, SUPPORT for SB 43 (Eggman) which would expand the definition of "gravely disabled" to include conditions that will result in serious harm to the physical and mental health of an individual.

The Antelope Valley Line is part of the regions Metrolink commuter rail system and connects Lancaster with Union Station in downtown Los Angeles. The line has several stations in the San Fernando Valley including in Sun Valley in Council District 6. This station has a travel time of 29 minutes to Union Station. Metro and Metrolink are currently working on a \$220 million project to upgrade the Antelope Valley Line which will allow for 30 minute bi-directional headways between Santa Clarita and Union Station. This would be a tremendous upgrade from current service on the line which now only consists of ten trains a day.

Sun Valley has a large low income and transit dependent population. Currently, the Sun Valley Metrolink station consists of a single platform and is located in an industrial area far from residents, businesses, and other transit connections. Many Sun Valley residents do not even know that the area has a Metrolink station. In order for Sun Valley to take advantage of the upgrades to the Antelope Valley line, the city should partner with Metro to explore how we can upgrade the Antelope Valley Station to be more of a community asset.

I THEREFORE MOVE that the CLA and CAO report back on how the city can partner with Metro and Metrolink to prepare a study for the Sun Valley Metrolink station that analyzes:

- Relocating the Metrolink station to Sunland and Van Nuys Boulevard and identify challenges and opportunities for each location in comparison with the existing location with consideration of impacts to Metrolink operations.
- Improving the Metrolink Sun Valley Station as a multi-modal Transit HUB by improving bus/shuttle service and active transportation as well as the feasibility of adding a second platform in response to the Brighton to Roxford Double Track Project.

I FURTHER MOVE that the CLA and CAO report back on any available funds that the city can contribute to this study.
