Council District 5 is coordinating a street banner campaign to confront an increase in antisemitic incidents in the district. LA for All is a creative-led campaign created by the Civil, Human Rights and Equity Department to stand against hate and encourage our city to speak up and speak out against hate crimes and hate incidents. The campaign meets at the intersection of art, advocacy, and community - and stands up for an inclusive LA.

Each year, the Anti-Defamation League (ADL) tracks incidents of antisemitic harassment, vandalism and assault in the United States. In 2022, ADL tabulated 3,697 antisemitic incidents throughout the United States; a 36 percent increase from the 2,717 incidents tabulated in 2021 and the highest number on record since ADL began tracking incidents in 1979. Reflecting a national rise in anti-Semitism and horrible attacks on the Jewish community here in the City of Los Angeles. LA for All banners will be printed in Hebrew in solidarity with our Jewish community.

I THEREFORE MOVE that the City Council, in accordance with the Los Angeles Municipal Code Section 62.132 approve the Street Banner program being coordinated by Councilmember Katy Yaroslavsky, as a City of Los Angeles Non-Event Street Banner Program for the period of **April 22, 2023 to October 15, 2023**.

By checking our city trees regularly, maintaining their health, and reducing any safety hazard for residents, structures, or vehicles, the City is able to enhance the quality-of-life for all residents. Over the years, the City budget has not maintained the necessary seven-year or less cycle of tree trimming city-wide. For Council District 10 residents, this service is in high demand and it's necessary that we provide supplemental services to ensure this work is completed on a regular basis.
