PUBLIC SAFETY and BUDGET, FINANCE, AND INNOVATION COMMITTEES REPORT and RESOLUTION relative to Fiscal Years (FY) 2022-23, 2023-24 and 2024-25 California Violence, Intervention and Prevention (2022-23 to 2024-25 CalVIP) grant award; and related matters.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. APPROVE the recommendations contained in the City Administrative Officer (CAO) report dated March 2, 2023, attached to Council file No. 22-1148, relative to the 2022-23 to 2024-25 CalVIP grant award.
- 2. ADOPT the accompanying Governing Body RESOLUTION attached to the CAO report dated March 2, 2023, attached to Council file No. 22-1148, as requested by the grantor and subject to the City Attorney as to form, which endorses the grant agreement and attests to compliance with the program and funding requirements of the grant.

<u>Fiscal Impact Statement:</u> The CAO reports that the acceptance of the 2022-

23 CalVIP Cohort IV Grant in the amount of \$4,000,000 and approval of grant-related actions will result in the implementation of enhanced gang prevention and intervention services in the Newton 1, Hollenbeck 1, Mission, Harbor, Southeast 1, and Southwest 2 Gang Reduction and Youth Development Zones. The required match of \$4,000,000 will be satisfied through a combination of salary, fringe benefit costs, and contractual services in the current year, and in 2023-24 and 2024-25. The composition of the match for 2023-24 and 2024-25 is subject to funding determinations by the Mayor and Council through the annual budget process. The proposed Reserve Fund loan of \$700,000 will used to provide cash-flow for service providers, which will be repaid upon final reimbursement of the CalVIP grant funds. Although all program costs are fully reimbursable by the grant, any significant delays in the timely submission of reimbursement requests will impact the repayment of the Reserve Fund loan and result in a negative impact to the General Fund. Full repayment will not occur until the end of the grant performance period on December 31, 2025.

<u>Financial Policies Statement:</u> The CAO reports the City's Financial Policies require that the City pursue Federal, State and private grants, but strictly limit financial support of these programs to avoid commitments that continue beyond available funding. The recommendations in this report comply with City Financial Policies in that the proposed funding is balanced against established revenue approved by Council actions and from Federal and State grant receipts. All funding is subject to the availability of grant funds and determinations by Mayor and Council.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. AUTHORIZE the Mayor, or designee, to:
 - a. Retroactively accept the 2022-23 JJCPA Grant in the amount of \$2,448,544 from the Probation Department to support the Juvenile Re-Entry Partnership Program for the provision of re-entry services to youth exiting County probation camps and returning to communities within the City, effective for a performance period of July 1, 2022 through June 30, 2023.
 - b. Submit any other necessary agreements and documents relative to the implementation of this program, subject to the review and approval of the City Attorney as to form and legality.
- 2. AUTHORIZE the Mayor, or designee, in accordance with the following chart, to retroactively negotiate and execute contracts with the following five community-based organizations to provide juvenile re-entry services in the City in conformance with the pro forma contract attached to the Communication from the Mayor dated February 23, 2023, attached to Council file No. 22-1442, for a performance period of one year, effective from July 1, 2022 through June 30, 2023, in a total amount not to exceed \$1,922,555, subject to the availability of funds, compliance with City contracting requirements, and the review and approval of the City Attorney as to form:

- 5. AUTHORIZE the Controller to increase appropriations within the Mayor's Budget Fund No. 100/46, Account No. 001020 Salaries, Grant Reimbursed for up to \$119,161, to be reimbursed by grant-funded salary costs by the 2022-23 JJCPA Grant Fund No. XXX/46, Account No. 46W146, Mayor.
- 6. AUTHORIZE the Controller to transfer up to \$48,439 from the 2022-23 JJCPA Grant Fund No. XXX/46, Account No. 46W299, Reimbursement of General Fund, to the Mayor Fund No.100/46, Revenue Source Code No. 5346 Related Cost Reimbursement from Grants for reimbursement of grant-funded related costs.

This loan is fully reimbursable by the grant and repayment will begin prior to the end of the grant performance period.
