PUBLIC SAFETY COMMITTEE REPORT relative to a status update on the development of a multi-year plan for unarmed response; and policy considerations for creating an Office of Unarmed Response (OOUR); and related matters.

Recommendations for Council action:

- CONFIRM the City's primary objectives for alternative response and the intended purpose of an OOUR, as outlined in the City Administrative Officer (CAO) report dated May 15, 2023, attached to Council file No. 22-0979.
- 2. INSTRUCT the CAO to develop, within the next 120 days, a robust performance management and evaluation program for the Unarmed Model of Crisis Response Pilot (UMCRP), and, if implemented, to monitor and gather key insights from the successes and opportunities from the pilot year; and, include all current models in their robust performance management and evaluation program for the UMCRP.
- 3. INSTRUCT the CAO to report to Council, within the next 120 days, on all funding the City is allocating to all programs that fall under Alternative and Unarmed responses and any duplicative services; and include the preliminary value for the dollar in regards to the efficacy of the program (for example what is the value of a mediation program as opposed to having interventionists, what is the value of a peace ambassador compared to other alternatives, etc.); and compare this to the current public safety system; and compare how the program improves the City's response toward

people's feelings of being unsafe.

- 4. INSTRUCT the CAO, in consultation with the Chief Legislative Analyst (CLA), the Mayor's Office of Community Safety, the Los Angeles Police Department (LAPD), and other partners, to report to Council within 90 days, on progress to determine which 9-1-1 call types are appropriate to divert to alternative response models, and specifically:
 - a. Which of these calls should be assigned to an OOUR.
 - b. Which of these calls are currently addressed by existing programs, which may be addressed by expanding existing programs, and which would require new programs.
- 5. INSTRUCT the CAO, in consultation with the CLA, the Mayor's Office of Community Safety, the LAPD, and other partners, to report to Council with regular updates to the City's alternative response framework based on the shared vision, including:
 - a. Reports on key leadership decisions and community feedback.
 - b. Updates on potential costs and timeline for program expansion.
 - c. Analysis of current programs' performance metrics and data.
- 6. AMEND the "Primary Objectives for Alternative Response" section contained in the CAO report dated May 15, 2023, attached to the Council file, to update and rearrange the order of objectives, and add an additional objective (Primary Objective No. 4), respectively, as follows:
 - a. Primary Objective No. 1: Reduction in use of force incidents in all calls and involvement of the criminal justice system.
 - b. Primary Objective No. 2: Improve the efficacy of sworn police

officer deployment and review the scope of work of the LAPD.

- c. Primary Objective No. 3: Improve social and mental health services for individuals in crisis or for select demographics (i.e. people experiencing homelessness).
- d. Primary Objective No. 4: View public safety in a more holistic way (i.e. looking at why people are concerned or frustrated with the current system, are people housed or facing food insecurity, etc.).

Fiscal Impact Statement: The CAO reports that there is no impact to the General Fund at this time. The \$1,000,000 in Fund No. 100/56, entitled OOUR, is sufficient for the first year of operation at the proposed staffing level for an OOUR. Additional funds may be required after year one to cover 12 months funding for the proposed staffing level, and pending the adoption of an alternative response framework to implement an unarmed response expansion plan. Without additional funding sources, the creation of an OOUR and expansion of unarmed response programs will likely have a significant General Fund impact. At this time, the CAO is working with the CLA to determine alternative funding sources for the programs described in the CAO report, including Medicare and other grant programs.

The City Council of Los Angeles is in the process of exploring the impacts of amending the Los Angeles Living Wage (LWO) and the Los Angeles Hotel Worker Minimum (HWMO) Wage Ordinance (CF: 14-1371-S13).

Many of the workers employed at Los Angeles International Airport (LAX) including janitorial workers, security guards, airplane cabin cleaners, airline catering workers, airline passenger service workers, and restaurant and retail workers, are unable to afford the average monthly rent in Los Angeles, especially on the westside close to LAX.

Over time, the roles and responsibilities of the workers at LAX have grown and changed. There have been reports that airplane cabin cleaners are now expected to perform work that is outside the scope of their daily responsibilities, including security checks. This may put them at a higher risk of potential danger if they are not properly trained on what to look for and how to respond if they encounter a potential risk.

As the Chief Legislative Analyst (CLA) reports back to Council on their analysis of the economic impacts of amending the LWO and HWMO Wage Ordinance, we also must ensure that all employees job descriptions are accurate at LAX and that no employee is being asked to do work beyond its original scope, especially any security checks that require additional training.

I THEREFORE MOVE that Council instruct the Chief Legislative Analyst to include in the report requested in Council File 14-1371-S13 an analysis that verifies that employees covered by the Living Wage Ordinance are not instructed to perform tasks beyond the core duties of their occupation.

There are some communities in the City that have longstanding issues associated with unabated nuisance properties, which create blight and crime and adversely affect the public's health, peace and safety of persons residing or working in the premises and surrounding area.

There is a property in Council District 8, 108 Motel, located at 10721 S. Broadway, Los Angeles, CA 90061, that has continued to be a source of criminal and other nuisance activity as evidenced by arrests performed and other criminal activity observed by the Police Department.

On April 18, 2018, pursuant to Municipal Code Section 12.27.1 (Administrative Nuisance Abatement Proceedings), the Council declared the site to be a public nuisance and required the discontinuance of the motel use and any similar land uses at the property (Council File No. 16-0451).

108 Motel continues to be a public nuisance, and the declaration of a public nuisance for this property is fully attributable to its current use and condition and in recognition that past efforts to abate this nuisance lot have been unsuccessful.

The Department of Building and Safety issued an order to vacate and secure the property, and recorded the action with the County Recorder's office stating that the property has been determined to be a nuisance and its present use has been vacated. However, the owner did not comply with the order to vacate and secure the property by the date specified on the order, and extension of time, granted by the Department of Building and Safety.

Given the owner's failure to secure the property, the Department of Building and Safety must now ensure that the building is vacated and secured by means of chain link fence, gates, or padlock as provided for in Municipal Code Section Sec. 91.9003.4.1 (Enforcement – Noncompliance with Department Orders), and in addition, Municipal Code Section 91.9003.4.2 (Notification), authorizes the Department of Building and Safety, to notify the property owner that a lien will be placed against the property to cover the cost of vacating and securing the property, and their right to a hearing.

I THEREFORE MOVE that the Council instruct the City Administrative Officer to identify funds to appropriate/transfer \$28,500 to the Department of Building and Safety, to pay for the costs to secure the nuisance vacated building known as the 108 Motel located at 10721 S. Broadway, Los Angeles, CA 90061, inasmuch as the owner did not comply with the order to vacate and secure the property by the date specified on the order, and extension of time, granted by the Department of Building and Safety, and removed the prior fence installed and paid for by the City (Council File No. 16-0451-S1).

I FURTHER MOVE that the Department of Building and Safety, with the assistance of the City Attorney, take all actions necessary, consistent with Municipal Code Section 91.9003.4.2 (Notification), to notify the property owner that a lien will be placed against the property 108 Motel located at 10721 S. During the height of the COVID-19 pandemic, the City's Al Fresco program provided an invaluable lifeline to our small business community, keeping restaurant doors open and money in the pockets of struggling Angelenos.

Since the program's inception, the Planning Department has issued approximately 154 temporary authorizations for outdoor dining in the Coastal Zone. While a Coastal Development Permit (CDP) is typically required for restaurants within the Coastal Zone that seek to add or expand outdoor dining space, various state laws were enacted to provide an easy path for dining establishments to obtain temporary authorizations for outdoor dining during the pandemic.

These bills include Assembly Bill 61 (Gabriel), which temporarily suspends local parking requirements for outdoor dining purposes through December 31, 2023. Additionally, the Coastal Commission has granted a number of temporary CDP waivers to allow outdoor dining areas and other pandemic-related activities in the public right of way.

However, once AB 61 sunsets and the temporary waivers expire at the end of this year, any restaurant in the Coastal Zone looking to make their outdoor dining areas permanent would need to obtain a CDP to continue their outdoor dining operations. The costs and time needed to obtain a Coastal Development Permit are significant and impose a serious burden on our coastal food establishments. The timeline for processing a CDP is approximately 6 to 9 months, and the fee is approximately \$16,000. This extra burden on our Coastal Zone restaurants is unfair and the City must act in good faith to address this inequity.

The idea behind a programmatic CDP is to consolidate multiple CDPs under one application process. As of now, a programmatic CDP has been discussed at a cursory level and the details of how it will be implemented are not mentioned at all in the current Al Fresco outdoor dining on private property proposed ordinance (Council File No. 20-1074-S4).

If no provisions are made for the 154 restaurants in the Coastal Zone, then starting January 1, 2024, their outdoor dining spaces allowed under the temporary authorization would be in violation of the Coastal Act and subject to enforcement by the Coastal Commission. This outcome is unacceptable and can only be avoided if the City takes action now. As such, the Planning Department must take the necessary actions to create and implement a programmatic CDP for Al Fresco outdoor dining on both private property and those in the public right of way in the Coastal Zone.

I THEREFORE MOVE that the Council instruct the Planning Department, with the assistance of the Department of Transportation, Department of Building and Safety, Bureau of Engineering, and in consultation with the City Attorney, and the Coastal Commission, to prepare a report within 60 days with recommendations to establish a programmatic Coastal Development Permit for Al Fresco outdoor dining on both private property and in the public right of way in the Coastal Zone.

The Ventura Cahuenga Boulevard Corridor Specific Plan (Specific Plan) (Ord. 174,052), first adopted in 1991, establishes a Project Impact Assessment (PIA) Fee for the purpose of funding Specific Plan transportation improvements and services, as well as pedestrian improvements.

Section 12 of the Specific Plan sets forth guidance as to how Specific Plan PIA Fee funds may be used, with reference to a list of improvements and services. Section 12.A of the Specific Plan enables City Council to authorize additional improvements and services, upon recommendation by both the Director of Planning and the General Manager of Transportation (LADOT), subject to findings set forth in Section 12.B and subject to review by the Specific Plan Project Review Board (PRB).

At the May 4th, 2023 meeting of the PRB, a proposal from the Sherman Oaks Business Improvement District (Sherman Oaks BID) to construct a Van Nuys Boulevard Median Project (Project) along Van Nuys Boulevard from Moorpark Street to Hortense Street utilizing a total allocation of \$683,473 in PIA Fee funds was supported by the PRB. The Sherman Oaks BID is contracting for design and construction and will fund on-going maintenance and watering for the median once constructed.

The Project will have five main benefits for the surrounding community, mitigating cumulative adverse impacts of new development within the Specific Plan area:

- Calm vehicular traffic on Van Nuys Boulevard;
- Eliminate the ability for illegal and unsafe left turns from southbound Van Nuys Boulevard into the Gelson's and Citibank parking lots and create an organized left turn lane into the Gelson's and Van Nuys/Milbank shopping center:
- Create a pedestrian refuge island for the southern leg of the crosswalk in the Van Nuys Boulevard / Milbank Street intersection;
- Build a new ADA Accessible curb ramp on the southwest corner of the Van Nuys Boulevard / Milbank Street intersection; and
- Beautify the retail shopping area on Van Nuys Boulevard and create a new welcome sign for the Sherman Oaks BID business area.

I THEREFORE MOVE that the City Council instruct the Department of Transportation, with the assistance of the Department of Planning, to report back within 30 days with a recommendation, and findings from the General Manager of the Department of Transportation and the Director of Planning as set forth in Section 12.B of the Specific Plan, regarding an authorization of expenditure of up to \$683,473 of Specific Plan PIA Fee funds for the proposed Sherman Oaks BID Van Nuys Boulevard Median Project located on Van Nuys Boulevard from Moorpark Street to Hortense Street.
