On Saturday, July 9, 2022, at approximately 1:35 a.m., Demond Camper was stopped inside his vehicle at 11688 South Central Ave. Mr. Camper had parked his car at his residence when the suspect approached the driver side of the vehicle and fired multiple rounds at the victim. The suspect fled on foot to an awaiting vehicle and fled the location. Officers found Mr. Camper, seated in the driver seat of his vehicle suffering from multiple gunshot wounds to his head. Paramedics arrived at the crime scene and pronounced the victim deceased at 1:52 am.

The person responsible for this crime represents an ongoing threat to the safety of the people of Los Angeles; therefore, it is appropriate for the City of Los Angeles to offer a reward for information leading to the identification, apprehension and conviction of the person responsible for the death of Demond Camper.

I THEREFORE MOVE that by adoption of this Motion, the City Council provide an offer of reward for information leading to the identification, apprehension, and conviction of the person responsible for the death of Demond Camper on July 9, 2022, and in support thereof, make the following findings pursuant to Division 19, Chapter 12, Article 1 of the Los Angeles Administrative Code:

- 1. That the death of Mr. Camper was caused by the willful misconduct of one or more persons.
- 2. That this offer of reward is consistent with and taken for the immediate protection of the public peace, health and safety of local residents, as well as visitors to the City, and is consistent with the need to arrest and convict the person who, because of not being apprehended, could by their actions further terrorize and present a continuing and immediate menace to the rights of persons in the City.
- 3. That what happened to the victim is an especially disturbing crime and therefore, as a matter of public policy, the City hereby offers a reward as an added inducement for persons to come forward with information leading to the identification, apprehension and conviction of the person or persons responsible for the death of Erik Brown.
- 4. That the sum of \$50,000 shall be the aggregate maximum sum of any payment or payments of a City reward in this instance.
- 5. That the offer of reward shall be in effect for six months from the date of the advertisement of the reward by the City Clerk.

WHEREAS, the National Association of Broadcasters credit AM radio for continuing to be the backbone of the Nation's Emergency Alert System; and

WHEREAS, the National Association of Broadcasters finds that 82 million Americans listen to AM radio monthly, thereby removing this technology from newer motor vehicles will inhibit individuals from using this technology as an outlet for information; and

WHEREAS, currently pending before Congress is S.1669 (Markey), which aims to continue production of this technology by requiring the Department of Transportation to mandate that new motor vehicles include AM radio technology as standard equipment; and

WHEREAS, motor vehicles manufactured in the United States, imported into the United States, or shipped in interstate commerce would be held accountable to comply with the provisions of the bill; and

WHEREAS, S. 1669, would allow the Department of Transportation to impose civil penalties on manufacturers that fail to comply with these guidelines; and

WHEREAS, the City of Los Angeles should support this action because this bill would protect the use of AM radio technology which continues to be an important source of information for listeners; and

WHEREAS, removing this technology would pose risks to constituents that rely upon or do not have the capabilities to access other news sources;

NOW, THEREFORE, BE IT RESOLVED that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2023-2024 Federal Legislative Program support for S. 1669 (Markey), which would mandate that new motor vehicles include AM radio technology as standard equipment in order to ensure the public's access to emergency notifications and news sources.

WHEREAS, Black women are incarcerated at a rate five times that of White men, and there are approximately 3,900 total incarcerated women in California, many of whom are the parents of the roughly 195,000 predominantly Black and Brown children in the state who have an incarcerated parent, who would be empowered to participate in school board races and other local elections if their right to vote is restored; and

WHEREAS, over 7,000 veterans in California are also disproportionately impacted by these provisions as many return to civilian life suffering trauma, which can cause a higher possibility of becoming unhoused or arrested; and

WHEREAS, currently pending before the Assembly is ACA 4 (Bryan) that would repeal requirements that disqualify electors and create a more equitable electoral system that is inclusive of everyone; and

WHEREAS, ACA 4 would lift voting restrictions for people serving in State or federal prison and allow them to cast their vote despite their conviction, giving them a choice in our democratic process; and

WHEREAS, a democratic system fails to be whole when a multitude of citizens are prohibited from voting and restricts them from having input on policies, laws, and representatives that affect them as well the rest of their community;

NOW, THEREFORE, BE IT RESOLVED, that by the adoption of this Resolution, the City of Los Angeles here by includes in its 2023-2024 State Legislative Program support of ACA 4 (Bryan), which would repeal constitutional provisions that disqualify people convicted in State or federal prison from voting.

### HOUSING & HOMELESSNESS

#### MOTION

One of the primary factors exacerbating the homelessness crisis is the low supply of housing. In recent years, the City of Los Angeles has invested a significant amount of resources and effort towards developing the City's housing infrastructure, especially as it relates to affordable and supportive housing —this includes the \$1.2B in Proposition HHH funding which is supporting the development of close to 10,000 units, and the millions more that have been invested to purchase and convert hotels and motels for interim and permanent housing.

It has been a shared priority of the Mayor and the City Council to identify and pursue every reasonable housing solution to address the region's homelessness and housing crisis. In 2016, the City Administrative Officer (CAO) started to proactively assess City-owned lands as well as other public and private land for suitability for permanent affordable housing development, supportive housing development, and short term uses such as for interim housing and storage facilities. This assessment includes a review of the zoning and physical constraints, site history, funding commitments, and the potential impact of redevelopment on existing City services, operations, and cost estimates.

To date, the CAO has assessed more than a 1,000 City-owned and other publically owned properties as well as privately-owned properties. As feasible parcels and appropriate funding are identified, the City utilized sites for the development of interim and permanent housing. A key aspect of addressing the homelessness challenge is pooling together resources across sectors and building partnerships beyond traditional means. The City is now looking at more creative ways to outreach to property-owners in order to expand the resources and opportunities to support its housing needs.

I THEREFORE MOVE that the City Council direct the City Administrative Officer (CAO), with the support of the Los Angeles Housing Department (LAHD), the Department of General Services (GSD), the Office of Finance, and other relevant city agencies to develop an online "clearing house" whereby landlords and property-owners in Los Angeles can express their interest in selling or leasing property to the City for use as interim, permanent supportive, or affordable housing.

**I FURTHER MOVE** that the CAO, with the support of LAHD, GSD, the Office of Finance, and other relevant city agencies report back within 60 days on the clearing house, recommendations for marketing the online portal to private property-owners, the process, timeframe, and metrics for assessing properties that are submitted through this process, any current funding sources available for the acquisition or leasing of property, and how this process will support the city's efforts at furthering the equitable distribution of affordable and supportive housing citywide.

## PLANNING & LAND USE MANAGEMENT

#### MOTION

On April 17, 2018, the City of Los Angeles declared a shelter crisis pursuant to Government Code 8698.4 with the intent to expedite the building of interim shelters to address the homelessness crisis. Additionally, AB 1197 exempts these emergency shelter projects from CEQA to help accelerate the building of these facilities. The June 2020 Roadmap Agreement commits the City of Los Angeles to building a minimum of 6,700 beds and the County of Los Angeles to fund the accompanying supportive services. The Roadmap Working Group led by the Office of the City Administrative Officer conducts regular meetings between City Departments to facilitate a coordinated, expeditious, design-to-construction process for these interim sites, and has resulted in the building of 5,300 beds within 10 months and as of June 20, 2023, 7,002 new Roadmap beds were open and occupied.

To accelerate the building of interim housing sites, the City focused on small, detached, prefabricated "pallet" units, also known as "cabins" and/or "tiny homes", with the Bureau of Engineering (BOE) leading in the design of each shelter site and overseeing the construction in coordination with the General Services Department (GSD), with the Department of Building and Safety (LADBS) issuing permits for construction and providing a Certificate of Occupancy after all health and safety building codes are met, and with the Los Angeles Fire Department (LAFD) inspecting and reviewing code compliance related to fire safety.

One promised benefit of using prefabricated units was that both installation and replacement of damaged and/or destroyed units would be a quick and simple process. However, the process to replace cabins requires coordination with the onsite operator, new plans to be submitted, and additional inspections to take place; and to pay permits and fees between City Departments takes months rather than weeks. Improvements to the process is required to enable the City to continue to address homelessness with urgency. As the City's inventory of interim housing grows, the need to add amenities based on resident feedback and to bring on other models of prefabricated units will require greater attention from City Departments.

I THEREFORE MOVE that the Council instruct the City Administrative Officer (CAO) with the assistance of the Chief Legislative Analyst (CLA), Mayor's Office, Bureau of Engineering, General Services Department, Los Angeles Fire Department, Los Angeles Department of Building and Safety, Los Angeles Planning Department and Los Angeles Housing Department (LAHD), and the Los Angeles Homeless Service Authority (LAHSA) to review the City's current permitting, approval, communication processes and include the following in the report:

- a) A process map for each interim housing model;
- b) Recommendations to further reduce construction timelines;
- c) Recommendations to improve communication between City Departments and contractors;
- d) Updates to current processes to accommodate new models of interim housing;
- e) Recommendations to better address evolving situations in a more expeditious and cost-effective manner such as: new prefabricated models, replacement of cabins, new fire alarm systems, hotel conversions/rehabilitation;
- f) Options for waiving fees for permits;

- g) Recommendations to implement a mechanism to review nightly bed rates as new models of interim housing emerge to ensure operation costs are covered;
- h) Recommendations for expediting interdepartmental transfer; and
- i) Recommendations on establishing a revolving loan fund to enable departments to quickly access funding to pay for permits and fees associated with change orders, payment of replacement pallet shelter units, insurance, and other related costs.

I FURTHER MOVE to instruct the CAO with the assistance of CLA, LAHD and LAHSA to review interim site operator contracts and report back with recommendations to enhance good neighbor protocols.

WHEREAS, the California Environmental Quality Act (CEQA) provides a process for evaluating the environmental effects of a project, including but not limited to, water quality, land use and agricultural resources, transportation and circulation, air quality and greenhouse gas emission; and

WHEREAS, under the current law, certain supportive housing projects and emergency shelters are already exempt from CEQA, there remain numerous projects that are delayed due to CEQA challenges being filed; and

WHEREAS, currently pending before the Legislature is AB 785 (Santiago), which would expand CEQA exemptions for publicly funded low-barrier navigation centers, supportive housing, 100% affordable housing projects, and transitional housing for youth and young adults in the City of Los Angeles until January 1, 2030; and

WHEREAS, AB 785 would help the City to expedite the construction of interim and permanent housing for people experiencing homelessness or those at risk of experiencing homelessness;

NOW, THEREFORE, BE IT RESOLVED that by adoption of this Resolution, the City of Los Angeles hereby include in its 2023-24 State Legislative Program SUPPORT for AB 785 (Santiago).

#### **HOUSING & HOMELESSNESS**

#### MOTION

On July 13th, the Downtown Women's Center (DWC), in conjunction with the Los Angeles County Homeless Initiative, unveiled the findings from the 2022 Los Angeles County Women's Needs Assessment (Needs Assessment).

Written in partnership between DWC, the Urban Institute, and HUB for Urban Initiatives, the report - which was based on surveys completed by 580 individuals and listening sessions with nearly 100 women from across all eight Service Planning Areas (SPAs) in Los Angeles County - represents the single most extensive research effort ever conducted to understand the unique needs of unaccompanied women, who are experiencing homelessness without children or other dependents.

Per the 2022 Greater Los Angeles Homeless Count, there were 14,403 unaccompanied women - constituting 68% of all female-identifying individuals experiencing homelessness - without stable housing in the Los Angeles Continuum of Care (CoC).

Amongst the most striking themes from the report is the emphasis on safety, and its relative absence, for unaccompanied women both experiencing unsheltered homelessness and those moving through the rehousing system. Safety was one of the single most important criteria for housing, and the most common barrier to accessing shelter cited by respondents was concerns for personal safety. These findings are particularly salient in light of the fact that 90% of respondents noted some history of victimization in their lifetimes.

The report also uplifted the pernicious nexus of domestic and intimate partner violence (DV/IPV) and homelessness. The most common reason for leaving permanent and stable housing, cited by 29% of respondents, was DV/IPV.

The City has taken important steps to better infuse a gender equity lens into its homeless response systems, including its recognition of unaccompanied women as a unique homeless subpopulation and the dramatic success of Project Safe Haven to house 3,000 DV/IPV survivors during the height of the COVID-19 pandemic. This Needs Assessment, however, points to the yawning gaps in our rehousing and homeless services systems when it comes to addressing the unique needs of historically-overlooked subpopulations.

I THEREFORE MOVE that the City Council instruct the Community Investment and Families Department (CIFD) and the Los Angeles Homeless Services Authority (LAHSA) to report back within 90 days on recommendations to enhance City programs currently serving female-identifying individuals experiencing homelessness and survivors of domestic/intimate partner violence (DV/IPV), based on the findings of the 2022 Los Angeles County Women's Needs Assessment.

**I FURTHER MOVE** that City Council instruct CIFD, LAHSA, and the Los Angeles Housing Department (LAHD) report back within 90 days on any current protocols or requirements regarding client/resident safety at City-funded shelter, interim housing, and permanent housing facilities, and to prepare recommendations for increasing safety measures, with an emphasis on non-punitive efforts, that account for the specific needs of DV/IPV survivors, LGBTQIA+ individuals, and female-identifying individuals.
