- 3. DIRECT the City Administrative Officer (CAO) to provide funding in the BOS 2024-25 budget for two new part time Event Attendant

positions. The two positions will provide education and outreach during City Hall and Civic Center events.

- 4. DIRECT the CAO and Chief Legislative Analyst (CLA), with support from the BOS, to convene a zero waste facilities and events working group comprised of City Departments and Bureaus that permit/coordinate/host or organize events, as well as City Departments and Bureaus that have on-site restaurants, concessionaires or food vendors to ensure the following:
 - a. That the requirements of the Zero Waste Ordinance No. 187718 are incorporated into relevant leases, agreements and events web pages and forms.
 - b. That the Departments and Bureaus provide information about their current leasing and events policies and logistics, so these can be evaluated, barriers identified, and logistics revised to facilitate zero waste measures.
 - c. That the systems for collecting events data are implemented, so that the City can accurately report the diversion of recyclables and organic materials.
- 5. DIRECT the BOS and the Department of General Services to report by January 2024, on the progress of the two organics pilot programs and resources needed to expand the program to additional City facilities and City sponsored events.

The Council District AB1290 Fund provides funding for redevelopment and community services in various Council Districts.

The Board of Public Works – Office of Community Beautification (OCB) has been designated by the City to provide for the proper planning, coordination, direction, and management of the City's graffiti removal and community beautification activities.

OCB currently has contracts with Coalition for Responsible Community Development, Gang Alternatives Program, Los Angeles Conservation Corps, and Los Angeles Neighborhood Initiatives for services in the district. The funding proposed for transfer will be used in existing contracts until new contracts with the providers have been executed. There is a Request for Proposals that is currently underway, and upon execution of the new contracts, any remaining funds will be allocated to the new contracts. This ongoing effort is of special benefit for the residents of the City and for CD-8 and deserves financial assistance from the City.

Sufficient funds are available in the CD-8 portion of the Council District AB1290 Fund for this purpose.

(Borrower), a New York nonprofit corporation and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, has requested that the California Municipal Finance Authority (CMFA) issue one or more series of its revenue bonds or other obligations, in an aggregate principal amount not to exceed \$30,000,000 (Obligations), for the purpose of refinancing all or a portion of the California Municipal Finance Authority Revenue Bonds, Series 2015, as well as the acquisition, construction, renovation, expansion, building improvements, equipping, repairs, and improvements for the facilities located at 6305 Yucca Street, 6301 Yucca Street, 1823 Vine Street, 1641 Ivar Avenue, 1812-1822 1/2 Ivar Avenue, 1810 Ivar Avenue, 6333 Yucca Street, and 6321 Yucca Street (Project) in Council District 13. The Project is owned and operated by the Borrower and will be used for educational, administrative, and ancillary purposes.

No City funds are or will be pledged to support the Project. The Obligations are payable solely from revenues or other funds provided by the Borrower. The City does not incur liability for repayment of the Obligations. The City is required by federal law to review and approve the issuance of bonds or revenue obligations for projects within its jurisdiction and conduct a public hearing.

In accordance with the Tax Equity and Fiscal Responsibility Act of 1982 (TEFRA) and as part of the issuance of the Obligations, the Borrower has requested that the City conduct the required public hearing (TEFRA Hearing) and approve the issuance of the Obligations by CMFA.

I THEREFORE MOVE that City Council allow the California Municipal Finance Authority to issue bonds in an amount not to exceed \$30,000,000 for the refinancing of all or a portion of the California Municipal Finance Authority Revenue Bonds, Series 2015, as well as the refinancing, acquisition, construction, renovation, expansion, building improvements, equipping, repairs, and improvements for the facilities located at 6305 Yucca Street, 6301 Yucca Street, 1823 Vine Street, 1641 Ivar Avenue, 1812-1822 1/2 Ivar Avenue, 1810 Ivar Avenue, 6333 Yucca Street, and 6321 Yucca Street in Council District 13; and hold a TEFRA Hearing and adopt the attached TEFRA Resolution at the City Council Meeting to be held on Friday, October 6, 2023 at 10:00am, located at 200 North Spring Street, Room 340, Los Angeles, California, 90012.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ANGELES APPROVING THE ISSUANCE OF THE CALIFORNIA MUNICIPAL FINANCE AUTHORITY REVENUE BONDS IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$30,000,000 FOR THE PURPOSE OF FINANCING THE ACQUISITION, CONSTRUCTION, IMPROVEMENT AND EQUIPPING OF EDUCATIONAL FACILITIES AND CERTAIN OTHER MATTERS RELATING THERETO

WHEREAS, the AMDA Inc., a New York not-for-profit corporation and an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986 (the "Borrower"), has requested that the California Municipal Finance Authority (the "Authority") issue revenue bonds in one or more series from time to time pursuant to a plan of financing in an aggregate principal amount not to exceed \$30,000,000 (the "Bonds") for the purpose of (i) financing certain new money projects as described below (the "New Money Projects"), (ii) refinancing all or a portion of the California Municipal Finance Authority Revenue Bonds (AMDA, Inc. Project), Series 2015 (the "Refunded Bonds"), the proceeds of which were used for the acquisition, construction, renovation, equipping and furnishing of certain educational and ancillary facilities (collectively, the "Refunded Projects" and together with the New Money Projects the "Projects"), (iii) funding one or more debt service reserve funds, (iv) funding the payment of certain swap termination fees and costs related thereto, if applicable, and (v) financing certain of the costs incident to the issuance of such Bonds; and

WHEREAS, the Projects include the acquisition, construction, renovation, expansion, building improvements, equipping, repairs, and improvements for certain educational and ancillary facilities, including dormitory facilities, classrooms, admissions, studios, offices, performance space, facilities used as a conservatory for the performing arts, administrative facilities, and improvements functionally related thereto, all of which are owned and operated, or to be owned and operated, by AMDA Inc. and located at: (1) 6305 Yucca Street, Los Angeles, California, in an amount not expected to exceed \$1,000,000, (2) 6301 Yucca Street, Los Angeles, California, in an amount not expected to exceed \$3,000,000, (3) 1823 Vine Street, Los Angeles, California, in an amount not expected to exceed \$15,000,000; (5) 1812-1822 1/2 Ivar Avenue, Los Angeles, California, in an amount not expected to exceed \$3,000,000; (6) 1810 Ivar Avenue, Los Angeles, California, in an amount not expected to exceed \$3,000,000; (8) 6321 Yucca Street, Los Angeles, California, in an amount not expected to exceed \$3,000,000; (8) 6321 Yucca Street, Los Angeles, California, in an amount not expected to exceed \$3,000,000; (9) APN 5546-003-009 in the City of Los Angeles, California, in an amount not expected to exceed \$3,000,000; and (10) APN 5546-003-015 in the City of Los Angeles, California, in an amount not expected to exceed \$3,000,000; and

WHEREAS, the Projects will be used for educational purposes of the Borrower, and will be owned and operated by, and used by, the Borrower; and

WHEREAS, pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code"), the issuance of the Bonds by the Authority must be approved by the City because the Projects are located within the territorial limits of the City; and

WHEREAS, the City Council (the "City Council") is the elected legislative body of the City and is one of the "applicable elected representatives" required to approve the issuance of the Bonds under Section 147(f) of the Code; and

WHEREAS, the Authority has requested that the City Council approve the issuance of the Bonds by the Authority in order to satisfy the public approval requirement of Section 147(f) of the Code and the requirements of Section 4 of the Joint Exercise of Powers Agreement Relating to the California Municipal Finance Authority, dated as of January 1, 2004 (the "Agreement"), among certain local agencies, including the City; and

WHEREAS, pursuant to Section 147(f) of the Code, the City Council has, following notice duly given, held a public hearing regarding the issuance of the Bonds, and now desires to approve the issuance of the Bonds by the Authority.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Los Angeles as follows:

The foregoing resolutions are true and correct.

The City Council hereby approves the issuance of the Bonds by the Authority. It is the purpose and intent of the City Council that this Resolution constitute approval of the issuance of the Bonds by the Authority, for the purposes of (a) Section 147(f) of the Code by the applicable elected representative of the governmental unit having jurisdiction over the area in which the Project is to be located, in accordance with said Section 147(f) and (b) Section 4 of the Agreement.

The officers of the City are hereby authorized and directed, jointly and severally, to do any and all things and to execute and deliver any and all documents which they deem necessary or advisable in order to carry out, give effect to and comply with the terms and intent of this Resolution and the financing transaction approved hereby.

The City Council expressly conditions its approval of this Resolution on its understanding that the City shall have no obligation whatsoever to pay any principal, interest, fees or any other costs associated with the Authority's issuance of the Bonds for the financing and/or refinancing of the Projects.

Neither the faith and credit nor taxing power of the City, the State of California or any political subdivision thereof, will be pledged to the payment of the principal or redemption premium, if any, or interest on the Bonds. The issuance of the Bonds will not directly, indirectly or contingently obligate the City, the State of California or any political subdivision thereof to levy or to pledge any form of taxation or to make any appropriation for their payment.

This Resolution shall take effect immediately upon its passage.

GOVERNMENT OPERATIONS

The affordable housing shortage and corresponding homelessness crisis across Los Angeles necessitate the development of viable City-owned properties as 100% affordable housing and/or permanent supportive housing.

The City's Asset Evaluation Framework (C.F. 12-1549-S3) is intended to help advance the City's economic development and housing efforts by establishing a uniform procedure to evaluate and designate City-owned properties for economic development, housing opportunities, and other City purposes, as well as to identify higher and better uses for such properties in order to maximize the value of City assets and to address priority concerns such as housing affordability and homelessness.

To advance the above efforts, there is a 16,073 square foot City-owned property located at 1345 N. El Centro Avenue and 6207 W. Afton Place in Council District 13 which may be suitable for development as 100% affordable housing or permanent supportive housing. In order to repurpose the property to its highest and best use in helping to address the City's housing and homelessness crisis, staff should be directed to evaluate the property to determine whether and how it can be feasibly developed into affordable or supportive housing.

I THEREFORE MOVE that the City Administrative Officer, with the assistance of the General Services Department, Department of City Planning, the Bureau of Engineering, the Los Angeles Housing Department, and any other relevant departments, be directed to initiate a review of the City-owned property located at 1345 N. El Centro Avenue in Council District 13 to determine its suitability for redevelopment as 100% affordable housing and/or permanent supportive housing, in conformance with the procedure set forth for the City's Asset Evaluation Framework, and to report back to the Municipal Facilities Committee City Council within 60 days with the assessment, a cost benefit analysis of leasing the site prior to redevelopment and a plan for development.

Traffic violence in Los Angeles is a serious problem. In 2022, 312 Angelenos lost their lives to traffic violence, the most in more than 20 years; as of September 2, 2023, there have been 206 deaths. Most traffic deaths and serious injuries result from identifiable and preventable causes, including excessive speed, and drunk and distracted driving. Despite this fact, traffic crashes are commonly referred to as "accidents," which implies that they are unanticipated and unpreventable, when all too often this is not the case.

Many agencies, such as the Federal Highway Administration, U.S. Department of Transportation and National Highway Traffic Safety Association, have adopted policies to use the terms "crash," "collision," and "incident" instead of the term "accident" when discussing traffic crashes. On June 30, 2021, the California Department of Transportation issued a memo to adopt such a policy and provided the following definitions:

- Accident is an incident that happens unexpectedly and unintentionally or an incident that happens by chance and without deliberate cause.
- Collision is an impact between objects, persons, animals, or other obstacles.
- Crash is a violent collision between objects, typically of one vehicle to another or of an obstacle.
- *Incident* is a distinct event, such as a crash, fire, or shooting.

The use of the term "accident" is inappropriate and disrespectful to victims of traffic violence, particularly in cases where motorists intentionally crash into other vehicles, bicyclists or pedestrians, or when a collision results from reckless behavior, such as drunk driving or street racing. While there may be limited instances that justify use of the term "accident," the City's use of more deliberate terminology can better support the design and implementation of safety countermeasures to address the factors that lead to traffic violence. Furthermore, this change will align the City with other state and federal entities who have already adopted this change in support of greater accuracy and consistency.

I THEREFORE MOVE that the City officially adopt the terms "crash," "collision," and "incident," in lieu of the term "accident" when discussing traffic crashes in any document or communication, except for instances where the City Attorney deems it necessary to use "accident" in litigation and related matters.

I FURTHER MOVE that the Department of Transportation, the Los Angeles Police Department, the City Attorney, the Department of Public Works, the Recreation and Parks Department, the General Services Department, and any other department that operates motor vehicles, report within 90 days regarding implementation of this new policy.

Council District 14 was home to this city's first "Filipinotown" called "Little Manila, situated approximately in the location of present day Little Tokyo. Today, Council District 14 remains the district with the largest Filipino American population, most of whom now reside in Eagle Rock and the broader Northeast Los Angeles area.

Due in large part to the significant population of Filipino-Americans in NELA, Eagle Rock became home to the United States' first 24 hour radio station dedicated to Filipino Americans, Radio Manila, headquartered in the former Philippine Village complex on Eagle Rock Boulevard. Although the Philippine Village has since been torn down and Radio Manila is no longer in existence, Eagle Rock remains a hub of the Filipino American community in Eagle Rock. The FilAm community has found a sort of community center in the Eagle Rock Plaza Mall, home to numerous flourishing Filipino American restaurants and businesses. Filipino restaurants also dot Colorado and Eagle Rock Boulevards and have been providing delicious food and quality service to the whole NELA community for decades.

I THEREFORE MOVE that in recognition of the cultural and historical significance of Philippine Village and Radio Manila in the ongoing story of Filipinos and Filipino Americans in Los Angeles, adopt this motion and authorizes the Department of Transportation to fabricate an Historical Monument sign stating: "Philippine Village: Former Hub of Eagle Rock's Filipino Community and Home to the Nation's First 24-hour Radio Station Dedicated to Filipino Americans, Radio Manila", and instruct the Department of Transportation to install the double-sided sign on the streetlight pole located in front of the former site at 4515 Eagle Rock Boulevard, Eagle Rock.

To address climate change, it is essential to electrify the transportation sector. In California, the transportation sector accounts for more than 50% of greenhouse gas (GHG) emissions, after accounting for extracting, refining and transporting vehicle fuels. In 2019, tailpipe emissions accounted for over 90% of the transportation sector's GHG emissions, and passenger vehicles alone accounted for 72%.

The federal, State and City governments have taken dramatic steps to promote electric passenger vehicles (EVs). The United States government provides a federal tax credit of up to \$7,500 per EV. The State of California plans to ban the sale of gas-powered cars by 2035, and its CleanCars4All program provides up to \$12,000 towards the purchase of EVs for income-qualified residents. The City of Los Angeles has embarked on an extensive program to install EV chargers, and the Department of Water and Power provides up to \$2,500 towards the purchase of used EVs, and up to \$2,000 for the installation of residential EV charging stations.

However, simply switching to EVs is not sufficient to meet our climate change goals. The California Air Resources Board has established a goal of reducing vehicle miles traveled by 25% by 2030, and promoting active transportation is essential toward meeting that goal.

Pedal-assisted electric bicycles (E-bikes) can provide a feasible alternative to passenger vehicles for many people. This is especially true in Los Angeles, where nearly half of all trips are less than 3 miles. E-bikes make it easier to ride on hilly terrain or in hot weather, to transport children or cargo, and to ride longer distances, especially for those who are older or less physically fit. While e-bikes may not be feasible for every trip, they provide enormous potential for multi-vehicle households to replace one or more vehicles with e-bikes.

E-bikes are environmentally preferable to EVs, especially given the types of vehicles that are prevalent in our streets. EV pickup trucks require about 50kWh/100 miles, and crossovers/SUVs require 25-30kWh/100 miles. E-bikes are more than 20 times more efficient, averaging about 1.1kWh/100 miles according to an ongoing study.

Because e-bikes are smaller and lighter than EVs, a typical e-bike battery uses less than 1% of the raw materials—such as lithium, cobalt and manganese—than the typical EV battery. A shift to e-bikes thus means less environmental degradation from mining, and less reliance on source countries with egregious human rights records. Moreover, the extra weight of EVs can create additional safety risk for pedestrians and bicyclists.

E-bikes are also far more affordable than EVs. Even with federal tax credits, nearly all EVs cost more than \$30,000. A good quality e-bike typically costs about \$2,000. In addition, because e-bikes can be charged from a standard 120V outlet, they do not require electrical upgrades (which DWP heavily subsidizes). While far cheaper than a motor vehicle, is still out of reach for many Angelenos.

Despite the importance of e-bikes toward meeting climate change goals, the federal, state and local governments generally have failed to adopt policies or subsidies to promote their purchase and use. The City should fill this gap, and follow the lead of other cities that have implemented local rebate or subsidy programs, including Santa Monica and Pasadena.

I THEREFORE MOVE that the Los Angeles Department of Water and Power (LADWP) be INSTRUCTED to report within 90 days on the feasibility of an e-bike subsidy program with qualifications similar to existing federal, state and local rebates for electric vehicles (EVs) and residential EV charging stations, with a focus on e-bikes that are likely to be used for utilitarian purposes and to replace vehicle trips, rather than for purely recreational purposes.

In Council District 15, within the Harbor Gateway Community Plan Area, the 'Athens on the Hill' community consists of many homes that may be historic-culturally significant. As such, the Planning Department needs to conduct a survey to determine the number of properties that qualify and meet the designation criteria. Under Municipal Code Section 12.20.3, a Historic Preservation Overlay Zone can be created in any area of the City that contains structures, natural features, or sites having historic, architectural, cultural or aesthetic significance.

In addition, an update to the Harbor Gateway Community Plan is actively underway. As such, this is the time to conduct an evaluation of this community's historic-cultural assets and implementation of the appropriate recommendations on design standards to protect the character of the 'Athens on the Hill' community.

Inasmuch as the Harbor Gateway Community Plan Area was last updated in 1996—nearly 30 years ago, it is necessary that as part of the ongoing Harbor Gateway Community Plan update, the Planning Department provides recommendations as to the historic-cultural significance of the properties located in the 'Athens on the Hill' community; and the appropriate design standards to protect the character of this community.

I THEREFORE MOVE that the Council instruct the Planning Department to prepare a report with recommendations, as part of the ongoing Harbor Gateway Community Plan update, on design standards to protect the character of the 'Athens on the Hill' community, generally bounded by 120th Street to the North; Figueroa Avenue to the East; Vermont Avenue to the West; and El Segundo Boulevard to the South.

I FURTHER MOVE that the Council instruct the Planning Department to conduct a survey to determine if the 'Athens on the Hill' community meets the criteria for historic-cultural designation, and based on the results of the survey, provide recommendations relative to the feasibility of the initiation of proceedings to establish a Historic Preservation Overlay Zone.

I FURTHER MOVE that the Council instruct the Planning Department, and the Department of Cultural Affairs, to prepare a report with recommendations to preserve cultural significant assets located in the 'Athens on the Hill' community.

The intersection of Glendale Boulevard and Fletcher Drive is heavily used by Angelenos traveling between Atwater Village, Silver Lake, and other abutting neighborhoods. This intersection leads to a network of amenities, local businesses, connections to freeways, and community greenspace, such as the Silver Lake Reservoir. The current configuration of this intersection makes it confusing for drivers while being highly inaccessible to people who walk or bike to the neighborhoods that it connects.

Because of the geometry of this intersection and its lack of a south leg cross walk, people walking south on the west side of Glendale Boulevard have two undesirable and unsafe options: Walk on the shoulder on the west side of Glendale Boulevard in between fast-moving vehicle traffic and a steep hillside, or cross three busy roads to get to the east side of Glendale Boulevard. The intersection of Glendale Boulevard and Fletcher Drive is on the High Injury Network (HIN) of our City's most dangerous streets for traffic violence. The City should explore both a new sidewalk to eliminate pedestrian gaps, and in-roadway solutions to increase pedestrian and cycling safety.

I THEREFORE MOVE that the City Council instruct the Los Angeles Department of Transportation, with assistance from the Bureau of Engineering and any other relevant departments, to report back within 120 days with recommendations and cost estimates to:

- Add pedestrian connectivity on the west side of Glendale Boulevard from the end of the existing sidewalk at Fletcher Drive south to the existing sidewalk near 2505 Glendale Boulevard;
- Create and/or improve ADA accessibility across Glendale Boulevard at Fletcher Drive; and
- Reduce the number of pedestrian crossing legs and distances, and increase safety for active transportation users at Glendale Boulevard / Fletcher Drive intersection.

New York City recently passed Local Law 35, which requires mental health professionals to be available in New York Department of Homeless Services shelters for families with children, requiring a ratio of one full-time mental health professional for every 50 families. This mandated service will provide early diagnosis, treatment, and referrals to emergency medical and psychiatric care providers for families and children experiencing homelessness. New York City, unlike the City of Los Angeles, directly oversees agencies that administer public health, medical, mental health, and homeless services, housing programs, and correctional programs; and is able to establish a minimum level of mental health services and require annual reporting of services offered and outcomes of participating New York City shelters.

For Los Angeles City, Federal and State law place the responsibility for providing mental health services and substance use disorder services, and other health programs, with Los Angeles County, with funding for these services distributed directly to the County. At the same, for Fiscal Year 2023-24, the City of Los Angeles is providing \$2,250,000 to bring on five additional County of Los Angeles Department of Health Services Multi-Disciplinary Teams and \$3,000,000 for street medicine teams to operate specifically within City boundaries. In addition, the Mayor has proposed to commit \$23,478,975 to a pilot substance use disorder treatment program, with \$7.8 million to be used to reimburse treatment providers, already contracted with the County, for additional time and services beyond what is currently provided by the County and/or by eligible benefits (e.g. Medi-Cal).

Over the course of nearly 60 years, the City has entered into several other agreements with the County, including the Joint Powers Agreement creating the Los Angeles Homeless Services Authority (LAHSA), and the Roadmap Agreement established through the United States District Court overseen by the Honorable Judge David O. Carter, which resulted in the City establishing and operationalizing more than 6,700 beds for people experiencing homelessness (PEH) in Los Angeles.

LA Alliance for Human Rights et al. v. City of Los Angeles et al. is a case that can reinforce the framework for the City to provide shelter and housing, while the County provides services to people experiencing homelessness. The settlement between the City of Los Angeles and the Plaintiffs from June 2022 establishes the City's commitment to create shelter and housing, and defines "City Shelter Appropriate PEH" as people who do not have serious mental illness and are not chronically homeless with a substance use disorder or chronic physical illness. By defining City Shelter appropriateness, the settlement inversely identifies populations that will require greater involvement from the County to care for: unsheltered higher-acuity individuals, individuals who are justice-involved, and the need to transition non-City Shelter Appropriate individuals currently in City shelters to County programs that meet their needs.

The September 12, 2022 Alliance Agreement of Terms signed by the City Administrative Officer and the Chief Executive Officer of the County, while non-binding, establishes services that the County is expected to provide related to specialized outreach teams. It also prioritizes City

residents for placement in permanent supportive housing units and access to County Homeless Initiative-funded high service interim beds. While this Agreement of Terms has yet to be approved by the City Council and Mayor, it is worth pursuing as it sets minimum terms and expectations for County services while additional services are sought for non-City Shelter Appropriate PEH.

The implementation of this and any future plans will require assessments to be conducted of sheltered and unsheltered PEH to determine appropriate levels of care. It will also require an assessment of the City's contract with the County for the delivery of health, mental health, and substance use disorder services. A trauma-informed assessment tool to diagnose severe mental illness, substance use disorder, chronic physical illness or disability, and specific Mental Health/DSM-5 conditions e.g. hoarding disorder, schizophrenia, and psychotic disorders that can affect housing stability, will need to be developed.

I THEREFORE MOVE to INSTRUCT the City Administrative Office (CAO) and the Chief Legislative Analyst (CLA) to report on methodology to determine adequate level of service for people experiencing homelessness (PEH) in the City and assessment tools or methodology for prioritizing this population for City or County shelters and services.

I FURTHER MOVE to INSTRUCT the CAO and CLA to report on mechanisms and strategies to require a minimum level of health, mental health, and substance use disorder services to meet the needs of unsheltered PEH and at interim and permanent supportive housing sites in the City, with options for the City to receive funding directly from the State and Federal government to administer these services.

I FURTHER MOVE to INSTRUCT the CLA and the CAO, in consultation with the City Attorney, to review the contracts and agreements that stipulates conditions for the County to adhere to, and report on recommendations to renegotiate and/or to improve access to, increase the availability of, and expedite the delivery of health, mental health, and substance use disorder services in the City, and within the context of any future actions related to the <u>LA Alliance</u> settlement.

I FURTHER MOVE to INSTRUCT the CAO and REQUEST the City Attorney to provide regular updates to the City Council on the progress in amending the contracts between the City and the County for the delivery of healthcare, mental health, and substance use disorder services in the City and on the implementation of *LA Alliance* settlement discussions/agreement.
