RESOLUTION CLERK FOR PLACED TO THE ON NEXT

WHEREAS, the Southern California Regional Rail Authority (Metrolink) is applying for \$4.7 Million Neighborhood Access and Equity Grant as part of the United States Department of Transportation's Reconnecting Communities and Neighborhoods Program for *Metrolink Sustainable Locomotives: Redressing Hustric Harms Along Legacy Railroad Tracks Project* (Project); and

WHEREAS, Metrolink plans to use the grant funds to purchase new locomotives powered by the lowest-emission diesel engineers that will replace and aging fleet of old diesel locomotives, reducing emissions of federally regulated pollutants by 53 to 76 percent; and

WHEREAS, with the new locomotives, Metrolink will have the largest fleet in California that is opertin gon on 100 percent renewable fuel, further demonstrating Metrlink's commitment to reducing emissions and greenhouse gasses; and

WHEREAS, when implemented, the Project will significantly reduce greenhouse emissions from regional passenger rail service in the nation's most polluted air quality basin, delivering improved air quality and public health benefits to an estimated 3.2 million people living and working along the 545 miles of Metrolink track, where more than half of the neighboring communities are designated as disadvantaged by USDOT; and

WHEREAS, the Project is a [rime example of advancing social and environmental justice through target transportation investments;

NOW, THEREFORE, BE IT RESOLVED, that by adoption of this Resolution, the City of Los Angeles supports the Southern California Regional Authority's *Sustainable Locomotives: Redressing Historic Harms Along Legacy Railroad Tracks Project* grant application for funding through the United States State Department of Transportation's Reconnecting Communities and Neighborhoods Program and encourages USDOT to partner with the State and the regions in a collective effort to transform and modernize passenger rail service through the award of this grant.

MOTION

In April 2022, the City Council and Mayor approved the acceptance of a \$53.3 million grant from the State of California - the Californians For All (CA4All) Youth Workforce Development grant (C.F. 22-0014). The Economic and Workforce Development Department (EWDD) serves as the grant administrator and processes invoices and reimbursement requests to the State of California for City departments and third-party service providers. The CA4All grant aims to 1) increase youth employment; 2) develop career opportunities; and 3) strengthen City/community capacity to address key areas of food insecurity, climate, and COVID-19 recovery.

During consideration of this issue, the Council approved a \$4.5 million Reserve Fund loan to avoid cash flow and prevent service disruptions related to the CA4All grant (C.F. 22-0683-S2). EWDD is now requesting an additional \$10 million to prevent service disruptions and pay participating City departments, service providers, and program participants on a timely basis.

I THEREFORE MOVE, that the City Council:

- 1) APPROVE an increase in the California for All Reserve Fund Loan, in the amount not to exceed \$10 million, to avoid cashflow and payment disruption to service providers and participants associated with the Californians For All Youth Workforce Development Grant, to be repaid at the end of the grant and upon receipt of full reimbursement from the State of California.
- 2) AUTHORIZE the Controller to process a Reserve Fund Loan and transfer up to \$10 million to the Californians for All Youth Workforce Development Grant Fund No. 65N to avoid cash flow and payment disruption to service providers and participants associated with the Californians for All Youth Workforce Development Grant, to be repaid at the end of the grant and upon receipt of full reimbursement from the State of California.
- 3) AUTHORIZE the Controller to make any technical corrections necessary to effectuate the intent of this action.

MOTION

The recent period of extreme drought that was punctuated last winter by intense precipitation is precisely the kind of pattern that climate scientists have long predicted. So despite having near record rains and snowpack, we know full well that the next drought is right around the corner and may be worse than the last one. Indeed, climate science tells us that we can expect longer, more frequent, and more severe droughts in the future so the City should be preparing now for this certain future. Doing so requires that the City plan for extreme drought and extreme precipitation.

In order to be more resilient, the City has set a goal of obtaining 70% of its water from local sources by 2035 and the Bureau of Sanitation is proceeding with numerous projects to ensure its treatment plants can supply recycled water for local use. But, reaching this ambitious goal will also require that we continue to build upon our long history of successful efforts to reduce water consumption. To that end, the Green New Deal has established water conservation targets, calling for a reduction in potable water use per capita by 22.5% by 2025, 25% by 2035, and maintaining or reducing 2035 per capita water use through 2050. The Los Angeles Department of Water and Power conducted a Water Conservation Potential Study that outlined a cost-effective conservation strategy to maximize water savings.

Despite these past successes, there still remain numerous opportunities to conserve water throughout the City that are as yet untapped. These include but are not limited to:

- requiring more efficient toilets in new construction and creating programs to replace older, less-efficient units in existing buildings;
- Imposing limits on the use of non-functional turf on industrial, commercial, institutional, and large-scale residential properties;
- prohibiting the use of potable water at large facilities such as golf courses and cemeteries or requiring strict efficiency standards at such facilities;
- requiring dual water metering to separate indoor and outdoor water usage; and
- establishing a conservation-based water rate structure to help make water more affordable for low income customers while disincentivizing water waste.

I THEREFORE MOVE that the City Council direct the Department of Building and Safety and the Department of Water and Power, in consultation with Bureau of Sanitation, Recreation and Parks, the City Attorney, and any other relevant departments to report to the City Council within 60 days on these and other opportunities to strengthen the City's water conservation efforts for residential, industrial, and commercial uses, including:

HOUSING & HOMELESSNESS

As Council District Six continues to lock arms with our City, County and non-profit partners to address the human crisis playing out on our streets we have an urgent need for increased outreach for the highest acuity unhoused population within our district. Hope the Mission has extensive experience specifically with outreach to unhoused constituents with substance use disorders. In partnership with Los Angeles County, who will administer the contract, Council District Six seeks the services of Hope the Mission (HOPE) to deploy multi-disciplinary teams to engage in targeted outreach within the district. The goal of this outreach is to convince more folks to accept assistance from substance use disorder counselors and provide greater access to detoxification pathways. HOPE also offers a twelve-step program that they can bring to A Bridge Home sites and shelters in Council District Six. These services will also be available on weekends, which is currently not available in the district.

TRANSPORTATION

RESOLUTION

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, the Los Angeles Municipal Code section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between 2:00 a.m. and 6:00 a.m.; and

WHEREAS, there is an increased problem with oversized vehicles parking along several street segments in Council District 11 where large vehicles are often parked overnight and constrict travel lanes, thereby creating dangerous situations;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to the Municipal Code Section 80.69.4, and the California Vehicle Code Section 22507, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 7 feet in height, during the hours of 2:00 a.m. and 6:00 a.m., along the following street segments:

- Southside of Centinela Avenue between Wooster Avenue and La Tijera Boulevard
- Both sides of Lucille Avenue between Glencoe Avenue and Louella Avenue
- North side of Washington Place between Wasatch Avenue and Centinela Avenue
- Both sides of Stoner Avenue between Gateway Boulevard and Interstate-10
- Both sides of Crescent Park West between Crescent Park East
- Both sides of Crescent Park East between Crescent Park West
- Both sides of Millenium Drive between Veranda Way and Runway Lane
- Both sides of Runway Lane between Millenium Drive and Runway Road
- South side of Runway Road between Runway Lane and Dawn Creek
- East side of Dawn Creek between Runway Road and Bluff Creek Drive
- West side of McConnell Avenue between Millenium Drive and Bluff Creek Drive
- South side of Bluff Creek Drive between 12657 Bluff Creek Drive and Village Drive

BE IT FURTHER RESOLVED that upon the adoption of the Resolution, the Department of Transportation be directed to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed, at the above locations; and

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to
