I MOVE that the matter relative to funding for nuisance abatement and related work at Oceanwide Plaza located at 1101 South Flower Street, CF 24-0114-S1 item 18 on the special agenda, be amended to strike recommendation #2 and replace it with the following instruction:

Instruct
AUTHORIZE the Department of Building and Safety, to execute any contracts necessary to remove objects and debris from the Public Right of Way surrounding the property at 1101 S Flower Street.
