

In addition, the Police Department reports that it regularly responds to issues at the site.

As this building is not required for the City's operations, is not suitable for any other purpose, and is a source of blight and other issues in the area, it should be torn down. City staff should be directed to begin this work immediately.

I THEREFORE MOVE that the Bureau of Engineering, with the assistance of the General Services Department be directed to demolish the existing vacant structure at 8230 Vista Del Mar.

I FURTHER MOVE that the City Administrative Officer be directed to identify funds for this purpose, and to make them available to the BOE and GSD as needed.

**MOTION**

There are a number of key freedoms that are at the very foundation of our nation, including the freedom to assemble, freedom of speech, and freedom to worship. The government at all levels is obligated to protect these rights by ensuring access to sensitive sites such as religious institutions, health clinics, community centers, and other locations. The City recognizes that access to these sensitive sites is vital for the health and welfare of the residents of the City. We also recognize that the exercise of a person's right to protest must be balanced against another person's right of access.

Los Angeles Municipal Code Section 41.19 states that "No person shall sit or stand on or at the entrance of any house of worship, hall, theater, or other place of public assemblage in any manner so as to obstruct the entrance to that place." However, recent incidents here in Los Angeles and across the nation have demonstrated the need to explicitly provide for a buffer zone around the employees and entrances to these types of facilities to ensure free and open access. The State of Colorado and several cities including Sacramento, Chicago, and Pittsburgh have enacted such bubble zones and the Los Angeles County Board of Supervisors has directed County Counsel to draft a similar ordinance for application in unincorporated areas of the county.

Given the increasing number of violent incidents that we have seen in our communities, the City should consider adopting this important policy to protect our sensitive sites. Such an policy would make it a misdemeanor crime for a person to do any of the following:

- a) Knowingly obstruct, detain, hinder, impede, or block another person's entry to or exit from a religious institution, healthcare facility, educational facility, or community/public facility.
- b) Knowingly approach another person within eight feet of such person, unless such person consents, for the purpose of passing a leaflet or handbill to, displaying a sign to, or engaging in oral protest, education, or counseling with such other person in the public way or sidewalk area within a radius of one hundred feet from any entrance door to a religious institution, healthcare facility, educational facility, or community/public facility.

I THEREFORE MOVE that the City Council request the City Attorney, with the assistance of the Police Department and any other department as needed, to prepare and present a draft ordinance which would:

- prohibit a person or persons from knowingly obstructing, detaining, hindering, impeding or blocking another person's entry or exit from sensitive sites including religious institutions, healthcare facilities, educational facilities or community/public facilities; and
- prohibit a person or persons from knowingly approaching another person within eight feet of such a facility without consent for the purpose of passing a leaflet or handbill, displaying a sign, engaging in protest, education or counseling in the public right-of-way within a 100-foot radius of an entrance to the types of locations listed above.

## MOTION

The Esri geographic information system (GIS) software supports primary operations in 23 City departments, bureaus and elected offices by providing a variety of software and cloud-based solutions through the City-wide Annual Requirements Contract (ARC) Number (No.) 230000000009, Enterprise Agreement (EA) No. 00309465. The GIS information utilized by the various departments and bureaus identified below include location and geographic data that the various agencies utilize on a real-time basis to perform geographic analysis and to provide special reimbursable services, to the public and other governmental agencies, such as preparing/producing maps for constituents visiting public counters, the issuance of building and public works permits, zoning and land use decisions, dispatching for fire and police services, crime analysis, management of water and power assets, asset management at the Harbor and Airport, emergency operations such as wild fire response coordination, truck routing for trash collection, affordable housing development and many other critical services.

The Bureau of Engineering (BOE) has been the City's lead agency on using GIS software and has been designated by the City as the Contract Administrator over the EA with Esri. The BOE has coordinated annual payments to Esri for the last nine fiscal years. The current contract, which began on July 1, 2022, authorizes BOE to continue as the Contract Administrator over the term of the EA, which expires on June 30, 2025.

To ensure that there is no lapse in services provided by Esri for the remainder of the fiscal year, approval of the recommendations below would streamline the payment process for both the City and the vendor. Requesting all the participating departments and bureaus coordinate with the Controller's Office and provide the funding and account information by a designated date, will allow the Controller's Office to make technical accounting corrections as necessary to ensure accurate funding transfers are done in a timely manner. City Council and Mayoral approval is required to authorize the transfer of funds by various City departments and bureaus to the Bureau of Engineering. The BOE would then be able to remit payment to Esri to ensure there is no lapse in service.

The total cost of the three-year EA term is \$7,950,000.00. This EA with Esri is for the term of July 1, 2022 through June 30, 2025. **One Annual payment of \$2,650,000 is due at the beginning of each fiscal year of the EA term. This year's payment is the final payment on the current EA.**

I THEREFORE MOVE, to ensure the continued benefits of the GIS software and maintenance support services during FY 2024-25, that the City Council and Mayor:

1. REQUEST the Controller to transfer as soon as possible, the following amounts from the following participating City Departments and Bureaus identified below, totaling \$2,650,000 to the Engineering Special Services Fund, Fund No. 682, Department No. 50, Appropriation Unit No. 50AVAN-Citywide Enterprise License Agreement-ESRI, Inc., so that the Bureau of Engineering can make full payment on the annual payment to ESRI for its special GIS related services.

## MOTION

In 2016, the Department of Recreation and Parks (RAP) and the Police Department (LAPD) entered into a Memorandum of Agreement (MOA) for sworn police services and non-sworn security services at parks and facilities under the authority of RAP. Under this MOA, LAPD Security Services Division (SECSD) is tasked with providing security personnel to conduct gate closures and openings at designated parks in the established Gate Closure Program. The designated parks are listed in Exhibit C of the MOA. Section G of the MOA stipulates that "from time to time, by Council Motion or administratively because of safety and security concerns, other parks may be added, on a temporary basis."

North Hills Community Park located at 8756 N. Parthenia, North Hills, CA 91343 in Council District 6 has seen an increase of illicit activities taking place after park operating hours. Those illicit activities include gang activity, the sale and use of narcotics, assaults to the community, and overnight parking.

**I THEREFORE MOVE** that the City Council request the Department of Recreation and Parks and the Police Department to include North Hills Community Park in the list of parks included in the Gate Closure Program.

MOTION

On June 24, 2024, a fire was started in the Sepulveda Basin near one of the many homeless encampments hidden within the Basin. While working to extinguish the fire, a firefighter was hit by an exploding object which sent the firefighter to the hospital.

This is the third major fire incident in the Basin within 5 years. In 2020, a fire broke out and quickly spread to six acres, forcing the shutdown of the 405 Freeway. It took 100 firefighters to bring the blaze under control. It was not clear what caused the fire, however, once firefighters extinguished the blaze, they discovered a body in the Basin. In 2019, a brush fire consumed nearly 60 acres and increased in severity due to several propane tank explosions.

Encampment fires like these are a threat to the Sepulveda Basin, which is home to several recreational areas, a Wildlife Reserve, a water reclamation plant, and an armory.

The Los Angeles Municipal Code (LAMC) contains various regulations affecting park and recreation areas, including the Sepulveda Basin. LAMC Section 63.44, Subsection P, designates the Sepulveda Basin Recreation Area as being in a high fire hazard zone. The subsection states that "no person shall light, ignite, set fire to, or burn any substance, or maintain an open flame of any kind for any purpose, including but not limited to cooking and barbecuing, except in areas specifically designated and posted to allow open flames." This same subsection also states that there should be signage around the area that reads "NO OPEN FLAMES BETWEEN APRIL 1 AND NOVEMBER 1."

In order to ensure that the Sepulveda Basin is protected from fires, including its recreational areas, wildlife reserve and public infrastructure, it is critical that existing regulations are abided by and enforced.

In addition to fire hazards, the Basin faces risks such as public safety concerns, hazardous waste, and flooding. Establishing a working group with relevant city, state, and federal departments would greatly benefit the region by addressing these diverse issues comprehensively.

**I THEREFORE MOVE** that the City Council instruct the Fire Department, with the assistance of the Police Department, the City Administrative Officer, the Chief Legislative Analyst and the Department of Recreation and Parks, to report within 30 days on the status of the Sepulveda Basin and the fire incident which occurred on June

24, 2024; and how the provisions of the LAMC are being enforced in the Sepulveda Basin to ensure fire risk mitigation, along with any recommendations to improve existing procedures to address encampments at the Basin. The report should also include fire risk mitigation recommendations for all other existing factors that lead to fires in the Basin.

**I FURTHER MOVE** that the City Council direct relevant departments like LAFD, LAPD, Bureau of Engineering, LASAN, Rec and Parks, etc., to participate in a working group convened by Council District 6 and the Office of the Mayor with the goal of developing solutions to address the various issues affecting the Basin. State and federal partners that oversee the land in the Basin should also be invited to participate in the working group.

# TRANSPORTATION

## MOTION

The City of Los Angeles has been working to enhance its active transportation network, improve the safety of people biking, and encourage the use of multimodal transportation options. Increasing the safety of people walking and biking, besides its inherent benefits, is also necessary to reduce emissions generated by personal vehicles (our highest source of Greenhouse Gas emissions).

However, despite these efforts, when bicycle lanes, sidewalks and other active transportation facilities are closed due to construction and other work or events in the public right-of-way, the City lacks a robust noticing process to inform people of impending closures. This is disruptive to people walking and biking and discourages active transportation if people cannot be reliably certain whether pathways will be open and safe to use. A closed bike lane, for instance, can force people biking to use a general purpose lane, inviting more potential conflicts with people driving.

In its development of the Public Right-of-Way Reservation System, the Bureau of Engineering had begun work on developing uniform construction notices and notification processes for projects in the public right-of-way (C.F. 20-1469). Currently, a minimum 10-day notice is required prior to beginning construction in the public right-of-way, but that notice is only required to be given to residents abutting the construction area. This work should be expanded to ensure that people walking and biking and stakeholders, such as the City of Los Angeles Bicycle Advisory Committee, Pedestrian Advisory Committee, and others, are included in the noticing process for major projects impacting an active transportation facility.

The Department of Transportation (LADOT) reviews and approves Traffic Control Plans for all major projects requiring lane closures. In recent years, LADOT has developed informal best practices for facilitating bicycle traffic through construction zones on a case-by-case basis, but has not yet formalized these practices to ensure consistent experiences for people biking.

**I THEREFORE MOVE** that the Department of Transportation, with support from the Bureau of Engineering and the Bureau of Street Services, be instructed to report back, within 90 days, with existing and/or proposed policies and procedures to notify and protect users during the temporary closure of active transportation facilities (sidewalks, off-street paths, and Class II and Class IV Bicycle Lanes), including notification, signage, equivalent facility and/or safe detour requirements.


